#### Regulation

The Indian and Pakistani Residents (Citizenship) regulations published in *Gazette* No. 10,004 of August 5, 1949, as amended from time to time, are hereby further amended by the insertion immediately after regulation 7, of the following new regulation —

"7A Where any applicant for registration under the Act who has made a request for the registration of any of his minor children, dies before the Commissioner disposes of his application, any notice or other document required under the Act to be served on such applicant shall, if there is no widow alive in respect of whom the applicant has made a request for registration, be served on such child

Provided, however, that where such child is less than fourteen years of age, such notice or other document shall be served on the person who the Commissioner is satisfied, after consultation with the Government Agent of the area in which such child resides, is the guardian of such child or the person who has custody of such child "
