1. The Colombo Port Rules, 1936, published in the *Supplement to Gazette* No. 8,251 of October 16, 1936, as amended by rule published in *Gazette* No. 9,878 of June 11, 1948, are hereby further amended in rule 21 by the substitution, for paragraph (4) thereof, of the following new paragraph.—

“(4) In addition to the charges for pilotage leviable and payable under the preceding paragraphs of this rule, in every case where a pilot is employed by a vessel other than a man-of-war, a further charge for pilotage shall be leviable and payable at the rate of—

- (a) twenty-five rupees, if the Pilot is employed on any day for the purpose of the movement of that vessel to or from any quay, dock, pier, jetty, landing stage, or alongside any other vessel, within the Port,  
(b) sixty rupees, if the Pilot is employed on any day for the purpose of the movement of that vessel within the Port while that vessel is not under command, and  
(c) thirty-five rupees, if the Pilot is employed on any day for any purpose between the hours of 6 p.m. and 6 a.m.

In this paragraph “not under command” has the same meaning as under the law for the time being in the United Kingdom.”

2. Rule 1 shall take effect on the 1st day of October, 1956.

BY virtue of the powers vested in the Minister of Home Affairs by section 13, and delegated to me under section 7, of the Excise Ordinance (Chapter 42) as modified by the Proclamation published in *Gazette Extraordinary* No. 9,773 of September 24, 1947, I, Arthur Lorenz Loos, Excise Commissioner, do amend the form of Toddy Transport Pass set out in Excise Notification No. 289, published in *Gazette* No. 8,232 of July 3, 1936 (as amended by Excise Notification No. 407 published in *Gazette* No. 9,932 of December 23, 1948), in the manner set out in the Schedule hereto.

### SCHEDULE

The form of Toddy Transport Pass set out in Excise Notification No. 289 published in *Gazette* No. 8,232 of

July 3, 1936 (as amended by Excise Notification No. 407 published in *Gazette* No. 9,932 of December 23, 1948), is hereby amended by the insertion immediately after condition 4A of the following new condition:—

“4B. Employment of a temporary substitute for the transporter.

The Contractor shall not—

- (a) employ a temporary substitute for the transporter named in the toddy transport pass unless he has first made an endorsement giving the name and address, and the date of commencement of the employment, of the substitute on the back of the toddy transport pass and duly signed and dated it himself or, if the contractor is unable to write, another person on behalf of such contractor has made, signed and dated such endorsement, and
- (b) where such endorsement has been made, employ a temporary substitute—
  - (i) for more than fifteen days from the date of commencement of his employment, or
  - (ii) after the contractor is informed in writing by the officer authorised to issue the toddy transport pass that such substitute is for any reason unsuitable for employment.”
