tioner, and the petition and affidavit of the petitioner having
been read

It is ordered that the petitioner above named as the widower
of the deceased be declared entitled to the letters of adminis-
tration to the estate of the deceased issued to him, unless the
respondents above named on or before December 26 1956, show
sufficient cause to the satisfaction of this court to the contrary

It is further ordered that the 4th respondent above named be
appointed guardian *ad litem* over the 1st, 2nd and 3rd respon-
dents above named who are minors, unless the respondents above
named or any other person or persons interested shall, on or
before December 26, 1956, show sufficient cause to the satis-
faction of this court to the contrary
