The Award

This is an award under section 17 of the Industrial Disputes Act, No. 43 of 1950, as amended by the Industrial Disputes (Amendment) Acts, No. 25 of 1956, No. 14 of 1957 and No. 62 of 1957. It relates to a dispute between the Eksath Engineru Saha Samanya Kamkaru Samithiya (hereinafter referred as the "Samithiya"), on the one hand, and Sakuntala Talkies, Eheliyagoda (hereinafter referred to as the "Talkies"), on the other.

2. The Commissioner of Labour by his Order made under section 3 (1) (d) of the Industrial Disputes Act dated 6th December, 1958, referred the above industrial dispute to me for settlement by arbitration. According to the statement of the Commissioner of Labour, the matter in dispute between the said Samithiya and the said Talkies is whether the non-employment of R. M. Hendrick Singho and D. M. Dhanapala by the management of Sakuntala Talkies, Eheliyagoda, is justified, and, if not, to what relief each of them is entitled.

3. The matter was taken up for hearing on the following dates: 8-1-59, 20-1-59, 9-2-59 and 23-2-59. Mr. Sirisena Herath, an office bearer of the Samithiya, appeared for the Samithiya throughout the hearing and Mr. H. A. G. Kalatuwawa, a partner of the Talkies, in the first instance, and later Mr. William Abeyasundera, Proctor, and still later Mr. Advocate Yogaratna instructed by Mr. William Abeyasundera appeared for the Talkies.

4. During the various stages of the proceedings, several proposals were discussed by the parties for the settlement of the dispute but without success. Towards the close of the hearing, more attempts were made to reach a settlement. After the case was closed, Mr. Herath representing the Samithiya, asked for an adjournment to consider certain definite proposals made by the Talkies for settlement of the dispute. This was granted.

5. On the last day of the hearing, both parties agreed on the general principal on which a settlement was possible, viz., the payment of a certain sum of money to Hendrick Singho and Dhanapala as an ex gratia payment for services rendered taking all circumstances into consideration.

6. As the parties would not agree on the quantum of this payment, they consented to abide by any decision I made in the matter.

7. In the case of R. M. Hendrick Singho, I consider that his non-employment is justified for the following reasons:—

- (a) He himself had admitted in writing that as he was becoming inefficient he asked the management to find another person to do his work.
- (b) Retrenchment had to be effected to offset the heavy losses sustained by the Talkies.

He has been discontinued after a month's notice. Hendrick Singho claims that he has not been paid in full for the months he worked, i.e., April, May and June 1958. This claim is correct and should be met by the Talkies.

He also states that he has not been paid for work performed during holidays which he is entitled to. I am unable to verify this.

The balance of the payments due to him for April, May and June, 1958, should be paid up to 15th June,

1958, and in addition he should be paid 1½ months gross wages for his 4 years of service in full settlement of the dispute as far as he is concerned.

8. With regard to D. M. Dhanapala, I am of opinion that his non-employment is justified owing to the following reasons:—

- (a) He has given a written statement that he was paid in full including one month's salary in lieu of notice and that he had no further claims on the management.
- (b) Retrenchment was necessary as a result of heavy losses sustained by the Talkies.

Dhanapala admitted having given the written statement but stated that a part of the statement had been altered by the management. I am unable to accept this. The Labour Officer had seen the written statement before it was lost from the files. Apart from this, no statement with the wording altered as alleged by Dhanapala, will be accepted by a normal business person.

Dhanapala's service is under 3 years and I feel that he should be paid one month's gross salary in addition to one month's salary already paid to him in lieu of notice in full settlement of the dispute.

9. The payments ordered above should be made through the Assistant Commissioner of Labour, Avissawella, within one month of the publication of this award in the *Government Gazette*.

THE AWARD

This is an award under the Industrial Disputes Act, No. 43 of 1950. It relates to an industrial dispute between the Hotel, Bakery and Beverages Workers' Union (hereinafter referred to as "the Union") and the Maliban Hotels, Limited (hereinafter referred to as "the Company"). The Honourable the Minister of Labour, Housing and Social Services by his Order dated 19th November, 1958, made under section 4 (2) of the Act, has referred the dispute to this Court for

settlement. The matter in dispute as set out by the Commissioner of Labour in his statement dated 13th November, 1958, is as follows:—

The non-employment of K. Premasiri.

This person was a former employee of the Company.

2. The inquiry before me commenced on the 10th of January, 1959, and was continued on various dates suitable to the Court and the parties; it was concluded on 20th February, 1959.

3. On the first date of inquiry some time was taken in the argument concerning the burden of proof. Mr. Shanmugathan for the Union urged that it was nothing but right for the employer to first lead evidence regarding the dismissal, and cited an Indian case of 1949. Mr. Kadirgamar, appearing for the Company, urged that this very question was raised on a number of occasions in this Industrial Court and cited among others the case of the Industrial Dispute No. 14 of 1956. The Court ordered that the Union should commence following the established procedure.

4. As will be seen from the statement of the Commissioner of Labour which was quoted earlier, there is only one dispute. The Union alleged mala fide by the Company in that K. Premasiri (the employee under reference) was victimised for trade union activities and asked for reinstatement of this employee. The Company contended that the services of K. Premasiri were discontinued by the Company after due inquiry on disciplinary grounds and that reinstatement of the said employee was impossible and impracticable.

5. After several witnesses called by Mr. Shanmugathan for the Union had been heard and had been cross-examined by Mr. Kadirgamar on behalf of the Company the two parties, after mutual discussion, arrived at the following settlement:—

- (a) That the Union was not proceeding with the claim made before the Court;
- (b) In view of the Union withdrawing its demand, that the management is prepared to make to K. Premasiri an ex gratia payment, without any acknowledgment of any right on his part to receive same, namely, a sum of rupees one hundred and ninety-six and cents fifty (Rs. 196.50), being three months' wages at Rs. 19 per mensem and three months' meal allowance at Rs. 46.50 per mensem.

Both parties accepted the terms of this settlement and agreed that payment was to be made by the Company's lawyers direct to the Union.

The Court is of opinion that the terms of settlement are fair and equitable in the circumstances of the case and makes its award accordingly.

WHEREAS "Hæmorrhagic Septicæmia" disease has broken out among cattle in Ehelapola Wasama in the Divisional Revenue Officer's Division of Matale North in Matale District of the Central Province, I, Aryadasa Amarasinghe, Chief Government Veterinary Surgeon, by virtue of the powers vested in me under the Contagious Diseases (Animals) Ordinance Amendment Act, No. 33 of 1957, and in terms of section 4, sub-section (1) of the said Ordinance (Chapter 327), do hereby declare an "INFECTED AREA"—the area bounded on—

North by Walmoruwe Wasama.
South by Paldeniya Wasama.
East by Narangamuwa Wasama.
West by Pallepola and Koswatte Wasama.

2. Under section 7 of the same Ordinance, I proclaim that no movement of cattle or cart traffic from and to this Wasama shall be allowed, until this proclamation is revoked.

The attention of all cattle owners and carters in the area, is drawn to the Contagious Diseases (Animals) Regulations, 1937, which lays down the actions which persons are by law required to take in an "INFECTED AREA". Details of these regulations can be obtained from the Veterinary Surgeon, Matale, and the Divisional Revenue Officer, Matale North at Naula.

This declaration shall take effect from the date hereof.

CONTROL OF VEHICULAR TRAFFIC AT THE RAILWAY LEVEL CROSSING AT RAGAMA AT 8 MILES 75 CHAINS ON THE WELISARA, RAGAMA, KADAWATA P. W. D. ROAD

TWO TOLL-BARS in replacement of the existing wooden gates at the above level crossing will be brought into use as and from 16th March, 1959, along with LIGHT SIGNALS for the control of vehicular traffic. Drivers of every vehicle shall obey these LIGHT SIGNALS which will operate in accordance with the following system:—

- (1) At a distance of 55 feet ahead of the Toll-Bar on the Welisara-Ragama end and 35 feet ahead of the Toll-Bar at the Hospital end a white line, hereinafter called "The Stop Line", drawn across the highway is provided in conjunction with each Light Signal.
- (2) At a distance of 10 feet to the rear of the stop-line, a colour light signal consisting of 3 lamps, one red, one amber and one green, facing the stream of traffic which the signal is intended to control is erected.
- (3) The lamps showing the colour lights are arranged vertically, the lamp showing the red light being the uppermost and that showing green light the lowermost.
- (4) The sequence of the signal lights for the purpose of controlling vehicular traffic will be as follows:—
 - (i) Red with the word "STOP" on the lens of the lamp;
 - (ii) Amber and Red together;
 - (iii) Green;
 - (iv) Amber.

(5) The significance of the Light Signals aforesaid is as follows:—

- (a) The red signal indicates that no vehicular traffic is to proceed beyond the stop-line until the green signal is shown;
- (b) The amber-with-red signal indicates an impending change in the signal from red to green but does not alter the prohibitory significance of the red signal;
- (c) The green signal indicates that traffic may pass the signal and proceed straight on with due regard to the safety of other users of the highway and subject to any directions which may be given by a Police Officer or other duly authorised person engaged in the regulation of traffic; and
- (d) The amber signal shown alone indicates an impending change in the signal to red and shall be taken as prohibiting all traffic from proceeding beyond the Stop-Line.

(6) If and when these light signals be defective, drivers of all vehicles shall obey hand signals exhibited at the level crossing gate.
