- 2. Conditions of Service.—Appointments will be subject to the Public Service Commission Rules, the Financial Regulations, the Regulations of the Manual of Procedure, Departmental Orders or Regulations, and any other orders or regulations issued from time to time by *be Government.

6. ORGANIZATION AND METHODS OFFICERS' TREASURY

He will, during such period, diligently and efficiently discharge all duties which he may be required to do, and shall enter into a bond with two approved sureties for the payment of rupees two thousand (Rs. 2,000) in the event of his leaving the Department before the expiration of five years service as a Draughtsman, Class II. The Agreement and Bond will come into operation from the date of appointment as probationary Draughtsman. Draughtsmen will be liable to transfer and may be posted to any station in Ceylon. On selection, Probationary Draughtsmen will be given a full training in Draughtsmanship.

They will be required to pass a qualifying examination at the end of the 3-year probationary period to be eligible for appointment to the grade of Draughtsman, Class II. Probationary Draughtsmen who fail to pass the qualifying examination at the end of the 3-year probationary period will be allowed two more attempts to pass the qualifying examination during which period they will remain on probation on the salary scale of Rs. 960—2 of 72—Rs. 1,104 per annum. Officers who fail to pass the qualifying examination will be discontinued.

They are also liable to be discontinued at any time during the period of probation if their work and conduct are unsatisfactory.

- (c) Appointments are pensionable. Officers do not, however, acquire pension rights until they are appointed as Draughtsmen, Class II.
- (d) Candidates selected as Probationary Draughtsmen if New Entrants as defined in para 2 (B) (V) of Treasury Circular No. 428 of 31.1.58, will be required to comply with any rules already made or that may hereafter be made for giving effect to the language policy of the Government and in particular for implementing the provisions of the Official Language Act, No. 33 of 1956.

Such candidates who do not take subjects (i)—(iv) specified in para 18 in the Sinhala medium

and who are selected for appointment should learn Sinhala during their probationary period. Appointment of these candidates as Draughtsmen, Class II, at the expiry of the probationary period will depend on satisfactory work and conduct, and on the passing of an examination in Sinhala in addition to the qualifying examination referred to in (b) above.

Those who fail to reach the prescribed standard of proficiency in Sinhala during their probationary period are liable to be discontinued but discontinuance may be deferred if the Surveyor-General is satisfied that a genuine attempt had been made to study the official language. Loss of seniority may be waived at the Surveyor-General's discretion if the probationer passes the test within a reasonable time thereafter.

Applications

- 5. Applications for admission to the examination must be made on forms which may be obtained from the Surveyor-General's Office, Fort, Colombo, up to March 4, 1959. Application forms are available in all the three media, and when applying for these forms, candidates should state the medium in which they intend to take up the examination, subject to the note to clause 18 (iv) of this notification.
- 6. Applications must be sent by registered post to reach the Surveyor-General, P. O. Box 506, Colombo, on or before March 10, 1959. Any application received after March 10, 1959, will be rejected. The application must bear a duly cancelled stamp or stamps to the value of Rs. 15.

Documents of Eligibility

14. The following documents (in original) should be attached to the applications:—

- (a) a certificate of good character signed by a responsible person. Note: If the candidate has been educated at a Government or Assisted School, the certificate of character must be from the Principal of the last Government or Assisted School which he has attended; otherwise, it may be from a Justice of the Peace, Advocate, Proctor or Notary, Divisional Revenue Officer or a permanent Government Officer in receipt of an annual salary of Rs. 2,400 or over or, generally speaking, some person whose name is known and to whom reference can readily be made. The name, designation and address of the person must be clearly indicated on the certificate;
- (b) a certified copy of the candidate's birth registration entry.
- Note.—(i) The special certificate of birth issued for school or educational purposes or a certified extract from the birth registration entry will not be accepted;
- (ii) Affidavits or baptismal certificates will not be accepted as substitutes for birth certificates;
- (iii) if the name/names appearing in the birth certificate differs/differ from the name/ names which the candidate ordinarily uses and under which the candidate enters for the examination, action should be taken immediately in terms of section 27 or 28 as the case may be, of the Births and Deaths Registration Act, No. 17 of 1951, to get the name in the birth registration entry amended. A certified copy of a birth registration entry effected more than one year after the date of birth, under section 24 (6) of the Births and Deaths Registration Act, No. 17 of 1951, as amended by section 2 of the Births and Deaths Registration (Amendment) Act, No. 15 of 1953, will be accepted for the purposes of making appointments only after consideration of the evidence by which the date of birth was established;

- (c) certificate of registration as a citizen of Ceylon or original official letter of acceptance of claim to citizenship by descent (where applicable);
- (d) certificate of educational qualification or where the certificate has not been issued, other official documents, e.g., Ceylon G. C. E. (Ordinary Level) results slip issued to private candidates or original letter from the candidate's Head of School.

Penalty for furnishing false particulars

- 15. (i) If a candidate is found to be ineligible according to the regulation for this examination, his candidature is liable to be cancelled at any stage prior to, during, or after the examination.
- (ii) If any of the particulars furnished by a candidate are found to be false within his knowledge or if he has wilfully suppressed any material fact, or if it is proved, at any time during the period of his service, that he was ineligible to sit for this examination, he will be liable to instant dismissal from the Service.
- (iii) Admission to the examination does not constitute acceptance of eligibility.

Identity Cards

In all written papers, marks will be deducted for bad writing and mistakes in spelling. Candidates whose writing is illegible are liable to be disqualified.

Medical Examination

20. The successful candidates will be required to pass a medical examination as to their physical fitness for service in any part of the Island.
