THE TOWN COUNCILS ORDINANCE, No. 3 OF 1946 AND THE LOCAL AUTHORITIES ELECTIONS ORDINANCE, No. 53 OF 1946

BY virtue of the powers vested in me by sections 2, 5, 6 and 30 of the Town Councils Ordinance, No. 3 of 1946, and section 82 of the Local Authorities Elections Ordinance, No. 53 of 1946, as modified by the Proclamation published in Gazette Extraordinary No. 9,773 of September 24, 1947, I, Jayaweera Kuruppu, Minister of Local Government and Cultural Affairs, do by this Order—

- (1) vary the limits of the town of Alutgama (as defined in the Order published in Gazette No. 9,911 of October 8, 1948), by the substitution, for the Schedule thereto, of the First Schedule hereto;
- (2) revoke the Order relating to the number of members of the Alutgama Town Council and the number and limits of the wards of the town of Alutgama published in Gazette No. 9,911 of October 8, 1948;
- (3) order that the Alutgama Town Council shall consist of seven members and that the town of Alutgama shall be divided into seven wards with the limits as defined in the Second Schedule hereto; and
- (4) declare that the provisions of paragraphs (1) (2) and (3) of this Order shall—
  - (a) in so far as they relate to any matter connected with the general election of members due to be held in the year 1959, come into effect on the date on which this Order is published in the Gazette; and

(b) in so far as they relate to any other matter, come into effect on the day immediately following the date of expiration of the term of office of the members of the Alutgama Town Council who are in office at the date hereof.

#### First Schedule

THE LIMITS OF THE TOWN OF ALUTGAMA

All that area of land situated in the villages of Alutgama West, Alutgama East, Seenawatte, Ganegama and Kaluwamodera (Part) in Kalutara Totamune, Kalutara District, Western Province, and bounded as follows:—

North.—By a straight line drawn from a point on the centre line of Bentota river to meet the centre line of the Colombo-Galle Railway line perpendicularly at a point 860 feet southwards from the centre of the junction of the said Railway line and Seelananda road; thence north-eastwards crossing the Colombo-Galle Public Works Department road to the said point on the said Railway line; thence by a line drawn north-westwards along the centre line of the said Railway line to its centre of junction with the said Seelananda road; thence south-eastwards and north-eastwards along the centre line of the said road and crossing Kandevihara road till it meets the centre line of Kepu-Ela.

- East.—By a line drawn from the last-mentioned point south-eastwards along the centre line of Kepu-Ela crossing the Welipenna road to its centre of confluence with Bentota river; thence south-westwards along the centre line of the said river to a point 30 chains measured north-east from the centre of the bridge on the Colombo-Galle road over the said Ganga.
- South.—By a line drawn from the lastmentioned point south-westwards along the centre line of the Bentota River to the centre of the bridge on the Colombo-Galle road over the said Ganga.
- West.—By a line drawn from the last-mentioned point north-westwards along the centre line of the Bentota River to the starting point of the northern limit of the area.

#### Second Schedule

#### WARDS OF THE TOWN OF ALUTGAMA

#### ward no. 1

- North.—By a line drawn from the centre of junction of Colombo-Galle Railway line and Cemetery road, north-eastwards and south-eastwards to its centre of junction with Centre road.
- East.—By a line drawn from the last-mentioned point south-eastwards and southwards along the centre line of Centre road to its centre of junction with Good Shed Road.
- South.—By a line drawn from the lastmentioned point south-westwards along the centre line of Good Shed road to its centre of junction with New road.
- West.—By a line drawn from the last-mentioned point north-westwards along the centre line of New road to its centre of junction with Colombo-Galle Railway line; thence north-westwards along the centre line of the said Railway line to the starting point of the northern limit of the Ward.

### ward no. 2

- North.—By a line drawn from the eastern extremity of the northern limit of Ward No. 1, north-eastwards along the centre line of the Cemetery road to its centre of junction with Welipenna road; thence north-eastwards along the centre line of the said road till it meets the eastern limit of the Town Council area; thence south-eastwards along the said eastern limit to the centre of confluence of Kepu-Ela and Bentota river.
- East.—By a line drawn from the last-mentioned point south-westwards along the eastern limit of the Town Council area to a point in line due east of the south-eastern corner of lot 246 in Town Survey Plan 60.
- South.—By a straight line drawn from the last-mentioned point westwards to the south-eastern corner of lot 246 in Town Survey Plan 60; thence by a line drawn westwards along the southern boundary of the said lot to its western extremity; thence by a straight line drawn south-westwards to the centre of the junction of Welipenna road and Good Shed road; thence south-westwards along the centre line of Good Shed road till it meets the southern extremity of the eastern limit of Ward No. 1.

West.—By a line drawn from the last-mentioned point along the eastern limit of Ward No. 1 to the starting point of the northern limit of the ward.

#### ward no. 3

- North.—By a line drawn from the centre of junction of New road and Colombo-Galle Railway line, south-eastwards along the western limit of Ward No. 1 till it meets the western extremity of the southern limit of Ward No. 1; thence north-eastward along the southern limit of Ward Nos. 1 and 2 till it meets the eastern limit of the Town Council area.
- East and South.—By a line drawn south-west-wards along the eastern and southern limits of the Town Council area to a point in line due south the south-western corner of lot 659 of Town Survey Plan 60.
- West.—By a straight line drawn from the lastmentioned point northwards to the southwestern corner of lot 659 in Town Survey
  Plan 60; thence by a line drawn northwestwards along the western boundary
  of the said lot to its northern extremity;
  thence north-westwards in prolongation
  to the centre line of Welipenna road;
  thence by a line drawn north-eastwards
  along the centre line of the said road to
  a point in line due north of the southernmost point of the centre line of the Railway siding; thence by a straight line
  north-westwards to the said southernmost
  point of the centre line of the said Railway
  siding; thence north-westwards along the
  centre line of the said Railway siding to
  its centre of junction with Colombo-Galle
  Railway line; thence north-westwards
  along the centre line of the said Railway
  line to the starting point of the northern
  limit of the area.

#### WARD NO. 4

- North.—By a line drawn from the centre of junction of New road and Colombo-Galle road; north-eastwards along the centre line of the said New road till it meets the starting point of the northern limit of Ward No. 3.
- East.—By a line drawn from the last-mentioned point along the western limit of Ward No. 3 to the southern limit of the Town Council area.
- South.—By a line drawn from the lastmentioned point south-westwards along the southern limit of the Town Council area to its western extremity.
- West.—By a line drawn from the last-mentioned point north-eastwards, north-westwards and again north-eastwards and north-westwards along the centre line of the Colombo-Galle road to the starting point of the northern limit of the ward.

## WARD NO. 5

North.—By a straight line drawn from a point on the centre line of Bentota River where it meets the western extremity of the village limit between Ganegama and Kaluwamodera, north-eastwards along the said village limit till it meets the centre line of Colombo-Galle road.

- East and South.—By a line drawn from the lastmentioned point south-eastwards along the centre line of Colombo-Galle road till it meets the starting point of the northern limits of Ward No. 4; thence along the western limit of Ward No. 4 to its southern extremity.
- West.—By a line drawn from the last-mentioned point north-westwards along the western limit of the Town Council area to the starting point of the northern limit of the ward.

#### WARD NO. 6

- North.—By a line drawn from the centre of junction of Cemetery road and Colombo-Galle road; north-eastwards along the centre line of the said Cemetery road to the northern extremity of the Western limit of Ward No. 1.
- East.—By a line drawn from the last-mentioned point along the western limit of Ward No. 1 to the eastern extremity of the northern limit of Ward No. 4.
- South.—By a line drawn from the lastmentioned point along the northern limit

- of Ward No. 4 till it meets the western limit of Ward No. 5.
- West.—By a line drawn from the last-mentioned point along the eastern limit of Ward No. 5 to the starting point of the northern limit of the Ward.

#### WARD NO. 7

- North.—By a line drawn from the western extremity of the northern limit of the Town Council area along the said limit to its eastern extremity.
- East.—By a line drawn from the last-mentioned point along the eastern limit of the Town Council area to the eastern extremity of the northern limit of Ward No. 2.
- South.—By a line drawn from the lastmentioned point along the northern limits of Wards Nos. 2, 1, 6 and 5 till it meets the western limit of the Town Council area.
- West.—By a line drawn from the last-mentioned point north-westwards along the western limit of the Town Council area to the starting point of the northern limit of the ward.
