SUBSIDIARY FOODSTUFFS (MALDIVE FISH)

THE CONTROL OF PRICES ACT, No. 29 OF 1950

Order

BY virtue of the powers vested in me by section 4 of the Control of Prices Act, No. 29 of 1950, read with section 3 (2) of that Act, I, Bandula Somasiri de Silva, Assistant Controller of Prices (Food), for the Administrative District of Matale, do by this Order—

should, as usual, be calculated proportionately from the maximum wholesale price per cwt. nett specified hereto ;

- (i) revoke with effect from 1st February, 1959, my Food Price Order No. ML. 1958/K dated August 16, 1958, published in *Ceylon Government Gazette Extraordinary* No. 11,476 of August 19, 1958, in so far as it relates to the Wholesale Dealer's maximum wholesale price and the Retail Dealer's maximum retail price mentioned in columns 3 and 4 respectively of Schedule II thereto of Maldivé Fish mentioned in column 1 of that Schedule ;
- (ii) fix with effect from 1st February, 1959, the prices specified in columns 3 and 4 of Schedule II hereto to be a Wholesale Dealer's maximum wholesale price per hundredweight nett, and a Retail Dealer's maximum retail price per pound nett to a consumer, respectively, above which Maldivé Fish shall not be sold within the Administrative District of Matale, appearing under column 2 of Schedule II, full particulars of which appear in Schedule I ;
- (iii) direct that for the purpose of this Order—
 - (a) any sale of any quantity of Maldivé Fish for purpose of re-sale shall be deemed to be a sale by wholesale ;
 - (b) any sale of any quantity of Maldivé Fish for the purpose of consumption or use shall be deemed to be a sale by retail ;
 - (c) the maximum amount that is payable for any quantity of Maldivé Fish which is less than or more than one cwt. nett and sold by wholesale

- (iv) direct that, within the Administrative District of Matale, no person shall sell Maldivé Fish which is adulterated with any other article ;
- (v) direct that, within the Administrative District of Matale, every trader, who has any Maldivé Fish in his possession or under his control at any place or in any vehicle, shall exhibit conspicuously at that place or on that vehicle a notice in which there shall be set out the maximum prices for Maldivé Fish specified in column 1 of Schedule II fixed by this Order for that area ;
- (vi) direct that, for the purpose of this Order "pound" or "lb." shall be deemed to be the standard pound avoirdupois weight ;
- (vii) direct that, within the Administrative District of Matale, every person who sells Maldivé Fish by wholesale shall, and every person who sells Maldivé Fish by retail shall, on demand, give the purchaser thereof a receipt in which there shall be set out—
 - (a) the date of the sale ;
 - (b) the quantity of Maldivé Fish sold (by weight) ;
 - (c) the price paid for the quantity sold ; and
 - (d) the nature of the transaction, that is to say, whether the sale was by wholesale or by retail ;
- (viii) direct that, when Maldivé Fish is sold, the maximum prices referred to in columns 3 and 4 of Schedule II shall include the price of wrapper or container, if any, in which such Maldivé Fish is sold.

RICE AND PADDY

THE CONTROL OF PRICES ACT, No. 29 OF 1950
Order

BY virtue of the powers vested in me by section 4 read with section 3 (2) of the Control of Prices Act, No. 29 of 1950, I, Sanmugam Paramanathan, Assistant Controller of Prices (Food), for the Mannar District, do by this Order—

(i) revoke with effect from this date the Food Price Order No. MN/5 dated 1st June, 1958, in respect of Rice and Paddy published in *Ceylon Government Gazette* No. 11,354 of 11.6.58;

(ii) fix the prices specified in columns 2 and 3 of the 1st Schedule hereto to be the maximum wholesale prices "per hundredweight nett" above which rationed rice and paddy respectively shall not be sold by wholesale in the areas mentioned in the corresponding entries in column 1 of the same Schedule; and

(iii) fix the prices specified in columns 2 and 3 of the 2nd Schedule hereto to be the maximum retail prices per pound, above which rationed rice and paddy respectively shall not be sold in the areas mentioned in the corresponding entries in column 1 of the same Schedule;

(iv) direct that for the purpose of this Order—

(a) any sale of any quantity of rationed rice or paddy for the purpose of re-sale, or any sale of rationed rice or paddy in a quantity of one hundredweight nett or more at a time shall be deemed to be a sale by wholesale;

(b) any sale of any quantity of rationed rice or paddy less than one hundredweight nett for the purpose of consumption or use shall be deemed to be a sale by retail;

(v) direct that no person shall sell any rationed rice or paddy which is mixed with any other article;

(vi) direct that when any rationed rice or paddy is sold, the maximum prices fixed by this Order shall include the price of wrapper or container, if any, in which such rationed rice or paddy is sold;

(vii) direct that in every area where maximum prices are fixed by this Order, every trader who has any rationed rice or paddy in his possession or under his control at any place, shall exhibit conspicuously at that place a notice in which there shall be set out the maximum prices fixed by this Order in that place; and

(viii) direct that for the purpose of this Order "pound" or "lb." shall be deemed to be the standard pound avoirdupois weight;

(ix) direct that in every area where maximum prices are fixed by this Order, every person who sells any rationed rice or paddy by wholesale and every person who sells rationed rice or paddy by retail shall, on demand, give the purchaser thereof a receipt in which there shall be set out—

(a) the date of sale,

(b) the quantity of rationed rice or paddy sold,

(c) the price for the quantity of rationed rice or paddy sold, and

(d) the nature of transaction, i.e., whether the sale was by wholesale or by retail.

 - (c) the maximum amount that is payable for any quantity of Maldive Fish which is less or more than one cwt. nett and sold by wholesale should as usual be calculated proportionately from the maximum wholesale price per cwt. nett specified hereto ;

- (4) direct that within the Administrative District of Kurunegala, no person shall sell Maldive Fish which is adulterated with any other article ;
- (5) direct that within the Administrative District of Kurunegala, every trader, who has any Maldive Fish in his possession or under his control at any place or in any vehicle, shall exhibit conspicuously at that place or on that vehicle a notice in which there shall be set out the maximum prices for Maldive Fish specified in column 1 of the Schedule fixed by this Order ;
- (6) direct that for the purpose of this Order, "pound" or "lb." shall be deemed to be the standard pound avoirdupois weight ;
- (7) direct that within the Administrative District of Kurunegala, every person who sells Maldive Fish by wholesale shall, and every person who sells Maldive Fish by retail shall, on demand, give the purchaser thereof a receipt in which there shall be set out—
 - (a) the date of the sale ;
 - (b) the quantity of Maldive Fish sold (by weight) ;
 - (c) the price paid for the quantity sold ; and
 - (d) the nature of the transaction, that is to say, whether the sale was by wholesale or by retail ;
- (8) direct that when Maldive Fish is sold, the maximum prices referred to in columns 2 and 3 of the Schedule hereto shall include the price of wrapper or container, if any, in which such Maldive Fish is sold.
