KNOW YE that by virtue of the powers vested in me by section 19 of the Army Act, No. 17 of 1949, I, Oliver Ernest Goonetilleke, Governor-General, do by this Proclamation call out on active service the Regular Reserve of the Ceylon Army and those units of the Volunteer Force of the Ceylon Army which are specified in Schedule I hereto to perform the duties specified in Schedule II hereto which I consider necessary for the maintenance of supplies and services essential to the life of the community.

Given at Colombo on the Twentieth day of February in the year One Thousand Nine Hundred and Fifty-nine.

Order under Section 23 (1)
