THE MUNICIPAL COUNCILS ORDINANCE,
No. 29 OF 1947

Order

BY virtue of the powers vested in me by sub-sections (2) (b) and (3A) of section 277 of the Municipal Councils Ordinance, No. 29 of 1947, as amended by Act No. 12 of 1959, and as modified by the Proclamation published in *Gazette Extraordinary* No. 9,773 of September 24, 1947, I, Jayaweera Kuruppu, Minister of Local Government and Cultural Affairs, do by this Order direct that a new Municipal Council in accordance with the provisions of the aforesaid Ordinance shall be constituted for the Municipality of Colombo in place of the Municipal Council which was dissolved by Order published in *Gazette Extraordinary* No. 11,211 of December 2, 1957.

THE MUNICIPAL COUNCILS ORDINANCE,
No. 29 OF 1947

Order

BY virtue of the powers vested in me by section 284 (a) of the Municipal Councils Ordinance, No. 29 of 1947, as modified by the Proclamation published in *Gazette Extraordinary* No. 9,773 of September 24, 1947, I, Jayaweera Kuruppu, Minister of Local Government and Cultural Affairs, do by this Order—

- (1) vary the limits of the Municipality of Colombo as defined in the Proclamation published in *Gazette* No. 6,470 of November 10, 1911, (as amended by Order published in *Gazette* No. 10,177 of November 24, 1950) by the substitution, for the limits set out in the Schedule to that Proclamation, of the new limits set out in the Schedule hereto; and
- (2) declare that the provisions of paragraph (1) of this Order shall—
 - (a) in so far as those provisions relate to any matter connected with the general election of Councillors of the Colombo

Municipal Council due to be held in the year 1959, come into effect on the date on which this Order is published in the *Gazette*; and

- (b) in so far as they relate to any other matter, come into effect on the first day of January, 1960.

SCHEDULE

THE LIMITS OF THE MUNICIPALITY OF COLOMBO

All that area situated in the Colombo District of the Western Province and bounded as follows:—

North : By a line drawn north-eastwards, eastwards and south-eastwards from the centre of the Hendala ferry along the centre line of Kelani Ganga to the centre of the ferry at the eastern end of Pasbetal road.

East : By a line drawn southwards from the last-mentioned point along the centre line of Kelani Ganga, crossing the Victoria bridge to the centre of its confluence with Kittampahuwa ela; thence south-westwards, southwards and south-eastwards along the centre line of the said ela to the centre of its confluence with St. Sebastian canal and Weragoda ela; thence south-eastwards along the centre line of the said Weragoda ela to a point in line with the centre line of Baseline road; thence southwards across the said ela and along the centre line of the said road to the centre of the bridge over Dematagoda ela; thence north eastwards and south-eastwards along the centre line of Dematagoda ela crossing the railway bridge to the centre of its confluence with Heen ela; thence southwards, eastwards and south-westwards along the centre line of Kinda ela *alias* Dematagoda ela to its confluence with Mahawatte ela; thence south-westwards along the centre line of Mahawatte ela to the centre of its confluence with Heen ela depicted in P.P. A. 2393—W.P.; thence southwards along the centre line of the said Heen ela, crossing the Narahenpita-Nawala Road to the centre of its confluence with Kirilapone canal; thence south-eastwards along the centre line of the said canal to the centre of its

confluence with Depa ela *alias* Ganima ela passing through grass land; thence southwards and south-eastwards along the centre line of the said ela to its extremity; and thence along the eastern boundary of assessment No. 40, Nugegoda road and crossing the Nugegoda road to the centre line of the K. V. railway.

South: By a line drawn from the last-mentioned point north-westwards along the centre line of the said railway to the centre line of the railway avenue; thence south-westwards along the centre line of the said railway avenue to a point in line with the northern extremity of the western boundary of lot 270 in T. S. P. 62; thence south-westwards along the western boundary of the said lot to the northern limit of the Dehiwela-Mt. Lavinia Urban Council area; thence westwards, southwards and north-westwards along the said Urban Council area to the centre line of Dehiwela canal; thence south-westwards along the centre line of the said canal to the low-water mark of the sea.

West: By a line drawn from the last-mentioned point northwards along the low-water mark of the sea to the south-western corner of the south-west Breakwater; thence eastwards across the said Breakwater to the water-edge of the Harbour, thence south-eastwards, south-westwards again south-eastwards, north-eastwards and northwards along the water-edge of the harbour to the south-eastern corner of the north-east Breakwater; thence westwards, northwards and eastwards along the southern, western and northern boundaries of the said Breakwater to its north-eastern corner; thence north-eastwards along the low-water mark of the sea to the starting point of the northern limit of the area.

Note: The south-west Breakwater and the Harbour have been excluded from the Municipal limits and the Crow Island has been included as part of the main land.

**THE MUNICIPAL COUNCILS ORDINANCE,
No. 29 OF 1947**

Order

BY virtue of the powers vested in me by sections 2 (c), 5, 6 and 9 of the Municipal Councils Ordinance, No. 29 of 1947, as amended by Act No. 12 of 1959, and as modified by the Proclamation published in *Gazette Extraordinary* No. 9,773 of September 24, 1947, I, Jayaweera Kuruppu, Minister of Local Government and Cultural Affairs, do by this Order—

- (1) assign to the Municipal Council to be constituted for the Municipality of Colombo, the following name and designation, namely, the "Colombo Municipal Council";
- (2) prescribe that the number of Councillors of whom the Colombo Municipal Council shall consist shall be thirty-seven;
- (3) revoke the Order relating to the limits of wards of the Municipality of Colombo published in *Gazette* No. 9,112 of April 21, 1943;
- (4) divide the Municipality of Colombo into thirty-seven wards with the limits as defined in the Schedule hereto; and
- (5) appoint the first day of January, 1960, as the date on which the term of office of the Colombo Municipal Council shall commence.

SCHEDULE

The limits of the wards of the Municipality of Colombo

WARD NO. 1—MATTAKKULIYA

North: By a line drawn from the western extremity of the northern limit of the Municipal Council area along the said limit to its eastern extremity.

East: From the last-mentioned point along the eastern limit of the Municipal Council area to the centre line of Victoria bridge.

South: From the last-mentioned point south-westwards along the centre line of Prince of Wales Avenue to the centre of its junctions with

Madampitiya road; thence north-westwards along the centre line of Madampitiya road to the centre of its junction with Dhawala Singharama Mawata.

West: From the last-mentioned point northwards and north-eastwards along the centre line of Dhawalasingharama Mawata and Henemulla Lane up to the southern boundary of premises bearing Assessment No. 19, Henemulla Lane; thence along the southern, western and northern boundaries of premises bearing Assessment No. 19, Henemulla Lane and along the southern and eastern boundaries of premises bearing Assessment No. 427, Ferguson road to the centre line of Ferguson road; thence westwards along the centre lines of Ferguson road and Modera street up to the western boundary of premises bearing Assessment No. 309, Modera street; thence northwards along the western boundary of premises bearing Assessment No. 309, Modera street and north-westwards along the western boundaries of premises bearing Assessment No. 307 and 307/2, Modera street to the western limit of the Municipal Council area; thence along the said limit of the Municipal Council area to the starting point of the northern limit of the ward.

WARD NO. 2—MODERA

North: From the western limit of the Municipal Council area, south-eastwards along the western limit of Ward No. 1 up to the eastern boundary of premises bearing Assessment No. 427, Ferguson road.

East: From the last-mentioned point south-westwards and southwards along the western limit of Ward No. 1 to its southern extremity.

South: From the last-mentioned point north-westwards along the centre lines of Madampitiya road and Temple road to the southern-most point of premises bearing Assessment No. 61, Temple road; thence along the western boundary of premises bearing Assessment No. 61, Temple road to the western limit of the Municipal Council area.

West: From the last-mentioned point along the western limit of the Municipal Council area to the starting point of the northern limit of the ward.

WARD NO. 3—ALUTHMAWATTA

North: From the western extremity of the southern limit of Ward No. 2, along the said limit to its eastern extremity.

East: From the last-mentioned point southwards along the centre line of Mahawatta road, to its intersection with the prolongation eastwards of the southern limit of premises bearing Assessment No. 315/15; thence north-westwards along the southern boundary of the said premises to its western extremity; thence south-westwards along the eastern boundaries of premises bearing Assessment No. 291/25, Mahawatta road and Assessment No. 162, Maradana road; and westwards and north-westwards along the southern and western boundaries of premises bearing Assessment No. 162, Maradana road, till it meets the south-eastern extremity of premises bearing Assessment No. 750/10, Bloemendhal road; thence south-westwards along the southern boundary of premises bearing Assessment No. 750/10, Bloemendhal road, till it meets the northern boundary of premises bearing Assessment No. 676/6, Bloemendhal road; thence south-westwards, south-eastwards and south-westwards along the eastern boundary of premises bearing Assessment No. 676/6, Bloemendhal road up to its south-eastern extremity.

South: From the last-mentioned point north-westwards along the southern boundary of premises bearing Assessment No. 676/6, Bloemendhal road to the eastern boundary of premises bearing Assessment No. 614, Bloemendhal road; thence southwards along the eastern boundary and westwards along the southern boundary of premises bearing Assessment No. 614 to the centre line of Bloemendhal road; thence southwards along the centre line of the said road to the centre of its junction with Aluthmawatta lane; thence north-westwards, southwards and again north-westwards along the centre line of Aluthmawatta lane to the centre of its junction with Aluthmawatta road; thence south-westwards along the centre line of Aluthmawatte

road to the centre of its junction with De La Salle Street; thence north-westwards, westwards and south-westwards along the centre lines of De La Salle street and cart track extending from De La Salle street to the centre of the junction with the cart track extending from the Rock House Lane; thence westwards along the cart track for a distance of 80 feet and thence northwards to the southern end of the protection mole of the Breakwater and to the western limit of the Municipal Council area.

West: From the last-mentioned point along the western limit of the Municipal Council area to the starting point of the northern limit of the ward.

WARD NO. 4—LUNUPOKUNA

North: From the western extremity of the southern limit of Ward No. 3 along the said limit to its eastern extremity.

East: From the last-mentioned point southwards, north-eastwards and south-eastwards along the western and southern boundaries of Kimbulawala, to the centre line of the railway leading to Harbour.

South: From the last-mentioned point westwards along the centre line of the said railway up to the eastern boundary of premises bearing Assessment No. 251/20; thence along the eastern and southern boundaries of the said premises up to the north-western corner of premises bearing Assessment No. 69/2; thence south-westwards along the western boundary of the said premises to the centre line of 16th Lane; thence westwards, south-westwards along the centre line of the said lane to the centre of its junction with College street, thence westwards along the centre line of College street to the centre line of Aluthmawatta road, thence south-westwards, along the centre line of Aluthmawatta road up to the northern boundary of premises bearing Assessment No. 435/4B; thence westwards along the said northern boundary to the western limit of the Municipal Council area.

West: From the last-mentioned point along the western limit of the Municipal Council area to the starting point of the northern limit of the ward.

WARD NO. 5—MAHAWATTA

North: From the southern extremity of the eastern limit of Ward No. 3 along the said limit to the western extremity of the southern limit of Ward No. 1, thence along the southern limit of Ward No. 1 to its eastern extremity.

East: From the last-mentioned point along the eastern limit of the Municipal Council area up to the northern boundary of premises bearing Assessment No. 624, Prince of Wales Avenue; thence westwards along the said northern boundary to the centre line of Prince of Wales Avenue; thence south-westwards along the centre line of Prince of Wales Avenue to the centre of its junction with Destructor road; thence south-westwards along the centre line of Destructor road to the eastern extremity of Parakrama road.

South: From the last-mentioned point south-westwards along the centre line of Parakrama road to the centre of its junction with Prince of Wales Avenue; thence north-eastwards along the centre line of Prince of Wales Avenue to the centre of its junction with Arthur De Silva Mawatha, thence north-westwards along the centre line of Arthur De Silva Mawatha to the centre line of Municipal drain.

West: From the last-mentioned point north-eastwards along the centre line of the said drain up to the southern boundary of premises bearing Assessment No. 319, Prince of Wales Avenue; thence north-westwards along the southern boundary and north-eastwards along the western boundary of the said premises and thence north-eastwards along the eastern boundaries of premises bearing Assessment Nos. 340/20 and 478/8, Bloemendhal road and thence along the northern boundary of premises bearing Assessment No. 478/8 and thence along the southern and western boundaries of premises bearing Assessment No. 478/6, Bloemendhal road and thence along the western boundaries of premises bearing Assessment Nos. 478/5 and 478/4, Bloemendhal road to the centre line of the railway leading to the harbour.

WARD NO. 6—KOTAHENA EAST

North: By a line drawn from the centre of junction of College street and 16th Lane along the southern limit of Ward No. 4 to its eastern extremity.

East: From the last-mentioned point along the western limit of Ward No. 5 to its southern extremity; thence south-westwards and westwards along the centre line of Municipal drain to the centre of junction of Skinners Road North and Bloemendhal road.

South: From the last-mentioned point north-westwards along the centre line of Skinners Road North with the centre of its junction with Jampettah street, thence westwards along the centre line of Jampettah street to the centre of its junction with Galpotta street.

West: From the last-mentioned point along the centre line of Galpotta street to the centre of its junction with Skinners Road North; thence northwards and north-westwards along the centre lines of Kotahena street and College street, to the starting point of the northern limit of the ward.

WARD NO. 7—KOTAHENA WEST

North: From the western extremity of the southern limit of Ward No. 4 along the said limit to the western extremity of the northern limit of Ward No. 6.

East: From the last-mentioned point along the western limit of Ward No. 6 to its southern extremity.

South: From the last-mentioned point westwards along the centre line of Jampettah street to its centre of junction with St. Anthony Mawatta and Korteboam street; thence along the northern boundary of premises bearing Assessment No. 161 to the centre line of railway; thence southwards along the centre line of the said railway up to the C. G. R. Goods Shed fence; thence westwards along the said fence to the western limit of the Municipal Council area.

West: From the last-mentioned point northwards along the western limit of the Municipal Council area to the starting point of the northern limit of the ward.

WARD NO. 8—KOTAHENA SOUTH

North: From the centre of junction of Jampettah street and Vivekananda Hill along the southern limits of Wards Nos. 7 and 6 to the western extremity of the southern limit of Ward No. 6.

East: From the last-mentioned point south-eastwards along the centre lines of Skinners Road North and Armour street to the centre of junction of Armour street and Old Moor street.

South: From the last-mentioned point south-westwards along the centre line of Old Moor street to the centre of junction with Mosque Lane 2nd.

West: From the last-mentioned point north-westwards along the centre lines of Mosque Lanes 2nd and 1st to the centre of its junction with Wolfendhal street; thence eastwards along the centre line of Wolfendhal street to the centre of its junction with Vivekananda Hill; thence north-westwards along the centre line of Vivekananda Hill to the starting point of the northern limit of the ward.

WARD NO. 9—KOCHCHIKADE NORTH

North: From the western extremity of the southern limit of Ward No. 7 along the said limit to the northern extremity of the western limit of Ward No. 8.

East: From the last-mentioned point along the western limit of Ward No. 8 to the centre of junction of Wolfendhal street and Mosque Lane 1st.

South: From the last-mentioned point south-westwards along the centre line of Wolfendhal street to the centre of its junction with Kayman's Gate, thence south-westwards along the centre line of Kayman's Gate to the centre of its junction with St. John's street.

West: From the last-mentioned point north-westwards along the centre line of St. John's Street to the centre of its junction with Reclamation road; thence along a straight line to the north-eastern corner of premises bearing Assessment No. 23/28, New Reclamation Grounds; thence

north-westwards along the wall forming the northern boundary of the said premises to the western limit of the Municipal Council area; thence along the said limit to the starting point of the northern limit of the ward.

WARD NO. 10—KOCHCHIKADE SOUTH

- North :** From the centre of junction of Kayman's Gate and Wolfendhal street along the southern limit of Ward No. 9 to its eastern extremity.
- East :** From the last-mentioned point along the western limit of Ward No. 8 to its southern extremity; thence south-eastwards along the centre line of Fire Gap Extension to the centre of its junction with Dam street; thence southwards along the centre line of St. Sebastian street to the centre of its junction with Akbar's Lane.
- South :** From the last-mentioned point westwards along the centre lines of Akbar's Lane and Beira road to the centre of junction with Saunder's place.
- West :** From the last-mentioned point northwards and north-eastwards along the centre line of Saunder's place to the centre of its junction with Dam street; thence westwards along the centre line of Dam street to the northern limit of the ward.

WARD NO. 11—ALUTHKADE NORTH

- North :** From the western extremity of the southern limit of Ward No. 8 along the said limit to its eastern extremity.
- East :** From the last-mentioned point south-eastwards and southwards along the centre lines of Armour street and Sri Sangaraja Mawata to the centre line of St. Sebastian canal.
- South :** From the last-mentioned point south-westwards along the centre line of St. Sebastian canal to the point of its intersection with the projection south-eastwards of the centre line of Ferry street; thence north-westwards along the said projection and the centre line of Ferry Street to the centre line of Hultsdorf Street; thence southwards along the centre line of Hultsdorf Street to the centre of its junction with Dam Street; thence north-westwards along the centre line of Dam Street to the eastern limit of Ward No. 10.
- West :** From the last-mentioned point along the eastern limit of Ward No. 10 to the starting point of the northern limit of the ward.

WARD NO. 12—ALUTHKADE SOUTH

- North :** From the western extremity of the southern limit of Ward No. 11 along the said limit to its eastern extremity.
- East :** From the last-mentioned point southwards and south-westwards along the centre line of Sri Sangaraja Mawata to the centre of its junction with Maradana road.
- South :** From the last-mentioned point westwards and north-westwards along the centre line of Norris road to the centre of its junction with Minhindu Mawata.
- West :** From the last-mentioned point northwards along the centre line of Saunder's place to the western extremity of the southern limit of Ward No. 10; thence along the said limit to its eastern extremity; thence along the eastern limit of Ward No. 10 to the starting point of the northern limit of the ward.

WARD NO. 13—NEW BAZAAR

- North :** From the western extremity of the southern limit of Ward No. 5 along the said limit to its eastern extremity.
- East :** From the last-mentioned point south-eastwards along the centre line of Destructor road to the centre of its junction with Grandpass road; thence south-westwards along the centre line of Grandpass road to the centre of its junction with Chapel place; thence south-eastwards along the centre line of Chapel place to the centre line of St. Sebastian canal.
- South :** From the last-mentioned point south-westwards along the centre line of St. Sebastian canal to the southern extremity of the eastern limit of Ward No. 11.

West : From the last-mentioned point northwards and north-westwards along the eastern limits of Wards Nos. 11 and 8 to the southern extremity of the eastern limit of Ward No. 6; thence along the eastern limit of Ward No. 6 to the starting point of the northern limit of the ward.

WARD NO. 14—GRANDPASS

- North :** From the point of intersection of the eastern limit of Ward No. 5 with the eastern limit of the Municipal Council area, along the eastern limit of the Municipal Council area to the northern extremity of the centre line of Baseline road.
- East :** From the last-mentioned point along the eastern limit of the Municipal Council area to the centre of junction of Baseline road and Stace road.
- South :** From the last-mentioned point westwards along the centre line of Stace road to the centre line of St. Sebastian canal; thence south-westwards along the centre line of St. Sebastian canal to the eastern limit of Ward No. 13.
- West :** From the last-mentioned point along the eastern limit of Ward No. 13 to its northern extremity; thence along the eastern limit of Ward No. 5 to the starting point of the northern limit of the ward.

WARD NO. 15—DEMATAGODA

- North :** From the point of intersection of the centre line of Baseline road with the centre line of Dematagoda ela along the eastern limit of the Municipal Council area to the centre of railway bridge over Dematagoda ela.
- East :** From the last-mentioned point south-eastwards along the eastern limit of the Municipal Council area up to the point in line with the northern boundary of premises bearing Assessment No. 231/32, Seevali Lane.
- South :** From the last-mentioned point westwards along the northern and western boundaries of premises bearing Assessment No. 231/32, Seevali Lane, up to the northern boundary of premises bearing Assessment No. 66, Baseline Avenue; thence westwards along the said northern boundary to the centre line of Baseline Avenue; thence along the centre line of the said Avenue to the centre line of Baseline road.
- West :** From the last-mentioned point northwards along the centre line of Baseline road to the starting point of the northern limit of the ward.

WARD NO. 16—MALIGAWATTE

- North :** From the point of intersection of the centre line of foot path depicted as lot 11 in P.P.A. 2831—W.P., with the centre line of St. Sebastian canal along the southern limits of Wards Nos. 13 and 14 to the southern extremity of the eastern limit of Ward No. 14.
- East :** From the last-mentioned point southwards along the centre line of Baseline road to the centre of its junction with Dematagoda road.
- South :** From the last-mentioned point westwards along the centre line of Dematagoda road to the centre of its junction with School Lane.
- West :** From the last-mentioned point northwards along the centre line of School Lane and Maligawatte road to the centre of its junction with Maligawatte lane; thence westwards and north-westwards along the centre line of Maligawatte Lane to the centre of foot path shown as lot 11 in P.P.A. 2831—W.P.; thence north-westwards along the centre line of the said foot path to the starting point of the northern limit of the ward.

WARD NO. 17—PANCHIKAWATTE

- North :** From the western extremity of the southern limit of Ward No. 13 along the said limit to the northern extremity of the western limit of Ward No. 16; thence along the western limit of Ward No. 16 to the centre line of Maligawatte lane.
- East :** From the last-mentioned point along the western limit of Ward No. 16, to the southern boundary of railway premises.
- South :** From the last-mentioned point south-westwards along the said southern boundary of the railway premises to the centre line of Maradana road.

West: From the last-mentioned point north-westwards along the centre line of Maradana road to the centre of its junction with Mohideen Masjid road; thence eastwards, northwards, north-eastwards and northwards along the centre lines of Mohideen Masjid road and Sri Sangaraja Mawata to the starting point of the northern limit of the ward.

WARD NO. 18—MALIGAKANDE

North: From the western extremity of southern limit of ward No. 17 along the said limit to its eastern extremity.

East: From the last-mentioned point along the centre line of School lane southwards to the centre line of Dematagoda road; thence westwards along the centre line of Dematagoda road to the centre of its junction with Reservoir road; thence southwards, westwards, southwards, westwards and southwards along the centre lines of Reservoir road and Reservoir lane to the centre line of Maligakande road.

South: From the last-mentioned point westwards along the centre line of Maligakande lane to the centre line of Maradana road.

West: From the last-mentioned point north-westwards along the centre line of Maradana road to the starting point of the northern limit of the ward.

WARD NO. 19—KUPPIYAWATTE EAST

North: From the western extremity of the southern limit of Ward No. 16 along the said limit to its eastern extremity.

East: From the last-mentioned point southwards along the centre line of Baseline road to the centre of its junction with Campbell place.

South: From the last-mentioned point westwards along the centre line of Campbell place to the centre of its junction with Sri Dhamma Mawata.

West: From the last-mentioned point north-westwards and north-eastwards along the centre line of Sri Dhamma Mawata to the centre of its junction with Zaleski Place; thence north-westwards and westwards along the centre line of Zaleski Place to the centre line of Temple road; thence northwards along the centre line of Temple road up to the western boundary of Kuppiyawatta temple premises; thence northwards along the western boundary of the said temple premises, up to the centre line of Dharmapala Mawata; thence westwards along the centre line of Dharmapala Mawata to the centre of its junction with Maligakanda road; thence northwards and westwards along the centre line of Maligakanda road to the southern extremity of the eastern limit of Ward No. 18; thence along the said limit to the starting point of the northern limit of the ward.

WARD NO. 20—KUPPIYAWATTA WEST

North: From the western extremity of the southern limit of the Ward No. 18 along the said limit to its eastern extremity.

East: From the last-mentioned point along the western limit of Ward No. 19 to its southern extremity.

South: From the last-mentioned point westwards along the centre line of Campbell place to the centre of its junction with Maradana road; thence south-westwards along the centre line of Regent street to the centre line of Norris canal road.

West: From the last-mentioned point northwards along the centre line of Norris canal road to the centre line of Stanley place; thence eastwards and north-eastwards along the centre line of Stanley place to the centre line of Maradana road; thence north-westwards along the centre line of Maradana road to the starting point of the northern limit of the ward.

WARD NO. 21—SUDUWELLA

North: From the point of intersection of southern boundary of St. Joseph's College with Beira lake eastwards along the said boundary and its prolongation to the centre line of Darley road; thence northwards along the centre line of Darley road to the centre of its junction

with Forbes road; thence eastwards along the centre line of Forbes road to the centre line of Deans road.

East: From the last-mentioned point southwards along the centre line of Deans road to the centre of its junction with Stanley place; thence eastwards along the centre line of Stanley place to the western limit of Ward No. 20; thence along the said limit to its southern extremity.

South: From the last-mentioned point south-westwards along the centre line of Regent street to the centre of its junction with Deans street, thence south-westwards along the centre line of De Soysa Circus to the centre line of Turret road; thence south-westwards along the centre line of Turret road to the centre of its junction with Park street.

West: From the last-mentioned point north-westwards along the centre line of Park street to the centre of its junction with Alston Place; thence south-westwards along the centre line of Alston Place to the centre of its junction with Hunupitiya road; thence north-westwards along the centre line of Hunupitiya road to the centre of its junction with Lake Crescent; thence north-eastwards and north-westwards along the centre line of Lake Crescent to the centre line of Hunupitiya Lake road; thence north-eastwards and north-westwards along the centre line of Hunupitiya Lake road to the centre of its junction with Dawson Street; thence north-eastwards along the centre line of Dawson street crossing Union Place to the centre line of Vauxhall street; thence along the eastern boundary of premises bearing Assessment No. 199, Vauxhall street to edge of Beira Lake; thence north-eastwards by a straight line to the starting point of the northern limit of the ward.

WARD NO. 22—MARADANA

North: From the north-western corner of St. Sebastian canal south-westwards along the northern edge of the said canal to the southern limit of Ward No. 12; thence along the southern and eastern limits of Ward No. 12 to the centre of junction of Sri Sangaraja Mawata and Mohideen Masjid road.

East: From the last-mentioned point along the western limits of Wards Nos. 17, 18 and 20 to the centre of junction of Maradana road and Stanley place.

South: From the last-mentioned point along the western and eastern limits of Wards Nos. 20 and 21 respectively to the eastern extremity of the northern limit of Ward No. 21; thence along the northern limit of Ward No. 21 to its western extremity.

West: From the last-mentioned point north-westwards along the eastern edge of Beira lake to the western edge of St. Sebastian canal, thence northwards, westwards and northwards along the western edge of the said canal to the starting point of the northern limit of the ward.

WARD NO. 23—COMMERCIAL

North: From the point of intersection of the south-western extremity of the south-west Breakwater with the western limit of Municipal Council area along the said limit of the Municipal Council area to the western limit of Ward No. 9.

East: From the last-mentioned point along the western limit of Ward No. 9, to the western extremity of the southern limit of the said ward; thence along the southern limit of Ward No. 9 and the western limit of Ward No. 10 to the southern extremity of the said western limit, thence along the western and southern limits of Ward No. 12, till it meets the northern limits of Ward No. 22, thence along the northern and western limits of Ward No. 22 to the south-western extremity of St. Sebastian Canal, thence southwards across the Beira Lake to the western boundary of premises bearing Assessment No. 31, Morgan Road, thence along the said western boundary to the centre line of Morgan Road, thence westwards along the centre line of Morgan Road to the centre of its junction with Kew Point Road, thence south-westwards along the centre line of Kew Point Road to the centre line of Kew Road, thence southwards along the centre line of Kew Road, to the centre of its junction with Kumaran Ratnam Road, thence southwards along the centre line of Kumaran Ratnam Road, to the centre of its junction with Mews Street.

South : From the last-mentioned point westwards along the centre line of Mews street and Ferry lane to the centre line of Malay street, thence southwards along the centre line of Malay street to the centre of its junction with Bridge street, thence westwards along the centre line of Bridge street to the centre of its junction with Church road, thence southwards and westwards along the centre line of Church road and Galle Face Drive to the western limit of the Municipal Council area.

West : From the last-mentioned point northwards along the western limits of the Municipal Council area to the starting point of the northern limit of the ward.

WARD NO. 24—HUNUPITIYA

North : From the point of intersection of the eastern and western limits of Wards Nos. 23 and 22 respectively south-eastwards along the western limit of Ward No. 22 to its southern extremity.

East : From the last-mentioned point along the western limit of Ward No. 21 to the centre line of Union place.

South : From the last-mentioned point north-westwards along the centre line of Union place to the centre of its junction with Saunders court thence south-westwards along the centre line of Saunders court to its western extremity, thence westwards along the prolongation of the said centre line to the Fire Gap, thence along the centre line of Fire Gap till it meets the centre line of railway, thence northwards along the centre line of railway to the southern limit of Ward No. 23.

West : From the last-mentioned point along the southern and eastern limits of Ward No. 23 to the starting point of the northern limit of the Ward.

WARD NO. 25—WEKANDE

North : From a point on the centre of bridge on Bridge street along the southern limit of Ward No. 23 to the western extremity of the southern limit of Ward No. 24, thence along the southern limit of Ward No. 24 to its eastern extremity.

East : From the last-mentioned point along the western limit of Ward No. 21 to its southern extremity.

South : From the last-mentioned point south-westwards along the centre line of Turret road to the centre of its junction with General's Lake road.

West : From the last-mentioned point northwards along the centre line of General's Lake road, to the south-eastern corner of Beira Lake, thence along the southern and western boundaries of Beira Lake to the starting point of the northern limit of the ward.

WARD NO. 25—KOLLUPITIYA

North : From the western extremity of the southern limit of Ward No. 23 along the said limit to the northern extremity of the western limit of Ward No. 25.

East : From the last-mentioned point along the western limit of Ward No. 25 to its southern extremity, thence south-eastwards along the centre line of Flower road to the centre of its junction with Inner Flower road.

South : From the last-mentioned point westwards along the centre line of Inner Flower Road to the centre of its junction with 27th Lane, thence northwards along the centre line of Unity Place, and westwards, southwards and westwards along the centre line of Kollupitiya Lane, to the centre line of Galle Road, thence southwards along the centre line of Galle Road to the centre of its junction with 14th Lane, thence westwards along the centre line of 14th Lane to the western limit of the Municipal Council area.

West : From the last-mentioned point along the western limit of the Municipal Council area to the starting point of the northern limit of the ward.

WARD NO. 27—BAMBALAPITIYA

North : From the western extremity of the southern limit of Ward No. 26 to its eastern extremity.

East : From the last-mentioned point south-eastwards along the centre line of Flower road to the centre of its junction with Thurstan road, thence southwards along the centre line of Thurstan road to the centre line of Reid avenue, thence south-westwards along the centre line of Reid avenue to the centre line of Havelock road, thence southwards along the centre line of Havelock road to the centre of its junction with Vajira road.

South : From the last-mentioned point westwards along the centre line of Vajira road to the centre line of Galle road, thence westwards along the centre line of Asoka Gardens to the western limit of the Municipal Council area.

West : From the last-mentioned point along the western limit of the Municipal Council area to the starting point of the northern limit of the ward.

WARD NO. 28—CINNAMON GARDENS

North : From the western extremity of the southern limit of Ward No. 25 along the southern limits of Wards Nos. 25, 21, 20 and 19 to the eastern extremity of the southern limit of Ward No. 19.

East : From the last-mentioned point southwards along the centre lines of Baseline road and Kanatta road to the junction with Buller's road.

South : From the last-mentioned point south-westwards along the centre line of Buller's road to the centre of its junction with Reid Avenue.

West : From the last-mentioned point along the eastern limits of Wards Nos. 27 and 26 to the starting point of the northern limit of the ward.

WARD NO. 29—BORELLA NORTH

North : From the western extremity of the southern limit of Ward No. 15 along the said limit to its eastern extremity.

East : From the last-mentioned point along the eastern limit of the Municipal Council area up to the northern boundary of premises bearing Assessment No. 24/5, 2nd Lane, thence westwards along the said northern boundary and southwards and south-westwards along the western boundaries of the said premises and Assessment No. 66, Rodney street to the centre line of Rodney Street, thence along the centre line of the said street to the centre line of Cotta Road.

South : From the last-mentioned point north-westwards, westwards and north-westwards along the centre line of Cotta road to the eastern limit of Ward No. 28.

West : From the last-mentioned point along the eastern limit of Wards Nos. 28 and 19 to the starting point of the northern limit of the ward.

WARD NO. 30—BORELLA SOUTH

North : From the western extremity of the southern limit of Ward No. 29 along the said limit to its eastern extremity, thence along the eastern limit of Ward No. 29 to the eastern limit of the Municipal Council area.

East : From the last-mentioned point along the eastern limit of the Municipal Council area to the centre line of the Government Dairy Road.

South : From the last-mentioned point westwards along the centre line of the Government Dairy Road to the centre line of the Narahenpita Road.

West : From the last-mentioned point northwards along the centre line of Narahenpita road and Kanatta road to the starting point of the northern limit of the ward.

WARD NO. 31—TIMBIRIGASYAYA NORTH

North : From the western extremity of the southern limit of Ward No. 28 along the said limit to its eastern extremity.

East : From the last-mentioned point along the western limit of Ward No. 30 to the centre of junction of Narahenpita road and Timbirigasyaya road.

South : From the last-mentioned point south-westwards along the centre line of Timbirigasyaya road to the centre line of Havelock road.

West: From the last-mentioned point north-westwards along the centre line of Havelock road to the starting point of the northern limit of the ward.

WARD NO. 32—TIMBIRIGASYAYA SOUTH

North: From the western extremity of the southern limit of Ward No. 31 along the said limit to its eastern extremity; thence along the western limit of Ward No. 30 to its southern extremity; thence along the southern limit of Ward No. 30 to its eastern extremity.

East: From the last-mentioned point along the eastern limit of the Municipal Council area to the centre line of Kirillapone canal.

South: From the last-mentioned point north-westwards, westwards and south-westwards along the centre line of Kirillapone canal to the centre line of Havelock road.

West: From the last-mentioned point north-westwards along the centre line of Havelock road to the starting point of the northern limit of the ward.

WARD NO. 33—KIRILLAPONE

North: From the western extremity of the southern limit of Ward No. 32 along the said limit to its eastern extremity.

East: From the last-mentioned point along the eastern limit of the Municipal Council area to the centre line of road branching east from the Nugegoda road and 12 chains south-east of the point of intersection of the Kelani Valley railway and Kirillapone-Nugegoda road.

South: From the last-mentioned point westwards along the centre line of the said branch road to the centre line of Kirillapone-Nugegoda road; thence westwards along the centre line of Kirillapone-Nugegoda road to the centre of its junction with High Level road; thence westwards along the centre line of High Level road to the centre of its junction with Pamankade road; thence south-westwards along the centre line of Pamankade road to the centre line of Havelock road; thence North-westwards along the centre line of Havelock road to the centre of its junction with High street; thence westwards along the centre line of High street to the centre of its junction with Peterson lane.

West: From the last-mentioned point along the centre line of Peterson lane to the centre of its junction with Perakumba place; thence eastwards along the centre line of Perakumba place and Suvi Suddharama road to the centre line of Havelock road; thence northwards and north-westwards along the centre line of Havelock road to the starting point of the northern limit of the ward.

WARD NO. 34—HAVELOCK TOWN

North: From the western extremity of the southern limit of Ward No. 27 along the said limit to its eastern extremity.

East: From the last-mentioned point along the western limits of Wards Nos. 31 and 32 to the southern extremity of the western limit of Ward No. 32.

South: From the last-mentioned point south-westwards along the centre line of Kirillapone canal to the western limit of the Municipal Council area.

West: From the last-mentioned point along the western limit of the Municipal Council area to the starting point of the northern limit of the ward.

WARD NO. 35—WELLAWATTA NORTH

North: From the western extremity of the southern limit of Ward No. 34 along the said limit to its eastern extremity.

East: From the last-mentioned point along the western limit of Ward No. 33 to its southern extremity; thence westwards along the centre line of High street to the centre of its junction with Hampden lane; thence southwards along the centre line of Hampden lane to the centre of its junction with Fussels lane.

South: From the last-mentioned point westwards along the centre line of Fussels lane to the centre line of Galle road; thence westwards along the centre line of Hamer's avenue to the western limit of the Municipal Council area.

West: From the last-mentioned point along the western limit of the Municipal Council area to the starting point of the northern limit of the ward.

WARD NO. 36—WELLAWATTA SOUTH

North: From the western extremity of the southern limit of Ward No. 35 along the said limit to its eastern extremity.

East: From the last-mentioned point southwards along the centre line of Hampden lane to the centre line of Dehiwala canal; thence southwards along the centre line of the said canal to the centre of its confluence with Bolgoda canal.

South: From the last-mentioned point along the southern limit of the Municipal Council area to its western extremity.

West: From the last-mentioned point along the western limit of the Municipal Council area to the starting point of the northern limit of the ward.

WARD NO. 37—PAMANKADA

North: From the western extremity of the southern limit of Ward No. 33 along the said limit to its eastern extremity.

East: From the last-mentioned point along the western limit of the Municipal Council area to its southern extremity.

South: From the last-mentioned point along the southern limit of the Municipal Council area to the eastern limit of Ward No. 36.

West: From the last-mentioned point along the eastern limits of Wards Nos. 36 and 35 to the starting point of the northern limit of the Ward.
