## Government Notifications THE FOOD CONTROL ACT, No. 25 OF 1950 Order No. 118

BY virtue of the powers vested in me by section 4 (1) (i) of the Food Control Act, No. 25 of 1950, I, Don Philip Rupasinghe Gunawardena, Minister of Agriculture and Food, do by this Order, prohibit the transport or removal of any quantity of any paddy to and from the Districts of Kandy and Matale, except under the authority of a permit issued by or on behalf of the Food Controller or Deputy Food Controller or Assistant Food Controller of the respective Districts.

"District" for the purpose of this Order means the revenue area of the Government Agent.

## THE FOOD CONTROL ACT, No. 25 OF 1950 Order No. 119

BY virtue of the powers vested in me by section 4 (1) (iv) of the Food Control Act, No. 25 of 1950, I, Don Philip Rupasinghe Gunawardena, Minister of Agriculture and Food, do by this Order, prohibit the removal from the Customs premises at any port or place mentioned in the first column of the Schedule hereto, of any rice, paddy, wheat, wheat flour or kurakkan, except under a permit issued by the person or any of the persons, as the case may be, mentioned in the corresponding entry in the second column of that Schedule, and except in accordance with such directions.

#### AIR MAILS

The terms, conditions and requirements relating to Air Mails published as the Air Mail Regulations, 1939, in *Gazette* No. 8,512 of September 22, 1939, as amended by any subsequent term, condition or requirement, are hereby further amended, as follows:—

- (1) In regulation 3, by the substitution, for paragraphs (2), (3) and (4) thereof, of the following new (2), (3) and paragraph:
  - "(2) Unpaid or underpaid Air Mail correspond-ence which it is not possible to have corrected by the senders shall be treated as
    - (a) Where no portion of the charges for the transmission of a postal article by Air Mail has been prepaid, such article shall be transmitted by the surface mail and shall be liable to a charge equal to double the surface mail charges, to be paid by the addressee, in respect of such article.

      (b) Where only a portion of the charges for the transmission of a postal article by Air Mail is prepaid, and the portion so prepaid is not less than 75 per centum of the charges for the transmission of such article by Air Mail, such article shall be transmitted by Air Mail, and shall be liable to a charge equal to double the amount of the deficiency, to be paid by the addressee in respect of such article, but that charge may not be less than the equivalent of 5 (gold) centimes, in the country of delivery.

      (c) Where only a portion of the charges for the transmission by Air Mail of a postal article is prepaid, and the amount so prepaid is less than 75 per centum of the charges for the transmission by Air Mail of such article, such article shall be transmitted by surface mail, and shall be liable to a charge equal to double the deficient postage at surface mail rates, to be paid by the addressee in respect of such article, but the charge may not be less than the equivalent of 5 (gold) centimes in the country of delivery.";
- (2) in regulation 4
  - (a) by the substitution, for the figures "30", of the figures "50"; and
  - (b) by the substitution, for the words "including India", of the words "including India and Pakistan.";
- by the substitution, for regulation 4A, of the following new regulation:—

  "4A. Advice of delivery and any other form used by the public—The weight of the advice of delivery and any other forms used by the public which may be attached to an air mail article shall be taken into account in calculating the Air Feeren substitute." on such article.".
