Food Price Order No. R/19/1959

THE CONTROL OF PRICES ACT, No. 29 OF 1950

WHITE REFINED SUGAR

Order

BY virtue of the powers vested in me by section 4 of the Control of Prices Act, No. 29 of 1950, read with section 3 (2) of that Act, I, Hewa Dinnie Weeraratne, Assistant Controller of Prices (Food), Ratnapura District, do by this Order—

- (i) revoke with effect from this date my Food Price Order No. R/10/1956 dated May 8, 1956, published in *Ceylon Government Gazette* No. 10,930 of May 18, 1956, in so far as it relates to the maximum wholesale and retail prices fixed in respect of White Refined Sugar;
- (ii) fix with immediate effect the prices specified in columns 2 and 3 of the schedule hereto to be the maximum wholesale price per cwt. gross and the maximum retail price per pound respectively above which White Refined Sugar shall not be sold in the areas mentioned in the corresponding entry in column 1 of the schedule hereto;
- (iii) direct that every trader who has White Refined Sugar in his possession or under his control at any place or in any vehicle, shall exhibit conspicuously at that place or on that vehicle a notice in which there shall be set out the maximum prices for White Refined Sugar fixed by this Order;
- (iv) direct that in every area where maximum prices are fixed by this Order, no person shall sell White Refined Sugar which is adulterated with any other article—
- (v) direct that for the purpose of this Order "pound" or "lb." shall be deemed to be the standard pound avoirdupois weight;
- (vi) direct that in every area where maximum prices are fixed by this Order every person who sells any sugar by wholesale shall, and every person who sells sugar by retail shall on demand, give the purchaser thereof a receipt in which there shall be set out—
 - (a) the date of the sale;
 - (b) the quantity of sugar sold (by weight);
 - (c) the price paid for the quantity of sugar sold, and
 - (d) the nature of the transaction, that is to say, whether the sale was by wholesale or by retail;
- (vii) direct that for the purpose of this Order—
 - (a) any sale of any quantity of sugar for the purpose of resale or any sale of sugar in a quantity of one hundred-weight gross or more at a time shall be deemed to be a sale by wholesale;
 - (b) any sale of any quantity of sugar less than one hundredweight gross for the purpose of consumption or use shall be deemed to be a sale by retail;
 - (c) "Sugar" shall exclude all forms of jaggery.
- (viii) direct that when White Refined Sugar is sold, the maximum wholesale and retail prices referred to in columns 2 and 3 of the Schedule shall include the price of wrapper or container, if any, in which the sugar is sold.

RAW BROWN SUGAR

Order

BY virtue of the powers vested in me by section 4 of the Control of Prices Act, No. 29 of 1950, read with section 3 (2) of that Act, I, Hewa Dannie Weeraratne, Assistant Controller of Prices (Food), Ratnapura District, do by this Order—

- (i) revoke with effect from this date my Food Price Order dated April 30, 1956, published in *Ceylon Government Gazette* No. 10,925 of May 4, 1956, in so far as it relates to the maximum wholesale and retail prices fixed in respect of Raw Brown Sugar ;
- (ii) fix with immediate effect the prices specified in columns 2 and 3 of the schedule hereto to be the maximum whole-sale price per cwt. gross and the maximum retail price per pound respectively above which Raw Brown Sugar shall not be sold in the areas mentioned in the corresponding entry in column 1 of the schedule hereto ;
- (iii) direct that every trader who has Raw Brown Sugar in his possession or under his control at any place or in any vehicle, shall exhibit conspicuously at that place or on that vehicle a notice in which there shall be set out the maximum prices for Raw Brown Sugar fixed by this Order ;
- (iv) direct that in every area where maximum prices are fixed by this Order, no person shall sell Raw Brown Sugar which is adulterated with any other article ;
- (v) direct that for the purpose of this Order " pound " or " lb." shall be deemed to be the standard pound avoirdupois weight ;
- (vi) direct that in every area where maximum prices are fixed by this Order every person who sells any sugar by whole-sale shall, and every person who sells sugar by retail shall on demand, give the purchaser thereof a receipt in which there shall be set out—
 - (a) the date of the sale,
 - (b) the quantity of sugar sold (by weight),
 - (c) the price paid for the quantity of sugar sold, and
 - (d) the nature of the transaction, that is to say, whether the sale was by wholesale or by retail.
- (vii) direct that for the purpose of this Order—
 - (a) any sale of any quantity of sugar for the purpose of re-sale or any sale of sugar in a quantity of one hundred-weight gross or more at a time shall be deemed to be a sale by wholesale,
 - (b) any sale of any quantity of sugar less than one hundredweight gross for the purpose of consumption or use shall be deemed to be a sale by retail,
 - (c) " Sugar " shall exclude all forms of jaggery ;
- (viii) direct that when Raw Brown Sugar is sold, the maximum wholesale and retail prices referred to in columns 2 and 3 of the Schedule shall include the price of wrapper or container, if any, in which the sugar is sold.
