THE DEFENCE (CONTROL OF IMPORTS) REGULATIONS

Notification

BY virtue of the powers vested in me by regulation 5A of the Defence (Control of Imports) Regulations, which has the force of law by virtue of the Import and Export Control (Continuation) Act, No. 27 of 1950, I, Victor Lloyd Wirasinha, Controller of Imports, do hereby alond the Schedule to Open General Licence No. 1, dated June 28, 1951, and published in Gazette Extraordinary No. 10,265 of July 3, 1951 (as amended by any subsequent Notification), as follows:

- (1) by the substitution, for items 298 and 298A, of the following new items:-" 298. Ladies' closed shoes (sizes 22.8 centimetres and upwards) with leather uppers and leather or rubber soles III N. Ladies' footwear (sizes 22.8 centimetres and upwards) with leather uppers and leather or rubber soles and with heels the length of which is 2 inches or more from the inner sole up to the point of contact of the heel with the ground, other than closed shoes
- (2) by the insertion, immediately after item 298A, of the following new items:—
 - "298B. Footwear with leather uppers and leather or rubber soles other than (1) gent's footwear (sizes 25·4 centimetres and upwards) and (2) ladies' footwear (sizes 22·8 centimetres and upwards) III
 - 298C. Footwear other than footwear with leather uppers and leather or rubber III soles and footwear wholly or partly of rubber
