RULES made by the Incorporated Council of Legal Education under Section 7 of The Council of Legal Education Incorporation Ordinance, 1900.

Rules

The Rules made under the Council of Legal Education Incorporation Ordinance, 1900, as last amended by notification dated April 27, 1959, published in the Ceylon Government Gazette No. 11,752 of May 29, 1959, were further amended at a meeting of the Council of Legal Education held on July 3, 1959, as follows:—

1. Rules 51 and 51A are repealed and the following new Rule 51 is substituted therefor:

- "51. Any person who has been duly called to the Bar in England, Scotland, or Ireland, may be admitted and enrolled an Advocate of the Supreme Court provided that—
- (a) either he has been in actual practice for at least three years in England, ecotland, or Ireland; or he passes the examination for Advocate students in the following subjects, viz.:—

 - (i) Givil Propedure and Pleadings, and
 - (ii) Law of Property,

having previously paid the normal examination fee for these subjects payable by an Advocate student at the Law College;

(b) he applies to the Supreme Court for admission as an Advocate and fulfils the requirements prescribed by Rule 37 and produces documentary proof of his call to the Bar in England, Scotland, or Ireland, together with an affidavit that he has not done of committed any act or thing rendering tim liable to be disbarred, and (c) the Registrar of the Supreme Court reports that the applicant is of good repute and that there exists no impediment or objection to his admission and enrolment."
