(d) The lessee shall during the said term use the land and the buildings thereon for the purpose of carrying on business as a first class Hotel and provide proper and sufficient accommodation for travellers and other guests at the said Hotel and for the purpose shall obtain all such licences as are now required or which may at any time hereafter be required to enable the lessee to sell spirituous liquors or other alcoholic drinks at the said hotel in such manner as may be necessary for the purposes of such business and shall also during the said term conform to the requirements for any statutory modifications or alterations of the liquor laws now obtaining and duly and promptly pay all sums and do all such acts as may be necessary to obtain the privilege of selling liquors as aforesaid.

(e) The lessee shall attend to all repairs and be responsible for the maintenance of the buildings.

(f) The lessee shall supply at its own expense all electric fittings furniture, linen, cutlery, crockery and glasses to be used in the premises and keep the same in good order to the satisfaction of the Government Agent.

(g) The lessee shall reserve for the use of His Excellency the Governor-General and suite free of charge, such accommodation as may at any time be required.

(h) The lessee shall not without the prior consent of the Land Commissioner, obtained in writing, sublet, assign, mortgage or otherwise dispose of or deal with its interest in this lease and every such sub-lease, assignment, mortgage or other disposition without such consent shall be absolutely void.

(i) The lessee shall within one month from the date of signing the lease at its own cost and expense insure with an Insurance Company approved by the lessor or by the Land Commissioner for and on behalf of the lessor the premises hereby demised against destruction by fire and shall during the term of this lease keep alive the said Insurance.

(j) The lessee shall not demolish or cause to be demolished any of the buildings on the land or portions of the said buildings nor make any

structural alterations whatsoever except with the prior written authority of the Government Agent and on such terms as regards compensation as may be approved by the Government Agent.

- (k) The lessee shall not cut or remove any trees or ornamental shrubs or plants standing within the said land without permission in writing from the said Government Agent first had been obtained.
- (l) The lessee shall permit the Archæological Commissioner to carry out excavations in the land if and when the Archæological Commissioner deems it necessary.
- (m) The lessee shall pay to the Government Agent a sum of Rupees one thousand (Rs. 1,000) before the execution of these presents as security for the due fulfilment of the conditions and covenants on its part which said sum of money is hereby mortgaged and hypothecated for the said purpose to and with Her Majesty the Queen, Her Heirs and Successors. If the lessee contravenes any of the conditions of this lease, it shall be competent for the Government Agent to forfeit the whole or any portion of this security. The lessee shall be entitled at the termination of this lease to any balance of this security.
- (n) If the lessee at any time shall (a) become bankrupt or compound with its creditors, or (b) permit the land or its interests therein to be sold in execution of a decree against it, this lease shall forthwith terminate and the lessor may thereon enter upon the land which shall forthwith revert to the Crown.
- (o) If any rent either in whole or in part due under this lease shall be in arrears for a period of 90 days after it has become due (whether legally demanded or not) this lease may be terminated forthwith under the provisions of

part X of the Crown Lands Ordinance, No. 8 of 1947, and the lessor may enter upon the land and repossess and enjoy the same.

- (p) If the land is (a) not used for purpose specified in clause 4 of this schedule, or (b) has ceased to be used for such purpose or (c) has been applied to any purpose other than that specified in clause 4 of this schedule or (d) is there has been any failure on the part of the lessee to comply with any conditions or to observe any covenants of this lease, the lessor hereby reserves the right to terminate this lease and the land together with the buildings and all plantations and improvements shall thereupon revert to and become the absolute property of the Crown.
- (q) At the expiration or earlier termination under clause (n), (o) or (p) of this lease, the lessee shall surrender the land together with all buildings thereon and all additions, improvements and fixtures thereto in good repairs and conditions (due allowance being made for fair wear and tear).
- (r) The lessee shall not be entitled on such surrender as aforesaid to any payment of compensation for any improvements whatsoever affected to the land or buildings or on any other account whatsoever.
- (s) The lessor reserves the right to prescribe if occasion demands, a maximum scale of charges which the lessee may require occupants of the Hotel to pay.
8. The Government Agent reserves the right to reject any or all the tenders.
