### **Price Orders**

Food Price Order No. H 27.

THE CONTROL OF PRICES ACT, No. 29 OF 1950

Ordei

BY virtue of powers vested in me by section 4, read with section 3(2) of the Control of Prices Act, No. 29 of 1950, I, Thambiah Sivagnanam, Deputy Controller of Prices (Food), for the Administrative District of Hambantota, do by this Order—

- (i) revoke with effect from June 15, 1959, the Food Price Order No. H 25 dated January 6, 1959, and published in Government Gazette Extraordinary No. 11,639 of January 12, 1959;
- (ii) fix with effect from June 15, 1959, the prices specified in column 2 and 3 of the Schedule hereto to be the maximum retail price per pound (lb.) above which rice shall not be sold within the respective areas mentioned in the corresponding entries in column I of the Schedule hereto;
- (iii) direct that no person shall sell rice which is adulterated with any other article;
- (iv) direct that when any rice is sold the maximum prices fixed by this Order shall include the price of the wrapper or container, if any, in which such rice is sold;
- (v) direct that for the purpose of this order "pound" or "lb." shall be deemed to be the standard pound avordupois weight.
