

UK COVID-19 variant detected from four areas in Sri Lanka



The highly contagious new variant of the coronavirus found in the UK was detected from samples obtained in Colombo, Avissawella, Vavuniya & Biyagama, said Dr. Chandima Jeewandara, Director of the Department of Immunology and Molecular Medicine of the University of Sri Jayewardenepura.

In January 2021, Sri Lanka reported that a new variant of the coronavirus found in the UK had entered Sri Lanka. A person who had arrived from the United Kingdom was confirmed to have been infected with this new vari-

ant of B.1.1.7 lineage. As per the statistics of the Epidemiology Unit of the Ministry of Health, the country is recording over 800 COVID-19 cases on a daily basis.

In late January, with the receipt of free vaccines from India, the Health Ministry launched a vaccination programme for the frontline health workers and the military. 

The Industrial Technology Institute (ITI) has certified the effectiveness of these locally manufactured insulators. These insulators have been produced by local companies with a higher specification than imported insulators.

tric fences as elephant barriers have been imported from New Zealend, China and several other countries spending massive amounts of foreign exchange.

It has been reported that the country has spent nearly Rs.1000 million to import insulators from these countries. We will be able to save massive amounts in foreign exchange with the commencement of local manufacture of insulators.

Counsel Thishya Weragoda with Sanjaya Marambe, Sewwandi Marambe, Meinusha Gamage and Sashya Karunokalage appeared for the petitioners. Counsel Harishke Samaranayake instructed by Namal Premardana appeared for the first respondent. State Counsel Swasha Fernando appeared for the Attorney General.

"I must also recognise that the elimination of the practice of Corporal Punishment may not be achieved through isolated incidents, but a profound understanding by those entrusted with the care of children that violence is not a justifiable means to the end of discipline. Cruelty, violence, physical harm, particularly in the view of setting an example is condemned by all major faiths of our country," Justice Thurairaja added.

The first tremor struck in the area at around 3.30 a.m. on the 22nd last month and there have been five tremors in three weeks.

Senior Professor of Geology at the University of Peradeniya Athula Senaratne said people should not be unduly worried about it, as it was only a very small tremor.

He said that when the geological map of the central highlands is observed, it is clear that there are a large number of fissures (cracks) in the Earth's interior and there are signs of an earthquake when there is

any movement in these fractures. He added that when a map of the



quake-hit areas of Victoria, Walapane and Madolsima in Kandy is drawn, it is clear that there is a similarity between these differences and those tremors.

He said that no other part of the world had experienced a tremor at the time of the quake and therefore it could be concluded that the quake was limited to this area.



Russia successfully performed its duties as a chairperson of several international forums and organisations, including BRICS, Russia-India-China group and Collective Security Treaty Organisation.

Over 70 events were held within the framework of the Shanghai Cooperation Organisation (SCO), including the SCO Summit on November 10. The member states coordinated their positions on a wide range of international issues and approved

2021-2025 and the Programme of Multilateral Trade and Economic Cooperation until 2035.

Activities within the framework of the Russian initiative for creating a Greater Eurasian Partnership have reached a new level: the Joint Commission on implementing the Agreement on Trade and Economic Cooperation between the Eurasian Economic Union and the People's Republic of China held its first meeting, and the updated programme of cooperation between the Eurasian Economic Commission and Association of Southeast Asian Nations until 2025 has been approved.

The Greater Eurasia concept was supported in the final documents of the SCO heads of state and government meetings.

Russia's efforts to resolve regional conflicts and crises brought concrete results. Russia's mediation helped put an end to armed clashes and restore peace in Nagorno-Karabakh. Emergency humanitarian aid was provided, proper conditions were created for the return of the refugees and displaced persons, a peacekeeping operation was launched, and the creation of a joint Russian-Turkish ceasefire compliance centre was agreed

Russia's mediation helped achieve a drastic reduction in shelling in east-

ern Ukraine and, in general, maintain ceasefire between the parties to the intra-Ukrainian conflict.

Cooperation of Russia with Iran and Turkey in the Astana format helped stabilise the situation in Syria. A considerable contribution to the settlement of humanitarian problems has been made by the international conference on the return of Syrian refugees and internally displaced persons held in Damascus (November 11-12), which was attended by delegates from over 20 countries. At the bilateral level, Russia continued providing assistance to Syria for overcoming the socio-economic crisis.

Substantial efforts have been made in combating new challenges and threats. Russia's efforts during the 63rd session of the UN Commission on Narcotic Drugs ensured the adoption of a resolution on promoting the involvement of youth in drug prevention efforts.

In 2020, Russian-Sri Lankan relations further expanded. In January, the Minister of Foreign Affairs of Russia, Sergey Lavrov paid a visit to Colombo and held talks with Presi-

dent Gotabaya Rajapaksa, Prime Minister Mahinda Rajapaksa and Foreign Minister Dinesh Gunawardena.

In February, Commanderin-Chief of Land Forces, General of the Army of Russia Oleg Salyukov was on a five-day visit to Sri Lanka and took part in the 72nd Independence Day celebrations as the Chief Guest.

In September, upon completing a business call at

sian large antisubmarine ships Admiral Tributs and Admiral Vinogradov took part in the rescue operation of the crew of the MT New Diamond crude oil carrier, which caught fire near the coast of Sri Lanka.

Despite the COVID-19 situation the volume of bilateral trade between January and November has increased by 27.4 per in comparison with 2019. There are good prospects of establishing cooperation between Russia and Sri Lanka in the field of production of Russian medicine, including anti coronavirus vaccine "Sputnik V".

This year, Russia will continue maintaining global security and strategic stability, first of all within the UN Security Council framework, and developing the ever-growing partnership with Sri Lanka.

Stern action against environment polluters - Amaraweera

President Gotabaya Rajapaksa has instructed the relevant officials to take action against those who destroy the environment. regardless of their status, Minister of Environment Mahinda Amaraweera said on Thursday.

He was speaking to a group of environmental journalists and senior environmentalists at the Ministry of Environment, the media unit of the ministry in a communique said.

The Minister said there is a massive propaganda campaign on some social media networks that deforestation and environmental destruction is taking place under this Government.

"Clearly there is truth in some of the environmental devastation revealed by the media. They do



not take place with the instructions of the Government. They are carried out by some racketeers. It seems that some local politicians are also involved in this. But a large number of untruths are covered up on social media to cover up real events".

He further stated that the Government will never disregard its commitment to protect the environment and those politicians as well as officials who are behind certain environmental damage incidents will be punished irrespective of status, if found responsible for the incidents.

"Although I instructed the Bopitiya Police to seize five dump trucks carrying building materials from Colombo to fill up the Muthurajawela wetland, a senior officer there did not take any action. It was later revealed that officer was allegedly involved".

Although the authorities have the ability to prevent some environmental damage, it has not been implemented. In a district, there is a large network of officers including District Secretaries, Divisional Secretaries, Grama Niladharis,

Environmental Officers, Geological Officers, Development Officers, Forest Officers, Agrarian Development Officers and Agricultural Research Officers".

The clearing of land for cultivation in certain places is not deforestation or environmental degradation at all, and environmental damage is being done with the intervention of certain racketeers and certain government officials, and the Ministry of Environment has taken legal action against a large number of such individuals, the Minister said.

Halt this devastation

dangerous trend is being observed relating to acts that have caused great harm to the environment such as clearing of forests, encroachment on reservations, destruction of biodiversity and large-scale sand mining etc. allegedly with local-level political backing, that if not checked could lead to a great calamity for the country's ecosystem.

Hardly a day passes without some act of environmental depredation including wanton destruction of forest land being reported on television. The latest is the attempt to fell an endangered and priceless tree in Gampaha that stands in the way of a road development project. The tree was about to face the axe but for the timely intervention of the Gampaha Assistant Forest Conservator that recalled a similar intervention of the self-same intrepid female officer to salvage a rich stretch of mangroves that was about to be cleared to pave the way for the construction of a playground. Prior to this we reported that vast acreages of mangroves in the Puttalam District were being cleared for prawn farming but this was stopped in the nick of time by the authorities, preventing grave environmental destruction.

The authorities must put a halt to this runaway destruction of the environment through massive deforestation, indiscriminate sand mining and other depredations that had gravely impacted the ecosystem, contributing to Climate Change. The country's forest cover which stood at 40 percent in the 1920s has today dwindled to a pathetic 17 percent. Ambitious programmes have commenced to extend this to 20-30 percent by 2050 and it is estimated that 65,000 hectares of new forest cover should be added to increase forest density by just 1 percent.

Environment Minister Mahinda Amaraweera said 100 persons who used political and money power to cause environment destruction had been brought before the law during the past six months. From what is evident this has not acted as an effective deterrent as forest destruction is going on apace. The Minister also says that plans are afoot to plant nearly 100,000 saplings countrywide during the next three months. But will this suffice if we are to see forest cover increased to 30 percent by 2050? How long will this programme be sustained? Besides, replanting if it is to have any effect, should be carried out where the original destruction had taken place.

Today farmers are hamstrung having to confront erratic climatic shifts, the chief cause for crop destruction and/ or crop failure. Mass tree planting campaigns should be done where it matters most. Having schoolchildren carry out tree planting in their school premises or getting commercial establishments to grow trees along roads is no solution in the effort to increase the country's forest cover. The denudation of forests to the extent it has taken place has not only wreaked environmental havoc and caused an ecological imbalance, it has also robbed the country of its much acclaimed beauty. Unlike in the past what we see today in the once salubrious climes in the hill country are dried up streams, spouts and waterfalls that once gushed in their enthralling majesty and the equally forlorn flora and fauna - all victims of rampant forest rape, which is a tragedy of immense proportions.

This Government came to power with a fund of public goodwill and great expectations that it will right the wrongs of the past. There is no doubt that President Gotabaya Rajapaksa would start cracking the whip against those responsible for clearing forests and inflicting other forms of environmental destruction on the

The President showed by example when he took prompt action to issue orders that the roadway being built across the Sinharaja forest should be constructed with no damage to the environment. The President should read the riot act once again. The wanton destruction that is being caused to the environment will certainly lead the country into a great calamity making it vulnerable to a myriad of natural disasters resulting from geological imbalances.

The spate of unprecedented landslides in hitherto safe zones has been directly attributed by experts to the indiscriminate damage caused to the environment. President Rajapaksa who as Secretary Urban Development Ministry, launched several environment friendly projects in the city of Colombo no doubt, would ensure the country would go green once again by regaining its lost forest cover which will also see an end to droughts, distorted weather patterns and ecological shifts.

The present human-elephant conflict which has gained the close attention of President Rajapaksa could also be directly attributed to the wanton destruction of the elephant habitat by politically backed businessmen for the construction of tourist hotels and similar projects.

True, economic advancement and commercial imperatives have placed all available space and land at a premium with the massive demand necessitating inroads into the country's pristine forests. If the trend continues, we will soon see this country turned into a desert land sans its signature flora and fauna as greed overtakes the future well-being of the country reducing it to a wasteland for our future generations. All efforts must be taken to prevent such a catastrophe.

Fair Distribution of Economic Welfare: Science against Myth

Part 2

he supply of public services whether fiscal or monetary or market regulation themselves are subject to and have created large distributional disparities. Some of examples are listed below.

• Although school education is free and common to all, the disparity among the quality of school facilities country-wide causes disparities of skill, knowledge, higher education and employment opportunities of students finishing school education.

 Licensing of businesses helps those parties to monopolize and accumulate wealth. Although the concept of fair market is applied, it helps those parties to monopolize and accumulate

• Despite the concept applied for market regulations, various mechanisms of insider dealings are driving markets to accumulate wealth to those

• Although the distribution of law and order is free to all citizens, the system generated cost and processes prevent its fair distribution while causing wealth to system operators.

• Price controls that are intended to benefit consumers of low-income brackets lead to black-markets due to failure of the state to provide adequate supplies and create wealth accumulation to those marketeers.

• Tax concessions given to entrepreneurs to supply products at low cost/ price to the public end up in wealth accumulation to those parties as there is no mechanism to ensure the fair distribution of those products.

• Various state policies on protection of natural resources and environment divided among various strata of bureaucracy without aligning them with underlying economic activities push many folks to poverty due to conflicts of bureaucracy.

The list can go on long pages to understand the brutality of disparities prevailing due to distributional issues of public services. President's discussions with villages programme reveal numerous examples for detrimental effects of distribution disparity of public services country-wide.

GOVERNMENTS AS THE CAUSE FOR DISTRIBUTIONAL DISPARITIES

The review of the history of economic governance systems in the world shows the origin of economic disparities throughout the history of human being is the governments. In primitive human stage, people lived in groups on natural resources without owning them by any individuals. In later civilizations, areal tribes emerged with leaders with the power to control people, resources and economic activities in the respective areas where the leaders started assigning or distributing land to their supporters and to tax people to fund the government.

Such control and distribution of land or resources and taxes have continued in systems of monarchy and present democratic governments around the world. That power is the prize available to those who attempt to win the governments. Therefore, human civilization has caused emergence of governments with the ownership of resources and the powers to distribute resources at their discretion which has caused present distributional disparities everywhere. Meantime, while continuing with similar distribution, governments themselves attempt to reduce disparities (caused by them) through another set of public services causing further disparities. This is true for all

socialistic and capitalistic governments. Nobody has any practical solution for this.

BROAD CONCERNS OVER DISTRIBUTIONAL POLICY RESULTS

The distribution of fair share and promotion of fair markets to ensure the fair distribution of production are fashionable concepts quoted in economic and political analyses where political slogans are played, especially at times of elections, on further policy actions to improve them. However, the reality is the continuity of all disparities without any material reduction whereas various shocks such as financial crises, natural calamities, geopolitical conflicts and health hazards result in pushing people to new facets of disparities. This is the outcome of several factors.

First, there are no definitions and yardsticks to measure the level of fairness desirable, given the world of disparities. Therefore, disparities are analysed under different hypotheses, mostly on political grounds. Second, although state policies are implemented, the list of policies that target the reduction of disparities and their performance or outcome are not assessed, other than conceptual speeches.

Third, the tendency of the bureaucracy to control markets in pursuit of lowering disparities limits competition and opportunities for innovations and access to productive resources that cause detrimental effects on the prevailing disparities. Intra-bureaucratic conflicts are so merciless and brutal on the disparities. However, their favourism provided through regulatory approvals and information sharing to some entrepreneurs to accumulate wealth from time to time is well-known. No wealthy persons can emerge without such favouritism of the bureaucracy, given the large number of economic regulations. For example, Mr. Jack Ma in China who created the Chinese e-commerce and IT business empire during the last two decades and entered the world billionaires' list has disappeared since last November where state investigations into his business empire, Ant Group, have suddenly commenced on the charge of creation of a business monopoly. Everybody knows that monopolies in Chinese governance system cannot emerge easily outside the eyes of the Chinese

DISTRIBUTION POLICY SCENARIO PROPOSED FOR SRI LANKA

There is no debate over the duty bound on the government to ensure fair distribution of economic benefits among its citizens, given its public mandate. Under the Directive Principles of State Policy and Fundamental Duties of the Sri Lankan Constitution (Chapter VI), Articles 27(2) (c)-(f), 27(7), 27(8), 27(13)-(15) assign the government with specific duties on fair distribution. These Directive Principles (although not enforceable in judiciary) are to guide the Parliament, President and Cabinet in the enactment of laws and the governance of Sri Lanka for the establishment of just and free society. There are various state institutions that have legal objectives, duties, mandates and discretionary powers directly and indirectly connected with distributional duties. Therefore, no new legal provisions are required to address distributional


aspects of the country. Policies required for fair distribution are neither rocket science nor economic models. Therefore, all are hypotheses-based tools. Their efficiency depends on the implementation efficacy. Therefore, the implementation strategy and the process matter. This can have various dimensions. Some thoughts are given below, given the complexities of the prevailing bureaucracy of the state.

• Identification of Disparities It is necessary to assess the levels of

key distributional disparities as defined and decide whether their levels and directions are unfair because disparities naturally prevail due to differences in human skill and access to productive resources. Further, specific policies may not be required even if the disparities are unfair if they are in the direction of gradual fall whereas disparities may in fact be hypotheses of some political analysts while the public may not be much concerned. Therefore, a careful assessment/investigation is necessary to decide whether disparities are alarming and require public policies to fix them in the public interest. The key hurdle here is the collection of ground data. The conduct of new sample surveys island-wide by statisticians based on questionnaires will not work. Therefore, data from existing sources such as IRD, Banks, Financial Institutions, RMV, Land Registry, Employers, Stock Exchange, EPF and EFT could be used to assess proxy variables to gage some items of distributions. In this regard, time series of information classified on households/persons are required. National aggregates are not relevant as they do not show the status of distribution. If such data are not compilable or investigation is not feasible, there is no basis for concerns over disparities or policies just on the basis of political hypotheses or slogans.

MYANMAR: RISING PROTESTS AGAINST MILITARY COUP

ens of thousands of protesters have come to the streets in Myanmar calling for the release of civilian leader Aung San Suu Kyi, with major risks of turning the country back to a long period of military rule, a decade after it began withdrawing from civilian politics.

The police have used tear gas, water cannon and also fired into the air to control the crowds, largely of youth. Three youths have been injured by the firing, one female student very seriously.

As pro-democracy protesters continue to flood the streets of many cities in Myanmar, there are fears of another long period of economic isolation.

Fresh protests took place on Thursday continuing days of demonstrations in major cities and towns inside Myanmar calling for the military to cede power following its February 1 coup.

Demonstrators marched peacefully in Naypyidaw - the capital and military stronghold - as well as Yangon, the largest city and commercial hub.

US President Joe Biden has approved an Executive Order for new sanctions on those responsible for the military coup in Myanmar, as the army detained another key aide to civilian leader Aung San Suu Kyi. The office of Suu Kyi's political party was searched by the military.

Washington would identify the first round of targets this week and was taking steps to prevent the generals having access to \$1bn in Myanmar government funds held in the United States. "We're also going to impose strong exports controls. We're freezing US assets that benefit the Burmese government, while maintaining our support for health care, civil society groups, and other areas that benefit the people of Burma directly," Biden said at the White House.

The UN Security Council has "emphasized the need for the continued support of the democratic transition" inside the country, after a military junta was installed on Monday ending five years of civilian rule, announcing that it was taking power for the period of a year before fresh elections.

The Security Council has called for the "immediate release of all those detained", and stresses "the need to uphold democratic institutions and processes, refrain from violence, and fully respect human rights, fundamental freedoms and the rule of law".

The Security Council call also had the support of China and Russia. Western countries have condemned the coup, but analysts believed Myanmar's new junta would not be as isolated as previous iterations, with China, India, south-east Asian neighbours and Japan unlikely to cut ties given the country's strategic importance.

India - China troops

India and China have reached an agreement on disengagement at Pangong Tso in Ladakh, India's Defence Minister Rajnath Singh has said in the Rajya Sabha, giving details of a breakthrough after a protracted stand-off and several rounds of talks between military commanders and diplo-

"Our sustained talks with China have led to agreement on disengagement on the north and south banks of Pangong Lake. After this agreement, India-China will remove forward deployments in a phased, coordinated manner," the Defence Minister said

"I want to assure this House that in these talks we have not conceded anything," he asserted. "The agreement that we have been able to reach with the Chinese side for disengagement in the Pangong lake area envisages that both sides will cease their forward deployments in a phased, coordinated and verified manner."

Mr. Singh said the Chinese would keep their troop presence in the North Bank area to east of Finger 8 and the Indian troops would be based at their permanent base at Dhan Singh Thapa Post near Finger 3. Similar action would be taken in the South Bank by both sides.

"These are mutual and reciprocal steps and any structures that had been built by both sides since April 2020 in both North and South Bank area will be removed and the landforms will be restored," he said.

The minister said both sides had also agreed to a moratorium on military activities in the North Bank, including patrolling, in traditional areas. Patrolling would be resumed when both sides reached an agreement in diplomatic and military talks. Mr. Singh said there were still some outstanding issues on deployment and patrolling at some other points along the LAC in eastern Ladakh and these would be the focus of further discussions.

Mars - UAE and China

The United Arab Emirates (UAE) and China made record reachings to Mars within two days, this week. UAE made history as the first Arab country to reach Mars.

China that has landed on the moon three times, completed its first successful journey to another planet in our solar system. The UAE Mars mission, named the Hope probe, reached the red planet at 7.42 p.m. Tuesday UAE time. It took 204 days and travelled 480 million kms.

This makes the UAE only the second country to ever successfully enter Mars' orbit on its first try, despite attempts being made since the 1960s. The only other country to have done so is India. The Hope probe is the first to complete its journey out of three Mars missions aiming to breach the planet's orbit this year. The US NASA's Perseverance rover is expected to reach Mars next week.

The Hope probe, a \$200 million project called Al-Amal in Arabic, was launched on July 20 from Japan's Tanegashima Space Station. It will now spend one Martian year — equivalent to 687 days on Earth — studying and gathering data on the red planet's atmosphere.

That time will enable it to create the first full map of the Martian atmosphere, with the help of three highly specialized instruments developed by the Emirati team: a highly sophisticated camera to photograph Mars and study its lower atmosphere, an ultraviolet spectrometer that will detect the planet's levels of carbon monoxide and oxygen, and an infrared spectrometer that will measure Martian dust, ice clouds and water.

China's Tianwen-1, spacecraft launched last July, has begun its orbit of the red planet. China is expected to try to place a lander and a robotic rover on the planet later this year. It would join what could by then be a trio of NASA spacecraft studying the Martian surface.

China's spacecraft left Earth last summer, taking advantage of a period when Mars and Earth were closest to each other during their journeys around the sun. That allowed a relatively

short transit between the two worlds. In arriving at Mars, China far surpassed its last attempt at an interplanetary mission, which failed nearly 10 years ago, although through no fault of the country's own. That Mars-bound spacecraft, Yinghuo-1, burned up in Earth's atmosphere when the Russian rocket it was travelling on failed in flight.

Biden- Jinping talks

U.S. President Joe Biden and his Chinese counterpart Xi Jinping held their first telephone call as leaders, with Biden saying a free and open Indo-Pacific was a priority and Xi warning confrontation would be a 'disaster' for both nations.

President Biden also underscored his "fundamental concerns about Beijing's coercive and unfair practices, its crackdown in Hong Kong, reported human rights abuses in Xinjiang, and increasingly assertive actions in the region, including toward Taiwan", the White House said in a statement.

President Xi told Biden that confrontation would be a "disaster" and the two sides should re-establish the means to avoid misjudgements, according to the Chinese foreign ministry's account of the call, which took place on Thursday. The Chinese leader also maintained a hardline tone regarding Hong Kong, Xinjiang and Taiwan, which Xi told Biden were matters of "sovereignty and territorial integrity" that he hopes the United States will approach cautiously.

It was the first call between Xi and a U.S. president since the Chinese leader spoke with former President Donald Trump in March last year. Since then, relations between the two countries have plunged to their worst level in decades,

with Trump blaming China for the COVID-19 pandemic. During the Trump administration, the United States launched a series of actions against China, including a trade war, sanctions against Chinese officials and firms perceived to be security threats and challenging Beijing's South China Sea territorial claims. Chinese officials have expressed cautious optimism that bilateral relations will improve under Biden and urged Washington to meet Beijing halfway.

Xi congratulated Biden on his election in a message in November, even though Biden had called him a "thug" during the campaign and vowed to lead an international effort to "pressure, isolate and punish China."

The Biden administration has made it clear that it will continue to maintain pressure on China, however, although it has also pledged to take a more multilateral approach. A senior Biden administration official told reporters ahead of the telephone call that Biden would be "practical, hardheaded, clear-eyed" in dealings with Xi, but wanted to ensure they had the opportunity to have an open line of communication, despite U.S. concerns about Chinese behaviour. The official said the call came at a time when the United States believed it was in a position of strength, after consultations with allies and partners, to lay out core concerns about China's "aggressive activities and abuses".

The Biden administration will look in coming months at adding "new targeted restrictions" on certain sensitive technology exports to China in cooperation with allies and partners, the official said. He also said there would be no quick moves to lift the tariffs the former Trump administration left in place against Chinese imports.

UK - India trade

UK Prime Minister Boris Johnson is seeking a major trade deal with India in what is being described as an "enhanced trade partnership", after the breakaway from the



European Union and the economic issues that follow this break. PM Johnson was to visit India for its Republic Day celebrations last month, but could not come due to the COVID spread in the UK.

UK Foreign Secretary Dominic Raab visited India in December last year for initial talks, and the International Secretary, Liz Truss has met Indian ministers on the trade talks.

India is already the UK's sixth largest non-EU trading partner after the US, China, Japan, Switzerland and Norway, and the relationship now supports more than 500,000 UK jobs.

For PM Johnson, signing a trade deal with a large market like India will help him politically sell the benefits of pro-Brexit to voters, ahead of the next general election.

In 2019, bilateral trade in goods and services between the two countries were respectively worth US\$15.7 billion and US\$18.9 billion (£11.5 billion and £13.8 billion), becoming increasingly important. The UK's services exports to India have grown at 7% a year between 2013 and 2018, and yet India continues to enjoy a trade surplus with the UK. The UK is also the second largest investor in India.

Meanwhile, India is the second largest investor in the UK after the US. India invested in 120 projects and created 5,429 new jobs in the UK in 2018-19. Indian companies in the UK turn over an excess of £40 billion. Steel to car-making giant Tata is easily the largest, but there are many other major Indian employers.

Late last year there was a declaration of a ten-year road map towards upgrading the nations' 2004 strategic partnership into a new "comprehensive strategic partnership" involving closer military ties, cooperation in the Indo-Pacific region, and measures to counter terrorism and fight climate change

Indian Prime Minister Narendra Modi is invited to attend the G7 summit in Cornwall, south-west England in June, and the changed geopolitical priorities following Brexit provide an incentive for both sides to negotiate a fast-track trade deal. For the UK, this reiterates the government's "Global Britain" strategy of developing stronger ties in Asia Pacific – in line with the country's application to join the Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP) free-trade bloc. Economic and political analysts see a new trade deal with India as an opportunity to foster post-Brexit and post-COVID recovery, giving British businesses greater access to a market of 1.3 billion people, when the prospects for global growth after the pandemic still remain uncertain.

UK companies already have a growing market share in India in several sectors, including food and drinks despite high tariffs and other trade restrictions. Notably, India is the third largest market for Scotch whisky, for instance.

WHO - COVID Wuhan search

An international team of scientists led by the World Health Organisation has said that the coronavirus "most likely" originated in animals before spreading to humans, and dismissed a theory that the disease had been leaked by a laboratory in the Chinese city of Wuhan. Scientists have been working in Wuhan, where the disease was identified, for the past four weeks as part of their search for clues to the origins of the COVID-19 pandemic. The long-awaited probe comes after months of negotiations between China and WHO about the arrangements of the investigation. The delay raises questions about the reliability of the findings. The investigators have visited hospitals, laboratories and markets, including the Huanan Seafood Market, the Wuhan Institute of Virology and the Wuhan Centre for Disease Control laboratory.

The visit, which has been shrouded in secrecy, was also expected to see researchers speak with early responders as well as some of the first patients. The team completed two weeks of quarantine before beginning to visit local sites.

Dr. Peter Ben Embarek, the WHO's food safety and animal disease specialist and chairman of the investigation team, told reporters the "most likely" pathway for COVID was a crossover into humans from an intermediary species. This hypothesis will "require more studies and more specific (and) targeted research," he said.

The initial findings of the investigation did not find evidence of large COVID outbreaks in Wuhan or elsewhere before December 2019. However, researchers did find evidence of wider COVID circulation outside the Huanan Seafood Market that month, Ben Embarek said.

He added it was not yet possible to pinpoint the animal intermediary host for the coronavirus, describing the findings after nearly a month of meetings and site visits as "work in progress."

"In terms of understanding what happened in the early days of December 2019, did we change dramatically the picture we had beforehand? I don't think so," Ben Embarek

"Did we improve our understanding? Did we add details to that story? Absolutely," he said.

It is hoped that information of the earliest known cases of the coronavirus, first detected in Wuhan in late 2019, could help to identify how the outbreak started and prevent future pandemics. The team had reached the conclusion that a lab leak should be regarded as extremely unlikely "on the basis of a serious discussion and very diligent research," added Liang Wannian, head of the expert COVID panel at China's National Health Commission.

Trump trial in US Senate

The trial of ex US President Donald Trump is in progress in the US Senate following the Impeachment passed in the House of Representatives, which is the second impeachment trial for Trump within one year, and the first ever to a US President

Prosecutors took US senators on a wrenching journey inside the horror of the US Capitol insurrection, making a devastating case that Donald Trump had plotted, incited and celebrated a vile crime against the United States.

Their previously unseen video evidence showed a bloodthirsty mob defiling Congress, heroism from overpowered police officers pleading for backup, high-profile lawmakers running for their lives and staffers hiding behind locked

Surveillance footage depicted then-Vice President Mike Pence being hustled away with rioters calling for him to be hanged only yards away. A police officer screamed in pain, trapped between a door and an invading crowd. In a horrific scene, Trump supporter Ashli Babbitt tried to climb through a window smashed by rioters before falling back, shot dead by a Capitol Police officer.

The Senate decided by a majority of 56 to 44 that the Trump trial was constitutional, and made way for the trial to continue, in the absence of Donald Trump who will not attend it.

COVID spread and vaccine

As the COVID-19 pandemic continues to spread, there are increased concerns about the variants of the virus that increase the infections, and thus leads to increased deaths. With 106.1 million confirmed cases and 2.3 million deaths at midweek, this remains the global crisis.

Countries are introducing partial lockdowns and many other restrictions to control the spread of the virus, with increased concerns about the UK, South African and Brazil variants.


Several coronavirus vaccines have now been approved for use, either by individual countries or groups of countries, such as the European Union and the World Health Organisation (WHO). Of the 72 countries and territories administering vaccines and publishing rollout data, 51 are high-income nations, 21 are middle-income and none are low-income.

Some countries have secured more vaccine doses than their populations need, while other lower-income countries are relying on a global plan known as Covax, which is seeking to ensure everyone in the world has access to a vaccine.

WHO Director-General Tedros Adhanom Ghebreyesus has warned that despite the growing number of different vaccines, current manufacturing capacity meets only a fraction of global need. "Allowing the majority of the world's population to go unvaccinated will not only perpetuate needless illness and deaths and the pain of ongoing lockdowns, but also spawn new virus mutations as COVID-19 continues to spread among unprotected populations," he told *Foreign Policy* magazine.

The US (41 million) and China (31 million) have given the most doses overall, while the UK has administered more than 12 million so far. The EU has admitted to delays in ordering and supplying the vaccines.

But when breaking the figures down by population, looking at doses administered per 100 people in the 10 countries giving the most vaccinations, Israel, the UAE and the UK top the list. Most countries are prioritising the over-60s, health workers and people who are clinically vulnerable.






he implementation of the Geneva Resolution is an onerous task. It will encounter various challenges and dilemmas. It requires the establishment of institutional structures and national legislation to give effect to the operative part of the Geneva Resolutions. Implementing legislation must not offend the 1978 Constitution and the 1976 Vienna Convention of the Law of Treaties (VCLT 1976)

The Geneva Resolutions

The Geneva Resolution can be classified as a non-treaty instrument. It is different from a treaty in many respects (Anthony Aust – Modern Treaty Practice). It does not require the consent of the State to be bound by such Resolutions. It has a preambular and operative part. It is likely to be interpreted in the same way as a treaty by reference to articles 31 and 32 of the VCLT 1969. It resembles the Resolutions of other UN Specialised Agencies such as IMO or ICAO which are of a binding

The proposed Geneva Resolution is likely to be different and devastating for Sri Lanka if it is based on the Report of the UN High Commissioner for HR. If so, it is desirable at this point of time to draft a counter resolution and outline Sri Lanka's proposals relating to reconciliation and accountability without taking a confrontational approach at this time.

OPERATIVE PART OF THE GENEVA RESOLUTIONS

Implementation of the operative part of the Geneva Resolutions can be dealt under four areas. These areas are - (a) Establishment of a truth-seeking and reconciliation commission; (b) Investigation into violations relating to human rights and international humanitarian law (IHL); (c) Reparation to victims; and (d) Guarantee of non-recurrence. All these areas are seen as an integral part of transitional

(A)TRUTH-SEEKING AND RECONCILIATION

Establishment of a Commission for Truth-seeking and Reconciliation is an important consideration in dealing with transitional justice. It is a sensitive area. It can 'open old wounds' and therefore such investigation should not be undertaken in Sri Lanka. It can create 'new wounds' that can get festered over a period of time. If so, the situation might become worse for reconciliation.

In South Africa, such commission was established under National Unity and Reconciliation Act No. 34 of 1995. It was necessary to do so as apartheid was an inherently anti-democratic and unjust system perpetrated by a white minority. The global community denounced apartheid with sanctions and recognised the right to self-determination by the majority community. In Sri Lanka, LTTE was engaged in an armed conflict to establish a separate state in defiance of the Constitution and International law. The global community proscribed LTTE as a terrorist organisation.

Hence, we should gently reject this requirement in the preambular part by reciting the reasons as outlined above.

(B) INVESTIGATION INTO VIOLATIONS **RELATING TO HUMAN RIGHTS AND HUMANITARIAN LAW**

Geneva Resolutions require investigation into violations relating to human rights and international humanitarian law (IHL). It is a requirement of transitional justice. Investigation should not be restricted to the final phase of the war, where Sri Lankan Security Forces had to proceed, amidst protests, to save the territorial integrity and sovereignty of Sri Lanka

from the tentacles of the rebel forces who used child soldiers and civilians as a human shield.

The Resolution requires Sri Lanka to establish a credible domestic mechanism. It must be fair to the accused as well as to the victims. The Resolution requires the inclusion of Commonwealth judges and prosecutors along with national judges and prosecutors. Inclusion of Commonwealth judges and prosecutors may encounter political and constitutional issues. In this context, when formulating the Report on Sri Lanka, the UN High Commissioner for Human Rights should read Article 46 of VCLT 1969 which says that any treaty or non-treaty instrument should not offend the fundamental principles of the Constitution.

Any investigation relating to violations of human rights law or IHL would be dangerous in Sri Lanka, unless such investigation is conducted as a non-international armed conflict under Common Article 3 of Geneva Conventions 1949. Unfortunately, in Sri Lanka, the Common Article 3 was not given effect to by the Geneva Conventions Act of 2006. The initial draft Bill prepared by me in 2001 incorporated the provisions relating to Common Article 3 of the Geneva Conventions of 1949 (draft Bill is on file with me) on the advice of the top legal advisers at ICRC headquarters in

These legal advisers came to the conclusion after consulting Jean Simon Pictet's five points enshrined in the negotiating record (travaux preparatoires) of the Geneva Conventions 1949 and I was given the goahead to draft the requisite legislation.

International human rights standards are also not properly transformed into national legislation in Sri Lanka. There are many 'deficiencies' and 'inconsistencies' in our national legislation. Assistance to and Protection of Victims of Crime and Witnesses Act, No. 4 of 2015 requires substantial amendments.

Unless international human rights standards are properly transformed into the domestic legal system by way of new legislation or amendment to existing law using the correct legislative techniques, any domestic mechanism established for this purpose will not be effective and will not be able to function according to international standards.

The operative part of the resolution will recite that accountability will be determined under Common Article 3

of the Geneva Conventions of 1949 and therefore national legislation needs to be enacted to incorporate Common Article 3 of the Geneva Conventions to the existing Geneva Conventions Act 2006 (A draft Bill is annexed as a schedule to this paper to illustrate the requisite amendment).

(C) REPARATION TO VICTIMS AND TRACING MISSING PERSONS

Reparation to victims is also an important requirement under Geneva Resolutions to promote reconciliation. Legislation has been already enacted to establish a domestic mechanism for such reparation. The amount granted is too small and may be increased in

It does not take into account reparation already provided to victims of war either through legislation or army routine orders or Cabinet Memoranda.

Unfortunately, the civilian victims, especially women who have lost their husbands or children have not been adequately compensated. Hence, there is a great need to compensate civilians who have suffered due to eviction, injuries, unlawful killing and/or those who have suffered due to suicide bomb attacks. The legislation must clearly identify those who are really entitled to these benefits in the context of Sri Lanka's armed conflict.

The operative part should recite the continued implementation of national legislation relating to reparation and of missing persons.

(D) GUARANTEE OF NON-RECURRENCE

Guarantee of non-recurrence is a very challenging requirement of the Geneva Resolutions.

In most countries, the reconciliation between ethnic and religious groups is handled by ethnic relations commissions. In developing countries such as Guyana and Trinidad and Tobago, these commissions are established through constitutional provisions. These commissions are empowered by law to take action where there is a threat to ethnic or religious harmony.

These commissions have produced literature relating to peace, harmony and development and organised drama festivals to promote racial and ethnic reconciliation. I have seen many plays written by Eric Brathwaite in Georgetown and Port of Spain and cried how backward my beloved country is in regard to reconciliation and creating ethnic harmony and unity. We have not understood that national security is ethnic harmony and unity, and ethnic harmony and unity is national

These commissions are empowered to refer any matter to a Tribunal established by legislation. Such matters include 'hate speech' or any act which causes ethnic disharmony. Issues relating to burial or cremation regard to those who died from COVID-19 should be referred to such a commission and not to politicians or religious bigots.

Establishment of an Ethnic Relations Commission and a Tribunal may satisfy the reconciliation requirement, as these commissions have prevented a fully-fledged armed conflict between diverse religious groups and ethnicities in many countries.

The Operative Part should recite the establishment of such institutions to make reconciliation more effective and efficient. It can be described as a 13+. Ethnic harmony is national secu-

ADDITIONAL REQUIREMENTS

Geneva Resolutions imposes additional requirements. These include the full implementation of the 13th

of Terrorism Act and the Public Security Ordinance. Implementation of the 13th Amendment, PSO and the PTA is part of the 'domain reserve' under Article 2(7) of the Charter of the United Nations. Hence, such intervention is not fair and legitimate.

IMPACT ON STATE SOVEREIGNTY

Implementation of the Geneva Resolutions and the recent Report of the HR Commissioner can impact on State sovereignty. In today's world, State sovereignty is diminished through ratification, accession or succession to treaties. A treaty per defitionem may restrict State sovereignty. However, a non-treaty instrument is not in the same category unless there is express or implied consent to be bound by it. Co-sponsoring gives implied consent.

În regard to ratified treaties, a State cannot hide behind State sovereignty to avoid international obligations. International compliance and control measures established by various legal regimes demonstrate that State sovereignty is diminished and the Westphalian Order does not exist anymore in its pristine form.

Implementation of the Resolutions may offend the provisions of the Constitution. In Sri Lanka, the Constitution grants sovereignty to the people and its elements are enshrined under Article 4 of the 1978 Constitution of Sri Lanka. If the legislative implementation of the proposed Resolution offends the Constitution, Sri Lanka should propose an alternative counter resolution which is in harmony with our constitutional provisions.

CONCLUSIONS


Implementing the Geneva Resolutions is an exacting task. It will encounter many challenges and dilemmas. The draft report evinces that the High Commissioner has not understood the atrocities committed by the rebel forces or 'Kadi's Case' in the European Court of Justice on freezing of assets without due process.

The High Commissioner has gone on to declare unfairly and wrongly that Security Forces who saved Sri Lanka's territorial integrity and sovereignty as enemies of mankind (Hostes Humanis) by subjecting them to universal jurisdiction and International Criminal Court (preambular part).

At this time, we must not forget that Former President Mahinda Rajapaksa saved the country from the rebel forces. If not for him, the armed conflict would have dragged on for many years. In this context, he was assisted by India, Pakistan, USA and many other countries.

He was also assisted by the Defence Secretary, Army Commander and many others. Since then, we have enjoyed freedom from fear and freedom from unlawful killing (preambular part needs to recite this fact).

The Geneva Resolution must not be rejected in toto. A rejection might send wrong signals to UN Member States. After all, the UN is the best friend of small and weak States, although the Thucydides' doctrine (powerful States do what they can and small States must accept what they must) still continue to apply in the conduct of international relations and diplomacy. Notwithstanding the aforementioned phenomenon, the UN has assisted small and weak States in situations where might is not right. Let us engage with



counter resolution and identify how we intend to deal with reconciliation and accountability taking into account ground realities, constitutional provisions and the political ramifications.

We need to understand Morgenthau's realism in dealing with this vexed issue and not engage in an unnecessary confrontation with Western countries. In my career, I have experienced quiet diplomacy and good reasoning with my Western counterparts at the UN or in diplomatic circles constitute the best tools that lead to victory at the end of the day. Such a strategic approach is important as the victories on the battlefield.

ANNEX

Geneva Conventions (Amendment) Act 2021

An Act to amend the Geneva Conventions Act 2006 (No. 4 of 2006); to give effect to Common Article 3 and for connected matters.

Be it enacted by the Parliament of

Short title and date of commencement

1. This Act may be cited as the Geneva Conventions (Amendment) Act 2021 and shall come into operation as the Minister may appoint by Order published in the Gazette.

Amendment of Section 2 of the

2. Section 2 of the Geneva Conventions Act No. 4 of 2006 is hereby amended by adding immediately after Section 2, the following Section 2A.

"2A. (1) A person who in Sri Lanka commits or aids, abets or procures any other person to commit a breach of paragraphs (a), (b), (c) or (d) in subarticle (1) of Common Article 3 of the Conventions as provided in Schedule V to this Act is guilty of an indictable offence.

(2) A person who commits an offence under Section 2A is liable -

- (a) Imprisonment for life or any lesser period where the offence involves the willful killing of a person protected by the relevant Convention;
- **(b)** Imprisonment for a term not exceeding fourteen years for any other offence.
- (3) An offence against Section 2A shall not be prosecuted in a Court except by indictment in the name of the Attorney General."

Amendment of the Schedules

(3) The Schedules to the Geneva Conventions Act No. 4 of 2006 is hereby amended by inserting immediately after Schedule IV, the following new Schedule V

"SCHEDULE V (Section 2A) CONFLICTS NOT OF AN INTERNATIONAL CHARACTER

In the case of an armed conflict, not of an international character occurring in the territory of the one of the High Contracting Parties, each party to the conflict shall be bound to apply, as a minimum, the following provisions.

(1) Persons taking no active part in the hostilities, including members of armed forces who have laid down their arms and those placed hors de combat by sickness, wounds, detention or any other cause, shall in all circumstances be treated humanely, without any adverse distinction founded on race, color, religion or faith, sex, birth or wealth or any other similar criteria.

To this end, the following acts are and shall remain prohibited at any time and in any place whatsoever with respect to the above mentioned persons:

(a) Violence to life and person in particular murder of all kinds, mutilation, cruel treatment and torture;

(b) Taking hostages; (c) Outrages upon personal dignity in particular humiliating and degrading treatment;

(d) The passing of sentences and carrying out of executions without previous judgment pronounced and regularly constituted court affording all the judicial guarantees which are recognized as indispensable by civilized peoples.

(2) The wounded and sick shall be collected and cared for. (Dayantha Laksiri Mendis LLB

103rd birth anniversary of Prof. J.E. Jayasuriya tomorrow

Dr. C.W.W. Kannangara – Through Prof. Jayasuriya's eyes

rof. Jayasuriya who was born on February 14, 1918, won a scholarship to the University College, Colombo, securing the third place at the Cambridge Senior Examination held in 1933. Due to his logical thinking skills, he graduated at the age of 21 with a First Class in Mathematics. Having to state the name of the Buddhist school he was serving at the selection interview, young Jayasuriya failed to attain his career ambition of joining the Civil Service. Jayasuriya, never repenting this, has stated later that had he joined the Civil Service, he would have lost his mission

In 1947, Prof. Jayasuriya proceeded to the UK to follow Postgraduate Studies at the Institute of Education, London University. Back home in 1949 with a Postgraduate Diploma and a MA in Education, he was appointed to the post of lecturer in Mathematics at the Teacher Training College, Maharagama. In 1952, he joined the Education Faculty of the Ceylon University and became the Professor of Education in the same university by 1957. He retired from university service in 1971 to accept an assignment in UNESCO, Bangkok, as the Regional Advisor in Population Education.

At the completion of this assignment, he returned home and engaged in research and publication and in a variety of projects in an advisory capacity, until his demise on January 23, 1990.

Prof. Jayasuriya had been an exemplary teacher, educational administrator, author, researcher, policymaker, international consultant as well as a devoted family man. He was considered a born teacher with all the characteristics of an exemplary model of an educator. His lessons, interspersed with questions, anecdotes, jokes and remarks had been very interesting to his students. Moreover, his ability to inculcate skills in the learner with practical examples rather than probing much into theory, shows how advanced he had been as a teacher. As a graduate of 21 years, he demonstrated success in managing a prestigious school in Colombo with experienced senior teachers. It is in recognition of his administrative capacity that the then Education Minister Dr. C.W.W. Kannangara handpicked him for the headship of the Central College that was established in the Minister's electorate, Matugama. Moreover, serving the Education Faculty of the Peradeniya University for 15 years as the Professor, Jayasuriya made it one of the best Faculties of Education. The Bachelor of Education Programme he launched at the same university also demonstrated instant success.

Prof. Jayasuriya has written three sets of books on Arithmetic, Algebra and Geometry for schoolchildren from Grade 6 to GCE O/L. His idea to produce school texts sprang from the change in the medium of instruction from English to mother tongue that called for new textbooks in the national languages. The texts he produced were used widely by schools until the government introduced the free textbooks policy in the 1980s. Educational Policies and Progress during British Rule in Ceylon (1796-1948) and Education in Ceylon Before and after Independence (1939) to 1969) are two of his publications wherein he discusses policy matters related to free education and controversial issues related to the medium of instruction, teaching of religion, denominational and government schools and curricular diversification. He has also published over 150 research papers on different aspects of education.

Prof. Jayasuriya's contribution to the field of policy formulation in education is also outstanding. His able guidance and leadership as the Chairman of the National Education Commission established in the 1960s, to propose policy for the period after the takeover of assisted schools, enabled the Commission to come up with some far-reaching proposals for a national system of education.

In recognition of his great contribution to the education of Sri Lanka, Prof. Jayasuriya was awarded the prestigious honour of being the first speaker of the C.W.W. Kannangara Memorial Lecture Series, inaugurated by the National Institute of Education (NIE) on October 13, 1988. On this occasion, he chose to pay his tribute to no other than the great Dr. C.W.W. Kannangara, the Father of Free Education in Sri Lanka, whom he held in high regard. His memorial lecture entitled "Democratization of Education: Contribution at the age of 70, just 15 months before his demise, at the height of a life enriched by knowledge and experience. On the 103rd birth anniversary of this great academic, the writer highlights what Prof. Jayasuriya appreciated and admired in Kannangara, in order to shed light on the very values and principles which he himself cherished and held dear to his heart.

Prof. Jayasuriya begins his lecture by acknowledging the privilege he had received to pay his tribute to one of the greatest Sri Lankan patriots. Highlighting the fact that Dr. Kannangara's contribution to education far transcends that of his contemporaries, he justifies the selection of Dr. Kannangara as the first educator to be honoured in this manner. To provide more scope for assessing Dr. Kannangara's contribution, he also introduces the term "democratization of education" that Kannangara has used in place of the common term "free education."

Moving on to sources that he has used in preparing for the lecture, Prof. Jayasuriya mentions the late K.H.M. Sumathipala's book on the History of Education in Ceylon, 1796–1965. Observing that a greater part of the book provides a well-documented account of Dr. Kannangara's life and work, he boldly states that the title of the book is misleading. Prof. Jayasuriya refers to the two books he had written himself, and says that he used these books in preparing for the lecture. Acknowledging that he has drawn a few facts from the first source, he affirms that all the comments and interpretations he is using in the lecture are his own.

Prof. Jayasuriya begins his tribute to Kannangara by discussing his educational and career attainments.He starts from the church where he was baptized and moves on to his early education that enabled him to access a better quality education by winning a scholarship in open competition. In appreciation of the gratitude that Kannangara demonstrated to the principal of the school, who had recognised and nurtured his great potential, Prof. Jayasuriya states that Kannangara set aside his ambition to enter the Law College for a while to yield to the principal's request to serve his alma mater. Prof. Jayasuriya goes on to explain how Kannangara gained recognition as an exceptional teacher of Mathematics due to the outstanding performance of his students in the subject and how he also excelled in his career as a lawyer when he fulfilled his career ambition later.

Prof. Javasuriva also highlights the school day talents of Kannangara in the areas of General Proficiency, Mathematics and English and how he also excelled in Pali and Sinhala while getting the best of the British public school tradition. He mentions the commanding heights Kannanagara reached in both law and politics and the 'felicitous phrase and paper thrust' that were in his repertoire for use as occasion demanded. He also brings to light how Kannangara was beaten by a candidate in an all-island scholarship examination that selected just one student for studies in a British University, and how one journalist disregarding the fact that he was among the cream of the country's youth in terms of intelligence and learning, ridiculed him as a small man who was denied a good education. Thus, Prof. Jayasuriya highlights the special talents of Kannangara, his successes and failures, the praise and ridicule that came his way along with some of his strong personal qualities such as his loyalty to his guru and his love for the national heritage.

Discussing Kannangara's early promise, Prof. Jayasuriya declares that Kannangara was no stooge, no chauvinist nor turncoat. Without these personal qualities, Prof. Jayasuriya claims that Kannangara, would have floundered half way, preventing his magnificent contribution to the progress of education in Ceylon. To justify that Dr. Kannangara was no stooge, Prof. Jayasuriya brings to light how he chose to resign his appointment to defy a manager's order to support his candidature at a Local Board election. To support the fact that Dr. Kannangara was no chauvinist, Prof. Jayasuriya refers to an incident which demonstrated that Kannangara was free of ethnic prejudice. He goes on to explain how Kannangara canvassed untiringly for a person of a different ethnic group who was engaged in a contest with a person from Kannangara's own ethnic background. Furthermore, Prof. Jayasuriya reveals how this action enabled Kannangara to be selected repeatedly as the Chairman of the

tive Committee of the State Council, an office associated with the ministerial portfolio for Education. To prove that Kannangara was no turncoat either, Prof. Jayasuriya mentions a financial situation where the government was compelled to introduce an ordinance to impose Income Tax. Considering income tax as an equitable form of taxation, he goes on to explain how Kannangara voted for this Ordinance in both the readings at the State Council, at a time when the majority of people's representatives, yielding to the power of a European lobby, opted to change their stand.

Prof. Jayasuriya next turns his attention to the Executive Committee of the time which played a significant role in the democratization of education. He highlights that this Committee until 1939, had no powers to exercise its supposed functions and refers to this as "the struggle for power of a powerless Executive Committee, 1931-1939." He then discusses how the egalitarian ideology of removing inequities and inequalities became the dominant motivation of the Committee thereafter. To this end, Prof. Jayasuriya notes the effort made by Kannangara to establish a new system that would ensure genuine democratization of education by providing equal opportunities to all children of the country, irrespective of their social class, economic condition, religion and ethnic origin. He identifies Kannangara as the man unwavering in this struggle, who strove with an iron will against overwhelming odds. Referring to other politicians who supported Kannanga ra, he says that several of them went only part of the way, a few most of the way, and just one nearly all the way.

Prof. Jayasuriya opens his discussion on the free education scheme that wasintroduced in 1944 by referring to the education context of 1943. He clarifies that it was the medium of instruction - English or bilingual - and not the type of school attended - government or assisted - thatbrought about the inequality of education. Knowing that the official language of the country was English and that 'no one without the knowledge of English can fill any high post,' he reports how the rich and the influential sent their children to fee levying English schools, leaving the gifted children of the poor to thelow paid jobs of vernacular teacher, ayurvedic physician or notary.

In order to make equality of education a reality, Prof. Jayasuriya brings to light the recommendations made by the Kannangara Committee not only to make education free in all schools but in institutions of tertiary education as well. He highlights how Dr. Kannangara considering free education at all levels as the panacea, fought for the acceptance of the scheme by stating, "we shall be able to say that we found education ... the patrimony of the rich and left it the inheritance of the poor."

In responding to a comment made by the Financial Secretary in relation to the high cost of free education, Prof. Jayasuriya brings outthe subtlety with which Kannangara dealt with the commentby claiming that the proposals are placed only to promote discussion with no commitment expected in respect of the extent or the date of imple- mentation. He also highlights how Kannangara in his

ministerial speech to the State Council meted out a devastating treatment to certain wealthy and prominent citizens who argued for the deferment of the proposals on the ground that their adoption even in principle would materially affect not only the system of education but also the entire economic and social organization of the island. Prof. Jayasuriya also brings to light the formation of the Central Free Education Defence Committee and the islandwide campaign it conducted to make sure that the Bill would not be shelved. Moreover, he indicates how the mass support for the Bill thus made two councillors withdraw their proposals for deferment and how the Bill was passed on May 27, 1947. Irrespective of the struggle, Prof. Jayasuriya observeshow the adoption of the principle of free education acted as a bonanza to the well-to-do by allowing them to receive free of charge the high-quality education for which they previously had to pay, while letting the masses continue with the poor quality education that had always been free for them.

In this context, Prof. Jayasuriya recognizes Kannangara's effort to establish central schools as a step of far-reaching importance for the democratization of education in Sri Lanka. At a time when Royal College alone, among government schools, was providing a quality education to the children of well-todo parents in Colombo allowing them to achieve higher education and lucrative employment, he highlights Kannangara's aim to provide through central schools a similar type of education at least to a small number of the most gifted rural children of

Prof. Jayasuriya identifies the staffing of central schools with the best teachers available as a revolutionary measure that facilitated this aim. He explains how this was initiated by creating a Grade II Special post for the headship of Matugama Central School and how this post was stepped up within months to a Grade I post.

He goes on to explain how this move enticed heads of assisted schools to join Central schools, making assisted schools to lose their best teachers to Central schools. Referring to the first distinction in Mathematics gained at the SSC in Matugama Central School, and declaring this as the first from a government school other than Royal College, Prof. Jayasuriya highlights how the recruitment of quality staff made Central schools, centres of excellence equaling Royal College. Furthermore, he highlights the success achieved by Matugama Central School in sending students to the universities first for Arts, and later for Science, and how other central schools followed suit soon after. All in all, he proudly declares how Central schools were thus able to rival long-established assisted schools, opening vistas of hope and opportunity to thousands of able students in rural Ceylon.

Prof. Jayasuriya also sheds light on Kannangara's effort to give the national languages their rightful place in the education system. To this end, he describes the inferior status given to the national languages within the education system of the time although the vast majority of people were literate only in the national languages. He elaborates that it was only seven percent of the population that was literate in English

by the early 1940s, irrespective of the fact that it was the English Language that held the position of pre-eminence in educational and administrative settings.

Prof. Jayasuriya goes on to explain how Kannangara placed a set of recommendations before the State Council in May 1944 to establish the sole use of the mother tongue as the medium of instruction at the primary level, the use of the mother tongue or the bilingual system as the medium of instruction at the post-primary lower level, and the mother tongue, the bilingual system or English as the medium of instruction at the post-primary higher level. He delightfully points out how this initiative enabled the introduction of Sinhala and Tamil as the media of instruction in post-primary classes, and how it enabled the action to be extended to the tertiary level with the admission of Swabhasha educated students to the universities.

Prof. Jayasuriya also discusses the attempt made by Kannangara to rationalize the school system. He begins his discussion by introducing the three types of schools government, denominational, and others managed by private authorities - that were supported by state funds. Next, he explains how the introduction of free education and the accompanying liberal grants made available to denominational schools generated a need for school rationalization. These schools were given 75.2 percent of the government grant while the government treated its own schools with much less generosity. Prof. Jayasuriya explains how Kannangara put forward a proposal to the State Council to make school funding more equitable. He elaborates how Kannangara made his stand on denominational schools abundantly clear by acknowledging that 'where duty demands that justice shall be done,' the service rendered by these schools in the past 'should not stand on the way of our taking proper action.' However, in spite of the fact that rationalization of the school system was necessary for the true democratization of education, Prof. Jayasuriya admits that it did not take place to the disappointment of Kannangara.

Prof. Jayasuriya highlights the efforts taken by Kannangara to make religious education a part of the school curriculum in government schools. Explaining the situation that existed at the time, he says that both assisted and government schools were given the opportunity to impart religious instruction to students of their religious denominations, but government schools could do so only before or after the regular school sessions. Prof. Jayasuriya mentions that Kannangara took action to lift this ban so that government schools could impart religious education during school sessions just like the assisted schools.

Prof. Jayasuriya also brings to light Kannangara's steadfast devotion to the ideal of robust and unexploited teaching profession in order to make democratization of education a success. He points out that Kannangara's efforts to eliminate the private sector in education was also motivated by his determination to put an end to the unfair treatment of teachers within the sector.

In the last section of his lecture entitled "Kannangara's contribution and martyrdom," Professor Jayasuriya sums up how Kannangara, for 16 years, strove unceasingly to throw the doors of educational opportunity wide open to every child born to this country. With any cause likely to be beneficial to the common people of the country being dear to his heart, he says that Kannangara became theirardent champion, displaying at all times a dogged perseverance and fearless advocacy to defend their rights.

Prof. Jayasuriya pays his final tribute to Kannangara by harking back to a presidential address that he delivered in Calcutta during his last year of office, and quoting the following eloquent words of Kannangara that enshrine his justifiable pride and satisfaction at his own achievements as the Education Minister: "... in spite of abuse and calumny, vilification and ridicule, I have succeeded in obtaining the sanction of the State Council of Ceylon for a scheme of free education, providing for all children of the land equal opportunity to climb up to the highest rung of the university, ... and for obtaining for our national languages their rightful place in that scheme as an essential prerequisite for building up a free, united and independent nation."

US acquires 200 mn more COVID vaccine doses

US: US President Joe Biden said Thursday the US had signed deals to acquire 200 million more Covid-19 vaccine doses as officials look to immunize the vast majority of the population by July.

The deals with Pfizer and Moderna, which the administration had announced it was seeking last month, increase the country's total vaccine supply by fifty percent, to 600 million doses.

"Just this afternoon, we signed ... final contracts for 100 million more Moderna and 100 million more Pfizer vaccines," Biden said after touring the National Institutes of Health near Washington.

"We're now on track to have enough supply for 300 million Americans by the end of July," he added. Both vaccines currently authorized for emergency use in the US require two

The US immunization campaign got off to a shaky start in December but has since improved: 46.4 million shots have now

The vaccine drive entered a new phase Thursday as 6,500 pharmacies began scheduling shots, but a wave of optimism brought about by falling cases could soon be tested by dangerous vari-

Anthony Fauci, the President's Chief Advisor on the pandemic, told NBC that by April, vaccines would start being available to anyone who wanted

them. While the shots are currently only available to adults, officials have voiced hope that ongoing studies would allow them to be approved for children in the coming

Since peaking on January 8 following the holiday

season, the US outbreak has been in steep decline, with an average of just over 100,000 daily cases down from more than

Between the number of people already vaccinated and the number of people who've already been infected, it's thought that around 40 percent of the population might have some immunity, which is also contributing to the slowdown in new cases.

The highly-transmissible B.1.1.7 variant that was first identified in Britain is also rapidly spreading in the US and is set to become the dominant strain by March, according to multiple studies.

This has the potential to reverse current progress, just as it did for example in Ireland, which had gotten its outbreak under control by late 2020, but was hit by a B.1.1.7 driven exponential wave in January and still recovering.

US: US President Joe Biden revealed Thursday that his first phone call with Xi Jinping lasted a marathon two hours, during which he challenged his Chinese counterpart on human rights, trade and regional muscle-

US: House prosecutors wrapped up their impeachment case against Donald Trump on Thursday with an impassioned appeal to the Senate to convict the former president of inciting the deadly January 6 attack on the US Capitol and bar him from holding office

"We humbly, humbly ask you to convict President Trump for the crime (of) which he is overwhelmingly guilty," said Democratic Representative Joe Neguse, one of the nine impeachment managers from the House of Repre-

"Because if you don't, if we pretend this didn't happen -- or worse, if we let it go unanswered -- who's to say it won't happen again?"

The House impeachment managers rested their case after two days of arguand hours of graphic video from the conviction highly unlikely. assault on the Capitol by Trump supporters who were seeking to halt certification of Democrat Joe Biden's November 3 election victory.

Trump's lawyers were expected to begin their defense on Friday, arguing that the former President cannot be held personally responsible for the storming of Congress.

They have also argued that the trial itself is unconstitutional because Trump is now out of office, although the Senate rejected that argument earlier this week.

Jamie Raskin, the lead House manager, reminded the 100 Senators who are sitting as jurors of their oath to render "impartial justice."

UK:A British judge on Thursday said a severely disabled 10-year-old boy who was smothered to death by his struggling mother was an "indirect victim" of the coronavirus lockdown.

Judge Bobbie Cheema-Grubb said Dylan Freeman's mother, Olga, was exhausted and had reached her "wits" end" looking after her son, who required round-the-clock

Olga Freeman, 40, admitted manslaughter by diminished responsibility and was ordered psychiatric hospital.

Sentencing her at the Old Bailey court in central London, the judge called the case "rare and desperately sad".

"I have no doubt at all that you were a remarkably loving and dedicated mother to a vulnerable child until multiple pressures overwhelmed you and your mind was swamped by a destructive illness," she

"To some unknowable extent, it should be recognised that Dylan was an indi-

normal life caused by the Covid-19 pandemic."

Olga Freeman walked into a police station on August 16 last year to report she had killed her son, who had extensive physical and mental health issues.

Police officers found him in a bedroom at their house in Acton, west London, covered by a duvet and surrounded by toys.

A post-mortem examination established he died from restriction of the airways

COVID deaths in Africa jump 40% in one month - WHO

REPUBLIC OF CONGO: Deaths from COVID-19 in Africa surged by 40 percent over the last month, the World Health Organisation said Thursday, as the continent's toll approaches 100,000.

"Over 22,300 deaths were reported in Africa in the last 28 days, compared with nearly 16,000 deaths in the previous 28 days," said the WHO Africa office based in the Republic of the Congo capital Brazzaville. This comes as Africa battles new, more con-

tagious variants and gears up for its largest-ever vaccination drive," the UN agency said in a statement after a virtual press conference.

The first coronavirus infections in Africa were detected in February last year. More than 3.7 million cases have been recorded since, with 96,000 deaths, according to the latest figures released by WHO Africa on Thursday.

"The continent is expected to reach 100,000 deaths in the coming days," the WHO added.

"The increasing deaths from COVID-19 we are seeing are tragic, but are also disturbing warning signs that health workers and health systems in Africa are dangerously overstretched," WHO's Africa director Matshidiso

Moeti said in the statement. Despite fears it would be hit hard, Africa saw fewer cases than much of the rest of the world during the earlier phase of the pandemic.

"In the second wave as cases surged far beyond the peak experienced in the first wave, health facilities have become overwhelmed," the WHO said.

With vaccine scepticism high in some parts of the continent, Moeti urged all Africans to "go out and get vaccinated when a vaccine becomes available in your country". - AFP

MYANMAR'S ARMY CHIEF WARNS ANTI-COUP PROTESTERS TO RETURN TO WORK

MYANMAR: Myanmar's ruling Army Chief General Min Aung Hlaing signalled waning patience Thursday with nationwide protests over the military's takeover, ordering demonstrators to return to work or face "effective actions".

His warning comes after a sixth consecutive day of anticoup rallies condemning the ouster of civilian leader Aung San Suu Kyi, and follows US President Joe Biden announcing sanctions against the Gen-

While the demonstrations have largely been peaceful, security forces earlier this week used tear gas, water cannon and rubber bullets on protesters, with isolated reports of live rounds being fired.

By late Thursday, General Min Aung Hlaing - who now holds legislative, judicial and executive powers - called for civil servants to return to work after days of nationwide strikes supporting the protests.

"Due to unscrupulous persons' incitement, some civil service personnel have failed to perform their duties," he said in a statement. "Effective actions will be taken."

Since the February 1 coup, there has been an outpouring of anger and defiance, calling for the release of Suu Kyi and other detained senior figures of her National League for

Democracy party. Demonstrators again marched peacefully on Thursday in Naypyidaw -the capital and military stronghold - as well as Yangon, the largest city and commercial hub, which saw tens of thousands flood into the streets.

"Don't go to the office," chanted a group of protesters outside Myanmar's central bank in Yangon, part of the effort urging people to boycott work and put pressure on the junta.

"We aren't doing this for a week or a month - we are determined to do this until the end when (Suu Kyi) and President U Win Myint are released," one protesting bank employee told AFP.

Joining the protest were dozens from the ethnic Karen, Rakhine and Kachin communities - drawn from Myanmar's roughly 130 ethnic groups, some of whom have faced intense persecution from the army.

"Our ethnic armed groups and ethnic people have to join together to fight against the military dictatorship," Saw Z Net, an ethnic Karen protester, told AFP. - AFP

MIKE POMPEO OFFERED CUSTOM **CHINA-MADE PENS AS MEMENTOS**

State Mike Pompeo, a vociferous critic of Beijing, offered memento pens that were made in China at dinners where he controversially entertained conservative guests, a watchdog said Thursday.

The group Citizens for Responsibility and Ethics in Washington released records it obtained under US freedom of information laws that found that Pompeo's State Department spent at least \$10,433 for 400 custom pens.

The pens were embossed with the "Madison Dinner" logo, referring to gatherings Pompeo held at taxpayers' expense in which he invited prominent Republicans -many of whom could be useful if he pursues a presidential run, as is widely speculated.

In correspondence released by the group, a company representative explains to a State Department employee that the decorated pens "ship from

US: Former US Secretary of China to airport hub in Chicago" and that "we are unable to ship from China facility directly to customer due to customs issues, etc." Pompeo considers his hard line on Beijing a key legacy, tweeting Thursday that the United States "must remain tough on China" after President Joe Biden's first call with his counterpart Xi Jinping. In a speech last year, Pompeo criticized previous administrations' economic and diplomatic engagement of Beijing, warning that China's trade policies "cost American jobs and strike enormous blows to the economies all across America."

The Madison Dinners, named after the US founding father and secretary of state, drew scrutiny as critics said Pompeo was making use of taxpayer resources to further his career.

PAKISTAN'S 'CHARLIE CHAPLIN' **BRINGING LAUGHS TO FRONTIER CITY**

PAKISTAN: Wearing a bowler hat and familiar toothbrush moustache, Pakistan's Usman Khan darts through traffic swinging a cane, teasing motorists and shopkeepers for laughs and a few rupees with a Charlie Chaplin impersonation that has become a viral sensation.

The 32-year-old actor in bustling Peshawar hopes the silent film antics of old will bring a bit of joy to the residents of the notoriously chaotic frontier city.

Khan said the idea to impersonate Chaplin's iconic character from "The Tramp" came to him as he watched a video of the legendary silent film actor while recovering from an illness. "I thought that I should start acting like Charlie and spread happiness among the people, to take their minds off the coronavirus pandemic," Khan told AFP. Dressed as Chaplin, Khan leaps into passing rickshaws, annoys local shopkeepers, and occasionally swats onlookers with his cane as he shuffles bow-legged across the city, where he is frequently mobbed by fans asking for selfies.

"It is my purpose to make people laugh, to make them happy, to help them get rid of their grief," said Khan. The act has proven to be a hit. In just two months, Khan has attracted more than 850,000 followers and garnered millions of likes on TikTok -- the hugely popular platform in Pakistan where he uploads videos of his slapstick routine.

But it hasn't always been all laughs for Khan, who like many in Pakistan is struggling to hold down a full-time job amid the economic fallout of the coronavirus epidemic. The Chaplin shtick, he said, has given him a new purpose. "That's why I like to get up like Charlie Chaplin, to hide all my worries and grief." - AFP

FRENCH NUN, EUROPE'S OLDEST **PERSON SURVIVES COVID-19**

FRANCE: Europe's oldest person, French nun Sister Andre, turns 117 on Thursday after surviving Covid-19 last month and living through two world wars, with a special birthday feast including her favourite dessert -- Baked Alaska.

Born Lucile Randon on February 11, 1904, Sister Andre said she didn't realise she had caught the coronavirus, which infected 81 residents of her retirement home in the southeast city of Toulon, killing 10 of

"I'm told that I got it," the nun told AFP ahead of her birthday. "I was very tired, it's true, but I didn't realise it."

But David Tavella, spokesman for the Sainte-Catherine-Laboure nursing home, said sh had "experienced a triple confinement: in her wheelchair, in her room and without a visit".

"So her birthday, it reinvigorates us," he added, following the deadly outbreak. Sister Andre said she was not going

to do anything special for her 117th birthday but the home is planning a celebration for her.

There will be a special mass at the home, which has a dozen nuns, and the chef is preparing a birthday feast of foie gras, capon fillet with porcini mushrooms and Sister Andre's favourite dessert: baked Alaska, washed down with a glass of

She says her favourite food is lobster and she enjoys a glass of wine. Born in Ales in a Protestant family, she grew up as the only girl among three brothers.

One of her fondest memories was the return of two of her brothers at the end of World War I.

She is the second-oldest living person in the world, according to the Gerontology Research Group, after Japanese woman Kane Tanaka, who is 118. Asked what she would say to young people, Sister Andre said: "Be brave and show compassion." - AFP

MEGHAN MARKLE WINS PRIVACY CLAIM

UK: Meghan Markle on Thursday won her high-profile privacy claim against a British newspaper group for publishing a private letter that she wrote to her estranged father.

The Duchess of Sussex, who is married to Queen Elizabeth II's grandson Prince Harry, brought the case against Associated Newspapers after extracts of the 2018 letter appeared in

Judge Mark Warby ruled that Meghan had a "reasonable expectation that the contents of the letter would remain pri-

The letter to Thomas Markle was written a few months after Meghan married Harry, and asked her father to stop talking to tabloids and making false claims about her in interviews.

The judge called it "a personal and private letter" about Meghan's own behaviour, her feelings of anguish about her father's behaviour -- as she saw it -- and the resulting rift".

The newspaper group's defence team argued the publication was to correct inaccuracies in a previous article in the US magazine People.

But the judge said the extracts published were "manifestly excessive and hence

unlawful". Meghan, 39, welcomed the

ruling, and thanked the court for holding Associated to account for what she said were "illegal and dehumanising prac-She accused the Mail on Sun-

day weekly, its daily sister title the Daily Mail and the MailOnline website of exploiting individuals like "a game". "For me and so many others,

it's real life, real relationships and very real sadness. The damage they have done and continue to do runs deep," she added. "The world needs reliable, fact-checked, high-quality news.

What the Mail On Sunday and its partner publications do is the opposite." Lawyer Mark Stephens, who specialises in reputation management, told AFP that "this is

a very big win for the Duchess of Sussex". Meghan and Harry quit frontline royal duties in March last

year and now live in California.

They have launched a number of legal cases against news outlets alleging invasion of privacy, including over paparazzi shots of their son Archie.

This has attracted criticism from some, as the couple are also launching themselves into the public eye with high-profile projects such as a Spotify podcast in which Archie made a brief appearance. - AFP

BELARUS: Belarus President Alexander Lukashenko said Thursday his country had defeated foreign attempts to overthrow his government and showed no signs of heeding the embattled opposition's calls for him to resign.

In a defiant address to loyalists, Europe's longest serving leader pushed back a timeline to introduce constitutional reforms that he had promised in the wake of mass protests against his decades-long rule that erupted last summer.

During the wave of demonstrations Lukashenko, 66, claimed the protesters had been incited by foreign governments to orchestrate his ouster, but on Thursday he said Belarus had successfully fended off the attacks.

"The blitzkrieg did not succeed. We held on to our country," Lukashenko said, using language especially resonant in a country that suffered huge losses at the hands of Nazi forces in

World War II. "Despite the tensions in society artificially created by external forces, we survived,' Lukashenko told hundreds of delegates on the first day of the All-Belarusian People's Assembly. "We have to resist at all costs. And 2021, this year, will be decisive."

Belarus's opposition, whose leaders including Svetlana Tikhanovskaya and Maria Kolesnikova have either been jailed or forced into exile in neighbouring EU countries, dismissed the assembly as a piece of political theatre.

The protests that broke out in August were the most serious threat to Lukashenko's rule since coming to power in the ex-Soviet country

Tens of thousands took the streets across the country to demand his resignation after he claimed to have won a sixth Presidential term in an August vote opponents said were rigged.

The authorities unleashed a violent crackdown on protesters, detaining thousands, many of whom reported torture and abuse in custody. Several people died in the unrest.

Lukashenko in November promised to change the Constitution to calm the protests, just weeks after he was shown during a demonstration brandishing a Kalashnikov assault rifle and referring to protesters as "rats."

Lukashenko reiterated Thursday authorities would draft a new constitution this year and put the changes to a popular vote in the beginning of 2021. - AFP

WHO warns against virus complacency

DENMARK: The World Health Organization (WHO) warned Europe against rash reopenings on Thursday despite a fall in new Covid-19 cases and Germany announced a partial border closure, reminders of the long battle ahead before vaccines can tame the pandemic.

Mass COVID-19 vaccination programmes are being ramped up in many countries in the race against more contagious variants, and governments are urging populations to continue to cope with closures as the inoculation campaigns move ahead.

But while new cases and deaths have come down in some places, a WHO official said it was by no means time to ease up.

"The decline in cases conceals increasing numbers of outbreaks and community spread involving variants of concern," said WHO Europe Director Hans Kluge.

"At this point, the overwhelming majority of European countries remain vulnerable," he added, pointing out the "thin line between the hope of a vaccine and a false sense of security".

More than a million cases are registered every week across the 53 member states in the UN agency's European region, which includes several in Central Asia.

But the number of reported cases has been falling over the past four weeks and deaths have also been declining over the past two weeks. Worldwide deaths have meanwhile climbed to nearly

2.4 million, with the United States the hardest-hit, while the Middle East surpassed 100,000 fatalities on Thurs-

Germany said on Thursday it will ban travel from Czech border regions as well as Austria's Tyrol due to concern over new variants.

The AstraZeneca shot forms the bulk of doses being rolled out around the world -- especially in poorer coun-

tries -- under the Covax programme. WHO expert Alejandro Cravioti said the organisation was awaiting more specific data on the vaccine's efficacy in over-65s, but it "would not be appropriate" to wait with "thousands of people dying". WHO said deaths from

COVID-19 in Africa surged by 40 percent over the last month, as the continent's toll approaches 100,000.

Two African nations announced deliveries of China's Sinopharm vaccine, including Equatorial Guinea, which said Beijing had donated 100,000 doses.

Zimbabwe will receive 800,000 doses by the start of March, with China donating a quarter and the government paying for the rest. Instagram blocked Robert F. Kennedy Jr -- nephew of assassinated US president John F Kennedy - for spreading misinformation about the virus and vaccines. - AFP

NEW YORK POLICE REMOVE BARRIERS FROM TRUMP TOWER

US: New Yorkers walking down Fifth Avenue in recent years have become used to navigating security barriers outside Trump Tower. Now, there's more space on the sidewalk.

The barricades that went up after Donald Trump won the presidential election in November 2016 have been removed, New York police confirmed on Thursday.

Police had already reduced their presence around Trump's New York home, located between 56th and 57th street, following President Joe Biden's inauguration on January 20.

Last Friday, "In partnership with the US Secret Service, the decision was made to remove the barriers around Trump Tower," an NYPD spokesman told AFP. Since leaving the White House, Trump has moved to his resort at Mar-a-Lago in Florida, which he made his official residence at the end of 2019.

But his company the Trump Organization, which is headed by his two sons, Donald Trump Jr. and Eric Trump, remains based in the 58-story skyscraper near Central Park.

The spokesman would not say what security has been left in place to protect the Tower or when members of the Trump family visit.

"The NYPD does not discuss security measures" he said. Trump Tower has been the site of many anti-Trump protests over the past four years.

Last summer, New York Mayor Bill de Blasio, a Democrat, took great joy in joining with activists to paint a giant Black Lives Matter slogan outside the tower. -AFP

RUSSIA SAYS NORWAY BECOMING 'PARADE-GROUND' FOR NATO

RUSSIA: Russia on Thursday claimed Norway was becoming the site of a military build-up on its frontiers ahead of the arrival this month of US bombers for exercises.

'We certainly can't talk of calm when tensions are rising on Russia's borders and a powerful parade-ground is forming for military operations against our country" Foreign Ministry spokeswoman Maria Zakharova told reporters in Mos-

American B-1B strategic bombers are expected this month at Norway's Orland airbase for joint training with the country's air force, which guards the NATO alliance's northern flank.

Zakharova claimed the Norwegian-US tion was "the latest in a series of similar events", highlighting the "permanent" presence of "American, British and Dutch" marines in northern Norway. She also noted a "port for maintaining American nuclear submarines" near Tromso.

"Such activities by Oslo threaten regional security and end the Norwegian tradition of not allowing foreign military bases on its territory in peacetime," Zakharova said.

Europe's far north has in recent years seen levels of military activity unprecedented since the Cold War, as tensions grow between Russia and

A US aircraft carrier was in 2018 sent to Norway for the first time since the 1980s, while the following year surface combat ships entered the Barents Sea in Russia's exclusive economic zone.

Norway's neighbour Sweden has announced a massive increase in military spending, even though it does not itself belong to NATO.

Moscow itself has announced that it will build new bases and has deployed military units further and further afield, as melting ice increasingly opens the Arctic to navigation.




SAUDI FEMALE ACTIVIST'S FAMILY **CREDITS BIDEN FOR RELEASE**

SAUDI ARABIA: The family of Saudi activist Louiain al-Hathloul said Thursday US President Joe Biden's election win helped secure her release after nearly three years' imprisonment, but cautioned she was still far from free.

Hathloul, 31, was provisionally released in Saudi Arabia on Wednesday.

She had been detained in May 2018 with about a dozen other women activists, just weeks before the kingdom's historic lifting of a decades-long ban on female drivers - a reform they had long campaigned for.

"I would say thank you Mr President

Alia al-Hathloul told a virtual press confer-

"It's a fact that Loujain was imprisoned during the previous administration, and she was released a few days after Biden's arrival to power.

"Biden's arrival helped and contributed a lot in my sister's release."

Biden, inaugurated last month, has pledged to intensify scrutiny of powerful Saudi Crown Prince Mohammed bin Salman's human rights record after the kingdom received something of a free pass under his predecessor, president Donald

Saudi Arabia, which has detained hundreds of activists, clerics as well as royal family members, abruptly accelerated some political trials - including that of Hathloul -- after Biden's election win late

On Wednesday, Biden welcomed the decision to release her, saying it was "the right thing to do".

The US State Department said the activist should never have been jailed.

The release of Hathloul, who is still under probation and is barred from leaving Saudi Arabia, came after her siblings launched a vigorous campaign overseas for her freedom in a major embarrassment for the kingdom.

The siblings posted pictures on Twitter of the smiling activist, who appeared physically weaker and had streaks of grey hair.

When asked what was the first thing her sister did upon her release, Alia said she "bought an ice-cream", a joy denied to her

In their first post-release video call with the activist on Wednesday, her other sister Lina al-Hathloul said they could not "trust her smile".

"We asked her 'when you were in prison, you said you were fine," said Lina. "She said 'what did you want me to do?... An electric (stun gun was) on my ear... They (prison authorities) were ready to electrocute me'." - AFP

TRUMP IS OFF TWITTER PLATFORM FOR GOOD - TWITTER CFO

US: Twitter will not allow former President Donald Trump back on the platform even if he runs for office again, the company's chief financial officer said.

'The way our policies work, when you're removed from the platform, you're removed from the platform, whether you're a commentator, a CFO or a current or former public official," Twitter Chief Financial Officer (CFO) Ned Segal said in an interview with television network CNBC.

Trump's "de-platforming" by Twitter came after a violent uprising by his supporters leading to a deadly siege at the US Capitol on January 6. Facebook and other social networks also banned Trump after the incident.

"Our policies are designed to ensure that people are not inciting violence," Segal said.

"And if anybody does that we would have to remove them from the service and our policies don't allow people to come back."

Trump was a prolific user of



Twitter during his campaign and in his four years at the White House, using the platform for policy announcements, to settle

scores and for his political campaign. He had more than 80 million followers when his account was suspended. - AFP

AT LEAST FIVE DEAD IN 100-CAR PILEUP ON ICY TEXAS FREEWAY

US: At least five people were killed and dozens more injured Thursday when about 100 cars crashed in a pileup on an icy freeway in Texas, authorities and a witness said.

The incident unfolded on a busy interstate road north of downtown Fort Worth, authorities said, when approximately 100 vehicles smashed into each other. Fort Worth Fire Department spokesman Michael Drivdahl told a news conference the crash was likely caused by icy conditions. Drivdahl said five people had died and 36 people were taken to local hospitals. He warned the toll could rise as rescue workers were still going through vehicles. Jason McLaughlin, a professional storm chaser, posted a video on Twitter he'd filmed at the scene showing dozens of mangled cars and trucks.

He wrote that "100+" vehicles were involved. "It's still chaos," McLaughlin told The Weather Channel.

"It looks like a couple of vehicles lost control and when that happened, everything just piled up behind them."

The National Weather Service warned of continued freezing rain and sleet in the area, making for ongoing treacherous driving conditions. - AFP

Some sportsmen are blessed with natural talent from birth in certain sporting disciplines. When they mature, they tend to move into various other sports with the influence of either their family or friends. Sri Lankan Olympic stars of yesteryear

Alexander Obeyesekere won many hearts at 1948 London Games

Alexander Indrajit Obeyesekere was born on March 9, 1918 to a boxing family. His father, Donald Obeyesekere who followed boxing at the Cambridge University in 1898, pioneered the introduction of boxing to Sri Lanka and is known as the 'father of boxing' in this country.

In addition, Alexander's brother, Danton Obeyesekere won several National Boxing Championships and also served as a judge at the London Olympic Games in 1948.

Alexander took to boxing at the age of 10 under the guidance of his father and brother and displayed his talent at test. several Inter-Schools Boxing Meets.

He also played a major role in helping Royal College to clinch the Stubbs Shield Boxing Championships on several occasions.

Alexander won the heavyweight 'B' class at the Stubbs Shield in 1935 and

class title in the following year.

Alexander first participat-Meet in 1939 and won the amateur and the intermediate bouts. As a strong puncher, he defeated the more fancied Sally of the CLI to win the lightweight class.

In 1941, he won the welterweight class and received his colours for boxing while winning his bout at the Layton Cup and Clifford Cup Meets. He also went on to clinch the Clifford Cup in 1942 after a close con-

Exhibition Boxing Meets were very popular in Ceylon during this era and Alexander had the opportunity of defeating the champion of the British Army in the welterweight class during a similar contest. In 1946, he won the Layton Cup in the welterweight class

took the heavyweight 'A' and the National Championships in the welterweight and middleweight class-

He also defeated Corporal Alfred of ed in the National Boxing the Army in the welterweight class and won the Clifford Cup in 1947. He then had the better of D. M. D. V. Perera of the Railway Department to win the National Championship.

> Alexander won some very close fights against Chris de Saram during the Selection Trials before qualifying to participate at the 1948 London Olym-

> At the Olympics, Alexander cleared his first hurdle successfully while overcoming his opponent G. P. Turkey of Pakistan quite convincingly.

However, his hopes were shattered when he was knocked-out by Z. Kula of Poland during the second-round competition. Despite that setback, Alexander kept his momentum in the local boxing scene and defeated young Vincent Perera in the second-round of the

1949 National Boxing Championships. Thereafter, he was selected to represent the county at the 1950 Empire Games in Auckland, New Zealand mainly because of his unbeaten record in the local boxing scene.

He certainly lived upto expectations and won a Bronze Medal for Sri Lanka while coming in third in the welterweight class category.

He later joined the CR and FC and represented the club in several local and international encounters. Alexander was also known as the 'Black Wolf' in the field of boxing and earned a great amount of respect from the Englishmen for his unique style which had the capacity to draw and retain the attention of the onlookers during a

He was also involved as a planter and was a proud father of one daughter and one son. He passed away on April 28, 2002 in Colombo at the age
