ABSTRACTS OF SEASON REPORTS.

ABSTRACTS OF SEASON REPORTS FOR THE MONTH OF MARCH, 1897.

CENTRAL PROVINCE.

NUWARA ELIYA DISTRICT.

Kotmale.—Maha cultivation : reaping continued ; prospects good. The weather was most favourable. Chenas being cleared. The supply of vegetables in the market was good ; fruits were scarce.

Uda Hewaheta.—Maha cultivation : paddy plants two months old. There was rain for about ten days, which was very favourable for the young plants. Kurakkan chenas have been harvested, with satisfactory results.

Walapane : paddy fields for the maha harvest have been sown, and the plants are growing well. There was not sufficient rain during the month. Kurakkan crops are being gathered.

NORTHERN PROVINCE.

MULLAITTIVU DISTRICT.

Weather : there were a few showers of rain during the month. The days were hot, and there was heavy dew at night.

Crops : paddy is being reaped and stacked throughout the district. Kurakkan and varaku are being reaped.

Agricultural operations : 30 bushels of paddy have been sown for idaippokam in Melpattu north.

General health : fever has prevailed in some divisions.

Cattle are healthy except those in a village called Udaiyar Samalankulam in Melpattu north, where murrain has broken out.

Prices of grain : paddy, Re. 1.25 per bushel ; rice, Rs. 3 per bushel ; kurakkan, 75 cents per bushel ; varaku, 62½ cents per bushel ; ellu, Rs. 4 per bushel ; kollu, Rs. 2.50 per bushel ; uluntu, Rs. 4 per bushel ; payaru, Rs. 4.50 per bushel.

RENT SALES.

NOTICE is hereby given that sealed tenders for the purchase of the under-mentioned Arrack Rent of the North-Western Province from July 1, 1897, to June 30, 1898, will be received by the Government Agent, Kurunegala, and the Assistant Government Agents at Puttalam and Chilaw :—

Puttalam and Kalpitiya.

The tenders, which must be in sealed envelopes superscribed "Tender for Arrack Rent," will be received at the Kurunegala, Puttalam, and Chilaw Kachcheries until 1 o'clock on Monday, May 3, 1897, when they will be opened. All persons making tenders must be present. In the absence of any tenderer no notice will be taken of his tender.

The person whose tender is selected by the Government Agent for submission to the Governor—should any be so selected—will be required to deposit at once one-tenth of the purchase amount in cash ; and should the tender be accepted by His Excellency the Governor, to furnish approved security for one-half of the whole purchase amount, or in cash for one-third of the whole purchase amount, within thirty days of the date of the receipt by him of the notification of the Governor's acceptance of his offer.

No title deeds will be accepted as security without a letter signed by the owner stating his willingness to hypothecate the same as security.

All title deeds tendered as security should be accompanied by a certificate obtained from the Registrar of Lands that the land to which they refer is unencumbered. This certificate must be obtained at the cost of the party offering security.

After the completion of the securities the 10 per cent. deposit referred to shall remain with the Government Agent, and shall be taken and applied in part payment of the last instalment and in part of the eleventh instalment, so far as the said 10 per cent. deposit extends.

Licenses to sell arrack wholesale from the storehouses shall be subject to a stamp duty of Rs. 100 each as required by the Ordinance.
