### THE REVENUE PROTECTION ORDINANCE

#### ORDER

WHEREAS the Cabinet has during the present session of Parliament approved of the introduction into the House of Representatives of a resolution whereby, if such resolution be carried, the export duties payable on the goods specified in column I of the Schedule hereto will be altered :

Now, therefore, in pursuance of the powers vested in me by section 2 of the Revenue Protection Ordinance (Chapter 191), read with the Proclamation under section 88 of the Ceylon (Constitution) Order in Council, 1946, published in *Gazette Extraordinary* No. 9,773 of September 24, 1947, I, Stanley de Zoysa, Minister of Finance, do hereby order the Principal Collector of Customs from midnight of 10th/11th July, 1958, to demand and levy on the goods specified in column I of the Schedule hereto (in lieu of the existing export duties payable thereon under the customs Ordinance), the export duties set out in column II of the Schedule, in addition to the export duties payable thereon under any written law other than the Customs Ordinance.
