### PART I: SECTION (I)—GENERAL

#### Price Orders

Food Price Order No. J/6/1958.

#### SUBSIDIARY FOODSTUFFS

#### THE CONTROL OF PRICES ACT No. 29 OF 1950

#### Order

BY virtue of the powers vested in me by section 4 read with section 3 (2) of the Control of Prices Act, No. 29 of 1950, I Chelliah Nitkunanathan, Assistant Controller of Prices (Food), do by this Order—

- (i) revoke with effect from this date my Food Price Order No. J/5/1958, dated 10th June, 1958;
- (ii) fix with immediate effect the prices specified in columns 2 and 3 of the first Schedule hereto to be the maximum wholesale price per cwt. gross and the maximum retail price per pound nett respectively, above which the article specified in the corresponding entry in column 1 of the same schedule shall not be sold within the Divisional Revenue Officer's Division of Jaffna (which includes the Municipal limits of Jaffna also);
- (iii) fix with immediate effect the prices which are for the time being fixed by me as the maximum wholesale price per cwt. gross and the maximum retail price per pound nett, for the Divisional Revenue Officer's Division of Jaffna (which includes the Municipal limits of Jaffna also); increased by the amounts specified in columns 2 and 3 of the second Schedule hereto to be respectively the maximum wholesale price per cwt. gross and the maximum retail price per pound nett above which the articles specified in column 1 of the first Schedule hereto shall not be sold within the areas specified in the corresponding entries in column 1 of the second Schedule hereto;
- (iv) direct that for the purpose of this Order—
  - (a) any sale of any quantity of any article for the purpose of re-sale or any sale of any article in a quantity of 28 pounds or more at a time shall be deemed to be a sale by wholesale;
  - (b) any sale of any quantity less than 28 pounds of any article for the purpose of consumption or use shall be deemed to be a sale by retail;
  - (c) a "wholesale dealer" in any article shall mean a person who is in the habit of selling by wholesale articles of the same description as that article;
  - (d) the "maximum wholesale price per cwt. gross" fixed for sales within the Divisional Revenue Officer's Division of Jaffna (which includes the Municipal limits of Jaffna also), shall apply to all sales by wholesale in whole bags;
  - (e) the "maximum retail price per pound nett" fixed for sale within the Divisional Revenue Officer's Division of Jaffna (which includes the Municipal Limits of Jaffna also), shall apply to all sales by retail;
  - (f) a "whole bag" shall mean a bag or bundle filled with any commodity or article;
- (v) direct that in every area where maximum prices are fixed by this order, no person shall sell any article specified in column 1 of the first Schedule hereto which is adulterated with any other article;
- (vi) direct that in every area where maximum prices are fixed by this order, every trader who has any article specified in column 1 of the first Schedule hereto, in his possession or under his control at any place or in any vehicle shall exhibit conspicuously at that place or on that vehicle a notice in which there shall be set out the maximum prices for such article specified in column 1 of the first Schedule fixed by this Order in that area;
- (vii) direct that in every area where maximum prices are fixed by this Order, every person who sells any article specified in column 1 of the first Schedule by wholesale shall, and every person who sells any article specified in column 1 of the same

schedule by retail shall, on demand, give the purchaser thereof a receipt in which there shall be set out—

- (a) the date of sale;
- (b) the quantity of such article sold (by weight);
- (c) the prices paid for the quantity sold; and
- (d) the nature of the transaction, that is to say whether the sale was by wholesale or by retail;

(viii) direct that the maximum wholesale and the maximum retail prices referred to in

columns 2 and 3 of the Schedules hereto shall include the price of wrapper, if any, in which such article is sold;

(ix) direct that for the purpose of this Order "hundred weight" or "Cwt." shall be deemed to be the standard hundred weight avoirdupois weight and "pound" or "lb." shall be deemed to be the standard pound avoirdupois weight.

**Order**

BY virtue of the powers vested in the Controller of Prices (Food), by section 4 read with section 3 (2) of the Control of Prices Act, No. 29 of 1950, I, Sellappah Sinnathambe, Assistant Controller of Prices (Food), for Vavuniya District, do by this order—

- (i) revoke with effect from this date Food Price Order No. V. 47 dated 25th June, 1958, published in the *Ceylon Government Gazette Extraordinary* No. 11,373 of 25th June, 1958, in so far as it relates to maximum Wholesale Price the wholesale dealer's maximum, wholesale price and the retail dealer's maximum retail price mentioned in column 2 to 5 of the schedule thereto of Masoor Dhal, Oorid (whole), Gram Dhal and Potatoes mentioned in column 1 of that schedule.

- (ii) fix with immediate effect the prices specified in column 2 to 5 of the schedule hereto to be a wholesale dealer's maximum wholesale price per hundred weight gross, a retail dealer's maximum retail price per pound nett to a consumer, above which the articles specified in the corresponding entry in column 1 of the schedule shall not be sold within the limits of Vavuniya District;

- (iii) direct that paragraphs (III) to (VIII) of the Food Price Order No. V. 47 of 25.6.58 relating to Subsidiary Foodstuffs published in *Ceylon Government Gazette Extraordinary* No. 11,373 of 25th June, 1958, shall apply in the case of articles mentioned in column 1 of the schedule hereto as though those paragraphs were incorporated in this order.

**Order**

BY virtue of the powers vested in me by section 4 read with section 3 (2) of the Control of Prices Act, No. 29 of 1950, I, Charles Samson Ranasooriya, Assistant Controller of Prices (Food), Matara District, do by this order—

- (i) Revoke with effect from this date Food Price Order No. MT5/58 dated June 6, 1958, published in *Ceylon Government Gazette Extraordinary* No. 11,354 of June 11, 1958, in so far as it relates to wholesale dealer's maximum wholesale price and the retail dealer's maximum retail price mentioned in columns 2 to 14 respectively of the first and second Schedules thereto of Oorid (whole), Gram Dhal, Masoor Dhal and Potatoes specified at the heads of columns 7, 8, 9 and 11 of those schedules.

- (ii) fix with immediate effect the prices specified in columns 2 to 5 of the first and second

schedules hereto to be the wholesale dealer's maximum wholesale price per hundredweight gross and the retail dealer's maximum retail price per pound nett respectively above which the articles specified at the heads of columns 2 to 5 of the schedules hereto shall not be sold within the areas specified in column 1 of the same schedules.

- (iii) direct that paragraphs (iii) to (viii) of Food Price Order No. MT5/58 of June 6, 1958, relating to Subsidiary Foodstuffs published in *Ceylon Government Gazette Extraordinary* No. 11,354 of June 11, 1958, shall apply in the case of articles mentioned in columns 2 to 5 of the first and second schedules hereto as though those paragraphs were incorporated in this order.
