G. G. O. No. N. 87/59.

Greetings :

WHEREAS it appears to me to be necessary to appoint a Commission for the purposes hereinafter mentioned :

Now, therefore, I, Oliver Ernest Goonetilleke, Governor-General, reposing great trust and confidence in your prudence, ability and fidelity, do in pursuance of the provisions of section 2 of the Commissions of Inquiry Act, No. 17 of 1948, by these presents appoint you, the said Sir Edward George Perera Jayetileke, Ronald Charles Bainbridge, Esquire, Hubert Richmond Kemp, Esquire, Masao Oyama, Esquire, and Nanayakkarapathirage Solomon Perera, Esquire, to be my Commissioners for the following purposes :—

- (1) to examine the manner in which Shipping Lines registered in Ceylon have conducted their business, with reference particularly to—
  - (a) efficiency of operation, including management, financing, booking freight and chartering of vessels, building up of reserves, and acquisition of ships,
  - (b) discharge of obligations to shareholders,
  - (c) discharge of any obligations undertaken to the Government of Ceylon; and

(2) to make recommendations for the development of Ceylon shipping with special reference to—

- (a) management of shipping business, including the securing of foreign expertise and the training of Ceylonese personnel,
- (b) financing,
- (c) procurement of ships,
- (d) chartering of ships,
- (e) the roles which the public and private sectors may most suitably play in the development of Ceylon shipping,
- (f) the contribution which may best be made to such development by the shipping lines already registered,
- (g) the manner in which the carriage by sea of Government cargoes may best be provided for with a view to assisting the development of Ceylon shipping, while ensuring that the rates of payment are reasonable, and
- (h) the Governmental machinery necessary to ensure implementation of the Government's policy in regard to such development :

And I do hereby appoint you, the said Sir Edward George Perera Jayetileke, to be the Chairman of the said Commission :

And I do hereby authorise and empower you, the said Commissioners, to hold all such inquiries and make all such investigations into the aforesaid matters as may appear to you to be necessary, and require you to transmit to me, as early as possible, a report thereon under your hands :

And I do hereby direct that such part of any inquiry relating to the aforesaid matters as you may in your discretion determine shall not be held in public :

And I do hereby require and direct all public officers and other persons, to whom you may apply for assistance or information for the purposes of your inquiries and investigations, to render all such assistance and furnish all such information as may properly be rendered and furnished in that behalf.
