BY virtue of the powers vested in me by subsection (1) of section 2 of the State Industrial Corporations Act, No. 49 of 1957, I, Peduru Hewa William de Silva, Minister of Industries and Fisheries, do by this Order, with the approval of the Government—

(1) specify the industrial undertaking previously carried on by the corporation known

as "Ceylon Oils and Fats", which was established under the Government Sponsored Corporations Act, No. 19 of 1955, and was subsequently dissolved, and constituted for the purposes specified in the First Schedule hereto, as the industrial undertaking to which this Order relates;

- (2) declare that a corporation shall be established for the purpose of taking over and carrying on the aforesaid industrial undertaking;
- (3) assign the corporate name 'Ceylon Oils and Fats Corporation ' to the corporation;
