THE CONTROL OF PRICES ACT, No. 29 OF 1950

Order

BY virtue of the powers vested in me by section 4, read with section 3 (2) of the Control of Prices Act, No. 29 of 1950, I Arthur Cuthbert Bartholomeusz, Assistant Controller of Prices (Food) for the Nuwara Eliya District, do by this Order—

- (i) revoke with effect from this date my Food Price Order N/E 36 dated June 7th, 1958 published in Ceylon Government Gazette Extraordinary Nos. 11,352 of 9th June, 1958 and 11,359 of 13th June, 1958 in so far as it relates to the Wholesale Dealer's Maximum Wholesale Price and Retail Dealer's Maximum Retail Price in respect of Masoor Dhal, Oorid (Whole), Gram Dhal and Potatoes.
- (ii) fix with immediate effect the prices specified in columns 2, 3, 4 and 5 of Schedules "A" and "B" hereto be the maximum

wholesale price per hundred-weight gross and maximum retail price per pound nett respectively, above which the articles specified in the corresponding entry in columns 2, 3, 4 and 5 of the Schedules "A" and "B" shall not be sold within the areas mentioned in the corresponding entry in column 1 of the Schedules "A" and "B" hereto.

(iii) direct that paragraphs 4 to 10 of Food Price Order N/E 36 dated 7th June, 1958 relating to Subsidiary Foodstuffs published in Ceylon Government Gazette Extraordinary Nos. 11,352 of 9th June, 1958, and 11,359 of 13th June, 1958, shall apply in the case of articles mentioned in columns 2, 3, 4 and 5 of Schedules "A" "B" hereto as though those paragraphs were incorporated in this Order.
