PART I: SECTION (I)—GENERAL

Food Price Order No. C 275.

SUBSIDIARY FOODSTUFFS.

THE CONTROL OF PRICES ACT, No. 29 OF 1950

Order

BY virtue of the powers vested in the Controller of Prices (Food) by section 4 of the Control of Prices Act, No. 29 of 1950, I, Kotuwe Muhandiram Dharmasena Jayanetti, Controller of Prices (Food), do by this Order—

- (i) revoke with effect from this date the Food Price Orders mentioned below ;
 - (a) Food Price Order No. C 269 dated May 30, 1958, and published in the *Ceylon Government Gazette Extraordinary* No. 11,332, dated May 31, 1958.
 - (b) Food Price Order No. C 273 dated July 3, 1958, and published in the *Government Gazette Extraordinary* No. 11,411, dated July 4, 1958.
- (ii) fix with immediate effect the prices specified in columns 2, 3 and 4 of the Schedule hereto to be an importer's maximum wholesale price per cwt. gross, a wholesale dealer's maximum wholesale price per cwt. gross, a retail dealer's maximum retail price per lb. nett to a consumer, respectively, above which the articles specified in the corresponding entry in column 1 of the Schedule shall not be sold within the Municipal limits of the Town of Colombo ;
- (iii) direct that for the purpose of this Order—
 - (a) any sale of any quantity of an article specified in column 1 of the Schedule for the purpose of resale of any sale of an article specified in column 1 of the Schedule in a quantity of one hundredweight gross or more at a time shall be deemed to be a sale by wholesale ;
 - (b) any sale of any quantity of an article specified in column 1 of the Schedule, less than one hundredweight gross for the purpose of consumption or use shall be deemed to be a sale by retail ;
- (iv) direct that in every area where maximum prices are fixed by this Order, no person shall sell any article specified in column 1 of the Schedule which is adulterated with any other article ;
- (v) direct that in every area where maximum prices are fixed by this Order, every trader, who has any article specified in column 1 of the Schedule in his possession or under his control at any place or in any vehicle, shall exhibit conspicuously at that place or on that vehicle a notice in which there shall be set out the maximum prices for such article specified in column 1 of the Schedule fixed by this Order, in that area ;
- (vi) direct that for the purpose of this Order, "pound" or "lb", shall be deemed to be the standard pound avoirdupois weight ;
- (vii) direct that in every area where maximum prices are fixed by this Order, every person who sells any article specified in column 1 of the Schedule by wholesale shall, and every person who sells any article specified in column 1 of the Schedule by retail shall, on demand, give the purchaser thereof a receipt in which there shall be set out—
 - (a) the date of the sale ;
 - (b) the quantity of such article sold (by weight) ;
 - (c) the price paid for the quantity sold ; and
 - (d) the nature of the transaction, that is to say, whether the sale was by wholesale or by retail ;
- (viii) direct that when any article specified in column 1 of the Schedule is sold, the maximum prices referred to in columns 2, 3 and 4 of that Schedule shall include the price of wrapper or container, if any, in which such article is sold.

THE CONTROL OF PRICES ACT, No. 29 OF 1950

Order

BY virtue of the powers vested in the Controller of Prices (Food), by section 4 read with section 3 (2) of the Control of Prices Act, No. 29 of 1950, I, Sellappah Sinnatambe, Assistant Controller of Prices (Food), for Vavuniya District, do by this order—

1. revoke with effect from this date my Food Price Order No. V. 48 dated July 17, 1958, published in the *Ceylon Government Gazette Extraordinary* No. 11,432 of 19. 7. 58, in so far as it relates to maximum wholesale price, the wholesale dealer's maximum wholesale price and the

retail dealer's maximum retail price mentioned in columns 2 to 5 of the Schedule thereto of Masoor Dhal, Oorid (whole), and Gram Dhal mentioned in column 1 of that Schedule;

2. fix with immediate effect the prices specified in columns 2 to 5 of the Schedule hereto to be a wholesale dealer's maximum wholesale price per hundredweight gross, a retail dealer's maximum retail price per pound nett to a consumer, above which the articles specified in the corresponding entry in column 1 of the Schedule shall not be sold within the limits of Vavuniya District.
