#### Government Notifications

##### THE QUARANTINE AND PREVENTION OF DISEASES ORDINANCE

BY virtue of the powers vested in me by regulation 1 of the regulations made under sections 2 and 3 of the Quarantine and Prevention of Diseases Ordinance (Chapter 173), published in the *Supplement to Gazette* No. 7,481 of August 28, 1925, as modified by the Proclamation published in *Gazette Extraordinary* No. 9,773 of September 24, 1947, I, Vimala Wijewardene, Minister of Health, do by this notification, confirm the declaration of the "diseased locality" specified in the Schedule hereto, made by the Superintendent of Health Services, Jaffna, the proper authority in that behalf, on August 9, 1958.

All that area contained within the limits of Village Committee areas of Naranthanai and Velanai and Town Council areas of Kayts in the Island's Division of Jaffna District in the Northern Province.

#### PROCLAMATION

WHEREAS cases of Small Pox have occurred within the limits of Layden Island in the District of Jaffna, Northern Province, I, Gunaratnam Jeremiah, Superintendent, Health Services, Jaffna, the proper authority in terms of regulation framed under the Quarantine and Prevention of Disease Ordinance (Chapter 173), and published in the *Gazette* of August 28, 1925, as modified by the proclamation in *Government Gazette* No. 10,713 of September 17, 1954, do hereby declare the area described in the following Schedule as a diseased locality.

2. This proclamation takes effect from 12 noon this Sixteenth day of August, 1958, and shall continue to be in force until rescinded.

3. All persons going into or leaving any part of the said infected area shall subject himself or herself to satisfactory vaccination at the spot or shall display signs of having been vaccinated within a period of three months from this date.
