# VOLUNTARY ARBITRATION BETWEEN MESSRS. ROWLANDS, LTD., AND THE CEYLON MERCANTILE UNION. 29th JULY, 1958

After discussion, the parties informed me that the matter is settled and the following is the settlement :----

1. The Company's view of the state of affairs during the period, June 27 to July 3, 1957, when there was a go-slow on the part of the monthly paid staff of the Company who are members of the Union, is that the said staff are not entitled to be paid for the said period and, as a matter of principle, should not in fact be paid.

2. The Union while disputing some of the facts in respect of the said period of time, namely June 27 to July 3, 1957, agrees that there is justification for the Company's action in regard to June 28.

3. The Union, in the interests of a settlement, agrees to a token cut of one day's pay. And the Company likewise in the interests of a settlement agrees to restrict the cut of pay to one day's pay from the said monthly staff.
