The Award

This is an award under section 17 of the Industrial Disputes Act, No. 43 of 1950. It relates to an industrial dispute between the Lanka Estate Workers' Union, 47. Drieberg's Avenne, Colombo 10 (Ihereinafter referred to as the "Union") and the Management of Havelock Tea Estate, Agalawatta (hereinafter referred to as the "Management").

2. By his Order dated 22nd November, 1961, made under section 4 (1) of the aforesaid Act, the Honourable the Minister of Labour and Nationalised Services referred this dispute to me for settlement by arbitration.

- 3. According to the statement of the Acting Commissioner of Labour dated 20th November, 1961, the matter in dispute between the aforesaid parties is "whether the non-employment of P. K. Babun Singho is justified and to what relief he is entitled."
- 4. When the matter was taken up for hearing on 20th January, 1962, at my request the parties discussed ways and means of settling this dispute and arrived at a settlement, the terms of which are as follows:--

"The Management will make an ex-gratia payment of Rs. 125 to P. K. Babun Singho alias Babun Appu. The Union withdraws its application for the re-employment of this labourer. Rs. 125 will be remitted by the Management to the Labour Officer, Matugama, for payment to P. K. Babun Singho alias Babun Appu who has no further claims against the Management. This sum is to be remitted to the Labour Officer, Matugama, on or before 20.2.62. Parties will bear their own costs."

5. The above terms of settlement are fair and equitable. I make award accordingly.

THE AWARD

This award relates to a dispute between the parties above named and is in terms of a settlement that the parties have come to. The dispute was referred to this Tribinal by the Honourabie the Acting Minister of Labour and Nationalised Services, by Order made on 19th September, 1961, under section 4 (1) of the Industrial Disputes Act., No. 48 of 1950, for settlement by arbitration. The matter in dispute specified in the statement of the Acting Commissioner of Dabour which

accompanied the Honourable Minister's Order is whether the non-employment of the employees whose names appear above is justified, and to what relief each of them is entitled.

At the sittings of the Tribunal, which were on the 2nd and 22nd of January, 1962, the employees were represented by Mr. W. M. M. G. Ran Banda whom the employees had nominated as their representative. The Ceylon Tobacco Company was represented by Mr. Lyn Wirasekera of the Employers' Federation of Cey.on on the first day and by Mr. S. B. M. Ranatunga, Personnel Assistant of the company; on the second.

The case for the employees was that they had been working as tobacco curers and the company, having terminated their services, had recruited others in their places. The company's case was that the employees were seasonal workers and their last period of seasonal employment came to an end on 30th June, 1960; there was now no need to employ any corrers as the farmers from whom the company was buying tobacco, having gained experience, were curing tobacco themselves.

The employees also complained about non-payment of over-time and holiday wages and about provident fund contributions, but these matters could not be admitted for adjudication as matters arising out of, or connected with, the matters specified in the statement of the Acting Commissioner of Labour. There was, however, nothing to prevent the parties coming to a settlement in respect of these matters too. The settlement that the parties have come to covers these also and is in the following terms:—

- 1. The company has paid Rs. 750 to each of the 13 employees whose non employment has been the matter in dispute and the employees have accepted the sum as relief in respect of distress consequent to the termination of their employment and payment in satisfaction of all their claims including the claim for provident fund benefits.
- 2. When occasions for the recruitment of labourers for employment at any of the company's leaf depots arise, the company will write to the following employees, who out of the 13 employees whose non employment has been in dispute are willing to accept work as labourers without prejudice to their rights under clause (3) to be considered for employment as watchers, overseers or field instructors, offering them employment as labourers. If any of the employees who are offered such employment accept the employment offered, they will be employed:—
 - 1. W. M. Tikiri Banda,
