PRINCE PHILIP DIES AGED 99




UK: Prince Philip, the longest serving royal consort in British history and a constant presence at Queen Elizabeth II's side for decades, died Friday aged 99, Buckingham Palace announced.

The death of the Duke of Edinburgh is a profound loss for the 94-year-old monarch, who once described him as her "strength and stay all these years".

The outspoken former Navy Commander devoted much of his life as the Queen's husband to charity work -- but was notorious for numerous gaffes, many deemed downright offen-

He was admitted to hospital on February 16, and went home after a month during which he was treated for a pre-existing heart condition and an infection. Announcing his passing, BBC television played the national anthem over a picture of Philip in his prime, dressed in military dress uniform. TO PAGE 02

Drug peddler "Cheeti" arrested

The couple, who celebrated their 73rd wedding anniversary in November, had been living largely in isolation at Windsor Castle, west of London, because their advanced age put them at

heightened risk from COVID-19. Philip and the Queen received their first vaccinations against the virus in January. Philip was born on the island of Corfu with Danish and Greek royal titles.- AFP

and making a false representation.

Oshala Herath had made a written complaint with CID on November 2, 2020 alleging that Parliamentarian Diana Gamage had fraudulently obtained an Official Sri Lankan passport without

disclosing her British citizenship. The CID informed the court that they have already recorded a statement from the complainant in respect of his written complaint and further said his statement was accompanied by supporting documents.

According to the B report, the CID has recorded statements from officials attached to the Department of Immigration and Emigration, Thimbirigasyaya and Dehiwela divisional secretariat offices and relevant Grama Niladhari officers in order to ascertain the authenticity of the documents furnished by the Parliamentarian including her birth certificate.

The CID has sought another date from the Court to report on the progress of the investigation.

The Ministerial Consultative Committee on Defence met under the patronage of President Gotabaya Rajapaksa at the Sri Jayewardenepura Parliamentary Complex on Thursday (08).

This is the inaugural meeting of the Consultative Committee after the election of the current Parliament. The President chaired the meeting in his capacity as the Minister in charge of the subject who is usually the Chairman of the Committee. A number of issues such as National Security, Promotion of Law and Order, Salaries of War Heroes,

Drug eradication and Annual Reports of Institutions under the Ministry of Defence were discussed at the meeting.

Government MPs, Ministers and Opposition MPs were present at the meeting. Parliamentary officials noted that this was the first time in recent times that such a large number of Ministers and Parliamentarians attended the Ministerial Consultative Committee on Defence.

Responding to a proposal made during the exchange of views on drug prevention, the President said that already a new National Policy on Drug Prevention has been formulated. It will be made available to the public soon. The President also pointed out the importance of using religious coun-

selling in the rehabilitation process of drug addicts.

With reference to a question arose on banning books containing ideas of religious extremism, the President said that the decision was not aimed at a specific religion but aimed at eradicating all forms of religious extremism.

The above was mentioned at the COPA Committee chaired by Prof. Tissa Vitharana which was held recently at the Parliament Complex.

According to the report, the Post-Harvest Losses (PHL) on the vegetables and fruits in Sri Lanka is estimated at 30-40 percent.

The report further reveals that about 73% of the adult population of the country do not consume adequate amounts of vegetables and fruits and that the malnutrition level of children under the age of 5

is also approximately around 21%. It was also revealed at the Committee on Public Accounts that Sri Lanka does not have a standard agricultural policy that covers the whole scope pertaining to the agricultural sector.

The fact that the last domestic agricultural policy formulated in 2019 is currently at the draft level and the need for an agricultural policy targeting the local and foreign markets was also brought to the attention of the Committee on Public Accounts.

The aforesaid was brought to light while taking into discussion the audit report regarding the Minimization of PHL of Vegetables and Fruits in Sri Lanka.

Another important area of focus of the Committee members was to establish an expeditious mechanism to prevent the unlimited profits made by middlemen causing a problem for both the local farmer and the consumer, minimizing post-harvest damage to vegetables and fruits in the country and the sale of agricultural products at reasonable

The COPA Committee also pointed out that due to the lack of an extensive cultivation plan covering the island to meet the food demand of Sri Lankans, farmers have resorted to cultivating to their liking thus resulting in over-harvesting of certain crops.

Though the Department of Agriculture is conducting a crop forecasting program every fortnight with a preannouncement pertaining

to the suitable vegetables to be cultivated for the next two weeks at present, it was noted that there was an inadequacy of the measures to resolve the said issue. Thus, the COPA Committee chair Prof. Tissa Vitharana instructed officials to pay further attention towards resolving the matter.

The Committee also paid attention towards obtaining the contribution of the District / Regional Agriculture Committees for this purpose; increasing the participation of agricultural officers engaged in the field of giving basic advice on cultivation plans related to vegetable and fruit cultivation, providing adequate training to a sufficient number of Agricultural Instructors, Agricultural Research and Production Assistants who are directly involved with farmers and farmers, minimizing the damage caused by the use of plastic crates during harvesting and transportation, the use of dehydration methods to reduce food waste, and formulating a proper mechanism to resolve the difference between wholesale prices in economic centers and retail prices in the surrounding area due to transportation costs as well as the large number of intermediaries.

The Committee chaired by Prof. Tissa Vitharana paid special attention to formulating a standard agricultural policy that protects both the farmer and the consumer of Sri Lanka.

The PMRP, its President Louis Benedict and its Joint Secretary Christine Perera filed this petition naming Minister of Health Pavithra Wanniarachchi, State Minister of Pharmaceutical Production, Supply and Regulation, National Medicines Regulatory Authority (NMRA) and its members and several others as respondents.

The Petitioners stated that it is the duty of the state to preserve the life, health and wellbeing of all its citizens. They said NMRA is made up of professionals and has been functioning as an independent body to ensure that efficacious safe and good quality medicine is available to the people.

The Petitioners further said during the pandemic, the NMRA appointed a panel of independent experts to conduct scientific evaluations of all COVID-19 vaccines.

The Petitioners said they got to know from media that a member of the NMRA, the nominee of the Sri Lanka College of Pediatricians has been removed as he had opposed approval being given to use the Chinese Sinopharm vaccine for COVID-19 as there was insufficient data to evaluate its safety.

The petitioners further said as of the time of such removal, the Chinese Sinopharm vaccine had not yet been granted emergency use listing by NMRA and it appeared that no adequate data had been provided by the manufactures of such vaccine regarding its safety and efficacy and details regarding clinical trials. The petitioners said the State Minister had made a fresh appointment to the said post.

However, petitioners said it appears to them that an expert medical panel of the NMRA had been established to consider granting approval to the Chinese Sinopharm vaccine but had not done so due to insufficient data being available to come to a decision on the safety, efficacy and immunogenicity of the Sinopharm vaccine. The petitioners said they are now aware that the several NMRA members have been removed and to date the requisite data to evaluate the safety and efficacy of the Chinese Sinopharm vaccine has not been received. The Petitioners said they believe that such a vaccine has been brought into the country without approval from the relevant experts authorized to do so.

Previously, the Marine environment Protection Authority (MEPA) had sought the Attorney General's advice on taking legal action under the Marine Pollution Prevention Act in connection with the marine pollution caused by the oil spill from the vessel.

The Marine Environment Protection Authority was informed by the Attorney General to go to the location of the vessel and investigate whether the oil spill from the vessel had caused marine pollution in the area. Following that, the report on the

Lankan Port Authority, the Colombo Dockyard, MEPA (Marine Environmental Protection Authority) and the Coast Guard have all calculated the cost of extinguishing the fire that broke out on the vessel. The 20 year old MT New Diamond

crude oil tanker was transporting 270, 000 metric tons of crude oil from the port of Mina Al Ahmadi in Kuwait to the Indian port of Paradip when a fire broke out abroad in the eastern seas of Sri Lankan on September 3.

The vessel was sailing 38 nautical miles off Sangamankanda Point when it caught fire with an explosion in a boiler in the ship's main engine room.

A joint effort by the Sri Lanka Navy, Air Force and Indian Navy succeeded in extinguishing the fire.

The Committee also drew attention towards the Annual Reports of the National Livestock Development Board from 2017 to 2020 not being tabled in Parliament. The Chairman of the Committee pointed out that the inability to table the Annual Reports is a major problem of the institution and directed the secretary to the State Ministry of Livestock and Farm Promotion and Dairy and Eggs Related Industries S. Senaratne to the expedite submission of the pending reports to Parliament.

The Committee stated that 166 vacancies had been vacant for some time and that action should be taken to fill those vacancies expeditiously. The Committee also expressed its dissatisfaction with the fact that several executive posts have been vacant for several years. The Committee observed that the Board did not have a Legal Officer and said that it was appropriate to create a new post and recruit a Legal Officer.

It was revealed at the committee meeting that by December 31, 2016, buildings worth Rs. 194,565,192 and structures worth Rs. 701,358,733 had been constructed where the ownership of lands belonged to 24 farms had been

maintained by the Board from 1974 and 1992 without any formal acqui-

The Committee disclosed that 12,617.43 hectares of land is owned together by National Livestock Development Board, Mahaweli Livestock Enterprises Ltd and Sri Lanka Poultry Development Company (Private) Limited whereby at the end of May 2019, the Livestock Development Board had 2,266.05 hectares, 9.7 hectares of Mahaweli Livestock Enterprises Ltd and 35.6 hectares Poultry Development Company (Private) Limited adding up to a total area of 2,311.35 hectares which remain unutilized land.

The Committee also drew attention to the fact that machinery capable of producing 3.75 tons of cattle feed owned by the National Livestock Development Board has been idle for several years.

Given that it was disclosed that the farms of Menikpalama, Dayagama and Ridiyagama, which have imported cattle, are in a situation where they are unable to cover at least the minimum direct cost, the Committee gave a directive to pay immediate attention to this matter.

The COPE instructed the Secretary to the State Ministry of Livestock and Farm Promotion and Dairy and Eggs Related Industries S. Senaratne to make a full review of the performance of the Wellard Project under the Board and to submit a full report to the COPE Committee as soon as possible.

The Committee also observed discrepancies in some accounts of the farms owned by the National Livestock Development Board and said those accounts should be re-exam-

A healthy move

resident Gotabaya Rajapaksa's pledge towards the creation of a robust health care system to benefit all citizens irrespective of their social status, covering all parts of the country, would be welcomed by all segments of society particularly the economically deprived. Addressing a gathering of doctors in Kandy on Thursday, the President stressed the need for the entire healthcare community including doctors and other healthcare professionals to work with the Government to address long-term problems. Medical professionals play a crucial role in our society. Their impact has been considerably heightened in the past year as a result of the pandemic. The President highlighted the numerous shortcomings he encountered during his visits to the rural areas in respect of delivery of healthcare and poor access to the health facilities for the rural populace. He said in some regions villagers had to travel 30 to 40 Kilometres to consult doctors and receive proper medical care. Hence, even though Sri Lanka has a free healthcare system these structural problems in the distribution of healthcare are a significant hurdle that should be overcome.

The President particularly stressed the need to improve healthcare delivery to the rural population and the careful attention of the medical community to guarantee good health to the entire population. After all, ensuring a healthy nation is one of the foremost goals outlined in his 'Vistas of Prosperity and Splendour' Document.

The President's emphasis on uplifting healthcare facilities in the villages is but an echo of a perennial complaint made in this regard, most particularly about the state of rural hospitals. The President made reference to his Gama Samaga Pilisandara programmes during which he is able to obtain a first-hand glimpse of the problems faced by the rural community vis-a-vis healthcare delivery. Rural hospitals are in dire straits marked by a chronic dearth of doctors. There is a shortage of 4,000 doctors in the country mostly affecting rural hospitals which compelled the GMOA to demand that doctor's retirement age be upped from the present 61 years to 63. There is also an acute shortage of certain medicines. There is also overcrowding in rural hospitals highlighting the lack of space. Rural hospitals are given a wide berth by doctors depriving the rural community of being treated by competent specialists. Frequent strikes by doctors and medical staff cause considerable hardships to patients, most notably in rural hospitals.

In the interim, until all these ills are rectified in the long term, priority should be given to preventive health. A holistic approach is the need of the hour, where accent will be laid towards improving the health of the community obviating the need for medical care. In this respect attention should be paid to the nutritional needs of the rural community. A majority of children in villages are marked by their stunted growth. Morbidity is common among pregnant mothers in the estate community. It is only axiomatic that illnesses and disease spring from factors such as lack of nutrition and weak immune systems. Measures should be taken to cater to their nutritional needs and the promotion of healthy lifestyles. Then half the battle would have been won. True, budgets reserve considerable financial provisions for nutritional needs of targeted communities. But it is also equally true that it is the rural population who are the most disease prone. Poverty levels too contribute to the lack of nutritional intake and unhealthy practices such as alcoholism. All these factors should be addressed if the goal of a healthy nation is to be achieved.

Meanwhile, the Government should address as a priority the issue of the shortage of doctors in the country. The problem, as already mentioned, is aggravated in the rural areas. The shortfall is bound to continue for some time, for according to the GMOA, many of those who pass their internships fail to join the State medical service in the first year. While the ratio of doctors in relation to population is 17 per 1,000 in most developed countries here it is less than one percent, according to reports. Attractive incentives should be provided for retaining our medical professionals. Steps should also be taken to recruit Lankan doctors serving abroad to meet the shortfall.

The impact of our medical professionals and other healthcare staff was amply showcased during the present health crisis. Their service, enduring much hardship and sacrifice at risk to their own lives stood out like a beacon for all professionals to emulate. The full value of their contribution will only be known once the country comes out of the present nightmare.

It is time that our health service is restructured in a way that would benefit all segments of the community as desired by the President. It is only the haves that receive the best attention courtesy private hospitals while those who could ill afford the costs are left in the lurch and condemned to suffer. This anomaly should be removed in a country which prides itself on its free healthcare service. Work should get started right away in redressing the balance to provide equal treatment (pun intended) to all.

New narco-terrorism network takes shape in South Asia

ndian security officials believe the interception of a Sri Lankan boat carrying 300 kilograms of heroin, five AK-47 guns and ammunition off the coast of Vizhinjam in Kerala in South India on March 25 points to a network of narco-terrorism with strong links to a group in Sri Lanka. The Indian officials told the media the network of narco-terrorism has created sleeper cells in Sri Lanka and other neighbouring countries, and exports drugs to foment trouble. They added that the drug income is then used to fund illegal activities, including extremist activities.

The Indian Coast Guard and the Narcotic Control Bureau (NCB) found heroin worth Rs 3,000 crores (LKR 720 million) stashed in the boat along with AK-47 rifles and 1,000 rounds of 9 mm ammunition. "A number of incriminating documents were also seized from the occupants of the vessel," said the NCB, adding that six Sri Lankan nationals were arrested

The investigations so far have revealed that an unknown vessel carried the heroin and arms consignment from Chabahar Port, Iran, and handed it over to the Sri Lankan fishing boat, Ravihansi, in the high seas near Lakshadweep. Ravihansi then attempted to traffic the consignment to Sri Lanka when the Indian authorities intercepted it. NCB officials said that earlier, Sri Lankan authorities, too, had seized drugs worth Rs 2.5 billion that had been smuggled from the Gwadar port.

Sri Lanka has become a vulnerable transshipment hub for Transnational Organised Crime (TOC) since the Tiger terrorists commenced drug trafficking and money laundering in the 1980s. The LTTE smuggled drugs to raise money for arms and ammunition. However, after establishing links with Norway, Canada and few other Western countries the LTTE transferred its drug money into legitimate businesses in the West.

Organised crime and new terrorism

That was the era in which the distinctions between organised crime and new terrorism, as distinguished from old terrorism in cause and effect, have increasingly become blurred. According to A. P. Wickramasekara, a Sri Lankan researcher at Naval Postgraduate School in California, referring to the convergence of TOC and new terrorism in Sri Lanka proposed three hypotheses.

First, new terrorism often avails itself of the means and methods of organised crime. Second, increasing TOC and the existing ethnic and religious disharmony pose a national security risk in Sri Lanka, increasing its vulnerability to new terrorism. Third, a lack of national strategies has prevented Sri Lanka from harnessing the instruments of national power to the fullest effect.

A case study evaluates al Qaeda and the Abu Sayyaf Group as potential examples of a TOC-new terrorism nexus. The thesis statistically proves the increasing TOC trends and provides evidence on the emerging roots of Islamic radicalization that might lead to new terrorism, which could cause serious threats for the national security of Sri Lanka.

Dr. Dhrubajyoti Bhattacharjee of the Indian Council of World Affairs pointed out that terrorism stands out to be a method of combat in which random or symbolic victims serve as instrumental targets of violence.

In his research paper, *Narco-Terrorism and South Asia*, he said Narco-terrorism could be defined as the "use of organised terror to secure control over a state by another state or organised criminal networks or by insurgents or by a combination of any or all of them to achieve fixed political, economic or social objectives based on organisational and financial empowerment through drug trafficking".

The involvement of the LTTE in narcotic transactions in the 1980s included bulk delivery of heroin and cannabis from producing areas in Asia via transit points to destinations in consuming countries, conveying relatively small consignments of heroin concealed in personal baggage from suppliers in Asian countries to intermediary contact persons in the Middle East, North Africa, South Africa and western countries, the operation of drug distribution networks dealing in consuming regions or countries and working as couriers between dealers and distributors.

Contraband trade between India and Sri Lanka

Contraband trade between India and Sri Lanka has, for long, been a lucrative commercial enterprise, controlled, for the most part, by gangs operating from both sides of Palk Strait. While Velvettiturai is considered to have served as the foremost centre of the smugglers from Sri Lanka, on the Indian side, Chennai, Tuticorin, Pattukotai, Rameshwaram, Tiruchendur, Ramnad, Nagapatnam, Cochin and a host of smaller localities inhabited by fishing communities have figured prominently among the smuggler bases and hideouts.

The experts say although terrorism is not a recent phenomenon and has been playing an important role in the world since the eighteenth and nineteenth centuries, terrorism since the 1960s is the child of the war created by the imperialist powers. The current Islamic terrorism is by and large a byproduct of the conflicts initiated by Western powers to control countries such as Afghanistan, Iraq, Syria, Libya and Iran.

The Indian Coast Guard seizure of the drugs and arms consignment on March 25 was not the first such instance. Early March, there was another seizure. Indian security sources told media that one Dubai-based smuggler was working for a multinational drug smuggling racket, and the money from this has been used to create unrest, and fund extremism. They said the money was used for the 2019 Sri Lanka Easter bombings, fuelling the farmer protest in India. According to Rakesh Asthana, the Director-General of the NCB, this network has cells in Sri Lanka, Maldives, Dubai, and East Africa.

In January this year, M. M. M. Nawas, a Sri Lankan national was arrested by the Narcotics Control Bureau along with his compatriot Mohamed Afnas for alleged involvement in an international drug trafficking racket. They had travelled to Gulf nations on a fake Indian passport.

"Investigations are underway to determine the facts. Both were living in Chennai under assumed

identities after they fled Sri Lanka," a Customs official said. "Nawas is wanted for an attempt to murder the Sri Lankan narcotics control bureau's inspector, Rangajeeva, on May 9, 2017. He went underground thereafter," the official added. Nawas is said to be a key associate of Kanjipani Imran, now lodged in jail.

The accused arranged vessels to transport drug consignments from the Gwadar port through maritime routes to transit points in Sri Lanka and the Maldives. Payments were made through the 'hawala' channel via Dubai.

Imran worked with Sri Lankan underworld figure Makandure Madhush. Madhush was killed in a crossfire between the police and some drug peddlers in October last year. They had earlier operated from Dubai, where they were arrested in 2019 and extradited to Sri Lanka. "In the recent past, some pointmen for drug smugglers in Sri Lanka have been found operating from Tamil Nadu," Indian security officials said, adding that a probe was underway to find out if Nawas had developed links with local criminal gangs for logistics support.

Last year, the drug enforcement agencies found that another Sri Lankan national, Angoda Lokka, a notorious drug trafficker and associate of Madhush, had been living in India since 2017. He died under mysterious circumstances in Coimbatore in July 2020. Lokka had fled Sri Lanka following an attack on a prison bus in February 2017, in which rival gang leader 'Samayan' was killed along with five other jail inmates and two prison officials. According to Indian NCB, the drug trafficking network involving Nawas has links in Afghanistan, Iran, the Maldives and Australia.

The Indian Coast Guard and NCB announced that there were six Sri Lankans in the boat 'Ravihansi' seized with heroin, five AK-47 guns and ammunition had on March 25, off the coast of Vizhinjam in Kerala. he United States and Iran have begun indirect talks in Vienna this week aimed at reviving the landmark 2015 nuclear deal. The Vienna discussions, the most important indirect talks between Iran and the US

on the deal for two years, are being conducted by the remaining signatories to the deal: Iran, France, Germany, the UK, China and Russia.

The new US special envoy on Iran, Rob Malley, has travelled to Vienna, but will not actually attend the talks, instead being available to provide input via the three European delegations.

The Iranian delegation is led by Iran's deputy Foreign Minister, Abbas Araghchi, a graduate of the University of Kent and a veteran of the talks that produced the landmark 2015 deal.

Both sides said Tuesday's talks would determine if there was a pathway to a settlement, but would not reach a settlement themselves, something that may take many

months. The last time Iran and the US came so close to resuming talks was at the UN general assembly in New York in 2019 when the Iranian President, Hassan Rouhani, rejected a French-led plan for the US and Iran to come back into mutual compliance. In response to the US decision to impose sanctions, Iran has taken a series of steps away from the deal, and is due in May to decide whether to allow UN weapons inspectors to visit its nuclear sites.

Ahead of the talks, the Iranian foreign ministry spokesman insisted the US could not attend the Joint Commission - the grouping that oversees the deal - and there would be no discussion of the possible step-by-step sequencing of how the two sides came back into the agreement.

He said the bulk of the discussions would be technical as well as legal. Iran has insisted there is no possibility of step-by-step discussions, arguing there is only one step: the removal of Trump's sanctions.

Joe Biden's administration wants to revive the accord but has said that this requires negotiations, partly because there are many different categories of sanctions, including some imposed unrelated to the nuclear deal, but linked to other deemed Iranian offences such as terrorism, missile procurement or human rights abuses.

The Islamic Revolutionary Guards Corps for instance has been designated as a terrorist organisation under the Countering America's Adversaries Through Sanctions Act of 2017. The Central Bank of Iran is also sanctioned for being a distribution point to groups such as Hamas and Hezbollah.

The presence of representatives from the Iranian Central Bank, the Iranian national oil company and the Atomic Energy Authority of Iran at the talks underlines the complexity of the technical task ahead in distinguishing sanctions linked to the deal and those that are not.

The Biden administration would also like Tehran to agree to hold wider talks about lengthening and strengthening the existing deal, something Tehran implacably opposes. The US appears to have accepted that this discussion is for a later date.

Both sides have difficult domestic audiences in their parliaments watching for any sign of backsliding. The Iranians are also expected to have national elections later this year, which could have a major impact on these talks, if not concluded earlier.

US warns China

The United States on Wednesday warned China against what the Philippines and Taiwan see as increasingly aggressive moves, reminding Beijing of Washington's obligations to its partners.

"An armed attack against the Philippines' armed forces, public vessels or aircraft in the Pacific, including in the South China Sea, will trigger our obligations under the US-Philippines Mutual Defense Treaty," State Department spokesman Ned Price told reporters.

"We share the concerns of our Philippine allies regarding the continued reported massing of PRC maritime militia near the Whitsun Reef," Price said, referring to the People's Republic of China.

More than 200 Chinese boats were first spotted on March 7 at Whitsun Reef, around 320 kilometres (200 miles) west of Palawan Island in the contested South China Sea, although many have since scattered across the Spratly Islands.

China, which claims almost the entirety of the resourcerich sea, has refused weeks of appeals by the Philippines to withdraw the vessels, which Manila says unlawfully entered its exclusive economic zone.

Tensions have also risen with Taiwan, which Beijing claims as part of China, with the self-governing democracy on Wednesday reporting that 15 more of the mainland's planes crossed into the island's air defense zone.

Price voiced "concern" about the Chinese moves, saying: "The United States maintains the capacity to resist any resort to force or other forms of coercion that would jeopardize the security or the social or economic system of the people on Taiwan.'

He was using language from the Taiwan Relations Act, under which the United States is obliged to provide the island with the means to defend itself against Beijing.

President Joe Biden has vowed a robust defense of allies and, in a rare point of continuity with his predecessor Donald Trump, has supported strong pushback against Chinese assertiveness.

Netanyahu again?

Israel's president has nominated the Prime Minister, Benjamin Netanyahu, to try to form a government following the latest inconclusive election, but voiced doubt that any candidate can forge a majority coalition.

Netanyahu has criminal charges on corruption, and his case began in the court this week. The Israeli laws permit such a person to be prime minister and head a govern-

"I have come to a decision based on the numbers of recommendations (from lawmakers), which indicates that Benjamin Netanyahu has a slightly higher chance of forming a government," President Reuven Rivlin said.

In Rivlin's consultations with party leaders following the March 23 vote, Netanyahu was backed by 52 lawmakers elected to Israel's 120-seat Parliament, the Knesset.

The Opposition Leader, Yair Lapid, earned 45 endorsements. There were 16 abstentions and rightwing nationalist Naftali Bennett secured seven votes from his own Yamina party.

'The results of the consultations, that were open to all, lead me to believe that no candidate has a realistic chance of forming a government that will have the confidence of the Knesset," Rivlin said. "In fact, if the law would allow me to do so, I would give the decision back to the representatives of the people."

President Rivlin referred directly to the misgivings of many Israelis about having Netanyahu try to form a government as he stands trial on corruption charges.

"I know the position held by many, that the president should not give the role to a candidate that is facing criminal charges, but according to the law and the decision of the courts, a prime minister can continue in his role even when he is facing charges."

Myanmar

The violence by the Myanmar junta against protesters continued this week with at least 581 killed, and more than 2,700 injured, with more international calls for the junta to curb its violence against citizens.

Myanmar's ambassador to the UK has been locked out of his country's Embassy in London, weeks after he broke with the military government by calling for the release of detained leader Aung San Suu Kyi.

Protesters in several townships in Yangon are asking the public not to celebrate the annual water festival called 'Thingyan', until the country's democracy is restored. The festival is scheduled for April 13-16 and marks the begin-

ning of the country's lunar New Year. Myanmar's junta has placed at least 100 celebrities on its wanted list for allegedly inciting protests against its seizure of power, taking aim at those with big social media

followings. Security Forces launched a morning raid using heavy arms in the township of Kalay in the country's northwest, killing at least eight civilians. Kalay is close to the border with the Indian states of Manipur and Mizoram. There are reports of increased numbers of Myanmar citizens, including police personnel escaping to Mizoram in India, and the people in Mizoram welcoming them, defying government calls to send them back to Myanmar.

The Myanmar-based Assistance Association for Political Prisoners says 581 people have been killed by Security Forces since the Feb. 1 coup, with 2,750 people currently detained.

French Foreign Minister Jean-Yves Le Drian says the European Union is preparing sanctions that can "be applied very quickly" against the Myanmar military's economic interests.

Security Forces have arrested one of Myanmar's bestknown comedians, the Associated Press reports, amid a crackdown on those the junta considers to be inciting protests. The comedian known as Zarganar, who is 60 and has a history of activism, was taken from his home in

Yangon on Tuesday. Meanwhile, some protesters splashed red paint around the country's largest city, as a reminder that the junta has blood on its hands. Earlier authorities broke up a protest by medical workers in Mandalay.

The Biden administration has resumed U.S. assistance to the Palestinians, including to the U.N. agency that deals with Palestinian refugees, nearly all of which had been eliminated by former President Donald Trump.

The State Department announced it would provide a total of \$235 million to projects in the West Bank and Gaza as well as to the U.N. Relief and Works Agency, or UNRWA. The administration had previously announced \$15 million for the Palestinians to combat the coronavirus pandemic. The resumption in assistance has raised concerns in Congress from pro-Israel lawmakers who say the money may violate U.S. law.

The Associated Press has previously reported that the administration notified Congress of its intent to ramp up aid to the Palestinians, but until Wednesday it had not publicly acknowledged any assistance other than that for COVID-19. The new assistance comes as the administration cements a new Mideast policy that in many ways is

directly opposite of the one pursued by Trump. "The United States is pleased to announce that, working with Congress, we plan to restart U.S. economic, development, and humanitarian assistance for the Palestinian people," Secretary of State Antony Blinken said in a statement. He said the money includes \$75 million in economic and development assistance in the West Bank and Gaza, \$10 million for peacebuilding programmes and \$150 million for UNRWA.

Blinken sought to forestall congressional criticism by saying that "all assistance will be provided consistent with U.S. law," but Republican members of Congress are already gearing up to fight the aid.

Blinken maintained U.S. support was key to advancing American interests in the region. "U.S. foreign assistance for the Palestinian people serves important U.S. interests and values," he said. "It provides critical relief to those in

The spread of COVID-19 is worst in Brazil with the daily death toll rising to above 4,000 and leading to a major political issue, with President Jair Bolsonaro strongly opposed to lockdown measures to contain COVID-19, as experts warned a large-scale stay-at-home was "absolutely necessary" to slow a deadly surge of the coronavirus.

The far-right president has defied expert advice on containing the pandemic, criticising lockdowns, face masks and vaccines even as the virus has claimed more than 340,000 lives in Brazil -- second only to the United States.

The situation in India is also worsening with a record 115.736 new coronavirus infections midweek, taking the total to more than 12.8 million cases, data from the health ministry showed.

The death toll in the world's third-worst-hit nation after the United States and Brazil reached 166,177, including 630 new fatalities, the most in four days.

With cases continuing to surge in many parts of the country, authorities have announced strict restrictions to curb the spread of the virus. On Tuesday, the capital New Delhi imposed a night curfew from 10 p.m. to 5 a.m. until April 30, with only essential services or people travelling to and from vaccination centres allowed on the streets.

The new Secretary General of Amnesty International, Agnes Callamard, has said: "At this point in the COVID-19 pandemic, even the most deluded leaders would struggle to deny that our social, economic and political systems are broken." She said that most governments have "failed the most vulnerable, the poorest and women".

The Guardian (UK) recently reported that rich countries with 14% of the world's population have secured 53% of the best vaccines.

'The Moderna vaccine will go to rich countries exclusively; it is not even being offered to the poor. In fact, nine out of 10 people in poor countries may never be vaccinated at all. Washington is sitting on vaccines, making sure no one gets any while the US needs them. The European Union had exported 34m doses to, of all places, Singapore, Saudi Arabia and Hong Kong - countries that have no problem sourcing or paying for vaccines.'

COVID-19 global infections and deaths at midweek were 133, 229,961 and 2,890,163. The key country figures were: US - 30,923,294 (559,117), Brazil - 13,193,205 (340,776) and India - 12,926,574, (166,862). The spread in France has led to a major lockdown, and in Italy too there are heavy restrictions of Easter celebrations.

He also said that in addition, 150 schools have been identified and a mechanism has been set to recruit around 20 children who are good in sports. "There is a

wrong notion that when you say Sports University, children only follow sports there. That is not so. Children can pursue their sporting career, but they should also engage in other academic activities."

Meanwhile, MP Buddhika Pathirana pointed out that the activities of some sports associations were problematic and urged the Sports Minister to look into their activities. Navy arrests two persons with explosives used for blast fishing

Naval personnel have carried out Naval Command during the past week, with a view to prevent illegal fishing practices conducted using commercial explosives. During these operations, the Navy arrested two suspects with several commercial explosives devised for blast fishing, the Navy stated in a communiqué recently.

The use of explosives for fishing by certain individuals can wreak havoc on the biodiversity and survival of the marine environment, destroying marine life and coral reefs. This illegal fishing method practiced by certain individuals deals a deadly blow on the law-abiding fishing community and has a major impact on the depletion fish stocks, the statement read.

Accordingly, the Sri Lanka Navy will continue to focus on the conservation of biodiversity and survival of the marine environment and remains to crack down on all forms of illegal fishing activities, including the use of explosives, in order to secure the livelihood of the majority of lawful fishing community, the press release added.

During a search conducted off the special operations in the Eastern Salpeyaru coast in Trincomalee on April 5, four charges comprising three water gel sticks each, six safety fuses about three inches in length, and a non-electric detonator were found in a waterproof canister moored by means of a buoy, the Navy stated.

By leaving explosives in waterproof canisters of this nature, a handful of people engage in such fishing practices endeavour to continue their illegal acts with scant regard towards marine environment, attempting not to be caught in continuous operations carried out by the Navy and other law enforcement, the statement read.

Meanwhile, the Navy also arrested a person with 82 water gel sticks during a search conducted with the Kuchchaveli Police in Erakkandi, Trincomalee, on April 1, and another individual with a water gel stick in Poduwakattu on March 27. The individuals and commercial explosives held during these separate operations were handed over to the Kuchchaveli Police for legal action, the statement added.

The Sri Lanka Jama'athe Islami (SLJI) is a religious organisation founded in 1954 for providing welfare services to the members and well-wishers in conformity with the Constitution of the country as provided in Clause 1(a) of the SLJI Constitution adopted on September 7, 1958, the statement read.

The SLJI is deeply distressed by the report of the Commission of Inquiry on the Easter Sunday attacks calling for the banning of this pre-eminent Muslim civil society, without giving the SLJI as an organisation, the right to be heard and in violation of the principles of natural justice, the SLJI said.

It is sad to note that the Commission had not acted in conformity with section 16 of the Commissions of Inquiry Act which requires parties 'whose conduct is the subject of inquiry under the Act or in any manner implicated or concerned in the matter under inquiry' to be represented and heard. The SLJI had never been noticed to appear before the Commission, they added.

In a reference to the SLJI, the report states that "this group possesses a considerable number of firearms and provided training for approximately 150 youths mainly selected from Muslim internally displaced camps". The Commission could have sent a team from the CID unit attached to it, seized the firearms and produced the persons who were in possession of the offensive weapons in proof of this frivolous allegation, the state-

The SLJI rejects this baseless and unfounded allegation as false. This type of findings brings into serious question the credibility of the other expressions of the Commission made against the SLJI and the Sri Lanka Islamic Students Movement (SLISM), an independent organisation affiliated to the SLJI and one-time leader of the SLJI, Ustaz Hajjul Akbar, the press release added.

The SLJI is surprised that the Commission had not given due weightage to the expulsion from the SLISM of one of its members for creating disharmony among the members in violation of the SLISM constitution and who was arrested years later allegedly in connection with the damaging of the Buddha statue in Mawanella, they added.

His father who was a member of the SLJI was also expelled for similar reasons, from the SLJI membership, well before the Buddha statues being vandalised. The expulsions from the SLJI done in consultation with the then President Ustaz Hajjul Akbar, of the father who was his own brother, and from the SLISM of the brother's son for conduct unbecoming of the high standards of conduct required under the Constitutions of the organisations and the country are the best evidence of the exemplary role of the SLJI and its then President, as well as the SLISM, the SLJI stated.

"The SLJI had condemned the vandalising incidents in December, 2018, and the Easter attacks of April 12, 2019, unreservedly as un-Islamic, inhuman, and barbaric. We hope to release a more detailed response against the unsubstantiated allegations very soon,' they added.



YUII Gagarin:

First Man

uri Gagarin was the first person to fly in space. His flight, on April 12, 1961, lasted 108 minutes as he circled the Earth for a little more than one orbit in the Soviet Union's Vostok spacecraft. Following the flight, Gagarin became a cultural hero in the Soviet Union. Even today, more than six decades after the historic flight, Gagarin is widely celebrated in Russian space museums, with numerous artefacts, busts and statues displayed in his honour. His remains are buried at the Kremlin in Moscow, and part of his spacecraft is on display at the RKK Energiya museum.

Gagarin's flight came at a time when the United States and the Soviet Union were competing for technological supremacy in space. The Soviet Union had already sent the first artificial satellite, called Sputnik, into space in October 1957.

Before Gagarin's mission, the Soviets sent a test flight into space using a prototype of the Vostok spacecraft. During this flight, they sent a life-size dummy called Ivan Ivanovich and a dog named Zvezdochka into space. After the test flight, the Soviet considered the vessel fit to take a human into space.

The third of four children, Yuri Alekseyevich Gagarin was born on March 9, 1934, in a small village a hundred miles from Moscow. As a teenager, Gagarin witnessed a Russian Yak fighter plane make an emergency landing near his home. When offered a chance years later to join a flying club, he eagerly accepted, making his first solo flight in 1955. Only a few years later, he submitted his request to be considered as a cosmonaut.

More than 200 Russian Air Force fighter pilots were selected as cosmonaut candidates. Such pilots were considered optimal because they had exposure to the forces of acceleration and the ejection process, as well as experience with high-stress situations. Gagarin, a 27-year-old senior lieutenant at the time, was among the pilots selected.

On April 12, 1961, at 9:07 a.m. Moscow time, the Vostok 1 spacecraft blasted off from the Soviets' launch site. Because no one was certain how weightlessness would affect a pilot, the spherical capsule had little in the way of onboard controls; the work was done either automatically or from the ground. If an emergency arose, Gagarin was supposed to receive an override code that would allow him to take manual control, but Sergei Korolev, the chief designer of the Soviet space programme, disregarded protocol and gave the code to the pilot prior to the flight.

Over the course of 108 minutes, Vostok 1 travelled around the Earth once, reaching a maximum height of 203 miles (327 kilometres). The spacecraft carried 10 days' worth of provisions in case the engines failed and Gagarin was required to wait for the orbit to naturally decay. But the supplies were unnecessary. Gagarin reentered Earth's atmosphere, managing to maintain consciousness as he experienced forces up to eight times the pull of gravity during his descent.

Vostok 1 had no engines to slow its re-entry and no way to land safely. About four miles (seven km) up,

Gagarin ejected from the spacecraft and parachuted to Earth. In order for the mission to be counted as an official spaceflight, the Federation Aeronautique Internationale (FAI), the governing body for aerospace records, had determined that the pilot must land with the spacecraft. Soviet space scientists indicated that Gagarin had touched down with the Vostok 1, and they did not reveal that he had ejected until 1971. Regardless, Gagarin still set the record as the first person to leave Earth's orbit and travel into space.

Upon his return to Earth, Gagarin was an international hero. A cheering crowd of hundreds of thousands of people greeted him in Red Square, a public plaza in Moscow.

A national treasure, Gagarin travelled around the world (including Sri Lanka) to celebrate the historic Soviet achievement.

When he returned home, Gagarin became a Deputy of the Supreme Soviet of the Soviet Union (the highest legislative body in the Soviet Union) and was appointed Commander of the Cosmonauts' Detachment. Because the Soviets did not want to risk losing such an important public figure, they were hesitant about allowing Gagarin to return to space. He continued to make test flights for the Air Force, however.

On March 27, 1968, Gagarin was killed (along with another pilot) while test-piloting a MiG-15, a jet fighter aircraft. He was survived by his wife, Valentina Ivanovna Goryacheva, and two daughters.

NASA's Apollo 11, the first mission to put people on the moon, landed in July 1969, and the crew left behind a commemorative medallion bearing Gagarin's name. They also left medallions for other astronauts who lost their lives in space or while preparing for

Over time, the U.S. and the Soviet Union began working together in their spaceflight endeavours. The first joint U.S.- Soviet spaceflight was in 1975, called Apollo-Soyuz. Following that, NASA sent several space shuttle astronauts to Soviet/Russian space station Mir after the fall of the Soviet Union in 1991. The shuttle-Mir collaboration paved the way for NASA and the Russian space agency (Roscosmos) to become major partners in the International Space Station programme, which first launched modules in 1998 and continues research today.

Gagarin's importance in the Russian space programme continues. Crews using the Soyuz spacecraft participate in a number of prelaunch traditions prior to climbing on to the spacecraft — to follow in the footsteps of Gagarin's historic flight. Beyond that, Gagarin is often held up as an example of character and heroism to younger children in Russia.

The 60th anniversary of Gagarin's flight is being commemorated this year. The space community also commemorates Gagarin's achievement every year with Yuri's Night, a celebration that takes place on his launch date of April 12. Yuri's Night was founded in 2001 and attracts thousands of celebrants each year. (Space.com)

ASTRAZENECA VACCINES REACH 100 TERRITORIES

SWITZERLAND: Covax backed the AstraZeneca jab on Thursday as the scheme celebrated shipping coronavirus vaccine doses to 100 different territories around the world, despite delays dogging deliveries.

AstraZeneca's COVID-19 vaccine accounts for almost the entire first wave of doses being distributed via the facility, which ensures the 92 poorest participating economies can access jabs for free.

But the programme has been hit by delays after New Delhi put the brake on exports from the Serum Institute of India plant to deal with a rampant second wave of COVID-19 infections.

The SII is one of two sites producing AstraZeneca doses for Covax. The other is in South Korea. Covax's first wave intended to distribute some 238.2 million doses to 142 participating economies by May 31.

Of those, 237 million are Astra-Zeneca doses and 1.2 million are Pfizer/BioNTech.

A number of nations have suspended the use of AstraZeneca's vaccine for younger populations after it was earlier banned outright in several countries over blood clot scares.

The EU's medicines regulator said Wednesday that blood clots should be listed as a rare side effect of the AstraZeneca jab, stressing benefits continue to outweigh risks.

Gavi said safety and efficacy was the "top priority for Covax". The 100th country milestone was reached with a delivery to the Caribbean island of St. Lucia.

It came 42 days after the first shipment landed in Ghana on February 24, with Ghanaian President Nana Akufo-Addo publicly taking the first shot.

So far, nearly 38.4 million doses have been delivered to 102 territories, including 61 of the 92 poorest

Head bit Brazil registered its

Hard-hit Brazil registered its deadliest day yet in the pandemic Tuesday with more than 4,000 deaths, fueling mounting calls for a lockdown -- something Bolsonaro has vehemently rejected.

Bolsonaro reiterated his opposition to lockdowns, which he argues cause economic damage that is worse than the virus itself.

"We're not going to accept these policies of 'stay home, close everything, lock down," he said on a visit to the southern city of Chapeco. "There's not going to be a national lockdown. Our army isn't going into the streets to force the Brazilian people into their homes." The virus has claimed nearly 337,000 lives in Brazil – second only to the United States.

Only 2% Africans get COVID jab so far

Africa is on the "sidelines" of the worldwide vaccination drive against Covid-19, with only two percent of the global total to have received jabs, the World Health Organization (WHO) said Thursday, citing supply, funding and personnel shortfalls.

WHO's Director for Africa, Matshidiso Moeti, blamed the slow pace of vaccinations in Africa on "inadequate supplies, lack of financing and lack of qualified personnel" as well as logistical problems.

Africa has been the least affected by the pandemic, with 4.3 million

cases including 114,000 deaths in an overall population of 1.2 billion, according to the latest figures from WHO Africa. Iran's COVID cases hit 2 m The number of confirmed coronavirus cases in Iran passed the two-million mark Thursday, while the daily caseload set a new record high in what a health official warned amounted to a "meteoric" spike.

As the Islamic republic reached the grim milestone, some health experts called for a lockdown of the capital Tehran to contain the country's fourth COVID-19 wave.

Over the past 24 hours, the country officially recorded 22,586 new cases of infection, reaching a new high, Health Ministry Spokeswoman Sima Sadat Lari said.

This marks an increase of more than 1,600 cases over the previous record, set just the day before. Iran also recorded an additional 185 coronavirus-related deaths, Lari said, bringing the total to 63,884.

EUROPEAN RIGHTS COURT BACKS OBLIGATORY VACCINATIONS

FRANCE: The European Court of Human Rights (ECHR) ruled on Thursday that democratic governments can make vaccinations obligatory, in a landmark judgement rejecting complaints brought by Czech families penalised for refusing compulsory jabs for their children.

It is the first time, since its creation in 1959, that the ECHR delivered a judgement about compulsory vaccination against childhood diseases.

Experts say it could have implications for COVID-19 vaccination policies although the Czech cases were lodged between 2013-2015, well before the current pandemic, and concern the vaccination of young children.

"The... measures could be regarded as being 'necessary in a democratic society" the court ruled, saying that the Czech health policy was consistent with the "best interests" of children. "The objective has to be that every child is protected against serious diseases, through vaccination or by virtue of herd immunity," it added. As a result, the court ruled there had been no violation of Article 8 on

the right to respect for private life of the European Convention on Human

The decisions by the Czech authorities were "fully consistent with the rationale of protecting the health of the population."

The decision was handed down by the Strasbourg-based court's highest instance, the Grand Chamber which is composed of 17 European judges, and cannot be appealed. It was passed by 16 votes to 1. Experts said the decision was above all a blow to so-called "antivax" movements in Europe who oppose all vaccines on principle, and is particularly timely as the COVID-19 pandemic is still raging worldwide with immunity through vaccination the

only clear solution.

This judgement "reinforces the possibility of a compulsory vaccination under conditions of the current COVID-19 epidemic," Nicolas Hervieu, a legal expert specialising in the ECHR, told AFP.

Tricksters use elderly disguise to get COVID vaccine



MEXICO: Two Mexican men in their 30s managed to get the coronavirus vaccine in the capital by disguising themselves as senior citizens, but were later caught, the authorities said Wednesday.

With their hair and eyebrows colored white, the men visited a vaccination center for over 60s wearing masks and plastic face shields, the city mayor's office said.

Both presented false identity documents and received the vaccine, but their plan fell apart when they had to speak with a worker at the center afterward.

"A colleague realized the voice was not that (of an old man), and that was when she called the authorities," Mexico City official Cristina Cruz was quoted by the UNOTV news site as saying.

The imposters face charges of identity theft, she said.

US targets Myanmar's State gem company

US: The United States on Thursday slapped sanctions on Myanmar's state gem company, vowing to deprive the military junta of a key moneymaker as it violently suppresses democracy protests.

The Treasury Department said it would block all assets and ban any transactions with the Myanmar Gems Enterprise, which manages the mining and marketing of the country's jade and other gemstones.

Secretary of State Antony Blinken said the United States was determined alongside allies to restore democracy and promote accountability in the country formerly known as Burma.

"By imposing targeted sanctions on this entity, we are send-

ing a clear signal to the military that the United States will keep increasing pressure on the regime's revenue streams until it ceases its violence," Blinken said in a statement.

He said the United States would turn up the heat until the junta "releases all those unjustly detained, lifts martial law and the nationwide state of emergency, removes telecommunications restrictions and restores Burma to the path of democracy."

The announcement comes in the midst of a gem emporium called by the junta in the capital Naypyidaw, with the ousted ruling National League of Democracy warning businesses not to participate.

The state-run New Light of Myanmar reported Thursday that the emporium on its sixth day alone sold close to \$2.5 million worth of jade.

Myanmar sold 825 million euros (\$980 million) in gems and jade through emporiums in 2017-2018, according to the Extractive Industries Transparency Initiative, which promotes openness on natural resource exports.

But 60 to 80 percent of gemstones from Myanmar are not declared, the initiative said in a 2016 study. Myanmar suspended gem emporiums last year due to the COVID-19 pandemic. - AFP

Soyuz crew marks 60 years of Gagarin's spaceflight



The anniversary of Yuri Gagarin's historic flight on April 12, 1961 is celebrated every year in Russia as Cosmonautics Day.

KAZAKHSTAN: A three-man crew was exoected to blast off to the International Space Station on Friday in a capsule honouring the 60th anniversary of Soviet cosmonaut Yuri Gagarin becoming the first person in space.

Reminders of Gagarin's achievement were everywhere at the Russia-operated Baikonur cosmodrome in Kazakhstan as Roscosmos cosmonauts Oleg Novitsky and Pyotr Dubrov and NASA astronaut Mark Vande Hei prepared for their half-year mission aboard the orbital lab.

The Soyuz MS-18 spacecraft that the trio was due to take off has been named after the legendary cosmonaut and Gagarin's portrait has been added to its exterior.

Gagarin also came up more than once in the traditional pre-flight press conference, where the crew was asked how they planned to mark Monday's anniversary once in space.

"We'll celebrate it together," said 43-year-old Dubrov, who is flying to space for the first time. "And we'll work hard!"

The anniversary of Gagarin's historic flight on April 12, 1961 is celebrated every year in Russia as Cosmonautics Day.

Friday's blast-off was expected to be from a different

launchpad than the one used for Gagarin's one and only mission, which saw him spend 108 minutes in orbit.

Last used in 2019, the Gagarin launchpad is undergo-

ing upgrades in preparation for a new generation of

Soyuz rockets and expected to return to action in 2023. Gagarin's mission was a propaganda coup for the Soviet Union and a huge win in the space race with the West, which became one of the Cold War's most exciting subplots. - AFP

Biden vows to tackle gun violence 'epidemic'

US: US President Joe Biden on Thursday branded US gun violence an "epidemic" and an "international embarrassment" at a White House ceremony to unveil his first attempt at getting the problem under control.

"This is an epidemic, for God's sake, and it has to stop," he said, calling shootings "a public health crisis."

"It's an international embarrassment," the Democrat, flanked by Attorney General Merrick Garland and Vice President Kamala Harris, told Congress members and gun control activists in the Rose Garden. "Enough prayers," Biden said.

"Time for some action." Several hours after Biden's announcement, a gunman opened fire at a Texas cabinetry plant where he was employed, killing one person and sending four others to the hospital in critical condition. No motivation was immediately known.

With Congress unable to agree on broad new gun regulations, like stricter background checks for gun buyers, Biden announced six executive measures which he said would help tamp down the crisis. Republicans immediately attacked the proposal, with the party's senior leader in the House of Representatives, Kevin McCarthy, warning of "unconstitutional overreach." Another proposed rule will be tightening regulations on arm braces designed to stabilize pistols, a device

used by the man who killed 10 people in a Colorado grocery store last month. Under the rule, pistols with braces would be classified as short-barreled rifles, putting them under stricter control.

Other measures include boosting support for agencies involved in tackling community violence and ordering the first comprehensive report on firearms trafficking in the United States since 2000. Nearly 40,000 Americans die each year from shootings.

While mass shootings like recent killings in Colorado, Georgia and California attract most attention, more than half of the annual death toll is due to suicide.

US: Donald Trump's top diplomat Mike Pompeo has been hired to appear on Fox News as a "contributor," the conservative cable news channel said Thursday.

"I intend to give viewers a candid, no-nonsense look at geopolitics, international relations and the America First policies that

helped chart the course for unprecedented American prosperity and security," the former secretary of state and member of Congress said in a statement released by Fox. "Mike Pompeo is one of America's most recognized and respected voices on foreign policy and national security

issues," Fox News Media CEO Suzanne Scott said. "I look forward to his contributions across our range of platforms to share his distinct perspective with our millions of viewers.

Pompeo took up the post of Secretary of State from his prede-

until the end of the Trump administration in January 2021. He was previously director of the CIA. Fox has hired other members of the Trump orbit in recent months, including his daughter-in-law and campaign advisor Lara Trump and former White House press cessor Rex Tillerson in April 2018 secretary Kayleigh McEnany.

The network has found itself embroiled in controversies over Trump's untrue allegations of election rigging in 2020, with voting machine maker Dominion seeking more than \$1 billion in a lawsuit over allegations Fox implicated the company in the false

George Floyd died from 'low level of oxygen', says doctor

US: A respiratory expert testified on Thursday that George Floyd died from lack of oxygen and police officer Derek Chauvin's knee was on his neck "more than 90 percent of the time" that he was handcuffed, facedown in the street.

Dr Martin Tobin, a pulmonologist, told the jury at Chauvin's murder and manslaughter trial that he had watched videos of Floyd's May 25, 2020 arrest "hundreds of times."

"Mr. Floyd died from a low level of oxygen," Tobin told the nine-woman, five-man jury hearing the high-profile case in a heavily guarded Minneapolis courtroom.

"This caused damage to his brain," he said, and arrhythmia -- an irregular heartbeat -which "caused his heart to stop." Tobin said Floyd's breathing weakened because he was face down on the street, handcuffed and with Chauvin and other officers on his neck and

Eric Nelson, Chauvin's Defense Attorney, has suggested at several points during the trial that Chauvin's body weight was actually on Floyd's shoulder or back at times and not

on his neck. Tobin disagreed.

"Officer Chauvin's knee is virtually on the neck for the vast majority of the time," he said, "more than 90 percent of the time." The Irish-born Tobin is testifying as an expert witness for the prosecution.- AFP

Biden resumes Palestinian aid, urges two-state solution

US: US President Joe Biden on Wednesday restored aid to the Palestinians to a tune of \$235 million, drawing a rebuke by ally Israel, as he promised to press for a two-state solution.

In his sharpest break on the conflict yet from the staunchly pro-Israel Donald Trump, Biden said the United States would resume funding for the UN agency for Palestinian refugees that his predecessor had severed.

The State Department said the United States would contribute \$150 million to the UN agency and offer \$75 million in economic and development assistance for the West Bank and Gaza as well

as \$10 million for peacebuilding efforts. In a call with Jordan's King Abdullah II, a longstanding US ally who recently faced down dissent within the royal family, Biden "affirmed that the United States supports a two-state solution to the Israeli-Palestinian conflict," a White House statement

Secretary of State Antony Blinken said that the US assistance to the Palestinians "serves important US interests and values" as "a means to advance towards a negotiated two-state solution."

"It provides critical relief to those in great need, fosters economic development and supports IsraeliPalestinian understanding, security coordination and stability," Blinken said in a statement. Israel, which had held off on criticism of Biden in his first months, denounced the assistance to the UN Relief and Works Agency for Palestine Refugees in the Near East, or UNRWA, which provides housing, schools and other care to more than six million Palestinian refugees and their descendants.

The Palestinian leadership hoped that the aid would mark the start of a concerted effort by Biden to pressure Israel, including on stopping settlements in the occupied West Bank.

Belfast in turmoil after Northern Ireland violence

NORTHERN IRELAND: Rioters waged a running battle with Police in Belfast on Thursday night -- tossing petrol bombs, setting fires and dodging jets from water cannon as a week of unrest showed no sign of letting up.

Hundreds of boys and young men gathered from early evening in a western neighbourhood in the Northern Ireland capital, which has been riven by violence over Brexit and domestic politics.

Masked and in hooded tops, they hurled rocks, bricks and glass bottles at police barricades where riot officers formed ranks with armoured Land Rovers.

Petrol bombs burst into flames in the

street and fireworks were aimed into police formations, exploding and smothering their lines in thick smoke. Behind riot shields and with batons drawn, police drove back the surging crowds late into Thursday night, as locals peered out of their windows to witness the spectacle.

Shanthikumar the iron man of Army and Sri Lanka rugby

St.Thomas' College, Matara is a prominent school located in the Southern Province which has played a phenomenal role in producing several academics and sportsmen who made their 'Alma Mater' proud locally and Internationally. J K Shanthikumar was one of the yesteryear sportsmen who had a prolific sporting career later representing the country in the game of rugby.

Shanthikumar was well known as 'Yakadaya' in the sporting circles and was born in 1958 in Matara. His father was J.K. Gilbert a clerk by profession and J.A.Wimalawathi his mother worked as a nurse. Shanthikumar continued his school career with St. Thomas', Matara and was very optimistic in maintaining good physique. He decided to participate in sports and played soccer and cricket from the beginning of his school career. He captained the school cricket and soccer teams and towards the latter part of the school career, was more keen on body building, eventually becoming the 'Mr YMBA Matara', when he was only 17 years old. In his final school big match cricket encounter against St. Servatius College, he was instru-

mental in saving them from certain defeat, playing a patient knock occupying the crease for almost five sessions.

After his school career, he joined the Sri Lanka Army. There, he went on to be involved in soccer and cricket. During a regimental soccer match, an unforgettable incident occurred. An officer held him by his hand and said he should come for regimental rugby practices on the next day as they were in

need of players for the Army rugby team.He team in 1989. was none other than late General Denzil Kobbakaduwa. This was the turning point of his sporting career and joined the Sinha Regiment to engage in rugby, until then he

never had any idea of what this oval shaped ball game was. His first rugby coaches were W.O.I. Piyathissa and late Major W.R. Bandara who taught him the basics of the game. Under them, he was privileged to represent the Sinha regiment team within six months and within one year competed with the Army team. It was General Denzil Kobbakaduwa who coached the Army side. The journey with them started in 1979 and surged ahead till 1999, an undisputed two-decade journey before he hung up his boots, which made him enter the record books, by becoming another player to don the rugby jersey for such a long time.

He made some experiments in his playing style with a little bit of extra aggression which was quite successful. He captained the Army

His indefatigable performance enabled him to get the National call in 1988 and went on to lock horns until 1990 with them. He played for Sri Lanka at two Rugby Asiads in Hong Kong in 1988 and Colombo in 1990 followed by several other tournaments

He also continuously represented the Defence Services team from 1982 to 1999. While he was a prominent figure in the Sri Lanka rugby team, he also represented the Sri Lankan Kabaddi team in 1993, when that sport was first intro-

duced to Asian Games. Apart from rugby, he also represented the Army Cricket team in the 1980/81 seasons. Represented the regiment soccer team from 1979 to 1990, Army Archery team in 1988 and 1989 and Army boxing team simultane-

After his tenure as a player, he opted to take up coaching and coached the junior academy of St. Peter's College way back in 1993. He was invited to coach the Army 'B' division rugby team from 2000 to 2010 and his last appointment was at Wesley College from 2012 to 2014.

He is grateful to a few special people who helped him as a village boy who came to Army without even knowing what rugby is, later transforming him to become the cyno-

sure of all eyes in his amazing sporting career. The first person in this list is late General Denzil Kobbakaduwa who changed his sporting career and was also instrumental in him playing rugby. Secondly, Field Marshal Sarath Fonseka for supporting his career as he encouraged and pushed him towards achieving his goals. The retired senior DIG Nimal Lewke for the

Sellappuliyage Lucian Benedict Rosa better known as S. L. B. Rosa was the captain of the Sri Lanka Team for the Munich Olympic Games in 1972.

He attended St. Mary's School Nawalapitiya up to Grade Two and later, he joined the Roman Catholic School in Ampitiya, Kandy. At school be showed interest in football. As part of his practice routine be used to


long distance running. eral victories in various Inter-School Hong Kong participated in this meet. Track and Field Meets. In 1963, he started his career as a soldier, in the Field Engineering Unit at the Sri Lanka

He registered his first major victory in 1965 at the National Athletics Championships when he beat the 1964 Olympic representative, R. J. K. Karunananda into second place in the 5,000m. Rosa also improved the record of 14.56.8s set up by Karunananda for this event by registering a time of 14.26.0s.

In 1966, he easily won the long-distance events at the Army Meet and won the 5,000m event once again at the National Athletics Championship.

These victories earned him a place in the Sri Lanka Team for the Asian Games that year. At the Asian Game he won two Bronze Medals by registering times of 14.56.0s for the 5,000m and 31.06.04s

for the 10,000m. The year 1967 was another milestone in his career. At the Nationals that year, he beat the Indian champion Kripal



In addition, he won the prestigious awards such as the Wilton Bartleet Cup, Duncan White Cup and the Governor-General's Cup. The year 1968 brought him much success in his sports

With his experience at these international meets behind him, he participated in the Asian Games held in Bangkok, Thailand in 1970. This was his crowning glory. He won the 5,000m event in a time of 14m 32.2s and the 10,000m with a new record time of 29m 55.6s.

His performances at these two races earned him such accolades as the 'Golden Boy of Athletics' and 'King of Long-Distance Runners in Asia.' This was the first occasion when a Sri Lankan had won two Gold Medals at the same meet. He represented Sri Lanka at the Munich Olympic Games in 1972 while studying in America but could only gain the 16th place in the second heat of the 10,000m race registering a time of 30m 20.2s.
