LAND SETTLEMENT ORDINANCE

Settlement Order No. 164 (Kandy)

- (h) At the expiration or earlier determination of the lease the lessee shall yield up and surrender quiet possession of the land and buildings and other improvements thereon in good conditions to the Government Agent, or any officer duly authorised by the Government Agent (due allowance being made for fair wear and tear).
- (i) The lessee shall not be entitled to any compensation from the Crown for any buildings left on the land or on any other account whatsoever.
