THE MOTOR TRAFFIC ACT, No. 14 OF 1951

IN terms of section 87 (4) of the Motor Traffic Act, No 14 of 1951, and regulation 18 of the Motor Traffic (Goods Carriage) Regulations, 1951, notice is hereby given that a public inquiry will be held into each of the following applications for Public Carriers' Permits and for Modification of existing Public Carriers' Permits for use of lorries for fee or reward, on the date, time and place shown against each application.

- 2. (i) At a public inquiry, no person other than the applicant and every person who has duly made objections to the grant of that application shall be entitled to be heard.
- (ii) The Commissioner may, in his discretion, permit any person other than a person referred to in para. 2 (i) above to be heard at a public inquiry.
- (iii) The Commissioner may, in his discretion, refuse to hear at a public inquiry any person if he is satisfied that the views of that person have already been stated adequately by some other person at that inquiry.
