

Easter Attacks: CID holds Rishad, brother under PTA

Forests, water and clean air as Fundamental Rights in new Constitution

Foreign Minister Dinesh Gunawardena said that he has proposed to include environment, forests, water, and clean air as Fundamental Rights in the New Constitution.

He was speaking at the 'Stakeholder Dialogue on Climate Change, Resilience and Just Recovery in the Sectors of Agriculture, Forestry and Biodiversity' held last Friday at Cinnamon Grand Hotel, Colombo.

"Climate change has become the biggest threat to the global existence of humankind. While Sri Lanka is focusing on address-

ing climate change impacts at local and national level, through existing mechanisms, we also continue our engagement and commitment to global action ever since climate change started gaining international traction, through various initiatives.

"Sri Lanka continues to focus on setting up national mechanism to facilitate the work related to the areas of the Warsaw International Mechanism under United Nations Framework Convention on Climate Change (UNFCCC). Since the ratification of the UNFCCC, in 1993,

and the Paris Agreement in 2016, we, as a country have made commitments focusing on key sectors and taking affirmative actions to address the impacts of climate change. In working towards climate action, it is important for us to also achieve sustainable development and at how resilience could be built through inclusive and participatory processes, integrate stakeholder driven decision making processes and implementa-

"I am pleased to mention Prime Minister Mahinda Rajapaksa opened Sri Lanka's largest wind farm, with a capacity of 100 MW, in the Mannar District. The total energy portfolio by 2030 will accommodate over 40 per cent renewable energy and with an anticipated 80 per cent

"Our country is currently engaging with international and regional entities to bring sustainable nitrogen management to the South Asian agenda.

Hambantota Pharma Zone ready for investors in June

Aviation and Export Zone Development State Minister D.V.Chanaka said all arrangements will be made for investors to begin construction of factories in the Pharmaceutical Zone in Arabokka, Hambantota in June.

In a bid to enhance foreign exchange earnings and save foreign exchange by way of import substitution, the government has decided to set up a Pharmaceutical Zone in Arabokka in Hambantota.

State Minister D.V.Chanaka said investors have shown

unprecedented enthusiasm in investing the pharmaceutical industry in the face of COVID-19 Pandemic

Addressing the progress review meeting of the dedicated Pharmaceutical Manufacturing Zone at his Ministry, the State Minister said President Gotabaya Rajapaksa has given specific instructions to him and Ministry officials to ensure that this project runs on time.

The Zone is expected to meet 40 per cent of the domestic pharmaceutical requirement by locally manufacturing drugs while creating pathway to USS 1 billion export earnings as import substitution by 2025.

Born in Colombo to a conservative Muslim family, his father was a proctor by profession. An old boy of Wesley College Colombo, he took to the family business then dominating the shipping industry in Sri Lanaka.

entered politics in 1945, as a Member of the Colombo Municipal Council. He contested the Maligawatte municipal ward as an Independent candidate supported by the Communist Party. As a young dynamic

politician, he rose to be the first Muslim Mayor of Colombo in 1960 from the United National Party. He entered mainstream politics by contesting the Borella constitu-

He served as Labour, Employment and Housing Minister in 1965 and was responsible in making legislation to grant gratuity for private sector employees. "Sputnik V" Covid-19 vaccine will be available by the end of April, while 400,000 doses will be available in May, 800,000 doses in June and 1,200,000 doses in July this year. Cabinet approval has already been granted to purchase and import 13 million doses of the Sputnik V vaccine.

Plans are already on to distribute around 600,000 doses of the Sinopharm COVID-19 vaccine donated by China to Sri Lanka in the next few weeks following WHO approval.

In addition, the State Pharmaceutical Corporation (SPC) has already signed preliminary agreements required for the import of the Pfizer/BioNTech vaccine and the Government is in the process of importing this mRNA-based vaccine as soon as possible.

The Head of the WHO Tedros Adhanom Ghebreyesus has reiterated in Geneva yesterday that adherence to basic public health guidelines is the backbone of the fight against the increased spread of COVID-19. Properly wearing the face mask, occasional hand washing with soap and water or hand disinfectants, the practice of social distancing, and avoiding non-essential travel and events are among the most important.

"Some sections of society think that the country should be locked down for some time as a solution



to control the spread of COVID-19. Although such an action may have satisfactory results at the beginning, in the long term it will have extremely detrimental effects on the lives of the people and the

"The Government pledged to pursue a nonaligned foreign policy but this leads to a position where we lose our sovereignty. We do not have the

capacity to clash with these countries. Anyhow, we are dependent on Chinese and Indian loans. Thus, the Government is trying to bargain parts of the country in exchange for debt," Silva said.

He said that the Supreme Court would only consider whether the Colombo Port City Economic Bill is in line with the Constitution, but it would not go into its economic and political implications on the country.

"A number of economic and political damages are expected from the Port City Bill. According to the Bill, Port city will be governed by a Commission five to seven people appointed by the President. It is unclear who will be appointed," he



City would create two counties and two laws instead of one country and one law. "The Port city Bill excludes a number of Acts such as the Urban Devel-

opment Act, Strategic Development Act, etc. Therefore, this does not belong to the Colombo Municipal Council or Western Provincial Council. In fact, the Parliament too is not accountable for this. We are going to make a grave mistake by taking this forward" he added.

MP Harini Amarasooriya also speaking to the media stated that the Colombo Port City would not be helpful to address the burning issues of the public.

"A Government that comes to power for five years has no right to make arbitrary decisions that could affect not only their tenure but also the generations to come. We urge the Government to seek the approval of the public before passing this Bill" she added.

"MP Bathiudeen was arrested previously also but was later released stating that there is not enough evidence. If he has done any wrong, legal action must be instituted in the Court of Law. MP Bathiudeen will not flee the country. He was arrested in the wee hours on Saturday stating that there is evidence against him. How come the evidence which was not there before came up suddenly?" he questioned.

Swat valley most venerable place for **Buddhists** - Lankan Bhikkus

Sri Lankan Buddhist monks said on Saturday that the paradisiacal Swat valley remained the centre of Buddhism and had immense importance for Buddhists all over the world.

They said this during their visit to the Buddhist archaeological sites of Gandhara Buddhist civilisation in Swat valley.

The delegation includes senior monks Ven. Dr. Walpola Piyananda Thera, Ven. Dr. Bodagama Chandima Thera, Ven. Dr. Kirinde Assaji Thera, Ven. Dr. Pallegama Rathanasara Thera, Ven. Prof. Kallanchiye Rathanasiri Thera, Ven. Uduwe Dhammaloka Thera, Ven. Muruththettuwe Ananda Thera, Ven. Embilipitiye Rahula Thera, Ven. Korathota Dammadassi Thera, Ven. Dr. Atapattukande Ananda Thera, Asela Pushpa Kumara Wickramasinghe and Aaishah Abu Bakr Fahad, who is Second Secretary (political) at the Pakistan High Commission, Colombo.

The monks said that Swat valley had high importance for Buddhists and its name meant a blessing.

Aaishah Abu Bakr Fahad said that during recent visit of Prime Minister Imran Khan to Sri Lanka he invited the Buddhist monks to Pakistan, so the Pakistan High Commission in Colombo organised the visit.

"We tried to take the delegation to the proposed Buddhist Trail and we hope that through this not only people-to-people contacts between Pakistan and Sri Lanka will strengthen, but the religious tourism will also increase from Sri Lanka to Pakistan," she said, adding it was also aimed at showing the true and peaceful image of Pakistan to the world. - The Dawn

Task force to prevent Diyawanna algae growth

A Cabinet paper will be presented this week to appoint a task force on the unusual algae growth in the Diyawanna Oya, Environment Minister Mahinda Amaraweera said.

"It has been confirmed that the discolouration of the water around the Diyawanna Oya in Parliament is due to Algae Bloom or algae growth. Experts have pointed out that this algae growth could further spread and could even lead to a strong odour in the surrounding environment," the Ministry said in a press release yesterday.

"It is proposed to appoint a task force with expertise to provide a solution to this environmental problem. The relevant Cabinet Memorandum has been finalised and Minister Amaraweera will present it at the next Cabinet meeting," the statement added.

Ministry Secretary Dr. Anil Jasinghe said that several factors have been identified with regard to this problem and steps were being taken to prevent the growth of this unusual algae growth.

The Secretary pointed out that such algae growth could be due to the neglect of sustainable development policies in the implementation of Sri Jayewardenepura development plans.

He said that a discussion would be held at the Ministry tomorrow with several experts who can work in this regard.

Speaker Mahinda Yapa Abeywardena convened a meeting in this regard last week. The Speaker instructed Secretary Dr. Jasinghe to take immediate action to prevent the growth of these algae.

Two foreigners die of COVID

Two foreigners were among those who died of COVID-19 in Sri Lanka on Friday and Saturday, the Government Information Department said. The number of COVID-19 deaths stood at 642 yesterday morning.

A foreigner (46) who was residing in Colombo 2 had died on Saturday while under treatment at the Kandy General Hospital. Ambassador Haidari recalled the recent condemnation by Sri Lankan Foreign Minister Dinesh Gunawardena of the terrorist attacks that daily take innocent lives in Afghanistan and greatly appreciated Sri Lanka's firm stance against all forms of extremism and terrorism with no distinction. He also extended to the President the gratitude of the Afghan people and government for the recent statement of the Sri Lanka Muslim Congress, which strongly rejected the use of terrorism and violence against civilians in the name of any religion, especially Islam, a faith of peace, tolerance, and co-existence.






BUDDHISM'S FIVE REMEMBRANCES **ARE WAKE-UP** CALLS FOR US ALL





A Bhikku venerating the Buddha





I love the first one. It makes me trust the whole list: newborn babies. When we encounter a newborn baby, even if we don't have any particular philosophy about the nature of reality, we are struck with something powerful. There's something earth-shattering about a newborn child. In that little face, we see all of it; we see something so perfect. And at the same time, we know that it can't remain. We would never wish for that baby not to grow up, to not get older. And at the same time, when that child gets a little older, we may not be able to see its perfection as clearly. So there's a sense of loss. There's an understanding that this is temporary — and at the same time, so complete.

The second divine messenger is "a bent over, broken-tooth, old person." Every time you see someone who has reached old age - and in this case, a kind of extreme example, someone who has really felt the ravages of age — that's a divine messenger. It's a kind of angel appearing to remind you, in case you forgot in this moment or for today that you, too, are of the nature to grow old, that you cannot escape.

Don't look away. Say thank you.

The third messenger is someone who is suffering from an illness. Part of what I love about this teaching is that I've heard people say, many times, that when you see someone else who is suffering, you should count your blessings that you're not suffering in the same way. This teaching is saying the opposite: "That person is suffering. Don't kid yourself - that person is showing you the nature of your life. You may not feel it acutely in this moment, but this is what it is to be human."

ften, someone will ask me, 'What's Buddhism about?" I usually go straight to what are known as Buddhism's "three — the concepts of dissatisfaction, impermanence, and non-self. I will tell the person, "These are the structural underpinnings of Buddhism." But that's a lot to take in. If I were being more skillful, I would probably have business cards printed up with the "Five Remembrances" of foundational Buddhism on them. And when someone asked, "What is Buddhism?" I would say, "Here. It's this."

· I am of the nature to have ill health. There

is no way to escape having ill health. · I am of the nature to die. There is no way to escape death.


· All that is dear to me and everyone I love are of the nature to change. There is no way to escape being separated from them.

My actions are my only true belongings. I cannot escape the consequences of my actions. My actions are the ground upon which I stand.

These Five Remembrances, first found in the *Upajjhatthana Sutta* ("Subjects for Contemplation"), are intended to be recited. They are intended to be memorized. They are things we can say every day. Maybe they are the first thing you say when you wake up, or the first thought you have before you go to bed; maybe they are taped next to your bathroom mirror or on your kitchen counter. And as they become internalized, they become a kind of touchstone, a constant reminder to yourself that you are of the nature to grow old, that there's no way around aging, that there is no way around sickness. There is no way around death.

These first three, of course, are basically what drove the Buddha to become the Buddha. These were the central wake-up calls of his life before he "woke up": sickness, old age, death. It's so commonsensical.

If you have all five memorized, there's no need for a further teaching. I'm going to ramble about these for a while, but it's all right there already. It's complete. It's Buddhism at its very, very best. It's perfectly clear. It's perfectly compassionate. It's perfectly concise. And you can't argue with it. It must







Prince Siddhartha sees sickness, death, old age and a sage

So we have sickness, old age, death, and then we have these last two. "All that is dear to me and everyone I love are of the nature to change." This is impermanence. "There is no way to escape being separated from" — and there we have a little bit of the spice of dukkha, or unsatisfactoriness. Everything is going to change; nothing is ever going to be as I want it to be, as I need it to be, as I think it should be. I can't keep the perfect thing. I can't keep anything.

We say these in the first person, but we can say them in the second person. Maybe not out loud, but as you are looking at your aging parents, as you are looking at your friend who s suffering from a debilitating disease, as you are looking at your children going through all the joys and the difficulties of growing up,

you can pause and think to yourself: You are of the nature to grow old.

You are of the nature to die.

You are going to suffer separation and loss. We shouldn't pretend otherwise. And of course, we can also say it as "we": we are all this. We are all going to lose what we have, if we ever had it. We are all of this nature. Some of my most grounded and simple moments in relationship to this practice have taken place in settings like subway stations,

moments of being crowded in by hundreds or thousands of people and looking out at so many faces, more than you can process, and then thinking, "Oh, we're ALL this. Everything that is true to me about this practice is true to them." It changes the room. It changes the air. Not because something good happened, but because that's my one brief honest look at where I am.

Remembrance #5 is maybe the most interesting. "My actions are my only true belongings. I cannot escape the consequences of my actions. My actions are the ground upon which I stand." This is about karma. I've heard it said, and maybe you have as well, this phrase, that we own our actions "but not the fruits of our actions." We experience the consequences, but we don't get to have the rewards. Within my tradition, Zen, we can understand this to a certain degree as practice-verification, Dogen's central teaching that the *meaning of what we do* is expressed, complete, in what we do. What we do is the

My life is being expressed 100 percent right now. This is what my life looks like right now. There's no back story. There's no other thing that you don't see. And it's equally true for you wherever you are, whichever part of the world you are in. However you are sitting, however you are breathing, that's you — not just a version of you but the complete you, the culmination of your life.

What you choose to do in this moment matters. There will be consequences. And while you get to choose which actions you take, you don't get to choose what those consequences will be. It's like aiming a bow and arrow while you're running: you know what you want to hit. Maybe you'll get it. Maybe you won't. You just do your best, but you have to accept the consequences for what happens because what other option is there? So Remembrance #5 is saying that what you do matters — so live like it does.

These Five Remembrances are powerful. They are enough. They are more than enough. But I want to add another piece, which is that in another sutra, in the Devaduta Sutta ("The Deva Messengers"), there's discussion

about the Remembrances, but from a different angle: "The Five Divine Messengers." When we encounter these five divine messengers, they are reminders of the Five Remembrances.

Again, don't look away. Realize what you

A meditating monk corpse was not uncommon at all. But these teachings came about in times when there was, for example, no photography. We have a different opportunity. Every time you see a picture of someone from the past, every time you see a photograph of someone who is no longer with us, you can pause and consider the fact that that person died and that you will too, that there is no escape. It isn't a punishment: it isn't unfair. It's just

who we are. And then there's the last divine messenger. This one, we need to examine a little bit; it comes from a different place. The last messenger is "a punished criminal." This image, of course, is intended to remind us of karma, but it points to a narrow definition of karma, something closer to "justice." Perhaps people had more faith in the criminal justice system 2,500 years ago, but if someone points out a "punished criminal" to me today, I don't simply assume the person got what they deserved. How can I know

If a divine messenger isn't sending the intended message, you can disregard it. Find something new. In this case, we're looking for something to remind us of karma luckily, literally everything does. Every time you can't find your keys, it's because you put your keys somewhere else. That too is karma — it doesn't have to look like justice. It doesn't have to be a balancing of the scales; that's a simplistic and dangerous view. It's simply that we do things, and omething comes of those choices.


When you breathe out, your body needs to breathe in again. Just like that, multiple times a minute, you have a reminder that what you do matters, that what you do now is leading to something else. We always bear the weight of that, but we can also choose that weight in the way we sit and stand and walk and speak, because again, what other option is there?

We can get so caught up in the idea that this tradition and this practice are about somehow perfecting ourselves or about purifying our view. Even if we are in a tradition that tells us not to see it that way, that particular door feels so wide, so open, so seductive. But if we choose that path, if we try to walk through that door, then we walk past this, the thing that is truly on offer.

Maybe, in the future, there is a better you, a wiser you, a more compassionate you. But in this moment, you don't need to focus on that at all. Just don't lie to yourself about the nature of your life. That's what these five are saying. Remember every day. Let them be the air you breathe. Metabolize them. And then, whatever you choose to do with your life, the actions you choose to take will come from that place of total honesty, of total transparency.

That's what these five are about. Not something out there. Not something to

If you are looking for a project, go grab a 5×7 card and write the Remembrances down, and stick it next to your mirror. Tape it on your kitchen counter. Put it on your desk. Let these five truths soak into your skin. You've always known them, because they've always been true. But best to remind yourself anyway. (Lion's Roar)

Sri Lankan's death in Japan casts spotlight on its refugee system

the authorities in Japan in August last year to escape from domestic violence, end up dying in detention in Nagoya last

Ratnayake Liyanage Wishma Sandamali, 33, who was taken into custody for overstaying her visa, died on March 6, having lost 20kg while she was in detention over a stress-induced stomach condition.

"I need to recover, but I don't know how to do it. Please help me to recover," she wrote in a February letter to non-profit group Start, which helps immigrants, adding that she was being deprived of medical atten-

She is the 18th foreigner to die in the custody of the Japanese

Immigration Services Agency since 2007.

The case has become a lightning rod for activists who decry inhumane Third World treatment in a First World country.

Wishma was vomiting blood in her final days, and was so weak that she had no control of her arms and legs.

The immigration authorities allegedly turned a blind eye to medical expert advice to put her on an intravenous drip or to grant her provisional release to ease her stress.

A report by public broadcaster NHK suggested that officials tend to suspect malingering for minor illnesses in their reluctance to grant provisional release.

Yet, at the same time, Japan is

pushing through reforms to its Immigration Control and Refugee Recognition law that will forcibly deport refugees if their applications for the right to stay are rejected twice.

The law allows immigrants to apply for refugee status as many times as they want. Deportations cannot be carried out during the application or appeal process.

The revisions, Justice Minister Yoko Kamikawa argued, will solve the problem of repeated asylum bids leading to indefinite detention and the accompanying

"Many individuals have been trying to avoid deportation, contributing to their prolonged detention," she said, insinuating that they have been trying to game the system.

COPE probes FFSL irregularities

The Committee on Public Enterprises (COPE) on Thursday drew the attention to irregularities of former Football Federation Chairman Manilal Fernando in using money provided by various institutions.

Accordingly, misappropriation of Euro 40,400 (nearly Rs. 6 million), which had been donated by the Italian Football Players Association to construct football playground in Kalutara, USD 60,000 (nearly Rs. 6 million), which had been given by the Asian Football Federation for competitions, Rs.10 million, which had been given by private company to construct 20 houses for Tsunami victims and USD 200,000, which had been donated by the Asian Football Federation were discussed at the meeting.

It was revealed that the President of the Federation has submitted an affidavit to Court stating that no such financial irregularities have taken place in the background of the Financial Crimes Investigation Division (FCID) concluding its investigations and filing cases in Courts. The committee pointed out that it was a serious matter to inform through an affidavit that it had not happened.

COPE Chairman Prof. Charitha Herath said that football in the country has fallen to a very low level despite such a large allocation of funds, it has fallen to such a low level. Therefore, the Chairman and former Chairman Manilal Fernando should be summoned immediately before the COPE to investigate the matter, the COPE said.

The COPE Chairman on Thursday suspended the COPE meeting of the Football Federation of Sri Lanka, due to the absence of the President of the Fed-Accordingly, the Presi-

dent and other officials of the Sri Lanka Football Federation and its former President Manilal Fernando will be summoned on May 6, the COPE Chairman said. The committee pointed

out that although 10 members were elected to the Football Federation Executive Committee, it was revealed that the Chairman would appoint another 18 members to the Commit-

The COPE instructed the Youth and Sports Ministry Secretary to intervene immediately as this is a problem, even though it is done in accordance with the Constitution of the Federation. Youth and Sports Ministry Secretary Anuradha Wijekoon said that an order will be issued soon to prevent the appointment of 18 members by the Chairman.

The Committee pointed out that the election committees to conduct elections of these sports associations are being set up by these associations and therefore, these activities are being carried out without any transparen-It was revealed that Rs.

750,000 will be given to the Chairman of the Election Committee for the forthcoming election of the Football Federation and Rs. 600,000 each would be given to the other two members and this was severely criticised by the Committee. It was also revealed that this situation has arisen due to the inability to oppose the decisions of the Chairman as there are 18 members appointed by the Chairman.

The COPE Chairman said that the Ministry should always be vigilant about the role of these associations and that direct supervision should be carried out by the Ministry.

Covid facts in perspective

he new Covid-19 protocols in place here are in the nature of health guidelines backed up with State sanction. They are definitely no cause for alarm. The worst is undoubtedly behind us as far as the pandemic is concerned, but intermittent waves are to be expected. That is the nature of this contagion.

In many ways, waves they are not — even though they are called "waves" by those who sensationalize these issues in the media, and social media in particular. A "wave" sees a distinct and substantial uptick in the number of cases that there is a need to use new terminology to describe what is happening. Sri Lanka has not seen that sort of increase in numbers of the infected though there is certainly a mild increase of those who are testing positive. That is not something to be alarmed about except that there is a cautionary tale reviewing the experience of some other countries.

All this is happening at a time the economy is picking up in significant ways. Economic activity in the country saw a manifold increase in the Sinhala and Tamil New Year period, which saw an increased number of people on the streets that is now partially being blamed in certain quarters for the new Covid numbers that are said to threaten the recovering economy. This "vicious circle" explanation of how things are happening is a mere fraction of the narrative. There would anyway be a natural increase in the numbers of Covid-stricken patients in the course of time. This is inevitable as there have not been enough people vaccinated yet for herd immunity to take hold.

All this information could bewilder and confuse some people if it is not filtered in a way that there is a logical reading of events. But the media and social media behaviour that overlap leaves too much room for idle speculation. The information control aspect of Covid is sometimes as important as actual disease control. But even countries such as New Zealand have had problems in this area.

The narrative about the pandemic and the pandemic itself are both unleashed in tandem, and could be chaotic. But very often the perceptions cause even more chaos than the pandemic itself. There is also a measure of what is called "vaccine complacency" affecting some of the most successful of countries when it comes to Covid curtailment.

Did vaccine complacency contribute in any measure to the current slight increase in numbers this country is seeing after the holiday season? Did enough vaccinated people break the protocols in place to contain the disease, to cause some sort of jump in numbers among those who were not vaccinated? It is possible this happened for the simple reason that those who are vaccinated can be carriers of the virus even though they would not succumb to it, or would experience mild to no symptoms.

In some countries social media was used to good effect with the State being able to muster the power of various alternate media platforms to good effect. In this regard the New Zealand example is exemplary. Could we replicate that situation here? Probably not as well as New Zealand has done, because there are still remote parts of this island in which certain popular social media platforms are not widely used, amazing though that may sound in this day and age.

Curbing the spread of needless panic is almost as important as channeling accurate information to the people. Those who consider social media as a trusted information source are more often part of the problem than they are a solution to the problem. Some who share seemingly innocuous posts are genuinely misinformed for the simple reason that they trust any source. Impressive looking posts that are immaculately crafted could be minefields of misinformation. That is what is scary about the social media age that has sophisticated methods of communication at the disposal of amateurs.

Over time, however, people too become wiser to the negative impact of certain fringe misinformation campaigns, some of which are unleashed as pure mischief while others are planned efforts at disturbing the vital social cohesion that is an important factor in combating the consequences from the smallish Covid outbreaks that happen from time to time. But by the time people learn the truth about misinformation it may be too late, which is why there should be a greater effort to educate people about the real picture. The Government is doing what is possible by getting the message across through available media, but this too paradoxically can motivate some people to take extreme measures such as panic buying of foodstuffs because they think the Government is not giving them the full picture with the precise motivation of avoiding panic.

Such paradoxes aside, it is important that people act responsibly. There are always the deviants that would share the wrong information or indulge in damaging gossip — but their impact would be minimal if people are as vigilant about the possibility of being duped by misinformation, as they are about the dangers of the virus.

Wear a mask in office, which should be well ventilated

ast Friday was a judgement day for Sri Lanka. During the most important press conference held this year so far, Sri Jayewardenepura University Department of Immunology and Molecular Medicine Professor Neelika Malavige said that the latest COVID-19 variant in Sri Lanka is airborne. This single and simple scientific fact has already decided the fate of Indian people and it will shortly decide the fate of Sri Lankans.

But Sri Lankans are much luckier than Indians because we still have the time and the chance to prevent a huge COVID-19 disaster similar to India. Prof. Malavige explained how you can get killed by a stranger not wearing his or her mask properly inside a building. She explained very well how it happens and said that when a person does not wear a mask properly inside a building, he or she contaminates the air inside the building and then leaves the building after waiting for some time. Then another person comes and does not wear the mask in the same building and he or she inhales the contaminated air. The result is that one can become COVID-19 positive even without associating per se with an infected person.

This tragedy is now at our hand's length. It is common to see how rich or poor, educated or uneducated, and young or old meet and speak with others without a mask or without wearing the mask properly, covering both the nose and the mouth. The majority remove the mask as soon as they enter their office or a familiar place where their relations or friends are. No one wears masks because there is no one to demand to do so. Friends are not concerned at all and relations are so sure that they are not COVID-19 positive. The Department Heads turn a blind eye and deaf ear when they come across a staffer without a mask. This situation existed in Sri Lanka from late

Most of the time employees give a sarcastic look at people who wear masks properly and wear additional protective equipment such as face shields or visors. The individuals who had power to monitor and regulate the COVID-19 prevention measures turned a blind eye towards such employees who broke the rules and regulations and made fun of the other employees who obeyed all rules and regulations.

It is a sin if someone has to pay the price of his or her life for an offence that he or she did not commit. Now it can happen due to the behaviour of the latest COVID-19 virus which is airborne. Maybe the

innocent victim does not know who contaminated the air of the building a few minutes ago because by then the culprit is not in the building. It is the same with air conditioned private and state-owned buses which run along expressways.

People who travel in air-conditioned buses do not wear masks properly and they sneeze and cough freely inside those buses spreading the COVID-19 virus which is now airborne. It is almost the same with all the other small air-conditioned offices with several employees. It is funny to see how some employees require air-conditioning turned to 15 or 18 degrees Celsius to stay and work inside a small office. If an employee increases the temperature of the air conditioner for a few minutes those employees shout at them. It seems all houses of those employees are fully air-conditioned 24x7. But now COVID-19 can kill the entire staff if one employee is an asymptomatic COVID-19 patient. This is the bitter truth all of us ignore.

It is strange that some Departmental and Agency Heads with all the scientific knowledge on airborne COVID-19 virus do not make sure that the entire Department gets proper ventilation by opening all windows and doors. Those who think that air-condi-

tioning is better than opening doors and windows to control the airborne COVID-19 virus can be forgiven if they had passed the eighth grade and become Department Heads by acting as henchmen of a politician or a top official, but what about educated Department Heads?

If someone is working inside a small air-conditioned office with a bunch of selfish employees, there is only one

way of saving himself or herself. That is wearing the best mask which costs nearly Rs. 2,000 in the market with goggles or shields during office hours. There is no other way. But if all employees care for all the others and strictly follow all health guidelines all the time, such an office is safe for anyone to work in.

To be a selfless employee one needs to do certain simple and inexpensive things. They are wearing a proper mask all the time inside his or her department, keeping at least two metres distance from another employee and washing hands properly for 30 seconds with soap and water whenever possible. He or she needs to keep a good hand sanitizer inside his or her pocket to use when soap and water is not available. The Department heads can get all important surfaces such as tables, door handles, telephones, railings, etc. cleaned once every two or three hours.

One female employee attached to a State Ministry located in Colombo 7 saved herself and her aged parents from COVID-19 recently by acting with a backbone and maintaining mindfulness. All her colleagues except herself became COVID-19 positive last October. She wore the best mask all the time while working in her Department and had meals and tea outside in the garden alone while all the others laughed at her and made fun of her. She did not associate with anyone during office hours. She washed her hands and used a good hand sanitizer all the time. All her friends abandoned her because she simply rejected their invitation to share food. But she still has the most valuable thing in her life, that is her aged parents.

At this moment we all need two main things. They are being mindful all the time and having a backbone to follow all health guidelines all the time and demand others to do the same. We have the right to protect ourselves. No one can violate our right to life.



COVID-19 VACCINES:

RICH COUNTRIES MUST MAKE A CHOICE

lmost one billion doses of Covid-19 vaccines have been administered around the world, and yet the weekly number of cases hit a record high last week, and deaths are climbing, on pace to eclipse 2020's grim tally. How can this be? Weren't vaccines supposed to douse the flames of the pandemic?

Yes, and they are. But here's the thing about an inferno: If you hose only one part of it, the rest will keep burning.

Many countries all over the world are facing a severe crisis, with high transmission and intensive care units overflowing with patients and running short on essential supplies, like oxygen.

Why is this happening? For several reasons: The rise of more transmissible variants, the inconsistent application and premature easing of public health measures like mask mandates and physical distancing, populations that are understandably weary of adhering to those measures and the inequitable distribution of vaccines.

Scientists developed several vaccines for Covid-19 in record time. Yet of the more than 890 million vaccine doses that have been administered globally, more than 81 percent have been given in high- and upper-middleincome countries. Low-income countries have received just 0.3 percent.

This problem is sadly predictable. When the HIV epidemic erupted in the 1980s, lifesaving anti-retrovirals were developed rapidly, and yet a decade passed before they became available in sub-Saharan Africa.

A year ago, the World Health Organization (WHO) and many global health partners came together in an effort to avoid history repeating. The Access to Covid-19 Tools (ACT) Accelerator, including the vaccine sharing initiative Covax, was begun to ensure the most equitable possible distribution of vaccines, diagnostics and therapeutics for Covid-19.

The concept was crystal clear: At a time when no one knew which vaccines would prove effective in clinical trials, Covax was designed to share the huge inherent risks of vaccine development, and to offer a mechanism for pooled procurement and equitable

While scientists toiled in laboratories, the

WHO and partners set standards, facilitated trials, raised funds, tracked manufacturing progress and worked with countries to pre-

Countries at all income levels, manufacturers and others in the private sector committed to participate.

But many of the same wealthy countries that were publicly expressing support for Covax were in parallel pre-ordering the same vaccines on which Covax was relying.

In January, I issued a global challenge to see vaccination underway in all countries within the first 100 days of the year. This was an eminently achievable goal.

By April 10 — the 100th day — we had come close to achieving it: All but 26 countries had started vaccination, and of those, 12 were about to start, leaving 14 countries that had either not requested vaccines through Covax or were not ready to start vaccinating.

But the amount of vaccines delivered has been totally insufficient. As of Thursday (April 22), Covax has distributed 43 million doses of vaccine to 119 countries — covering just 0.5 percent of their combined population of more than four billion.

Since the ACT Accelerator's birth a year ago, many of the world's biggest economies have given strong support to Covax politically and financially, but they have also undermined it in other ways. First, vaccine nationalism has weakened Covax, with a handful of rich countries gobbling up the anticipated supply as manufacturers sell to the highest bidder, while the rest of the world scrambles for the scraps. Some countries have placed orders for enough doses to vaccinate their entire population several times over, promising to share only after they have used everything they need, perpetuating the pattern of patronage that keeps the world's have-nots exactly where they are.

Second, vaccine diplomacy has undermined Covax as countries with vaccines make bilateral donations for reasons that have more to do with geopolitical goals than public health. This inevitably leaves countries with the least political clout as wallflowers at the vaccine

Third, vaccine hesitancy has hampered the rollout of vaccines, through the same combination of myth and misinformation that has enabled measles to resurge around the world.

Reports of very rare side effects linked to some vaccines have spurred countries with other options to cast some aside. This includes vaccines that many of the world's low-income nations were relying on but now question. Let's be clear: While safety is paramount and we pay careful attention to any signs of adverse events, the shots' benefits vastly outweigh the risks for all four vaccines with WHO emergency use listing.

And fourth, a new trend — let's call it vaccine euphoria — is undermining hard-won gains as some countries relax public health measures too quickly and some people assume that vaccines have ended the pandemic, at least where they live.

It doesn't have to be this way. Scarcity drives inequity and puts the global recovery at risk. The longer this coronavirus circulates anywhere, the longer global trade and travel will be disrupted, and the higher the chances that a variant could emerge that renders vaccines less effective. That's just what viruses do.

We face the very real possibility of affluent countries administering variant-blocking boosters to already vaccinated people when many countries will still be scrounging for enough vaccines to cover their mostat-risk groups.

This is unacceptable. Analysts predict vaccines will generate huge revenues for manufacturers. Meanwhile, the ACT Accelerator is still \$19 billion short of the funds it needs to expand access not just to vaccines but also to diagnostics and treatments like oxygen. But even if we had all the funds we need, money doesn't help if there are no vaccines to buy.

The solution is threefold: We need the countries and companies that control the global supply to share financially, to share their doses with Covax immediately and to share their knowhow to urgently and massively scale up the production and equitable distribution of vaccines.

One way to do this is through voluntary licensing with technology transfer, in which a company that owns the patents on a vaccine licenses another manufacturer to produce its shots, usually for a fee. Some companies have done this on a bilateral basis. But such agreements tend to be exclusive and nontransparent, compromising equitable access.

A more transparent method is for companies to share licenes through the Covid-19 Technology Access Pool, a globally coordinated mechanism proposed by Costa Rica and started by the WHO last year.

Another option, proposed by South Africa and India, is to waive intellectual property rights on Covid-19 products through a World Trade Organization agreement that would level the playing field and give countries more leverage in their discussions with companies. Governments could drive greater sharing of intellectual property by offering incentives to companies to do it.

If this is not a time to take those actions, it's hard to fathom when that would be.

In combination with proven public health measures, we have all the tools to tame this pandemic everywhere in a matter of months. It comes down to a simple choice: to share or not to share.

Whether or not we do is not a test of science, financial muscle or industrial prowess; it's a test of character.

brave new world that has such people in't!' Miranda said in Shakespeare's *The Tempest*, on first sighting the shipwrecked courtiers. Today, at the end of the second decade of the 21st century, most of us have a sense of it as the world is in a state of disorder. All about us is prominently chaotic. The world is ravaged to an extent by Covid-19 and the failure of governments and multilateral institutions, and an attempt to see the light at the end of the tunnel may be too simplistic. With the future of humanity threatened and uncertain, the 'new world' has failed to believe in a consensus-based approach to finding a mechanism to decode the global pandemic, and creating a common task force to save humanity from suffering an unprecedented crisis consecutively in the second year.

While reading The New World Disorder and the Indian Imperative by Shashi Tharoor and Samir Saran, one gets a very clear sense of the new world order in transition. The book prominently deals with the roots of the universal predicaments — from the inequity of the post-war international power politics to the fundamental causes of the new world's illiberal leadership. In the South Asian region too, the wind of change is well felt. Yet the authors overlook India's growing leadership issues and rightly believe in its potential in the long run where it has a major role to play in shaping future global trends.

Rise of the East

The rise of the East is wrongly viewed with skepticism and fear by the West, precisely so, as somewhere it is erroneously made synonymous

with the 'rise of China'. This may just be one of the factors of a serious perception gap; however, it is strong enough to be not undermined by the West's strategic and economic thinkers. India's peaceful growth principles are beckoning for all the good reasons. Notwithstanding its short-term precariousness on home turf and in the immediate neighbourhood, India's potential is something that should be debated before writing off the 'Asian Century Dream' in haste. One can be incorrigible in maintaining a stand on

As the South Asian countries are facing a sort of humanitarian crisis amid the second wave of Covid-19, one can wonder whether they can explore the potential of 'the new world order' with the aim of gaining in the post-recovery phases. Sharing a broad mission can be helpful to India, Nepal, Bhutan, Bangladesh, Sri Lanka, Afghanistan, Pakistan and the Maldives. It would be crucial how these

countries view China's aggression in the South Asian region and its adverse implications for regional unity and bilateral relations. Not often discussed, though also not beyond the obvious, a very promising regional association like the South Asian Association for Regional Cooperation (SAARC) could not do as well as expected with China's territorial and market overreach. In comparison, India's posture in the neighbourhood has been conciliatory, and its dominance in the region merits being seen through the same perspectives.

"The international liberal order is facing a moment of crisis. With Darwinism (or the survival of the strongest and fittest) having guided the construction and management of international systems of governance for seven decades, it is no surprise that as sweeping change overtakes the

world, there are no longer many takers for these arrangements. Globalisation is confronted by economic nationalism. Strong leaders are exploiting the grievances of citizens (whether imagined or real) to discard global ideals and champion local interests. And the prospects of a 'global village', of the world coming ever closer together, seem to be in reversal. A zero-sum approach to development and the securitization of growth are creating new potential for conflict at a time when the institutions of global governance are weaker than ever before," write Shashi Tharoor and Samir

They make it amply clear how the newly disrupted world is not short on opportunities for the countries that have been hitherto given no due by a niche group of countries. Desperate times call for desperate measures, and

is certainly high as the world is reassured of seeing a complete reset.

Braving the New World Order

There is no single multilateral institution including the United Nations that can exactly ascertain the level of losses the world has witnessed with the Covid-19 global pandemic. In fact, the UN's failure in communicating the imminent dangers of unknown biological warfare disguised as a malady, and making a concerted effort to constitute an international task force for a global approach to save the world, is too big to be ignored. Today, we are already living in a ravaged world that can't live in harmony if the old institutions find no new way to justify their

existence. At the cusp of a defining change, it

as an aspirational country, India' stake is wishful that the South Asian countries come forward for reimagining South Asia and staking a claim in the new world order. To brave the challenges, some of the inherent weaknesses have to be addressed, especially on the bilateral front. Essentially, for finding a strong basis for regional and sub-regional economic and strategic integration, the bilateral hiccups and unhelpful baggage of the past have to be effectively dealt with. In South Asia, a new chapter of cooperation should be driven by regional unity rather than symbolisms of bilateralism and trilateralism. A shared vision for regional peace and prosperity will help bilateralism and trilateralism too. If the region gets a new lease of life through a renewed approach of cooperation, the new world disorder will be rather eventful after the crisis. (Kathmandu Post)

SIGNIFICANCE OF BAK FULL MOON POYA

Origins of spiritual diplomacy

he significance of Bak poya is historical since it marks Buddha's second visit to Sri Lanka. This is noteworthy, as Bak is a month of national importance as well.

According to Mahavamsa, Buddha could foresee an imminent war between two Naga Kings Culodara and Mahodara, uncle and nephew, over a jewel-studded throne that made Him think of visiting Lanka for the second time. Professor Wilhelm Geiger explains the conflict in the translation of Mahavamsa:

"That same Naga Mahodara was then a King, gifted with miraculous power in a Naga Kingdom in the ocean, that covered half a thousand Yojanas. His younger sister had been given (in marriage) to the Naga-King on the Kannavaddhamana mountain; her son was Culodara. His mother's father had given to his mother a splendid throne of jewels, then the Naga had died and therefore this war of nephew with uncle was threatening and also the Nagas of the mountains were armed with miraculous power.

Mahavamsa also records that the Buddha was accompanied by a deity to Sri Lanka.

"The deva named Samiddhisumana took a rajayatana-tree standing in Jetavana, his own fair habitation and holding it like a parasol over the conqueror, he with the Teacher's leave, attended him to that spot where he had formerly dwelt. That very deva had been, in his latest birth, a man in Nagadipa.

On the spot where thereafter the rajayatana-tree stood, he saw paccekabuddhas taking their meal. And at the sight his heart was glad and he offered branches to cleanse the alms-bowl.

Therefore he was reborn in that tree in the pleasant Jetavans garden, and it (the tree) stood afterwards outside at the side of the gate-rampart. The God of all gods saw (in this) an advantage for that deva and for the sake of the good which should spring (therefrom) for

our land, he brought him hither (to Lanka) together with his tree.


Mahavamsa then relates how Buddha settled the dispute and the next development of events.

"Hovering there in midair above battlefield the Master, who drives away (spiritual) darkness, called forth dread darkness over the Nagas. Then comforting those who were distressed by terror he once again spread light abroad.

When they saw the Blessed One they joyfully did reverence to the Master's feet. Then preached the Vanquisher to them the doctrine that begets concord and both (Nagas) gladly gave up the throne to the Sage.

"When the Master, having alighted on the earth, had taken his place on a seat there and had been refreshed with celestial food and drink by the Naga-Kings, he the Lord, established in the (three) refuges and in the moral precepts eighty kotis of snake-spirits, dwellers in the ocean and on the mainland.

"The Naga-King Maniak-



khika of Kalyani mother's brother to the Naga Mahodara, who had come thither to take

part in the battle and who, aforetime, at the Buddha's first coming, having heard the true doctrine preached, had become established in the refuges and the moral duties, prayed now to the Tathagata: â€~Great is the compassion that thou hast shown us here, O Master!

Hadst thou not appeared we had all been consumed to ashes. May thy compassion yet light also especially on me, O thou who art rich in loving-kindness, in that thou shalt come again hitherto my dwelling country, O thou peerless one'.

When the Buddha had consented by his silence to come thither, he planted the rajayatana-tree on that very spot as a sacred memorial and the Lord of the Worlds gave over the rajayatana-tree and the precious throne-seat to the Naga-Kings to do homage thereto. â€~In remembrance that I have used these do homage to them, ye Naga-Kings!â€

Buddha's calling forth dread darkness over the Nagas should not be misunderstood. The Buddha holds fame for being the Greatest Compassionate on earth. The concept bears a symbolic meaning;

Buddha preached the dark side of the world, and the Naga tribes were scared just to hear and visualise them. That paved the way for them to comfort later on.

Buddha's visits to Sri Lanka are believed to be false and legendary in certain sects. One reason is that it is not contained in Tripitaka, the official document of Buddha's life. Tripitaka contains more philosophically important factors, rather than history. Buddha had been to Sri Lanka thrice: the first visit to Mahiyangana, second to Jaffna, then called as Nagadipa, and third to Kelani-

The common question is that if Buddha had already been to Sri Lanka, not only once, but thrice, why did Arahant Mahinda visit Sri Lanka once again. Arahant Mahinda, of course, had a mission to fulfil: to establish the Upasampada Bhikku order. The suitable time was not ripe for Buddha to consider establishing the serious Bhikku order. However, Buddhism was not alien when Arahant Mahinda set foot.

Fruits of an intellectual struggle

orthern Sri Lanka is said to have been blessed by Thathagatha the perfect one with the outcome of his intellectual struggle - the absolute truth of life during the month of Bak.

Dhamma chronicles reveal that he diverts his divine eye, a countless number of times on the lives of countless beings and their journey in the sea of Sansara, to come to their aid and relieve them of their suffering

This is said to be his daily routine. In the fifth year of his supreme enlightenment, while he was at Jetavanarama, Sri Lanka had caught his divine eye. Mahodara a powerful King in Nagadeepa whose younger sister named Thirachchika married a Naga King had been offered the above throne which was later inherited by her son Chulodara.

The raging King was about to wage war when Thathagatha appeared immediately which happened to be the month of Bak. Here the inhabitants who belonged to various tribes such as Yakka and Naga, Naga being more advanced in trade and industry supporting the Naga Kings with their rough behaviour and poor intellect though opposed the Buddha at the beginning, they did have the good fortune to be blessed with the message of the Dhamma.

Rajayathana Kiripalu Rukha A deity named Samiddhi Sumana who had made the above banyan tree his abode, in Jetavana accompanied Thathagatha holding the uprooted tree as an umbrella to him, who knew that it was a merit bestowing act to the

On arrival seeing the Naga Kings involved in fighting, Sakyamuni with his psychic powers appeared above, in the sky performing miracles which made the Nagas astonished and happy. Finally having listened to the sermons displaying the masterly knowledge of unity and harmony, meththa and compassion they worshipped Thathagatha with overwhelming shraddah and within minutes the throne was offered to him in unison and



became pious devotees thereafter

The Naga King Maniakkitha, the ruler of Kelaniya who had become a follower of the Buddha during his first visit to Mahiyangana, while on his way to help Chulodara Mahodara in the battle ground, moved by the compassion of the Buddha thanked him profusely for settling the dispute. He further pleaded for a souvenir to worship and consequently the Buddha offered him the Kiripalu tree and the throne. History says that where Kiripaluruka was planted a Chetiya was built enshrining the Minipalanga by Chulodara and Mahodara.

Nagadeepa Seya The temple premises with

its glittering dagaba bear testimony to Thathgatha blessings. This above mentioned Chaitya, Nagadeepa Seya is supposed to be one of the 16 most sacred places to be worshipped in Sri Lanka. This is a milestone in Sasanic history and is of considerable historic value and immense cultural significance.

History records that it was developed and reconstructed by pious Kings like Devanampiyatissa, Dutugemunu and converted into a fully accomplished sacred place. According to the golden Sannasa Wallipuram committed to writing during the reign of King Vasabha, it is the present Jaffna peninsula that was identified

as Nagadeepa.
Invitation to Thathagatha
When King Maniakkitha met
Thathagatha on his second
visit to Lanka at Nagadeepa he
was very anxious that the great

master, visit his kingdom too. With universal love towards all beings he arrived at Kelaniya later in the eighth year of his enlightenment. This honoured invitation had been made on a Bak full moon day, paving way for the third visit of the Buddha to this Dharmadweepa. There is other evidence which highlight the importance of Buddha's visit to Nagadeepa during the month of Bak. Surrounding areas bear testimony to this. To show profound religious devotion and respect to Thathagatha, devotional activities include, the offering of flowers, incense and oil lamps coming down from Buddha times to this day. These offerings are made as a mark of gratitude in return for Buddha's blessings.

It is believed that villages in and around Nagadeepa known as †Mallakam' and †Chunnakam' indicate places where flowers and incense were supplied for the worship of the Buddha. Further, the Buddhist chronicles make mention of †Puwangu Divayina, Ka-ara Divayina, Manda Divayina' as popular Buddhist villages in the area, entirely devoted to Buddhist activities.

One can well and truly say that Nagadeepa the most favoured spot visited and blessed by Buddha occupies a unique place in the history of the island as a blissful place showered with peace and harmony among the inhabitants. May the relics enshrined in the Chetiya usher the area with unity for the peaceful co-existence of all beings.

etta (lovingkindness) is that sense of openness when we feel connected to everyone and everything in the world. In some ways, it's a natural outgrowth of mindfulness practice and just the general cultivation of happiness in our lives. When the Buddha talks about lovingkindness, he's clearly pointing to something different from what we usually call "love.†In fact, his teachings point to the problems with selective love, and how that leads to clinging and ultimately suffering as things change. The Metta Sutta tells us to spread love over the entire world to everyone, no matter what we think or feel about them. This is unconditional love, love that doesn't expect or need a return, love that sees past the petty differences and disputes in life to the universal longings for happiness that we all share. In practicing lovingkindness, we are faced with our clinging, our judgments, and our selective caring. We see that what we usually call love may have a lot of conditions tied up with it: "I'll love you as long as you love meâ€ or "as long as you give me what I want.†And, further, we see that the love we have for our dear ones makes us vulnerable to grief and loss.

Traditionally, metta practice focuses on three categories: those we love, those we are neutral or have no strong feelings about, and those we have difficulties with. Before we work with these categories, the practice suggests we first focus on a benefactor or beloved person (or even a pet). When we spend time sending lovingkindness to this beloved, we accomplish a couple of things: first, we soften ourselves up a bit, so that we are ready to send love to others; and second, we get a clear sense of what love feels like so that we establish that kind of baseline.

After connecting with the beloved, we then try to send love to ourselves. Many people find this to be one of the most difficult aspects of the metta practice. At least in our culture, many of us have complicated, and often negative, feelings about ourselves. To see ourselves as just another person deserving love is a valuable exercise. Here we start to disidentify with ourselves, see ourselves in more objective terms. When we can see ourselves as just another imperfect human, equally deserving of love as anyone else, it becomes easier to offer love to ourselves.

Moving from focus on ourselves to focus on all the rest of the people we care about-family, friends, intimates, and partner-the heart tends to open more easily. Now we might feel ourselves getting into the flow of lovingkindness. Without obstruction, and using the phrases, feelings, and visualizations of the practice, the mind can become quite focused and concentrated, so that, not only do we enjoy the pleasant feeling of love, but also the powerful feeling of concentration, called samadhi, that comes with deeper meditation practices.

We then try to carry these two qualities, the openheartedness and the focus, into giving metta to a neutral person or persons. For many people, this seems to be an awkward practice at first, but I think it has great potential in terms of growing a broad sense of lovingkindness for all beings.

A neutral person is someone we don't have strong feelings about, either positive or negative. I've used people like the clerk in the video store and the security guard at the bank. These are people I can visualize pretty easily because I've seen them many times, but I certainly don't like or

dislike them in any meaningful way.

At first, and naturally enough, it might be hard to feel much about these people,



but the practice gives us a form we can simply follow without worrying about the results. You see the person in your mind, you say the lovingkindness phrases to yourself, and you try to connect in your heart. What helps me in doing this practice is contemplating the universal desire for happiness and freedom from suffering. Even though I don't really know this neutral person, I know that, just like me, they want happiness. So, in a sense, I'm connecting with my own wish for happiness and just projecting it onto them.

As we work with the neutral person, we have the opportunity to see what the Buddha was getting at. It might be easy to wish happiness for your loved ones, but as you wish that, it's still very personal for you. You have some investment in their happiness, so it's difficult to disidentify with their happiness. However, with the neutral person, you have no investment, so you have to connect with something else, this universal longing that is impersonal. That moves you away from your self-identification into a more authentic metta. As long as there is identification or longing or investment in someone else's happiness, we aren't experiencing uncon-

I think that many people can get caught up in the idea that metta is about feeling good and praying for people you care about. This is something of a distortion of the teachings. Yes, being immersed in metta is a pleasant experience, but that experience isn't the goal of the practice.

Working with the difficult person makes this fact clear. If we were just trying to feel good, we certainly wouldn't spend time thinking about someone we don't like. The difficult person can be someone you've had conflict with or toward whom you have a resentment. Sometimes when no one in my life comes up, I just use a political figure that I disagree with. In any case, this is a place where we have to apply a strong mindfulness to our practice so that we don't lapse into aversion, anger, judgment, or resentment. As we follow through on the practice, visualizing the person and saying the phrases, it's very likely that we will not feel much that's positive, at least in our initial efforts. We need to be careful that the mind doesn't wander into negative thoughts and that we just keep with the simple task of the practice, staying with the words and the breath in the heart. Here, you may be able to get some insight into the limits of your own capacity for love. That's a valuable thing to see. It can give us some goals as well as show us where some of our own suffering comes from.

Clearly, the great spiritual masters believe that the capacity to love our enemies is one of the vital tasks of human evolution. Jesus spoke of this and exemplified it when he forgave those who crucified him; the Buddha explains this in the "Simile of the Saw,†in which he says that even if someone were sawing off our limbs one by one, no thought of hatred should arise. If we want to be truly loving people, unconditionally and for all beings,

we have to work with some form of this practice. It's certainly not something that I've come anywhere close to mastering, but I have found that with compassion practice, I can get some sense of this.

After working with the difficult person

After working with the difficult person, we can move to the expansive part of metta practice. This is actually a complete shift because no longer are we thinking about any individuals, but working instead with a sense of space. This space is what the Buddha is talking about in the Metta Sutta when he says that we are "radiating kindness over the entire world, spreading [it] upwards to the skies and downwards to the depths, outwards and unbounded, free from hatred and ill will.â€

This is a somewhat more difficult area of practice to describe because it doesn't have the same cognitive elements of the earlier pieces. Instead, we are working more with a feeling, a feeling of expansiveness and connection. Hopefully when we arrive at this part of the practice, we've developed something of an inte sense of lovingkindness. While focusing on that feeling, that authentic wish for all beings to be free from dukkha, or suffering, we being a process of imaginative expansion. We can use a visualization if that works, while we stay connected to the feeling in the heart and imagine that the love is growing.

First we see/feel that love filling and enveloping the room we are in. Then we let that feeling expand out through the whole building, the neighborhood, outward in all directions until it touches everything on earth. This can be done slowly or quickly, depending upon how much time you have and how into it you are. You can think of specific groups of people you want to send love to: the sick and dying, the oppressed, or whatever comes up for you. You can also send love to animals, plants, and the earth itself.

At this point, you may lose the sense of boundaries with your body, and experience a sort of floating or fluid sensation. I'm not trying to tell you how you should feel-just know that anything in this realm is normal and helps to support this part of the practice. When we've spread loving-kindness over the entire planet, we then expand into space, vast and limitless. We try to permeate the universe with loving-kindness.

Once we've sat in this place of boundless love for a littlewhile, we can bring ourselves gradually back into the body and heart, and close the period of meditation.

Practice-Metta Phrases

I've more or less outlined the practice above. Always start by connecting with the breath, so you have some attention in your body, preferably at the heart. As I've said, we first send metta to a beloved person or benefactor, then ourselves, our dear ones, a neutral person, a difficult person, then radiating to all beings. A big part of this, then, is the felt sense of lovingkindness; however, this feeling may be stronger, weaker, or even absent at times. Nonetheless, we continue the practice by visualizing the people we are sending metta to, maybe naming them, and repeating phrases. You should use phrases that

are some typical ones: May you be happy May you be peaceful

May you be peaceful May you live with ease.

resonate for you and are simple and

direct. Not more than four phrases. Here

May you live with ease. Some people like to add something like, "May you be safe.â€

Stay in touch with your breath; notice feelings of happiness or resistance that come up at various stages; let the phrases flow with the breath and stay connected to the heart.

Buddha's second visit

The enlightened one arrived in Sri Lanka, accompanied by Diety Samiddhisumana on a Bak Full Moon Poya day to settle a war between two factions of Naga community. The Buddha's mission was to bring peace to this island. Bak Poya Day, therefore is a significant day for Sri Lanka.

In the fiftieth year of his enlightenment, the Buddha perceived with his divine eye, a dispute brewing between the two factions of Nagas led by two Kings Chulodara and Mahodara.

The Mahavamsa says, Mahodara ruled the Kingdom of the sea, who gave his younger sister in marriage to the Naga King. Chulodara was their son. His mother's father has gifted to his mother a Gem studded throne. This magnificent chair resulted in a war between the uncle and nephew. The Buddha, visited Sri Lanka, preached his doctrine to the warring factions Chulodara and Mahodara at Nagadeepa, in Northern Sri Lanka.

The Buddha first created darkness while hovering in mid-air, above the battle field. He illuminated the whole area. When the Naga Community seeing this miracle, joyfully paid their obeisance. The Blessed one illustrated the value and the benefits that they accrue from unity and peaceful co-existence and the evils of discord.

DighajÄ nu once visited the Buddha and said: â€~Venerable Sir, we are lay men, leading the family life with wife and children. Would you teach us some doctrines which will be conductive to our happiness?' The Buddha spoke on four things which are conductive to a man's contentment in this samsara: one-- he should be skilled, efficient, energetic and earnest in whatever profession he is occupied, and he should know it thoroughly; second: he should look after his possession, which he has thus earned, with the sweat of his brow; third: he should have kalyÄ á¹‡a-mitta or good friends who are virtuous,

learned, faithful, liberal and intelligent, who will direct him along the correct path away from immorality; fourth: he should use up reasonably his expenses, in proportion to his returnsâ€" meaning he should live within his resources and save a portion.

Give up all you have ever thought about yourself; start as if you knew nothing, and begin to understand ourselves for the first time. How to free ourselves from bonds of life? We have to investigate ourselves â€" not someone explaining while we listen, agreeing or disagreeing, but taking a journey of discovery into the most deep corners of our minds. And to take such a journey we cannot be burdened with prejudices, opinions, and conclusions - all that we have collected for thousands of years and more.

How can we be free to look and learn when from the moment we are born to the moment we die, our minds are shaped by a particular culture in the narrow pattern of the â€~I'`me' and â€~mine'? We have been conditioned for centuries by nationality, religion, caste, language, class, custom, tradition, education, literature, art, convention and propaganda of all kinds, the pressures, the climate we live in, the food we eat, our friends, our family, our experiences -and therefore our reactions and responses to every problem are conditioned. You will never be free of it, and if you think, 'I must be free of it', you will fall into another form of conditioning. Even when you look at a tree and say, 'That is a jak tree', or 'that is a mango tree', the naming of the tree, which is general knowledge, it has so conditioned you that the word comes between you and actually observing the tree.

So it is for us to decide whether or not we wish for complete freedom. You can be free from doctrine very easily, by scrutinizing it, but the purpose for that freedom from dogma has its individual reaction since the desire to be free from a doctrine may be that it is no longer fashionable or opportune. If we say we do, then we have to understand the character and structure of freedom. Is it freedom when you are free from pain, free from anxiety? Or is freedom itself something completely different? You can be free from envy, resentment say, but isn't that freedom a response and therefore not freedom at all?

Silly Nationalistic Belief

All youth, are in revolt against the world, and that is a good thing in itself, but revolt is not freedom because when you revolt it is a reaction and that response sets up its own pattern and you get trapped in that pattern. You can be free from patriotism because you believe in internationalism or because vou sense it is no longer reasonably necessary to adhere to this silly nationalistic belief. You can effortlessly put that away. Or you may counter against some religious or political leader who has guaranteed you freedom as a result of restraint or


revolt. But has such rationalism, such commonsense conclusion anything to do with liberty? You think it is something novel, but it is the old in a different mould. Any societal or political rebellion will inevitably slip back to the good old bourgeois frame of mind. If you say you are free from something, it is a rejoinder which will then become another reaction which will bring about another conventionality, another form of authority. In this way you can have a chain of responses and accept each reaction as independence. But it is not freedom; it is merely a link of a modified history which the mind adheres

There is only your relationship with the world nothing else; there are no guides, no teachers.. When you understand this, what you feel, what you think, how you work, all self-pity goes. We will not

thrive on blaming others, which is a type of self-

If you examine very closely what is taking place and observe it, you will see that it stands on a rational conception. What is imperative is not a philosophy but to observe what is in fact taking place in our daily existence, inwardly and outwardly. And when we look at what is happening in the world we commence to understand that there is no external and internal process; there is only one unitary process, it is a whole movement. To be able to stare at this seems to me all that is required, because if we make out how to look, then the whole thing turns out to be very clear, and to look desires no viewpoint, no teacher. Nobody need tell you how you should look. You just look.

s you progress in sustained, daily practice, it might be helpful to have an overview of meditative insight. Of course, there are many maps of the spiritual journey, and what follows is simply one way of highlighting some different aspects of

Often people think of mindfulness as present moment awareness-living in the present moment, rather than being lost in thoughts of past and future. And while this is certainly a necessary prerequisite for mindfulness, it is not enough. It is possible to be fully in the moment and still be completely lost in whatever the experience might

For example, there is something I call "black Lab consciousness.†You may be familiar with black Labrador Retrievers. They are immensely playful, friendly dogs, who seem to be very much in the moment, lost in their worlds of sight and sound and smell. It doesn't seem that they are ruminating about the past or future, but at the same time, they don't appear to be at all mind-

For much of the time, our own minds are in a similar situation. Even if we're not lost in thought, we may not be mindfully observing what is arising. Here, there is an important distinction between attention and mindfulness. How many times during the day do we hear sounds or see sights without the meta-cognition of knowing that we're hearing or seeing? We're simply lost in the experience, much like a black Lab. Attention allows us to know the object, but without necessarily opening to its nature (or to the knowing itself) on a deeper level. The Portuguese poet, Fernando Pesoa, described this well:

Live you say in the present. Live only in the present. But I don't want the present, I want reality.

In order to accomplish the understanding of reality. mindfulness also has an ethical component, which is knowing our experience without the often unnoticed filters of greed and aversion.

The beginning of practice-and throughout our entire journey-we remind ourselves to actively notice what it is we're experiencing and, at the same time, to be aware of any attitude in the mind regarding it. The difference between being lost in a present moment experience and being mindful of it is very obvious every time we wake up from being lost in a thought. Just there, in that moment of transition, we can feel the difference between the deluded mind of non-awareness and the wakeful quality of mindfulness.

At first, it may feel quite effortful to remember to be mindful. But as the momentum of our practice grows, there may be more space between thoughts and more awareness of whatever is arising in our bodies, our minds, or in the external environment. And at a certain point, a level shift takes place. While we're still aware of what is arising, there is an even greater awareness of the process of change itself. It's as if we have shifted the emphasis of awareness from content to process. Here, experience flows on more smoothly, and mindfulness seems to be happening by itself. We still get lost, but our

minds return more effortlessly to being mindful of the flow of phenomena.

This shift can be illustrated by the images of an arch and a trough. At first, it's as if we're balancing at the top of an arch, often falling off to one side or another and

requiring an effort to climb back up to the top. But through that effort, at some point the arch inverts to become a trough, where we're simply resting at the bottom. We still may be pulled off center, that is, getting lost in various momentary experiences, but then quite

effortlessly, the mind settles back into balance, into the flow of changing phenomena.

An important insight begins to emerge at this stage of practice. We begin to be clearly aware of two different but unified aspects of all experience: that is, in each moment we see the wise progression of knowing and object, arising and passing away together. Usually, the object is more predominant, but at times we can also emphasize the knowing aspect. We might understand this in terms of foreground and background. At times, there will be a natural interweaving of the two, and at other times we can choose to give emphasis to one or another, still remembering that they always arise together. For example, we might be feeling the sensations of the breath quite intimately and then it's as if we put these sensations to one side (or let them recede into the background) and rest more in the awareness


For those exploring this aspect of practice, the question may arise, "How can I be more mindful of the knowing?†While it will come naturally as we continue our meditation, there is one linguistic re-framing that I found to be extremely helpful in this regard. Usually, we describe experience, either consciously or unconsciously, in the active voice, with a subject, a verb and some object. "I'm knowing a sound†or "I'm knowing a movement.†If we reframe these experiences in the passive voice-"a sound being known†or "a movement being known†-we have taken the "I†out of the equation. The actor is no longer the subject and we can see how effortlessly the knowing arises in every moment, without an "Iâ€ making the effort.

It's very simple. As an experiment, just now, you might move your arm back and forth, noticing how effortlessly the movement is being known. Of course, the mind will still wander from time to time, but we can always come back to the simplicity of things being known moment after moment. Because of this effortless quality, it's easier to rest in the knowing aspect, even for short periods of time, again remembering that we'll also be aware of what's being known at the same time.

Another important understanding happens when we notice the tendency to lean into the next moment-what I call the "in order to†mind. We may be with a strong sensation in order for it to diminish, or with an emotion in order for it to go away, or even being with an in breath but already leaning into the arising of the out breath. This is one aspect of what the Buddha called "craving for becoming.â€

We can taste one dimension of freedom in those moments when we're not leaning, not wanting to become. On this fundamental, moment to moment level, the mind is free of cravingâ€|for anything. In the morning of the Buddha's enlightenment, it's said that a verse came to his mind, expressing the depth of his awakening. The last two lines of that verse say, "Realized is the unconditioned, achieved is the end of craving.â€

This is a reminder that the essence of our practice is non-craving-the Third Noble Truth of the Buddha's teaching: the end of suffering. And although for us, the end of craving might at first be momentary, it does give a real taste of peace.



Following are excerpts from an interview with Theravada Buddhist monk Venerable Ajahn Suchart Abhijato of Thailand.

How can we develop
mindfulness and Metta
(Loving -kindness) Mind?

A: To develop mindfulness you need to have a 'mindfulness' object such as your body – movement. Keep watching every movement of your body and action. Whatever you do, concentrate on what you do. That's what it means. Don't send your mind elsewhere. [For example] when you are brushing your teeth you should keep watching brushing your teeth, and not thinking about other things.

With Metta, you need to be friendly to everybody. So when you meet people smile and say 'Hello' and if there is something to share with them, [do share] - when people are happy share it with them. This is what practising Metta (kind) means. Also do not hold a grudge when somebody does something wrong to you. You should forgive them. This is also Metta. Whatever you do, you must not hurt them either physically or mentally. This is what having Metta means. Having a Metta mind means [having] goodwill towards all living beings.

What role does one's 'Chutti Citta'
play, when an individual's next
birth is concerned?

A: The Chuthi Citta will connect itself to a new body. Eventually it will come across an available body, then it will connect to this physical body by sending the streams of Vinyana or consciousness to attach to the five mental objects/organs of the body.

If a person dies with a pure
"Kusala citta", will he definitely
get a good birth?

A: It depends on the total summation of the good and the bad Kamma. They will be competing to take control of your mind. If your good kamma is more than your bad kamma then your next birth will be a good birth. If your bad kamma is more than your good kamma then your next birth will not be a good birth.

What key factors
will determine
one's rebirth?

A: Your kamma. Your good and bad kamma. It is like your financial account. You have both debit and credit. If you have more debit than credit then you are in the green. if you have more credit than debit then you are in the red. Same way with good and bad kamma.

As the Buddha said, what we experience in this lifetime results from what we ourselves created in the past. Can we overcome all our bad kamma by engaging in good deeds in this birth. What's the Buddhist explanation?

A: Some of our experiences are the results of our past good or bad Kamma. But they don't determine what your present Kamma will be. You are the one who can choose the kamma you want to make - good or bad kamma


Your bad kamma will eventually [once it has shown its consequences] disappear from your mind.

What is the best way to practise Buddhism?

A: The Buddha taught us to do three actions - 1) avoid bad kamma, 2) do only good kamma, 3) purify the mind. - get rid of the defilements such as greed, hatred and delusion in the mind - purifying the mind by the practice of meditation.

Thousands of people fall prey to Covid 19. At the moment over three million people have died. Are these people destined to die at this particular moment? Is it their kamma?

A: Well, it is the kamma to die. For every birth there is death. But when and where [to die] depends on circumstances that they happen to be in. So those people who die just happen to have the right conditions for them to die. So they die. For those still alive, it means they don't have the right condition for them to die yet. But eventually they will find the right condition for them to die sooner or later. Everybody will have to die.

It is said that the highest form of birth is to be born as a human being. However there is also a view that the "Devas" are above humans and human beings are in the habit of praying for gods to achieve material benefits/to cure illnesses etc. Are the Devas truly more powerful than us?

A: No, Devas cannot do anything for us. We cannot pray to devas and expect them to do something for us. When they say human birth is the highest form it means it is the best form for Enlightenment. It is the best form to receive the teachings of the Buddha. If

there is a Buddha around or his Noble Disciples, [humans] have the chance to become Enlightened, to be liberated from the realms of existence, to be liberated from aging sickness and death forever.

For Devas it is harder to achieve Enlightenment because they need someone who can communicate [with them] either the Buddha or his Noble Disciples. Not all Noble Disciples can connect with the Devas. So it is better to become a human being than a Deva as far as becoming Enlightened is concerned.

In Sri Lanka "Bodhi Poojas"
(paying homage to the Bo tree) is
a common ritual practised by the
Buddhists in order to invoke a blessing on
oneself or others. There are certain cults
who view such acts with scorn. What is your
view of Buddhist Bodhi Pooja concept?

A: The concept of paying respect to the Bodhi Tree is really to remind us of the Enlightenment of the Buddha. That is what it means. [Thoughts] are focused on the Buddha, so that we don't forget that once upon a time, a few thousand years ago, there was a person sitting under the Bodhi tree and became Enlightened, became free from suffering forever. That is the purpose of paying respect to the Bodhi Tree, to recollect the Buddha's Enlightenment and once you have recollected the Enlightenment of the Buddha it will inspire you to become Enlightened. So you will study the teachings of the Buddha to see the way to become Enlightened. Then you would start to practise the teachings of the Buddha in order for you to become Enlightened.

When practising meditation,
laymen often find it little hard to
stay focused. How to stay focused
on meditation/what we are doing?

A: You have to train your mind with mindfulness from the time you get up and to the time you go to sleep. You should take control of the mind right away as soon as you wake up by forcing [making] the mind to concentrate on the body movement. Keep watching what the body is doing, keep reciting a mantra 'Bhuddo Bhuddo, Bhuddo'. Then you will stay focused and when you meditate you can calm your mind easily.

How can one tame one's

Monkey Mind?

A: Again mindfulness is the key here. Be mindful of your body movement and be mindful of a mantra such as Bhuddo , Bhuddo. Just keep training yourself in mindfulness all the time, from the time you get up to the time you go to sleep. Then you will have continuous mindfulness and when you sit and meditate you can calm the mind and tame the 'monkey' in the mind.

Is it true that feeding hungry animals and being kind to them is a very insignificant activity in terms of acquiring merit when compared with treating and feeding a hungry human being?

A: No, the merits are the same. Animals and humans are the same 'thing'. They need kindness, they need help. So when you give 'kindness and help' to them you get merit. That does not matter who you give to. The act of giving itself is what makes you have [acquire] merit. and if you want more merit then you have to give more . That is all. It is not the person or the animal who received the help from you. It is the amount that you give [that matters]. The more you give the more merit you will get.

Greece opens doors to vaccinated tourists

Teenage models Lydia-Angel Beach and Charlotte Claussen are seated on Monastiraki Square drinking in the warm Athens sunshine, having just sated their post-casting hunger with a juicy takeout souvlaki from classic kebab joint Thanasis.

London-born Beach, 18, who grew up in Ibiza, and her colleague Claussen, 19, from Hamburg, flew in a few days ago, after Greece's decision to lift a quarantine requirement for vaccinated travelers and those testing negative for Covid-19 from key tourism markets.

"It's model season, so we're here for work but also combining it with a vacation," says Beach. "The weather is amazing, the people are really welcoming and the food is really good. Everyone speaks English, so it's easy to get around."

There aren't many other tourists currently enjoying what would be the start of peak season in Athens, but there soon could be.

As of April 19, residents of the European Union, the United States, the UK, Israel, Serbia and the UAE who have been inoculated or present a negative PCR test up to 72 hours prior to arrival are free to enter Greece and must abide by domestic restrictions on movement.

The country has promised to open to all other countries on the terms, as of May 15.

The move has so far been unmatched by any other major tourist destination in Europe -- where new waves of Covid-19 are currently



prompting heavy lockdowns. And even for Greece they represent a bold step at a time when restrictions for locals are still in place.

A tiny minority in Greece, including some opposition politicians, see it as an unnecessary gamble, risking a further rise in Covid cases, which reached a new peak earlier in April. It comes at a time when healthcare services are

already stretched. But in a country where 20% of national income depends on cash from visitors and the effects of a decade-long financial crisis are still being felt, most people see it as a vital step out of a financial hole, insisting that vaccines and testing will help weather any virus resurgence.

For the first visitors, the easing of restrictions in Greece is already proving a welcome contrast to tighter controls at home.

"In Germany, Covid-19 restrictions are much stricter," says Claussen. "Things It's a good place to travel to activities. For now, they can right now and Greece really needs tourists," she says.

She and Beach are thrilled to learn that restaurants and bars, which have remained closed for much of the past year but can provide delivery and takeout, are due to open for outdoor dining on May 3.

"It will be nice to be able to go out for a cold beer after working a 12-hour day," says Claussen.

For Greek citizens, the official messaging around the country's opening up is mixed. While the government has taken to the international stage to throw doors open wide and tantalize visitors with the prospect of warm Mediterranean sunshine, locals are still subject to restrictions.

Greeks remain in lockdown and are required to send an SMS or carry a handwritten note in order to leave their homes to visit a doctor, assist someone in need, shop at the supermarket or get some exercise, are much more relaxed here. among other restricted

There is some light at the tunnel's end. Greece's vaccination program is speeding up, with appointments for those in their 30s opening up next week. Rates of transmission, intubation and death appear to be decreasing slightly, and Greece's Covid toll of 329,134 cases and 9,864 deaths is relatively low.

Earlier this month, store owners breathed a sigh of relief after being permitted to welcome customers with an in-store appointment or picking up items ordered in

advance. Schools are in the process of reopening with the aid of self-testing kits for teachers and students. Dr. Theoklis Zaoutis, professor of pediatrics and epidemiology at the University of Pennsylvania School of Medicine and a member of the Greek government's Covid-19 advisory committee, tells CNN that the decision to open is essential to restoring national morale.

He says officials are willing to slam on the brakes if Covid cases start to get out of hand.

"We want to give [the Greek] people a ray of hope, given that everyone is tired," he tells CNN. "If the numbers get better or worse, we have an opportunity to change the road map," he says.

We have two tools now that we didn't have last year, namely vaccines and self-testing kits. Twenty-five percent of the population has received at least one vaccine dose. The goal is to increase vaccination across all age spectrums."

Despite the government's move to warm up the tourism engines -- following a disastrous 2020 that saw arrivals Greece-wide plummet from a record 31.3 million in 2019 to 7.4 million last year -- by gradually phasing in arrivals, it appears that travelers are hesitant, for now.

Most of the smaller hotels dotted around Athens remain shuttered, with many expected to open on or after June 1 in line with their counterparts on the rest of the mainland and the islands. (CNN)

India's daily cases climb to new world record

India's coronavirus infections rose by 346,786 overnight, the health ministry said on Saturday, setting a new world record for the third consecutive day, as overwhelmed hospitals in the denselypopulated country begged for oxygen

India is in the grip of a rampaging second wave of the pandemic, hitting a rate of one COVID-19 death in just under every four minutes in Delhi as the capital's underfunded health system buckles.

The government has deployed military planes and trains to get oxygen from the far corners of the country to Delhi. Television showed an oxygen truck arriving at Delhi's Batra hospital after it issued an SOS saying it had 90 minutes of oxygen left for its 260 patients.

"Please help us get oxygen, there will be a tragedy here," Delhi Chief Minister Arvind Kejriwal appealed to Prime Minister Narendra Modi in a conference on

The crisis is also being felt in other parts of the country, with several hospitals issuing public notices that they don't have medical oxygen. Local media reported fresh cases of people dying in the cities of Jaipur and Amritsar for lack of the

India surpassed the U.S. record of 297,430 single-day infections anywhere in the world on Thursday, making it the global epicenter of a pandemic that is mixing between people, which he said waning in many other countries. The was essential. (CNBC)

Indian government had itself declared it had beaten back the coronavirus in February when new cases fell to all time lows.

However, COVID-19 deaths across India rose by 2,624 over the past 24 hours, the highest daily rate for the country so far. Crematoriums across Delhi said they were full up and asked grieving families to wait.

The country of around 1.3 billion has now recorded a total of 16.6 million cases, including 189,544 deaths.

Health experts said India became complacent in the winter, when new cases were running at about 10,000 a day and seemed to be under control, lifting restrictions that allowed for the resumption of big gatherings.

Others said that it could also be a more dangerous variant of the virus coursing through the world's second most populous country where people live in close proximity, often six to a room.

"While complacency in adhering to masks and physical distancing might have played a role, it seems increasingly likely that this second wave has been fueled by a much more virulent strain," wrote Vikram Patel, Professor of Global Health at Harvard Medical School, in the Indian Express. WHO emergencies director Mike Ryan said reducing transmission in India would be a "very difficult task" but the government was working on limiting



World envies US vaccination success

As India announced grim records the highest daily coronavirus infection tallies in a single country - Americans were enjoying a spring of vaccine abundance.

In India, just 1.4 percent of the population has been fully vaccinated, and overwhelmed hospitals have been running short of oxygen. Meanwhile, in the United States where 1 in 4 Americans are fully vaccinated and more than 40 percent have gotten at least the first dose — a major Miami hospital, Jackson Memorial, said it would begin winding down vaccinations because of excess supply and weakening demand.

In Michigan, health workers are rolling out shots to high school students. In North Carolina, doses sat on shelves earlier this month

during a pause for spring break. A World Health Organization, on globlong-simmering debate over the glaring gap in vaccine access largely between rich and poor countries, but among some developed nations, too — is now boiling over, with global figures and national leaders decrying the vaccine plenty in a few nations and the relative drought almost everywhere else.

African nations such as Namibia and Kenya are denouncing a "vaccine apartheid," while others are calling for policy changes in Washington and a broader rethink of the intellectual property and trademark laws that govern vaccine manufacturing in global pandemics.

"It's outrageous ethically, morally, scientifically," said Maria Van Kerkhove, an epidemiologist with the al vaccine inequities. "We have all the kindling to start

fires everywhere," she said in an interview. "We're sitting on a powder keg."

It is happening at a demarcation point in the pandemic. In some countries with high vaccination rates — including the United States, Britain and Israel — coronavirus numbers are decreasing or plateauing. But globally, the number of new cases per week has nearly doubled since February, according to the WHO, particularly as some nations in the developing world witness their highest infection rates yet.

"Many countries still have no vaccines whatsoever," said Rob Yates, executive director of the Center for Universal Health at Chatham House,

a London-based think tank. "You're seeing much anger, and I think it's justified."

The surging numbers come as a chain reaction of vaccine nationalism is hindering the flow of doses to poorer nations through Covax, a WHO-backed effort to distribute vaccines around the world.

India, a massive vaccine maker - mostly producing the AstraZeneca formula — has largely stopped exporting as its own surge worsens, dealing a major setback to the slow Covax rollout.

The global initiative had expected 71 percent of its initial doses to come from India's Serum Institute, the country's largest vaccine maker. But so far, Covaxhas delivered 43 million doses of its 2 billion-dose goal this year. (Washington Post)

Merkel calls for tough new restrictions

German Chancellor Angela Merkel says that "tough" new COVID-19 rules are necessary to curb the spread of the virus. Merkel made the remarks in a

weekly video address Saturday, according to The Associated Press. It comes after the country imposed new "emergency brake" restrictions that went into effect at midnight, including a new curfew.

During the address, Merkel said the measures were "urgently needed," and noted that other countries like Britain and Ireland saw infection rates drop due to strict meas-

"No country that managed to break the third wave of the pandemic and then loosen restrictions again did so without tough meas-



ures such as nighttime curfews," she said, according to the AP.

The speech came after Germany announced on Friday that its "emergency brake" restrictions would go into effect Saturday after the upper house of Parliament passed a law allowing the government to do so,


according to CNN. The law allows the government to

impose lockdowns on states, as opposed to states making such efforts on their Germany imposed curfews between 10 p.m. and 5 a.m. and is limiting private gatherings, sports and shop openings in areas that report over 100 new infections per 100,000 people in one week, CNN reported.

Germany reported 22,262 new coronavirus cases Saturday and 289 new deaths, according to Johns Hopkins University.

Overall, it's logged 3.2 million coronavirus infections and 81,492 deaths. It has also administered 24 million coronavirus vaccine doses and fully vaccinated 7 percent of its population. (The Hill)

Baghdad hospital fire kills 82 people

At least 82 people died in a hospital fire Saturday night in Iraq's capital city of Baghdad, the Iraqi Interior Ministry said Sunday.

Another 110 people were injured in the blaze at Ibn al-Khatib Hospital, according to ministry spokesman Major General Khaled Al-Muhanna.

The fire started after oxygen tanks exploded, two health officials at the hospi-

tal told CNN. Social media videos showed a chaotic scene as firefighters scrambled to put out the blaze and health workers tried to evacuate patients. People from all over Iraq are referred to the



hospital in southeastern Baghdad, including many with Covid-19.

Civil defense teams are still at the scene of the accident, investigating the causes that led to this fire, which caused the loss of the lives of many of patients and their companions," according to a statement released by Iraq's Health Ministry

earlier Sunday. The ministry said health workers and civil defense teams were able to save at least 200 people including patients, and would have an

exact number of those killed and wounded at a later time. Iraqi Prime Minister Mustafa al-Kadhimi said the hospital fire was "a crime" and insisted those responsible should be held accountable, according to a statement released by his

office Sunday. "I have directed an immeinvestigation and questioning of the head of the hospital, the head of security and maintenance, and all those concerned until the negligence is found and held accountable," Al-Kadhimi said in the statement. He added that he had ordered results within 24 hours. (CNN)

As confirmed daily coronavirus cases rise and certain localities face new surges, a doctor stressed that new virus mutations could prolong the pan-

"The thing that worries me is that there are still so many infections that we give the virus an opportunity to mutate," Dr. Jeremy Faust, an emergency medicine physician at Brigham & Women's Hospital, said on Yahoo Finance Live.

"Once in a while, one of those mutations does crop up in a way that can hurt us. So what I keep hoping that I won't wake up and read in the next paper is that now I've got one that's 10 times worse or one that hits kids harder.

The current 7-day average for hospitalizations in the U.S. is at 5,631, a 1.6% increase from the prior week. The CDC noted that while hospitalizations have declined since their peak in

January 2021, they have been steadily increasing since March 22.

"As we move through the population and vaccinate more people, there's a point there that at some point, if I get a mild case of COVID but I don't really notice it, then my case doesn't really matter," Faust said. "As long as I'm not spreading it to others, who could be harmed? So for me, a really good metric to watch is hospitalizations. Hospitalizations give you a pretty good sense of how people are doing in the community.'

Nearly 90 million American adults are fully vaccinated, while roughly 135 million have received at least one dose. For the U.S. to reach herd immunity, an estimated 75-80% needs to be fully

"Herd immunity is going to be a moving target because natural immunity could wane," Faust said. "We don't know how long the vaccine immunity cases in the U.S. (Yahoo)

will last, although I'm pretty optimistic it will last a while. To me, the way you know you're at a place where you can return to normal is if our rates of flulike illnesses and COVID-like illnesses are close to our historical norms — not the norms of the last 15 months. I want to see a sustained low level of hospitalizations."

All three of the major vaccines available in the U.S. — from Pfizer, Moderna, and Johnson & Johnson — have proven to be effective against severe COVID-19 infections. However, those efficacy rates can decrease when up against certain variants. There are currently three main variants (also known as mutant strains) that have spread around the world: the B.117 (the British variant), the B.1.351 (the South African variant), and the P.1 (the Brazilian variant). The British variant now accounts for the majority of newer



Former world billiards champion M.J.M. Lafir remembered

Sri Lanka's first world title winner M.J.M. Lafir will be remebered on his 39th death anniversary, today ,A religious ceremony will be held over here in Kandy at the Katuplai Jumma Mosque at Mahaiyawa. He is the man who won the first world title for the country by winning the World Amateur Billards Championship in Bombay in the year 1973, in the

month of November.

He was victorious against all his opponents and also scored the highest break of 859. It is an achievement without parallel in the

annals of sports in Sri Lanka. Prior to this pinnacle of success, Lafir had participated in international championships in Billiards and Snooker in Edinburgh, Scotland, Malta, and Auckland since 1970, but failed to win any of them.

failed to win any of them.

At the World Snooker tournament in Edinburgh, Scotland, in Oct-Nov 1970, Lafir defeated I L Glozier(NZ), Paul Mifsud (Malta), John Clint (N Ireland), D Sneddon (Scotland), but lost to John Phillips (Scotland) and Sidney Hood (England).

At the World Amateur Billiards Championships in Valetta, Malta, in Nov 1971, Lafir finished fourth defeating D Sneddon (Scotland), Paul Mifsud (Malta), Lance Napper (New Zealand)and lost to Manuel Fransisco (South Africa) in the preliminary rounds.

In Nov-Dec 1972, at the World Open Billiards Championship, held in Auckland, New Zealand, in which professionals as well as amateurs participated, Lafir lost to Clark McConachy(New Zealand), Eddie Charlton (Australia), Paddy Morgan (Ireland), Satish Mohan(India), Leslie Driffield (England) and Michael Ferreira (India) but won

against C Everton (Wales), Jim Fryer (England), Kinsley Kennerly (England) and Jack Karneham (England) but failed to qualify for the final round. So, it was in 1973 that he

So, it was in 1973 that he finally reached the pinnacle of his career by winning the World Amateur Billiards Championship in Bombay. He defeated Clive Everton (Wales), Michael Ferreira (India), LU Demarco (Scotland), Alfred Nolan (England), Satish Mohan (India), Eric Simons (New Zealand), Brian Kirkness (New Zealand), Phil Tarrant (Australia), and Paul Mifsud (Malta) and wrote

his name in world sport, especially billiards.

On his return to Sri Lanka, after winning the World Amateur Billiards Championship, he was given a red carpet welcome on Dec 22 1973. He was received and garlanded at the airport by the Sports and Parliamentary Affairs Minister K.B Ratnayake, Minister of Finance Dr N.M Perera, Minister of Education Dr Badiuddin Mahmud, Minister of Transport Leslie Gunawardena, Deputy Speaker IA Cader, Sir Razik Fareed and officials of the Cue Association and members of MICH. Lafir

and his wife, Misriya, were conducted in a motorcade from the airport through the streets of Colombo where large crowds gathered to welcome him home . He was given a rousing welcome at the MICH Fort. He also paid a courtesy call on President William Gopallawa, and Prime Minister Sirimavo Bandaranaike, both of whom gave him a warm welcome. The Colombo Municipal Council accorded him a civic reception on December 31, 1973 presided over by

Mayor Vincent Perera. In January 1974 he was given a grand welcome in

Kandy, and an exhibition billiard game was played between him and MSU Mohideen at the Trinity College hall The people who organized this event were Chandra Wijenayake, A.M.I.N. Marikar, Dr. C.D.L. Fernando. M.E. Marikar, A.C.M. Faleel, E.W. Balasuriya and Simon Marawanagoda.

MJM Lafir was born on May 27, 1930 at St. Joseph's Street, Grandpass and joined MICH(Moors Islamic Cultural Home) in 1947 and was grateful to the MICH for discovering, nurturing and grooming him for big time billiards.

Lafir reigned supreme for 24 years between 1949 and 1973, he annexed the National Billiards title of Sri Lanka 16 times and the National Snooker title on 15 separate occasions. He went across to India and won their National Snooker title on seven occasions from 1956 to 1976, defeating some of the Indian stalwarts. . The Colombo Municipal Council renamed Messenger Street, as M.J.M. Lafir Mawatha, as a tribute to his contribution to the cue game. He passed away on April 261981, a month before his 51st birth-

The match was also part of the International Cricket Council (ICC) World Test Championship.

Sri Lanka declared their first innings at a massive 648 for eight and while Bangladesh did lose two early wickets, Tamim Iqbal's half-century took the visitors to 100 for two before ran put an early end to the proceed-

Opener Saif Hassan had bagged a duck in the first innings and fell for one in the second innings to paceman Suranga Lakmal.

First innings centurion Najmul Hossain Shanto - bagged a duck as Bangladesh soon found themselves reeling at 27 for two in their second innings at one stage.

Tamim, however, eased the nerves and scored a brisk half-century. He collaborated with Mominul Haque to prevent any further damage in the session.

Earlier, Dimuth Karunaratne resumed on 234 but failed to get to the 250-run mark while Dhananjaya de Silva fell seven short of his highest Test score and was dismissed for

Skipper Karunaratne was named Player-ofthe-Match and expressed his satisfaction of returning to form following a disappointing series in the Caribbean.

"I had a very hard time in the West Indies. First few overs I was struggling but I thought if I get a start and hang around, I can get a big one," he stressed.

"We thought the wicket would have good pace and bounce but in these conditions, with the heat, it was a bit flat."

Meanwhile, Bangladesh Captain Mominul Haque said that it was a good team performance that helped them to come out with a

"I think it was a team performance, everyone contributed, especially Shanto. We were set up really well by Tamim Iqbal and later on Liton and Mushy did really well," he explained.

'The bowlers tried really hard, especially Taskin, Miraz and Taijul. It depends on your mentality [dealing with bubbles]. When you represent your country, you have to adjust it's totally a mental thing. I'm happy as a captain to contribute for the team.'

EU hosts GSP ENGAGEMENT WEEK, Virtual Conference

uring the Week of 22 - 25
March, the GSP
Hub which is a
European Union
(EU) funded project launched in 2020 hosted an important virtual engagement relating to the EU's Generalised Scheme of Preferences (GSP) to increase awareness, transparency, and to engage with stakeholders of GSP.

The objective of this brief article is to present the key issues discussed at this virtual Engagement Week, as most of which are of contemporary importance for Sri Lanka being a beneficiary country of EU GSP scheme. The virtual GSP Engagement was attended by representatives of the European Commission, civil society, academia, industry and trade associations, as well as EU and beneficiary countries. The conference provided a platform for interaction between the economic rationale and the perspective of the value of the Generalised Scheme of Preferences (GSP) and focussed on how the GSP can help economic diversification, what kind of opportunities it presents for EU producers, and how civil and environmental targets can be achieved in beneficiary coun-

The GSP hub plays a vital role in engaging stakeholders to increase the use of GSP, through bringing new EU investment, encouraging European companies to import from the beneficiary countries and promoting the related international sustainability standards. The GSP Hub maintains a website to facilitate the understanding of the GSP, its activities, and associated important topics, including specifics related to the EU's GSP and a tailor-made monitoring database for facilitating the dissemination of information and building of an active feedback mechanism for stakeholders.

The virtual Engagement Week had five Webinar sessions focusing on the topics of the GSP and Export Diversification, the GSP and Green Economy, the GSP and Labour Rights, the GSP and Inclusive Growth, and the way forward on the trade policy review and the review of the GSP Regulation. The webinar sessions were organized with expert inputs followed by panel discussions.

The Vice President of the European Parliament, who is a Member of European Parliament (MEP) from Finland Heidi Hautala, inaugurated the GSP Engagement Week with a keynote address. She explained the object and purpose of the GSP and the need to further improve the scheme to be more effective in terms of helping the beneficiary countries. At this inaugural session Sri Lanka's Ambassador to the European Union Grace Asirwatham participated as one of the panellists who contributed very pertinent and useful inputs to the discussion presenting the perspectives of Sri Lanka on a number of issues.

First, Ambassador Asirwatham explained the policy initiatives and measures taken by Sri Lanka to achieve greater diversification and measures that the EU should take to facilitate diversification of the export portfolio of beneficiary countries, including Sri Lanka. Second, in her intervention, the Ambassador covered a full spectrum of activities and issues related to Sri Lanka as a GSP beneficiary country. A summary of salient points shared at the Conference is given below;

- Sri Lanka was thankful to the EU for the support and cooperation extended to Sri Lanka under the Partnership Cooperation Agreement. Sri Lanka enjoyed Standard GSP since 1971 and it became a GSP plus recipient in 2005. However, due to certain shortcomings in the implementation of Conventions, the GSP plus benefits were withdrawn in 2010, yet Sri Lanka was able to regain the GSP plus in 2017.
- GSP which is a non-reciprocal trade preferential arrangement helps developing and least developed countries to achieve sustainable development making use of tariff preferences for their exports to the largest consumer market in the world.
- GSP plus concessions provide greater benefits to Sri Lanka to enter the EU market with zero or reduced tariff basis. Overall the EU GSP plus status has had a positive economic and social impact, in Sri Lanka.
- Sri Lanka was the first country to liberalize its economy in South Asia, to foreign trade and investment in 1977. As early as 1978 Sri Lanka strengthened the investment laws to make it more export-oriented FDIs and established an Economic Commission which is the current Board of Investment (BOI) to facilitate FDIs, oversee export processing zones and function as the One-Stop-Shop for Investments in Sri Lanka. Sri Lanka also established the Export Development Board (EDB) in 1978. With these arrangements, Sri Lanka was emulating the industrial success of East Asian nations. Sri Lanka's transformation from an agriculture-based society to a more industrial and services-based economy started with product diversification in the industrial sector with garments being the pioneer in that direction.
- However, Sri Lanka's economic transformation was impeded by three decades of a civil war on terrorism, regional and global financial crisis, epidemics, tsunami, Easter Sunday bombings in 2019, and the ongoing corona health crisis. Despite these challenges, over the years Sri Lanka experienced a shift away from domestic agriculture to industrial and service sector activities.
- Yet, the Sri Lankan economy was less diversified, dependent on a handful of industries for its export earnings. Sri Lanka's traditional export items are apparel, tea, rubber, spices, and coconut. Sri Lanka's non-traditional exports of services such as ICT, tourism, and logistics have grown significantly in the last decade. These sectors have proven their ability to diversify and access new market destinations.
- Until BREXIT came into force, the EU was the largest export destination for Sri Lanka

with Euro 3 billion worth of exports in 2019, of which Euro 2.5 billion were entitled to GSP plus tariff concessions. Sri Lanka's GSP+ status has resulted in making the EU, Sri Lanka's largest trading partner ahead of India and China. In the months following the regaining of GSP+ in 2017, Sri Lanka's exports to the EU (calculated in Figure 1 below) increased by more than 12% (2019 compared to 2017). This included a doubling of the fisheries export under the EU GSP concessions, in response to a removal of the import ban on fish, and significant export increases in apparel, tea, tires, gems, motor vehicle parts and footwear (Figure 1 and 2).

• However, Sri Lanka's overall GSP utilisation level recorded at 62.75% in 2019, with the worth of Euro 1.6 billion actual exports under GSP concessions. There is variety of reasons for the low-level utilization including lack of product and market diversification.

Figure 2: GSP+ utilization rate of Sri Lanka by product sectors in 2019


Third, focusing on the recent policy initiatives and program measures taken to promote

must undergo two transformations in Sri Lanka to be able to meet the rules of origin criteria – from cotton to fabric, and from fabric to textile. Since Sri Lanka imports most of its textile from other countries for manufacturing apparel items for export to the EU, it has been an impediment to meet the rules of origin requirements.

The EU Regulation on the Rules of Origin (ROO) provided for cumulation arrangements such as Bilateral Cumulation, Regional Cumulation, Cross-Regional Cumulation, and Extended Cumulation. Cumulation rules of origin criteria allow Sri Lanka to claim originating status for components that do not origi-nate in Sri Lanka but are used in the production process in Sri Lanka. Cumulation is possible with ma-terials originating in countries that are part of Sri Lanka's regional group: Bangladesh, Bhutan, India, Maldives, Nepal and Pakistan. Cumulation rules also apply between two regions such as SAARC AND ASEAN etc. It can also take place, under certain conditions, with materials originating in countries that have a free trade agreement with the EU. Finally, cumulation is possible with materials originating in the EU.

However, the approval procedure related to Cross Regional Cumulation was rather time-consuming or not given. Due to this reason, the exports with raw materials or accessories

mit a request for extended cumu-lation with Vietnam, against the backdrop of Vietnam's recently signed free trade agreement with the European Union. To assist exporters from Sri Lanka, the EU GSP Plus guide prepared by the ITC (and available in Sinhala, Tamil and English) provides detailed insight into the requirements and regulations to be complied with in order to access the EU market under the GSP+scheme.

 The double transformation criteria applied to apparel products originating from the beneficiary countries of General GSP and GSP Plus has adversely affected the GSP utilization and making the product diversification even more difficult. However, this criterion was not applicable to the beneficiaries of the GSP scheme "Everything-But- Arms" (EBA) extended to the Least Developed Countries (LDC). This is widely seen as a discriminatory application of ROO across the different GSP arrangements. For example, under the apparel sector, the General GSP and GSP Plus beneficiaries were bound to follow the yarn-fabricapparel process which is double transformation while EBA beneficiaries follow only a single transformation such as fabric to apparel. The GSP plus was designed to be a special incentive scheme yet these discriminatory rules cannot be considered as incentives.

• The international distribution of value chain activities such as design, production, marketing, distribution, etc., have become increasingly essential and inevitable in the

Responding to a question on Sri Lanka adapting to green practices, the Ambassador very eloquently stated that Sri Lanka was one of the world's most ethical sourcing destinations, particularly for apparel. Sri Lanka's motto on apparel was 'Garment without Guilt'. Sri Lanka has strong potential to enhance its external trade performance since her brands were increasingly associated with high quality and ethical manufacturing practices, focusing on Green concept, environmental safeguards and practices, and targeting zero child labour through pioneering 'Child Labour Free Zones'.

Further, Sri Lanka was building an environmentally friendly fabrics zone, pushing for more green energy and better waste management. Sri Lanka wanted to ensure all companies operating in free zones to take advantage of green credentials when selling overseas. Sri Lanka also engaged in promoting exports of organic and fair trade exports. The Ambassador further said that Sri Lanka would like to join the campaign of the EU to make the GSP green for which necessary support by way of capacity building and resources from the EU is required.

Further, Ambassador Asirwatham also took the opportunity to comment on the GDP per capita-based graduation criteria pertaining withdrawal of GSP benefits. As per the current GSP rules, one of the GSP Plus eligibility criteria was to remain at a lower-middle-income level and upon graduating to upper-middleincome status and after maintaining the new income level for three consecutive years the GSP benefits withdrawal process will be initiated with an additional adaptation time. On this issue, the Ambassador presented a valid opinion that the withdrawal should not be done solely based on GNI figures and the EU should also consider other aspects of economic vulnerabilities and the actual developments on the

As the final point, Ambassador Asirwatham highlighted the fact that the GSP tariff advantages would erode in time to come as the EU was entering into FTAs and other bilateral trade agreements with larger and emerging economies, especially in the Asian region. This would result in affecting the GSP beneficiary countries by way of additional competition to find market opportunities and investments.

The issues raised and suggestions presented at this engagement were well received and discussed during the virtual conference. Ambassador Grace Asirwatham was the only Ambassador who was engaged as a panelist in the weeklong Engagement on GSP by the GSP HUB in

Besides the points discussed at virtual conference hosted by the GSB HUB, the following two important developments need attention;

01. Brexi

Roughly 30 percent of all Sri Lanka's GSP+ exports are destined to the United Kingdom (UK). Specifically, based on 2019 statistics, they consist of apparel, textile and footwear; rubber and plastic articles; machinery; and coffee, tea and spices. As of January 1, 2021, exports destined for the UK are no longer covered by the EU GSP scheme; rather, they are covered by the UK's GSP scheme. Considering that the UK is a major trading partner for Sri Lanka, it would be important to closely monitor developments relevant to the UK's GSP scheme.

The UK's current GSP largely mirrors the EU's GSP scheme: it contains three frameworks, which correspond to the three arrangements in the EU GSP system. Specifically, it includes a Framework for the Least Developed Countries (LDC), which corresponds to the EU's EBA arrangement; the Enhanced Framework, which corre-sponds to the EU's GSP Plus arrangement; and the General Framework, which corresponds to the EU's Stand-ard GSP scheme. Countries that are GSP Plus beneficiaries under the EU GSP Plus framework automatically qualify to receive preferences under the Enhanced Framework. It must be noted, however, that differences apply with respect to the tariff lines subject to tariff reductions.


02. 2023 expiry of EU GSP regulation The regulation that governs the current GSP scheme expires on 31 December 2023. Currently, on the basis of an evaluation of the effectiveness of the GSP scheme, discussions are ongoing regarding the future of the EU GSP regulation, with a number of different options and scenarios on the table: a continuation of the scheme as is; a discontinuation of any GSP arrangement; and fine-tuning the existing regulation (https://trade.ec.europa.eu/doclib/docs/2020/february/tradoc_158624.pdf).

The Commission is currently preparing a proposal for the review of the current GSP scheme.

This proposal is expected to be adopted by

This proposal is expected to be adopted by the second quarter of 2021, once approved by the Parliament and Council.

It is most likely that a new GSP regulation will be adopted in 2023 that will incorporate various amendments, including updating the list of 27 conventions that must be complied with as a condition to receive GSP Plus preferences, the product graduation threshold, the safeguards mechanism and an examination of the relationship between GSP and EU Free Trade Agreements.

 The Sri Lanka government Budget for
 2021 covered all economic sectors as per the
 Government National Policy Framework-Vistas

- The government has identified 5 main sectors and 17 subsectors, for development over the next five years. The five main sectors include manufacturing, information and communications technology, tourism, agriculture, and infrastructure.
- A national trade policy is being formulated and a regional industrial zones development program to promote industries at the regional level was approved for action. Further, in order to diversify the export basket and empower the SME sector, the government proposed to establish 1000 Export Production Villages (EPVs) around Sri Lanka.
- The government budget for 2021 offered tax breaks for investments of \$10m or more in the five strategic industries to encourage investors in the manufacturing sector for export diversification.
- Within the EU, Germany, France, Belgium, Netherlands, Italy, and Poland have been Sri Lanka's main traditional markets and Sri Lanka is making efforts towards market diversification. Such efforts included a business focus on EU countries with which Sri Lanka had fewer trade connections, market surveys, business intelligence, and fact-finding activities, increased participation in trade and investment expos and business activities in those countries as well as decisions to establish resident diplomatic missions in Romania and Spain and appoint effective Honorary Consuls to facilitate trade expansion and market diversification.

Fourth, responding to the question on any measures that the EU should take to facilitate diversification of the export portfolio of beneficiary countries, including Sri Lanka, the



• Concerning the low-level of utilization of the GSP plus (See Table 1), the overall preference utilization rate in 2019 was only 62%. In other words, only 62% of Sri Lanka's exports actually benefitted GSP+ preferences under the GSP scheme. As illustrated in Figure 2, utilization rates were especially low for the textile, electrical and machinery sectors. While inherited domestic productive capacity constraints, common to many developing countries, have been the key reasons for lack of product diversification, a number of other external reasons have also prevented maximizing the benefits of the GSP scheme.

The most important one was the strict Rules of Origin criteria. For product diversification especially for manufacturing most GSP recipient countries including Sri Lanka had to depend on other countries for raw material and accessories. For textile and garments, the double transformation rule applies, that is, products





originating in other coun-tries do not qualify for GSP plus tariff concessions. Further in the South Asian region, as countries are competing with each other, getting an Origin certificate for raw materials or accessories from those countries is also difficult to qualify under regional cumulation.

In this regard a case in point is the joint request submitted by Sri Lanka and Indonesia seeking ap-proval under cross regional cumulation for raw material originating in Indonesia, which has been pend-ing with the EU for nearly 3 years. Sri Lanka is also expected to sub-

• EU should also help to devise a mechanism for the GSP beneficiary countries to attract investments from the EU region and to find markets for services as part of the promotion of export diversification. The EU should also help beneficiary countries to digitalize the economies and strengthen e-commerce facilities.


