GENERAL CONDITIONS APPLICABLE TO APPOINTMENTS TO POSTS IN THE PUBLIC SERVICE ADVERTISED IN THE "CEYLON GOVERNMENT GAZETTE"

Allowances.—Unless otherwise stated, Rent Allowance, temporary Cost of Living Allowance and temporary Special Living Allowance are payable according to Government Regulations.

2. Conditions of Service.—Appointments will be subject to the Public Service Commission Rules, the Financial Regulations, the Regulations of the Manual of Procedure, Departmental Orders or Regulations, and any other orders or regulations issued from time to time by the Government.

3. Terms of Engagement.—(i) In the case of appointments to the non-pensionable establishment (excluding those on daily rates of pay) appointees will be required to contribute 5 per cent. of their salary to the Public Service Provident Fund, and they will be allowed to contribute, at their option, a further 5 per cent. The Government contribution in either case will be equal to $7\frac{1}{2}$ per cent. of the salary paid in at the close of each financial year.

(ii) Appointees may be required to furnish security in terms of the Public Officers (Security) Ordinance, if so required by the Head of their Department.

(iii) Appointees other than those already in the Public Service will be required to pass a medical examination by a Government Medical Officer as to their physical fitness to serve in any part of the Island.

4. New Entrant Officers--

- (i) The period of probation/trial of "New Entrant Officers" appointed to pensionable posts/non-pensionable posts, as the case may be, shall be 3 years unless a longer period is prescribed in respect of any posts.
- (ii) "New Entrant Officers" will be required to comply with any rules already made

or that may hereafter be made for giving effect to the Language Policy of the Government and in particular for implementing the provisions of the Official Language Act, No. 33 of 1956.

- (iii) (a) These officers will be required to acquire proficiency in Sinhala during their period of probation/trial.
 - (b) Their confirmation, at the expiry of the period of probation/trial, will depend, *inter alia*, on the passing of a proficiency test in Sinhala.

Those who fail to reach the prescribed standard of proficiency in Sinhala during their period of probation/trial are liable to be discontinued, but discontinuance may be deferred if the appointing authority is satisfied that a genuine attempt had been made to acquire proficiency in the Official Language. Loss of seniority may be waived at the discretion of the appropriate authority if the officer passes the test within a reasonable time after the due date.

- (iv) New Entrant Officers who qualify for entry into the Public Service through the Sinhala medium will be exempted from the Proficiency Test in Sinhala.
- Note.—The term "New Entrant Officers" in this context means officers appointed to posts in the Public Service on or after September 24, 1956, who are not deemed to be old entrant officers in terms of subparagraphs 2 (ii) (b) and 2 (ii) (c) of Treasury Circular N. 379 of 23rd May, 1957.

5. Qualifications required.—Every applicant must furnish satisfactory proof that he is a Ceylonese. A "Ceylonese" is a citizen of Ceylon by descent or by registration. 6. War Service Concession.—Provided they are qualified in all other respects, ex-Servicemen of Her Majesty's Fighting Forces and full-time members of the Auxiliary Fire, Air Raid Precautions and Civil Defence Services (excluding those who had left these Services of their own accord), will be allowed to deduct periods of such service commencing from September 3, 1939, at the earliest, and up to December 31, 1949, at the latest, from their ages for purposes of eligibility alone, provided that they joined the Forces before August 15, 1945, and that such service was satisfactory and continuous.

7. Other Requirements.—(i) Applications from officers of the Public Service who are qualified must be forwarded through the Heads of their respective Departments. In the case of applications from officers holding permanent posts in the Public Service, the Heads of the Departments concerned should, in forwarding the applications, state whether or not they are prepared to release

SCHOLARSHIPS IN INSURANCE

IT is proposed to award four scholarships in insurance practices and management under the Technical Co-operation Scheme for South and South-East Asia. These scholarships are tenable for a period of approximately six months in New Zealand and Australia. The New Zealand Government has kindly consented to make arrangements for the provision of training facilities for two scholars with the Government Life Insurance Office and State Fire and Accident Insurance Office. The Australian Government has kindly consented to make arrangements for the provision of training facilities for two scholars with non-life insurance companies, i.e., fire, accident—marine and general—as well as with life insurance companies. The period of training may be extended if considered insufficient

2. Applications for these scholarships are invited from members of the staff of Insurance Companies in Ceylon who possess practical experience in Insurance work. Such applications should be recommended by the Management of the Insurance Company in which the applicant is employed at present. The authority recommending the application should pay due regard to the fact that the training is intended to assist the selected applicants in qualifying for managerial positions in insurance firms.

3. Applicants must be citizens of Ceylon by descent or by registration and must be not less than 25 years and not more than 40 years of age on December 22, 1958.

4. The terms and conditions governing the award of these scholarships will be settled in due course in consultation with the Governments of New Zealand and Australia. Arrangements will also be made for adequate subsistence allowances, fares, &c.
