#### Trade Marks limited to colours

Where it is stated in the advertisement of an application that the mark upon its registration is to be limited to

certain colours, the colours are, as far as possible, indicated in the accompanying representation of the mark in the usual heraldic manner.

#### Association

Where it is stated that an advertised mark is to be associated (under Section 22 of the Trade Marks Ordinance (Cap. 121)) with another mark, it is indicated by its official number.

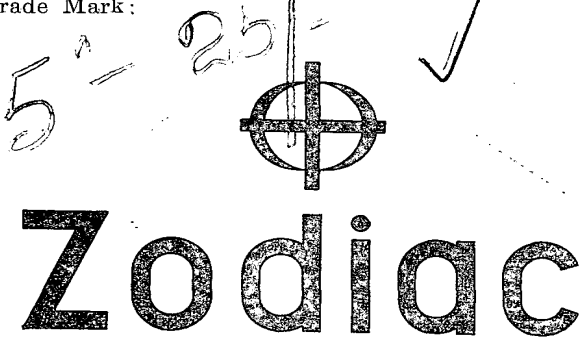
NOTICE is hereby given that any person who has grounds of objection to the registration of the following trade marks may, within two months from the date of this Gazette, lodge notice of Opposition on form T. M. No. 7 bearing an uncanceled or impressed stamp of Rs. 25. The period of lodging Notice of Opposition may be enlarged by the Registrar if he thinks fit and upon such terms as he may direct.

Formal opposition should not be lodged until after reasonable notice has been given by letter to the Applicant for registration so as to afford him an opportunity of withdrawing his application before the expense of preparing the Notice of Opposition is incurred. Failure to give such notice will be taken into account in considering any application by an Opponent for an Order of Costs if the opposition is uncontested by the Applicant.

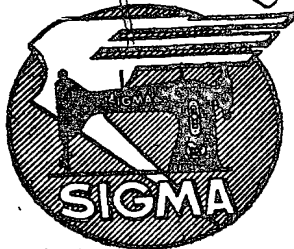

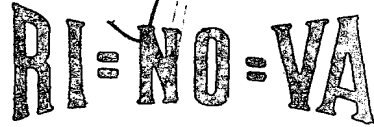

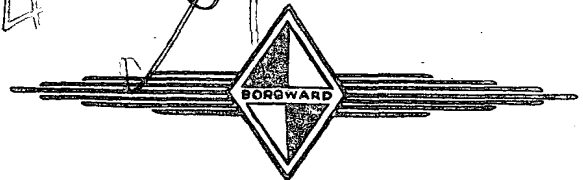

"Improvements in and apparatus for the preliminary treatment of tea leaf."

*Abstract.*—The nature of the invention can be ascertained from Claims 1, 2 and 3 which reads as follows:—

1. A method for the preliminary treatment of tea leaf which comprises the step of subjecting a resilient layer of the leaf to a plurality of pressure operations between two substantially non-resilient surfaces.

2. A method as claimed in claim 1, which comprises passing the layer of leaf a plurality of times through a pair of substantially non-resilient rollers.

3. A method as claimed in claim 1, which comprises passing the layer of leaf through a plurality of pairs of substantially non-resilient rollers.
