Failure to give such notice will be taken into account in considering any application by an Opponent for an Order of Costs if the opposition is uncontested by the Applicant.





" Process for preparing gas mixtures containing hydrogen and carbon monoxide.'

Abstract — The nature of the invention can be ascertained from Claim 1 which reads as follows:—

1. Process for preparing gas mixtures containing hydrogen and carbon monoxide by partial combustion at superatmospheric pressure of a hydrocarbon with

oxygen, steam being supplied if desired, in which the hydrocarbon is atomized through an opening in the wall of a reaction chamber, the oxygen being supplied rotatingly into the reaction chamber with a movement rotating about the axis, such that the hydrocarbon is rapidly mixed with the gases, with the result that the reaction proceeds very rapidly, wherein the oxygen and any steam used is introduced into a whirl chamber situated in front of the reaction chamber from a space surrounding this whirl chamber via a number of tangential slots, characterized in that the oxygen and any steam used is passed through the slots at such a rate that the greatest difference in pressure on the inside of the space surrounding the whirl chamber is small compared to the pressure drop over the slots.
