5. Tenders are to be made up on forms which will be supplied upon application at the Colombo Kachcheri, and no tender will be considered unless it is on the recognized form.

6. All alterations and erasures must be initialled by the tenderers.

7. A deposit of Rupees two hundred (Rs. 200) will be required to be made at the Colombo Kachcheri, and a receipt produced for the same before any form of tender is issued. Should any person decline or fail to execute an indenture of lease within ten days of its being presented to him by the Government Agent, Colombo District (hereinafter referred to as the Government Agent), or fail to furnish the security specified in condition 9 below within ten days of receiving notice in writing that his tender has been accepted, such deposit will be forfeited to the Crown. Notice of acceptance will be deemed to have been received by the tenderer if it has been sent by post addressed to, or left at, the address given by the tenderer. Tenderers must make their deposits for tender forms before 2 p.m. on December 3, 1958, and obtain the necessary forms in time as tender forms will not be issued thereafter.

8. Each tender must be accompanied by a letter signed by two responsible persons whose addresses must be given engaging to become surety for the due fulfilment of the contract.

9. The tenderer, whose tender is accepted, will be required to deposit, within ten days of receiving notice that his tender has been accepted, one-fourth of the amount tendered as cash security for the due fulfilment of the conditions of the lease, and sign conditions of sale. In the event of breach of any of the conditions of the lease, this sum will be forfeited to the Crown.

10. The indenture of lease, which the lessee will be required to execute, will contain the following conditions, amongst others:—

- The term of the lease shall be one year commencing from 5th December, 1958.
- The lessee shall be entitled to the option of paying the amount tendered in full or in equal monthly instalments. Each monthly instalment shall be payable in advance on or before the first day of each month.
- The lessee shall pay any rates and taxes whatsoever in respect of the lease.
- The lessee shall not make any use of the soil of the land.
- The lessee shall not assign, transfer, sublet or otherwise dispose of his rights under the lease without the permission of the Government Agent previously obtained in writing.
- Neither the lessee nor his workmen shall pick any immature nuts from the coconut trees on the land.
- Neither the lessee nor his workmen shall lop the branches of or fell or otherwise damage any trees standing on the leased land without the permission of the Government Agent previously obtained in writing.

- (viii) The lessee shall not erect any buildings or other structures on the land without the permission of the Government Agent previously obtained in writing.
- (ix) The lessee shall not occupy or in any way use any buildings on the land, or cause any damage thereto or remove any material therefrom.
- (x) The Government Agent shall be entitled to fell any trees on the land or to resume possession of the whole or any part of the land in respect of which the lease is issued. In that event, the lessee shall be entitled to proportionate reduction of the rent. The decision of the Government regarding the amount of any such reduction of rent will be final.
- (xi) The Government Agent reserves the right to appoint any watchers and other necessary staff to safeguard Crown interests in the land and the buildings thereon.
- (xii) The lease shall be liable to termination on one calendar month's notice being served on the lessee or left on the land. In such event, the lessee shall be entitled to a proportionate reduction of the rent in respect of the unexpired portion of the lease, but no compensation whatsoever.
- (xiii) Any breach of any of the conditions of the lease shall render the lease liable to immediate cancellation without compensation on the orders of the Government Agent.
- (xiv) The lessee shall pay inspection and assessment fees in respect of rubber trees, if and when he is required by the Rubber Controller to do so.
