WHO approves Sinopharm vaccine


The World Health Organization (WHO) on Friday approved China's Sinopharm's Covid-19 vaccine for Emergency Use, easing the way for poorer nations to get access to another much-needed shot to help end the pandemic. Sinopharm is the first Chinese shot to be classified as safe and effective by the W.H.O.

The approval allows the Sinopharm vaccine to be included in Covax, the World Health Organization's global initiative that is designed to promote equitable vaccine distribution around the world.

Reliable vaccine access could improve further next week when the W.H.O. considers another Chinese shot, made by the company Sinovac. TO PAGE 02

In a Zoom call with President Gotabaya Rajapaksa yesterday, World Health Organisation (WHO) Chief Dr Tedros Adhanom Ghebreyesus has commended the Government for its efforts to control the spread of COVID-19, adding that that his Organization is willing to extend its fullest support to the Government's initiatives in this regard.

The fruitful Zoom discussion was held from the Presidential Secretariat.

Dr Tedros commended President Rajapaksa for his leadership in controlling COVID-19 by successfully controlling the first wave of the pandemic. The WHO Director General said that Sri Lanka's success was discussed many times at conferences

held under the patronage of the WHO. The WHO Chief expressed the hope that the current surge in affected persons would soon be brought under control through effective

Globally, there is a need for 20 million doses of the Oxford AstraZeneca/Covishield vaccine for the second dose.

Sri Lanka is facing a shortage of 600,000 doses of the AstraZeneca vaccine to complete the second dose for those who received the first dose in April. The second dose has to be given in 12 weeks.

The President said he hoped that the WHO would assist in meeting that urgent



A proposal to establish new Export Processing Zones has been submitted by the Budget in 2017 as per the plan of the Good Governance Government and six new Export Zones were to be established by end 2020.

It was proposed to construct new Export Processing Zones along the Expressway Corridor and Rs. 1 billion has been allocated in 2017, Rs. 4500 million has been allocated for 2018 and Rs. 1 billion for 2019.

However, out of the six proposed zones, work had commenced by 2020 in only the Bingiriya and Millaniya Export Processing Zones, out of which work on the Millaniya Export Processing Zone has already been suspended, the report said.

The construction of the Millaniya Export Processing Zone has been suspended due to court action against land acquisition for not paying attention to the challenging

areas in the feasibility studies and more than Rs. 208 million has been spent on the construction of the zone so far.

It is planned to construct access roads to the Millaniya Export Processing Zone at an estimated cost of Rs. 3900 million and it was proposed to complete the construction

Rs.20.5 million has been paid to the Road Development Authority in 2017 and 2019, but it has been revealed that no construction work on access roads has commenced as at November 07, 2019.

The construction of access roads in the Bingiriya Export Processing Zone is estimated to cost Rs. 90.2 million and Rs. 350 million has been paid to the Road Development Authority in 2018 and 2019.

However, the construction of these roads has not been completed on time, the report said.

15 mn face masks disposed in Sri Lanka daily

Large numbers of birds fall prey

million face masks are disposed of in Sri Lanka daily and these masks have become extremely harmful, especially to birds, Environment Minister Mahinda Amaraweera said.

"It is reported that in the first six months of 2020 alone, 800 tons of face masks were imported to the country," he said.

The Minister said that a large number of birds die due to face mask straps getting entangled around their necks and legs.

Therefore, the Minister urged the public to pay attention to cutting off the straps on either side of the face mask before disposal.

Minister Amaraweera made this observation issuing a message to mark the World Migratory Bird Day which falls today (March 8). The theme of this day's event is "Sing, Fly, Soar - Like a bird".

Migration of birds is birds from different parts of the world to other countries for climatic as well as biological reasons. Bird migration often occurs in some countries with the onset of winter. As a result, birds find it difficult to find food and shelter, so they fly in search of suitable climates.

Ornithologists say birds from Siberia, Northern India and Central Russia come to Sri Lanka, the Environment Ministry in a communiqué

During the bird migration you can even see the exact route they are tak-

ing and even clearly see where they stop to rest. About 115 to 150 species of birds migrate to Sri Lanka from these countries. Due to the climatic conditions of our country, there have been reports of some birds not returning and settling

As we have identified, there are three areas in our country where bird migration takes place. Birds who enter the country from the old lands near Kalpitiya along the western coast of India, those who enter the country from the eastern coasts of India and Jaffna and Mannar, and

some birds fly through the Andaman Islands and enter the country between Jaffna and Trincomalee.

Meanwhile, the new edition of the Red Data Book on Endangered Species of Wildlife in Sri Lanka has been printed and completed. Environment Minister Mahinda Amaraweera instructed the Central Environmental Authority to immediately edit the Red data Book. Accordingly, the release of the Red Data Book was scheduled to take place this week. But it has been decided to postpone it for a few more days due to the current COVID-19 pandemic situation. The Minister instructed the Central Environmental Authority to thank all the environmental organisations and environmentalists who had supported the project and launch the Red Data Book. However, it also contains information on endangered birds in our country and maintains the ideal environment for wildlife to live, while maintaining the international recognition of our country as the only country in the world with the largest wildlife population per square kilometre. The Minister of Environment says that is important.

Securing our borders

or once, the law enforcement appears to have got their act together. Abandoning their soft approach, which saw only halfhearted efforts being made to get the public to adhere to health protocols, the Police have now got really tough. Television showed groups of police personnel manhandling traders, motorists and others who were found to be without their face masks or not wearing them in the proper way, bodily carrying them away to mete out punishment.

Perhaps this is the language the public who have been remiss in following the health guidelines understand. This is hardly the time for such niceties as personal liberties although excesses should be avoided. We are in the midst of a death dealing pandemic. One recalls that in the initial stages of the Coronavirus the Indian Police resorted to extremely tough measures to enforce the restrictions beating up violators and frog marching men, women and children on the roads, for violating local curfews. For some reason the harsh treatment witnessed initially is no more evident.

Had the heavy stick continued, perhaps India would not have come to this sorry pass today. Perhaps our law enforcement, albeit belatedly are using the methods earlier adopted by the Indian Police with much success. There should be no let-up in this regard, for going by all evidence only heavy handed action will succeed in bringing the public to heel albeit for their own good and the good of the country.

Each offender is to be fined Rs. 8,500 and with even a prison term awaiting him/her, in addition. After all, a face mask costs only Rs. 10. An offender now stands to lose 850 times this amount due to his/her folly. According to Police Spokesman DIG (legal) Ajith Rohana they have so far arrested 5,486 persons for not wearing face masks or violating quarantine rules and 5,400 of them have been charged. The Police certainly will have their kitty overflowing by the time we have seen off the pandemic, if ever this comes to pass.

It is not known if those who violate the health guidelines were recipients of the first dosage of the vaccine which had given them confidence to flout the rules. This is because there were assurances given by the health experts that the first jab was nearly 70 per cent foolproof, meaning that the risk of infection

However, as already reported, State Minister Dr. Sudharshani Fernandopulle was of the view that the vaccine alone was not a panacea and following health protocols was equally important in avoiding infection, echoing the views of the World Health Organisation (WHO).

In any event, the public will have to settle for the vaccines being given as and when they arrive due to various glitches in the supply, chiefly due to the situation in India. Worse, the contagion that was ravaging only in the central parts of India has now started invading the Southern States such as Tamil Nadu and Kerala. Tamil Nadu yesterday reported over 23,000 positive cases whereas one month ago the number was less than 3,000. With only 32 Km separating the two countries this certainly is a cause for concern. The authorities should start closely monitoring the situation and put in place safeguards to ensure that the virus is kept at bay, before it is too late. The move to suspend all arrivals from India is a prudent move. However, the main threat will come from rogue fishermen and smugglers from Tamil Nadu entering Northern waters.

True, poaching by Tamil Nadu fishermen in Lankan waters has been a perennial problem and whenever arrests are made the practice had been to detain and release them subsequently after the intervention of the political establishment on both sides. However, there is no room for such a soft approach in the present context. This is amidst reports that Tamil Nadu fishermen may be fleeing the State to escape the pandemic rather than poach in our waters and there is every possibility that they could blend in with the Northern fishermen and enter the country. Reports of such attempts had indeed come to light which should raise the concern of the authorities.

It only needs one carrier to set ablaze the entire North and with it the entire country, with the virus said to be of a new and more virulent "double mutant" strain as can be seen from what is unfolding in India. Enhanced attention should be paid to the maritime border in the Palk Strait separating the two countries with constant Naval patrols deployed to block any intrusions into Lankan waters from across the bay. Northern fishermen too should be asked not to venture far afield given the potency of the new mutant that is ravaging our giant neighbour. Any mixing of the two groups of fishermen could spark a new wave of the disease.

We have our plate full in the valiant attempts of the authorities to rein in the spread of the virus without having to cope with a fresh and deadlier version of the pandemic coming across from the Sub-Continent.

SARS TAUGHT CHINA HOW TO HANDLE A PANDEMIC



While China stepped up investments in its health infrastructure after SARS, the US downgraded it and India had always neglected it.

s on May 6, the internationally accepted pandemic figures were as follows: the US, 32.6 million infections and 579,000 deaths; India, 20.7 million infections and 226,000 deaths; and China, 90,721 cases and 4,636 deaths. The contrast is clear. The main reason: China had greatly improved its public health infrastructure, the US downgraded it and India neglected it.

In an article in The Conversation dated November 3, 2020, Elanah Uretsky, a Brandeis University Professor and an expert on public health in China, had said that the control of the COVID-19 virus in China "was not the result of authoritarian policy, but of a national prioritization of the health sector after the SARS pandemic."

SARS, which struck the world in 2002-03, had infected over 8,000 people worldwide and killed about 800, 65% of which were in China and Hong Kong. "SARS exposed serious weaknesses in China's public health system and prompted its Government to reinvent its public health system," Uretsky wrote. Specifically, the Government "improved training of public health professionals and developed one of the most sophisticated disease surveillance systems in the world."

In contrast, the Trump administration in the US had made major cuts to the budgets of the National Institutes of Health and Centres for Disease Control and Prevention. The budget submitted by the Trump administration in February 2020, as the pandemic was beginning, had called for an additional reduction of US\$ 693 million to the CDC budget.

In the case of the Government of India, the health budget has always been low. By the last count it was 0.34% of the GDP, while it should be 2.5% as per the 2017 National Health

China's steps

Knowing that there were no safe or proven treatments or an effective vaccine, China relied on time-honoured non-pharmaceutical interventions to conquer the epidemic. "First and foremost was containing the virus through controlling the sources of infection and blocking transmission. This was accomplished through early detection (testing), isolation, treatment and tracing the close contacts of any infected individual," she points out.


Though it was caught off guard when COVID-19 broke out in December 2019, the Government quickly mobilized its resources to bring the epidemic almost to a halt inside its borders within three months, the US expert said. The methods China adopted to fight COVID-19 had their origin in the way it tackled the SARS epidemic, including mask wearing, widespread testing, contact tracing and isolation. The only difference was in the intensity of the control measures, many of which came under flak in Western democracies for their severity.

But they worked. Within a year of the outbreak of COVID-19 in Wuhan, people in China were able to "travel, eat in restaurants and go into theatres, and kids go to school without much concern for their health," Uretsky

There is a general opinion in the West that Chinese official statistics are suspect and there could be under

reporting of inconvenient facts. But Ananth Krishnan, Beijing correspondent of the Indian daily The Hindu and author of India's China Challenge: A Journey through China's Rise refutes this contention as regards COVID. "There is no evidence to suggest there are currently thousands of cases or hidden outbreaks. This is backed up by, among other things, the return to normalcy, opening of schools, the boom in domestic travel, the current situation in hospitals, and not to mention, independent accounts from foreign reporters based in China," he wrote a year after the outbreak.

Initially, Beijing suppressed news of the emergence of an unknown killer in Wuhan in the Hubei Province in December 2019. Around 80,000 were infected and 30,000 had died there. But the Government came out of hiding in January 2020 to declare a lockdown in that province between January 23 and April 16. More than 50 million people in Hubei Province were quarantined. Some other provinces were also locked down for various periods. The lockdowns were exceptionaly stringent.

Plethora of measures

The Government made good use of the lockdown to plan and execute a plethora of control measures. New York Times reported that the Government had ordered the erection of entire towns of prefabricated buildings to serve as quarantine centres. Hospitals came up in a matter of days. Farm lands were commandeered, and within hours, owners of construction companies and factories were given orders and funds came quickly. Sinopharm, a stateowned pharmaceutical company, got government funding in three and a half days according to New York Times. Contact tracing and testing was aggressive. The Hindu reported that in Qingdao, the entire city of 10.92 million was tested in five days.

The State quickly mobilized its huge bureaucracy. More than 4,000 medical workers were sent to ground zero in Hubei. And the vast Communist Party network right down to the hamlet level was harnessed to good

The indigenously-developed Chinese vaccine might have been produced and used without following the set international procedure, but the Government gambled by using it on millions in China and making it available to subsequently to 80 countries and international organisations. There were reports that the Chinese vaccines were less effective than

Western makes. But overall, the vaccines have worked with little or no

Other key factors

Besides efficiency there were other contributory factors. A major advantage that China had (and still has) is that the average Chinese citizen is habitually acquiescent, following orders instinctively. This enabled large-scale mobilization with a mere bark of an order or the crack of a whip. In contrast to democracies, the Chinese State is unabashedly intrusive. As the New York Times put it: "The top leaders have levers to reach down from the corridors of central power, to every street, and even apartment building!"

Breaches of virus containment rules were deemed anti-national and punished. A New York Times report mentioned a villager near Shijiazhuang who was tied to a tree because he tried to flout quarantine restrictions to go out to buy cigarettes. More than 5,000 local party and government officials were sacked in 2020 for failure to deliver, the paper reported.

The security or surveillance system put in place initially to identify, track, intercept and punish political dissenters, came in handy in COVID-19 infection contact tracing. India's former National Security Advisor Shivshankar Menon says in his latest book: India and Asian Geopolitics that China has consistently spent more on domestic surveillance and security than on external defence. Indeed, there was suppression of speech and dissent, so much so that the doctor who first reported the virus in Wuhan was arrested. Subsequently he succumbed to COVID triggering world-wide outrage. However most Chinese would argue that unimpaired circulation of information could have hampered virus containment.

Though China recovered almost fully in 2020, it continues to be extremely vigilant about the resurgence of the pandemic. There are still about 15,050 cases to be cured. Recently, there had been "imported" cases due to which, a Chinese stateowned airline, Sichuan, suddenly stopped vital cargo flights to India, putting Indian vaccine manufacturers in a spot. However, later, due to the dire situation in India, the airlines and the Chinese government expedited relief supplies.

During the height of the pandemic, the Chinese economy did plummet like other economies in the world, but China got on to the road to recovery faster. Even Western media reports acknowledged that during the 76-day lockdown in Wuhan, major industries were allowed to function. Innovative measures were taken to keep economic activity going, albeit with the most stringent safeguards. Few contracts were cancelled. Few workers were laid off. Government gave loans and waived taxes to stimulate continued activity. Those in quarantine and under lockdowns were very well served by commandeered but highly trained personnel. New ways of functioning under lockdown were discovered and implemented.

With the wheels of the economy kept moving, China grew by 4% while the other economies fell by 43%, according to UNCTAD.

ndia has now accounted for more than half the global cases of COVID-19 and 25 percent of global deaths as the pandemic continues to spread in the country leading to more major health, social, economic and political issues.

Experts have warned that India must be prepared for a third wave, given the high levels of circulating virus. UNICEF Executive Director Henrietta Fore said: "Unless the world steps up and helps India now, there will be reverberations across the region and the world in terms of virus-related deaths, virus mutations and supply delays".


As India seeks to expand its vaccination programme, amidst shortages of the vaccines in many states, there are calls from many countries for a global waiver plan on patent protections for COVID-19 vaccines. The Initial move has been made by India and South Africa within the World Trade Organisation.

The country is faced with a continuous shortage of oxygen in the hospitals, the lack of beds, ventilators, and ICU facilities in hospitals, despite considerable amounts of related aid being received from many foreign countries. It is also short of crematorium space as the numbers dead continue to rise.

Prime Minister Narendra Modi and the Bharatiya Janata Party (BJP) led by him is coming in for increased criticism and protests too, with regard to its failure to curb the spread of the pandemic, its claims to deheated it, and allowing huge gatherings of people, at political rallies at several state elections, and at religious festivals that drew massive crowds.

The BJP failed in its attempt to gain control of the West Bengal state, with Chief Minister Mammata Bannerjee leader of the Trinamool Congress, being elected for a third successive term, and her becoming a major challenger to Modi's national leadership. The DMK obtained a lead vote in Tamil Nadu, and opposition parties led in Kerala too. The BJP had a gain in the northern Assam state.

BIDEN FOR VACCINE WAIVER



US President Joe Biden

US President Joe Biden's administration on Wednesday announced support for a global waiver on patent protections for COVID-19 vaccines, offering hope to poor nations that have struggled to access the life-saving doses.

India, where the death toll hit a new daily record amid fears the peak is still to come, and South Africa have been leading the fight within the World Trade Organisation (WTO) to allow more drugmakers to manufacture the vaccines—a move pharma giants opposed.

Biden had been under intense pressure to waive protections for vaccine manufacturers, especially amid criticism that rich nations were hoarding COVID-19 vaccines.

Tedros Adhanom Ghebreyesus, head of the World Health Organisation (WHO), called the US decision "historic" and marked "a monumental moment in the fight against COVID-19."

With supplies for Americans secured, the Biden administration will continue efforts "to expand vaccine manufacturing and distribution," and will work to "increase the raw materials needed to produce those vaccines."

cines."
For months the WTO has been facing calls to temporarily remove the intellectual property protections on COVID-19 vaccines, known as a TRIPS waiver in reference to the agreement on Trade-Related Aspects of Intellectual Property.

WTO chief Ngozi Okonjo-Iweala on Wednesday described it as the "moral and economic issue of our time."

But that notion has been fiercely opposed by pharmaceutical giants and their host countries, which insist the patents are not the main roadblocks to scaling up production, and warned the move could hamper innovation.

"A waiver is the simple but the wrong answer to what is a complex problem," the Genevabased International Federation

INDIA WARNED OF COVID THIRD WAVE

of Pharmaceutical Manufacturers and Associations lobby group said, describing the US move as "disappointing."

K. Vijay Raghavan, the Indian government's principal scientific advisor, said the country of 1.3 billion people had to prepare for a new wave of infections even after beating down the current wave, which has taken the country's caseload above 20 million infections.

In an effort to boost the country's collapsing health system, India's reserve bank announced \$6.7 billion in cheap financing for vaccine makers, hospitals and health firms.

In London, foreign ministers from the Group of Seven wealthy democracies committed to financially support the vaccine-sharing programme, Covax.

G7 FOREIGN MINISTERS

Boris Johnson and US Secretary of State Antony Blinken discussed the "close alignment" between foreign policy in London and Washington during their meeting this week.

A No 10 spokeswoman said the PM and Mr. Blinken agreed UK-US cooperation would be "instrumental" in tackling COVID-19.

They also welcomed their nations' joint work on areas like trade and defence.

It came as G7 powers met in London for their first face-to-face meetings in over two years. The group discussed challenges including climate change and threats to human rights. The talks were held amid tight COVID restrictions.

The G7 group - the world's seven largest so-called advanced economies - is made up of the UK, Canada, France, Germany, Italy, Japan and the United States. It has invited Australia, India, South Korea and South Africa to be guests, with the UK's efforts to deepen ties with the Indo-Pacific region.

The UK, which currently holds the rotating presidency of the G7, will host a leaders' summit in Cornwall next month.

At their meeting, Mr. Johnson and Mr. Blinken agreed that UK-US cooperation would be "instrumental" in making progress in the fight against coronavirus, alongside "protecting the environment and other international priorities", the spokeswoman said.

The spokeswoman added that foreign policy issues, including Afghanistan, Iran and China,

were also discussed, and Mr. Johnson "looked forward to welcoming" US President Joe Biden to the UK when he attends the leaders' summit in June - his first overseas trip since his election victory.

ISRAEL - NETANYAHU FAILURE

Israel's President Reuvan Rivlin has asked Opposition Leader Yair Lapid to form a new government, after Prime Minister Benjamin Netanyahu failed to combine a group to form a coalition government. This could lead to the end of the lengthy rule of Benjamin Netanyahu.

Netanyahu's right-wing Likud party finished first in the March 23 election, Israel's fourth inconclusive vote in less than two years, helping the divisive premier earn a 28-day mandate to negotiate a government. He is facing charges of fraud, breach of trust and bribery in a series

of scandals in the Israeli courts.
But that mandate expired
Tuesday and Netanyahu
informed President Reuven Rivlin he had been unable to secure
a majority in the 120-seat Parlia-

Netanyahu's failure further highlighted deep fractures in the Israeli electorate, which spread its support across the political spectrum, including far-right Jewish extremists and a conservative Islamic party.

President Rivlin has given a 28-day mandate, stating that it was clear the centrist former television anchor "has the best chance to form a government", having the pledged support of 56 of Parliament's 120 members, still short of a majority.

Lapid, whose late father was a Cabinet minister and who himself is a veteran journalist and politician, now has four weeks to reach a deal with potential partners. He now has the chance to make history by ending the reign of Netanyahu, Israel's longest-serving prime minister. Netanyahu, 71, has held the post for a total of 15 years, including the past 12.

Netanyahu's political future was thrown into question when he failed to assemble a ruling coalition in the four weeks allotted to him, raising the possibility that his 12-year run as Prime Minister – the longest in Israeli history – could soon come to an end, following more than two years of political paralysis.

However, there is the possibility that a fifth consecutive elec-

tion is still possible, if Lapid too fails to form a coalition to control the majority in the Knesset.

The last election, which was held on March 23, ended in deadlock for the fourth consecutive time in the past two years. Despite repeated meetings with many of his rivals and unprecedented outreach to the leader of a small Islamist Arab party, Netanyahu was unable to close a deal.

Netanyahu has become a divisive figure in Israeli politics, with the last four elections all seen as a referendum on his rule. He has been desperate to remain in office while he stands trial, using his position to lash out at prosecutors and seek possible immunity from prosecution

Netanyahu has been charged with fraud, breach of trust and bribery in a series of scandals. The trial has moved into the witness phase, with embarrassing testimony accusing him of trading favours with a powerful media mogul. Netanyahu denies the charges, accusing law enforcement, the judiciary and the media of waging a "witch-hunt" against him.

FRANCE - CLIMATE LAW



French President

France's National Assembly has approved a wide-ranging climate change bill which will bring major changes to the country's policies on ensuring major improvements on climate change.

The draft legislation was

approved in a first reading by the Lower House of Parliament, where President Macron has a working majority. It has been heavily criticised by environmental groups. The bill now passes to the Senate before a final vote in the lower house.

Campaigners see it as too

timid given the pace of climate change globally and accuse the French leader of half-hearted commitment to a cause he has admitted to embracing belatedly.

France's Environment Minister, Barbara Pompili, has defended the text, saying it "will affect the daily life of all of our citizens" and is "one of the biggest laws of the (president's) term".

Measures include bans on domestic flights under two and half hours that can be done by train, restrictions on renting badly insulated properties, or the creation of a new "ecocide" crime to punish polluters.

The overall aim is to put in place measures that will enable France to meet its target of reducing its greenhouse gas emissions by 40 percent compared with 1990 levels by a dead-line of 2030.

Lobby groups such as Greenpeace have called it a "lost opportunity of Macron's term", while even the president's own environmental advisory council said it would "have a potentially limited impact".

It is also less ambitious than new targets for 55 percent cuts agreed at the EU level and falls short of a German plan which was rejected last week by the country's constitutional court as "insufficient".

Climate change and protection of the environment are likely to be bigger themes in next year's presidential election than the last one in 2017, which Macron won while barely campaigning on the issue.

The European Parliament and EU member states agreed a target in late April of cuts of at least 55 percent by 2030 from 1990 levels – compared to the 40 percent target set in the French law.

MYANMAR

As the protests by an unarmed public against the military junta in Myanmar continues, an ethnic rebel group in northern Myanmar has said it shot down a government military helicopter, during heavy fighting over a strategic position.

The claim by the Kachin Independence Army came as protests against Myanmar's military government continued in Kachin State and elsewhere in the country. It would be the first aircraft shot down during recent hostilities between the government and ethnic guerrilla armies. There was no immediate comment by the government on the incident.

The Kachin are one of several ethnic minorities who have allied themselves with the nationwide protest movement against the military's February ouster of the elected government of Aung San Suu Kyi, who was arrested and remains in detention. The country's ethnic minorities have been fighting for decades against the central government for greater autonomy.

Government actions are underway against the Kachin and the Karen, another ethnic minority in eastern Myanmar that maintains their own armed forces, and also have been the target of airstrikes. The fighting in Kachin and Karen states has displaced more than 45,000 villagers.

Col. Naw Bu, a spokesman for the Kachin Independence Army, said his group's forces shot down the aircraft after government forces used helicopters and jet fighters in an attack on Montauk township, where the Kachin seized a base at the foot of Alaw Bum mountain from the government on March 25.

Naw Bu said it was the first

Naw Bu said it was the first aircraft shot down in what has become a fierce battle lasting almost two weeks after the government attacked with heavy artillery and fighter jets.

The ruling junta continues to also face a challenge in the cities and towns of Myanmar, where street protests are still being held more than three months after it seized power.

Security Forces continue to use lethal force to break up the protests. The Assistance Association for Political Prisoners, which tracks deaths and arrests, said at least five civilians were killed Sunday on what protesters declared was Global Myanmar Spring Revolution Day.

The organisation said Security Forces have now killed 765 protesters and bystanders, and that 3,555 people have been detained since the army's seizure of power. About 40 journalists are among those being held.

and Indian governments are also promising to work "constructively" on reducing illegal migration between them, including mounting a stronger "fight" against the use of forged documents.

UK Home Secretary Priti Patel said: "This landmark agreement with our close partners in the government of India will provide new opportunities to thousands of young people in the UK and India seeking to live, work and experience each other's cultures.

"This agreement will also ensure that the British government can remove those with no right to be in the UK more easily and crack down on those abusing our system."

UK Prime Minister Boris Johnson and Indian Prime Minister Narendra Modi held a virtual meeting on Tuesday to discuss a "roadmap" for cooperation over the next decade on health, climate, trade, education, science and technology, and defence.

Trade between the UK and India is worth about £23bn per year, and the UK government hopes to double that by 2030.

COLOMBIA - PROTESTS

The international community has decried what the UN described as an "excessive use of force" by security officers in Colombia after numerous deaths during days of anti-government protests.

The United Nations, United States, European Union and rights bodies joined a chorus of criticism after official data showed 19 people were killed and 846 injured in running clashes with the Security Forces.

Colombia's human rights ombudsman -- a state agency independent from the government -- said 89 people were listed as "disappeared."

Tens of thousands of Colombians have taken to the streets in demonstrations that began last Wednesday against a proposed tax reform, but have since morphed into broader protests against the government of President Ivan Duque.

On Tuesday, protesters blocked roads in several parts of the country, coinciding with fresh demonstrations in the capital Bogota and in Cali in the west of the country.

Cali, Colombia's third-biggest city and the worst-affected by the ongoing unrest, has had soldiers patrolling its streets since last Friday on government orders.

The Ministry of Defence has deployed 47,500 uniformed personnel countrywide. In Cali alone, 700 soldiers, 500 riot police officers, 1,800 other police and two helicopters have been put into operation.

The Office of the UN High Commissioner for Human Rights voiced "profound shock" on Tuesday at an overnight incident in Cali in which police allegedly "opened fire" on demonstrators, reportedly killing and injuring several.

"What we can say clearly is that we have received reports, and we have witnesses, (of) excessive use of force by security officers, shooting, live ammunition being used, beatings of demonstrators and as well detentions," spokeswoman Marta Hurtado told reporters in Gene-

On Tuesday, blockades of the main roads in the Cali region caused delays in petrol deliveries and concern about the fate of trucks transporting oxygen and medical supplies in the midst of the coronavirus pandemic.

The UN called for calm ahead of fresh rallies planned for Wednesday, saying Security Forces should use firearms only as a last resort when facing an imminent threat of death or serious injury.

"Nothing justifies armed people who, protected by the legitimate desires of citizens to march, go out to shoot defenseless citizens and cruelly attack our police," said Duque, who on Sunday withdrew the proposed reform that sparked the initial protests.

Defence Minister Diego

Molano said the violence was "systematic, premeditated and financed by criminal organisations..."Our public forces must be ruthless towards those who use vandalism," the minister warned.

EU spokesman Peter Stano said it was a priority to stop the escalation of violence "and to avoid any disproportionate use of force by Security Forces."

And US State Department deputy spokeswoman Jalina Porter underlined the right of all people to protest peacefully... "Violence and vandalism is an abuse of that right. At the same time, we urge the utmost restraint by public forces to prevent additional loss of life," she said

Amnesty International called Tuesday for an "end to repression of protests and the militarization of cities."

'Deadly new surge in South Asian COVID-19 cases threatens reversal of global gains'

We may be exhausted, but the virus is not yet exhausted. Now more than ever, we must commit ourselves to wearing masks, washing our hands with soap as often as possible, keeping the required physical distance, and getting ourselves vaccinated if we have the opportunity to do so," he added.

None of us are safe until all of us are safe," the Regional Director said.

"As we work to respond to the public health emergency, we cannot forget the profound impacts of the pandemic on children. Children are being directly affected by the disease in higher numbers than ever before. They are losing parents and caregivers, becoming witnesses to scenes no child should ever see, and being cut off from their schools and vital support networks. As resources are diverted and services saturated, the essential health services they so heavily rely on—including routine immunisation programmesmised, if not shuttered entirely," he added.

"If this happens, it will once more be the most vulnerable children and families who will suffer most. The first wave of the pandemic caused drastic cuts in the availability and use of essential public health services in South Asia, costing us the lives of an estimated 228,000 children and 11,000 mothers. We simply cannot let this happen again," Laryea-Adjei said.

We must do everything within our power to keep essential health, immunisation and nutrition services running, and make sure women and children everywhere feel safe to use them. Viruses know no borders. We must come together now as a global community to stop the devastation and protect our children," he added. (UN News)

UNESCO study shows sharp increase in online violence against women journalists

A UNESCO discussion paper points to a sharp increase in online violence against women journalists and reveals how such attacks are 'inextricably bound' with disin-religious bigotry, and other forms of disformation, intersectional discrimination, and populist politics.

The paper, titled 'The Chilling: Global Trends in Online Violence against Women Journalists', presents an edited extract from a forthcoming interdisciplinary study carried out by the International Centre for Journalists (ICFJ).

The first of its kind in terms of its scope and methodology, the paper is based on a global survey of 901 journalists from 125 countries; long-form interviews with 173 journalists and experts; two big data case studies assessing over 2.5 million social media posts directed at prominent journalists Maria Ressa (The Philippines Laureate of the 2021 Guillermo Cano World Press Freedom Prize) and Carole Cadwalladr (UK); 15 detailed country case studies; and a literature review covering hundreds of scholarly and civil society research publica-

The discussion paper provides hard facts and detailed analysis on the following key

• Online attacks have real-life impacts. Not only do they affect mental health and productivity, but physical attacks and legal harassment are increasingly seeded online.

• Misogyny intersects with other forms of discrimination. Women journalists who are also disadvantaged by racism, homophobia, crimination. They face additional exposure to online attacks, with worse impacts.

• Gendered online violence intersects with disinformation. While orchestrated disinformation campaigns weaponise misogyny to chill critical reporting, reporting on disinformation can be a trigger for heightened

• Online attacks against women journalists have political motives. Political actors, extremist networks, and partisan media are identified as instigators and amplifiers of online violence against women journal-

• Social media platforms and news organisations are still struggling to respond effectively. In the context of an increasingly toxic information ecosystem, platforms are seen as major enablers for online violence.

When women journalists turn to them or their employers in the midst of an online violence storm, they often fail to receive effective responses and even face victimblaming behaviour.

A team of 23 international researchers from 16 countries, led by Julie Posetti, Nabeelah Shabbir, Diana Maynard, Kalina Bontcheva, and Nermine Aboulez, contributed to the study. (UN News)

Coastal clean-up programme in

he definition for a separate state was stipulated in the Montevideo Convention which came into force in December 1933 among Latin American countries and the United States and is now considered a part of International Law. The criteria for statehood according to the Convention are that a state must possess a permanent population, a defined territory, a Government, and the capacity to conduct international relations. As far as the Colombo Port City (CPC) is concerned none of the conditions required to fulfil this has been found.

Justice Minister Ali Sabry, PC, claimed that the Port City is very much a part of the Colombo administrative district but then there are arguments that the Bill should go before the Western Provincial Council for approval, Gamini Marapana, President's Counsel, however, rejected this contention when he said since the Provincial Councils are not in operation the argument does not arise with regard to the Colombo Port City. This is a point that the Supreme Court, the Apex Court looking into the constitutionality of the Bill, will look at.

In the meantime, the Government should also take a close look at Clause 7 and Section 4 subsection 2 of the Colombo Port City Economic Commission (CPCEC) Bill which respectively states that:

The Bill provides for the establishment of a Commission consisting of five to seven persons appointed at the sole discretion of the President;

The Commission shall, in consultation with the Project Company, and with the concurrence of the President or in any event that the subject of the Colombo Port City is assigned to a Minister, with the concurrence of such Minister, identify any amendments to the Master Plan, and if such amendments are considered necessary in the national interest or in the interest of the advancement of the national economy, to ensure through its viability the enhancement of the businesses carried on, in and from the Area of Authority of the Colombo Port City.

These apart, the former Central Bank Governor Dr. Indrajit Coomaraswamy took a closer look at the CPCEC Bill and emphasised the need to compare it with the provisions of the Greater Colombo Economic Commission (GCEC) which had more autonomy in terms of infrastructure, taxation, customs etc.

Dr. Commaraswamy's observations are as follows.

"Several countries have overcome ideological, political or capacity-related constraints to improve their business climate by creating special economic zones/ enclaves. Foreign Direct Investment (FDI)-driven export growth has often been the key to accelerate the growth and employment generation trajectory of an economy. This has been the case for countries as large as China or as small as Singapore and also, for more centrally-planned economies such as Vietnam, or more market-oriented ones. Special zones have been a useful mechanism for attracting FDI and promoting exports as they present a more manageable prospect for pushing through policy, structural or institutional reforms which are more difficult on a national scale.

Shannon, in Ireland, provided an initial template for setting up special zones. Sri Lanka was one of the early movers in the developing world when it implemented the

The GCEC had a great deal of autonomy in terms of infrastructure provision, taxation and customs. It would be good to compare the GCEC Act with the current CPCEC Bill in terms of their respective provisions concerning these matters.

An important dimension of this comparison should be how matters related to public finance (both revenue and public expenditure) are handled in terms of Parliamentary oversight. Any resources that have an impact on the Consolidated Fund would normally involve Parliamentary oversight. One would need to examine the constitutionality of avoiding Parliamentary oversight in such circumstances.

In a country where revenue collection is severely challenged (less than 12 percent of Gross Domestic Product (GDP) when peers mobilise over 20 percent), it is questionable whether such generous tax concessions are

investment. There are several other more significant considerations. Sri Lanka built up its vaunted social indicators by consistently collecting 20–21 percent of GDP. In a recent op-ed, Professor Mick Moore pointed out that revenue constraints lead to loss of sovereignty as Governments are forced to accept external conditions to raise the financing they require.

Careful consideration should be given to he provisions in the Bill relating to the legal and regulatory functions of the Commission and the entities under it. They should be aligned with good practice elsewhere, particularly about the nexus between oversight functions within the zones and outside it.

The Bill should set out the mix of expertise and experience that should be reflected in the composition of the Commission. It should be built into the Bill as much as possible to ensure that the appointments are based on professional merit rather than political favour. One way of doing this is to provide for bodies such as the Charted Accountants of Sri Lanka, Bar Association of Sri Lanka, and Association of Professional Bankers to recommend (or even nominate) representatives for the Commission.

This may not be perfect, but it is better than leaving it to individual politicians.

Entities such as the Central Bank of Sri Lanka, Attorney General's Department, Securities and Exchange Commission and Financial Intelligence Unit should have senior ex-officio membership of the Commission or key entities under it.

All provisions of the proposed Act should be carefully screened to ensure that they do not discriminate unduly against the rest of the economy.

I should also point out that taxation serves to transfer some of the benefits accruing from the Colombo Port City to the population at large. This is important given that tax collections would have assisted in financing the infrastructure and educating/ training workers for the CPC.

A recent Price Waterhouse Coopers (PWC) report states that the Sri Lankan economy stands to gain from the proposed Colombo Port City.

Extracts from the study:

"At present, Sri Lanka receives around US\$ 1–1.5 billion through FDI annually. Hence the expected flow of FDI would be sizable and it is expected that Sri Lanka will be well-positioned for attracting FDI due to Port City Development. Moreover, it is

expected that there will be a spillover effect as well where the Port City may encourage FDI flows outside the project. Taken together, the Port City should be a key driver in attracting FDI in future Sri Lanka.

Government revenue will be derived through several channels during the development of the Port City. At the land reclamation and common infrastructure development stage, the Government may incur some costs for providing certain infrastruc ture facilities to the outer border of the Port City namely electricity, water, and road access etc.

Some concessions and exemptions given on import duty may have a negative impact on Government revenue (in terms of loss of royalty payments for sands, and import of material etc).

Besides, in each operational year, the Government could receive revenue worth US\$ 800 million from income taxes, import duties, and license fees etc. Taken together, the Port City will be a good source of revenue generation for the Government and would certainly support the Sri Lankan Government in increasing its expenditure on development and welfare activities elsewhere, along with reducing the dependency on borrowing. However, it should be noted that the estimates were based on the prevailing/proposed tax rates and any exemptions or concessions provided for the operators within the Port City may lead to a reduction in tax revenue.

The economic impact assessment which captures both direct and indirect effects clearly indicates that the Port City would have a significant impact on the national economy in terms of employment generation, attracting FDIs, GDP contribution, BOP (Balance of Payment) and Government revenue when it progresses as envisaged.

The Port City could be classified as a strategic investment project and a potential source and driver of economic growth and development for Sri Lanka. Such investment projects elsewhere in the world have historically played a significant role in transforming developing economies into more advanced ones.

One of the key determining factors in achieving the expected result would be the pace of the city development process and the enablement of its smooth functioning. Delays in construction, as well as the red tapes to functioning, could significantly lower the economic potential. In this context, it would be beneficial to have a clearly defined regulatory policy framework for the Port City, as this would support the achievement of the aforementioned economic targets. It is important to highlight that in addition to the impact on economic growth, any negative developments and barriers could affect the attraction of FDIs to the Port City project and other investment projects in Sri Lanka."

The Port City in short gives an explicit picture of how Sri Lanka could develop its economy to go forward in the global economic melee and stand as a steadfast economy in the developing world.

World Thalassaemia Day falls today

Towards a Thalassaemia-free Sri Lanka and World

Senior Prof. ANUJA PREMAWARDHENA and Dr. SHIROMI PERERA

orld Thalassaemia Day is celebrated every year on May 8 to commemorate Thalassaemia victims and to encourage those who struggle to live with the disease. The theme for this year is "Addressing Health Inequalities across the Global Thalassaemia Community".

Every year since 1994, the Thalassaemia International Federation (TIF) is organising many diverse activities for the International Thalassaemia Day, with the objective of drawing the attention of the public, patient associations, public authorities, healthcare professionals, and industry representatives, to fuel discussions and promote actions on a particular theme related to the prevention, management or treatment of the disease in a patient-centred

Thalassaemia is the most common inherited blood disorder worldwide, resulting from the defective synthesis of haemoglobin, which causes a major health problem in many parts of the world especially in underdeveloped countries. It has the highest frequency in areas where malaria is endemic, such as the Mediterranean, Southeast Asia and India, suggesting positive selection by the malaria parasite. The global distribution of thalassaemia is observed in a broad band extending from the Mediterranean basin, parts of Africa through the Middle East, the Indian Subcontinent and Southeast Asia to the Pacific Islands.

In Sri Lanka, beta thalassaemia is the most common haemoglobin disorder and it is highly prevalent in the North Western Province especially in the Kurunegala District. However, at present, a significant number of thalassaemia cases are reported in the other districts at a different rate. There are around 2,500 reported cases undergoing treatment and around 50-60 new cases diagnosed as beta thalassaemia each year. The majority of them belongs to thalassaemia major and E- beta thalassaemia. In recent years, the number of patients who have been to hospitals in Sri Lanka with severe forms of thalassaemia has significantly increased. Therefore, this disease is posing an increasingly dangerous public health problem to the Sri Lankan Government

According to statistical predictions, there are over 800,000 beta thalassaemia carriers in Sri Lanka. This accounts for 2.5 percent carrier frequency, however, in some isolated patches, it has increased up to 10 percent. Even though there is a low number of cases of alpha thalassaemia reported in Sri Lanka compared to beta thalassaemia, it has been reported that the occurrence of several different forms of alpha thalassaemia of which the deletion forms of alpha+ thalassaemia is the most common with a carrier frequency of 10 percent.

Therefore, the purpose of this article is to inform the public on thalassaemia disease, its different forms, diagnostic methods, various treatment methods and the current situation of thalassaemia in Sri Lanka.

Thalassaemia is an inherited blood disorder resulting from the defective synthesis of haemoglobin. It is a Non-Communicable Disease (NCD) that is passed down through families (inherited) from one generation to the next generation. Severe thalassaemia patients require lifelong blood transfusions due to the premature destruction of red blood cells.

Thalassaemia is broadly classified into two major forms namely alpha thalassaemia and beta thalassaemia, depending on the globin chain(s) which are inefficiently synthesised due to the mutation of the respective genes.

Haemoglobin is the protein in red blood cells that carries oxygen throughout the body. Each haemoglobin molecule consists of two alpha globin chains and two beta globin chains covalently linked to a haem group porphyrin through an iron atom. Thalassaemia occurs when there is a defect in a gene that helps in the synthesis of one of these proteins. Once these genes are mutated, they will not produce the proteins. Alpha thalassaemia occurs when alpha globin genes related to the alpha globin protein synthesis are mutated. Similarly, beta thalassaemia occurs when beta gene defects

affect the production of the beta globin protein. Beta thalassaemia is the most common form found in Sri Lanka. There are three major subtypes of beta thalassaemia - thalassaemia major, thalassaemia minor and thalassaemia intermedia - depending on the degree of clinical severity and genetic makeup. The production of beta globin proteins in haemoglobin is regulated by beta genes. For this, a pair of genes is responsible, one of which is inherited from the mother and the other from the father. If one of these genes is mutated, one can live a healthy life without any symptoms. These are called 'thalassaemia carriers' of the disease. Unfortunately, if a person inherits thalassaemia genes from both mother and father, he or she becomes a thalassaemia patient. In such a baby, the production of haemoglobin is reduced and the red blood cells begin to be destroyed. At the same time, the formation of red blood cells is reduced. They are called thalassaemia major

patients. If only one of the parents is a carrier of thalassaemia, their children have a 50 percent chance of being a thalassaemia carrier. Their children do not suffer from thalassaemia major. Thalassaemia carriers are completely healthy individuals and can carry thalassaemia through generations. If both parents are carriers of thalassaemia, they have a 25 percent chance of having healthy children, a 50 percent chance of having a thalassaemia carrier, and a 25 percent chance of having children with thalassaemia major.





Thalassaemia Major patients

There are four alpha globin genes that produce the alpha globin protein. Of the four alpha globin genes, two are inherited from each parent. Individuals who inherit a single alpha gene deletion are known as 'silent carriers' and those who inherit two genes cis (-alpha-/alpha) or trans (-alpha /-alpha) deletion are called 'thalassaemia carriers'. Haemoglobin HbH is caused by the deletion of three of the four alpha genes. These patients show thalassaemia symptoms and require a blood transfusion for their survival. Deletion of the four alpha genes is called haemoglobin Bart hydrops fetalis syndrome and such children will not be born.

The genetic interactions underlying the phenotype of beta thalassaemia intermedia include (1) inheritance of two mild beta thalassaemia alleles (2) inheritance of two beta thalassaemia alleles with factors that increase HbF production or alpha thalassaemia (3) inheritance of single beta thalassaemia allele with excess alpha globin genes (4) inheritance of single beta thalassaemia allele with haemoglobin variants. Thalassaemia intermediate patients in Sri Lanka are mainly E-beta thalassaemia and non-E-beta thalassaemia patients with excess alpha globin genes.

When considering the symptoms of thalassaemia, thalassaemia minor persons or carriers do not show any symptoms. It can only be detected by a blood test. Thalassaemia major


patients have premature destruction of red blood cells, causing them to develop symptoms early in life. Although they appear to be normal healthy babies at birth, they show anaemia between three-four months. Symptoms of thalassaemia include paleness, insomnia, loss of appetite, vomiting, jaundice, poor growth, decreased activity, frequent infections, and protrusion of the abdomen due to swelling of the spleen and liver. Thalassaemia intermedia have an intermediate condition between thalassaemia carriers and thalassaemia major. These patients develop symptoms later in life and show a much wider range of symptoms.

Thalassaemia can be diagnosed by a simple blood test (Full Blood Count). If there is a decrease in haemoglobin level and red cell index (mean cell volume (MCV) <80fl or mean cell haemoglobin (MCH) <27pg), it is an indication for having thalassaemia. Thalassaemia can then be confirmed by a special test such as High-Performance Liquid Chromatography (HPLC) or Capillary Electrophoresis (CE).

When treating thalassaemia patients, thalassaemia minor patients are only carriers and do not need a blood transfusion. However, regular blood transfusions should be carried out monthly for patients with severe thalassaemia. Also, iron chelation should be done to remove excess iron from the body. Immunisation should also be given properly. Thalassaemia intermediates do not require a monthly blood transfusion. Treatment methods vary from patient to patient as they are treated according to their symptoms and the severity of the disease.

The treatment of beta thalassaemia has been mostly confined to blood transfusion and chelating therapy and a few other modern therapies such as treatment with antioxidants and the induction of foetal Hb by hydroxyurea and erythropoietin. In addition, bone marrow transplantation has offered a definitive cure for a fraction of patients with available donors. The above treatment methods are costly and cause a severe financial burden to the health sector in the country.

Therefore, for a developing country like Sri Lanka, the most appropriate, successful and cost-effective method is to prevent affected

births. Pre-marital blood tests to screen for thalassaemia, preventing marriage between two carriers of thalassaemia and marriage between blood relatives would be most useful in preventing the birth of an affected

As mentioned earlier, we do not know where these habits came from. It is the same gentlemen who dispose of garbage that piles up in their home on the roadside, who abandon families of cats and dogs in the vicinity of Buddhist temples.

Sometimes there are devotees who visit the temple only to invite the resident monks to carry out the ritual of 'Pansakula' when a death occurs in the family.

When someone dumps animals, the monks of the temple do not take these animals to another place. What they do is share alms they receive, with these uninvited and unwanted animals. In some temples, the alms they receive are even not enough for the monks. So, either the animals starve or the monks starve. The monks cannot prevent these animals from breeding and becoming victims of illnesses. Some do not like to visit temples which are teeming with animals, since they believe they are dirty and smelly.

According to information obtained by the organization 'Dhamma Voice for Animals' from their representatives across the country, sometimes there are about 20 dogs in a temple. In another temple there could be 15 cats. These animals have



nowhere else to go and the temples do take care of them. Recently a programme was held at the Balapitiya Kurunduwatta Shailabimbarama Viharaya in the South to treat dogs that had been left in temples and to carry out sterilisation operations. Another programme was held to raise awareness among Dhamma school children, about the sin of harming innocent animals. This was led by the Dhamma Voice

for Animals. The significance of this programme is that it was conducted based on a concept of an activist who is not a Sri Lankan but an American who deeply loves and cares for abandoned animals in Sri Lanka.

The many dimensions of animal rights

How can you love some animals but eat others? t's a question posed frequently by vegan activists, often accompanied by a picture of a cute dog or cat juxtaposed with an equally adorable pig or

Despite Americans' food preferences, most of us like to think of ourselves as animal lovers there's about one cat or dog for every 2.4 people — and many Americans can even express pretty radical views about animal rights, at least when pollsters call.

For example, 32 percent of respondents to one 2015 Gallup poll agreed that "animals deserve the exact same rights as people to be free from harm and exploitation." Skeptical of such strong support for animal rights, I conducted a follow-up survey a few years later, finding an even higher rate — 47 percent — endorsed this view. (I'm a professor and researcher who studies social movements, food systems, and animal rights.)

These results might lead you to believe that one-third to a half of Americans support giving animals substantial rights. But when respondents support animal rights in polls, they're not actually talking about all animals.

In reality, people have a classification system for animals in their heads, and then perceive and treat them differently based on those classifications. Case in point: 75 percent of my survey respondents identified as an "animal lover," though only about six percent followed a vegetarian or vegan diet. How we sort animals into different categories is shaped by an intersecting and evolving mix of factors, based in human psychology, cultural norms, direct experience, and media exposure.

Each year in the US alone, billions of animals are factory-farmed in terrible conditions, millions are confined in cages in medical labs, and countless animals' habitats are cleared for development.

Until we have a clearer picture of how people actually think about animals, we have little hope of changing public opinion, let alone the laws that govern how animals live and die.

As a way to better understand these surprising poll results and their inconsistencies, I conducted a series of focus groups with diverse groups of Americans. My research demonstrates the serious barriers that stand in the way of change — while also pointing to some strategies to shift the way people think and eat.

For the focus groups, I first screened participants by asking them the same Gallup poll question — whether they believe "animals deserve the exact same rights as people to be free from harm and exploitation.

When thinking about the poll question, many people told me their mental picture of "animals" was restricted to only those they considered pets. Regardless of their response to the poll, almost no one endorsed the idea that all animals deserved legal protection on par with humans. As one respondent put it, "There is definitely a hierarchy."

The conversations showed people slot different animals into different mental categories, a mostly unconscious sorting process that has enormous implications.

The topic has received some attention in recent from social psychologists and anthrozoologists, although there remains ongoing debate about what, exactly, these

categories are, as does a recognition that there will be major differences across global

cultures. One study proposes four clusters based on

the animal's perceived warmth (defined as whether they have good intentions toward humans) and competence (defined as whether they have capability and skill). The groups included predators (low warmth, high competence), companions (high warmth, high competence), prey (high warmth, low competence), and pests (low warmth, low com-

While these existing categories are useful for scholars, they don't really reflect how people discuss animals in their everyday lives. In order to inform research and practice, I wanted to understand how people make sense of these issues on their own terms.

Based on my focus groups and some additional surveys, I came to identify four main categories of animals that people held within their mental schema: companions, wildlife, food/farm, and pests. From there, people connected each category to a different set of moral obligations and ideal forms of legal protection.

Companion animals included household pets, mostly dogs and cats but also a host of other domesticated animals, such as horses and rabbits. These animals were spoken about with sincere love and affection, and participants supported strong laws to protect them.

Wildlife brought to mind charismatic megafauna such as great apes, elephants, and whales. People believed these animals deserved respect and the ability to live free from human control, and many argued it was unethical to force them to perform as circus acts. However, respondents were ambivalent about the ethics of keeping wildlife in zoos, which they saw as having valuable educational and conservation possibilities.

Food/farm animals referred not only to those most common in the American diet pigs, chickens, cows, fish, and the like — but also to several so-called "exotic" animals less frequently consumed in the United States, such as an octopus or alligator. Here, participants expressed hope that

these animals would not be subject to excessive cruelty, and in some instances recognized the moral ambiguity of their own meat consumption. Mostly, though, people just tried not to think much about it.

Finally, the category of pests included animals with little to no moral consideration or legal protection. "I don't look at pests like that as animals," another respondent said. "I don't look at rats and roaches and stuff, even though they are animals, I don't look at them as animals." (VOX)

POPE HAILS 'TIRELESS' **WORK OF INDIAN MEDICS**

While reviewing about the state-wise trends on **COVID-19 vaccine wastage**, the Prime Minister said there is a need to sensitise states that the speed of vaccination does not come down. "Citizens should be facilitated for vaccination despite lockdowns and healthcare workers involved in vaccination must not be diverted for other duties," it

He was briefed that around 31 per cent of eligible population over the ag of 45 has been given at least one dose.

Meanwhile, Health Ministry numbers showed 3,980 deaths in the past 24 hours, taking the national total to 230,168, and 412,262 new cases, taking India's caseload since the pandemic began over 21 million

Meanwhile, Pope Francis hailed Thursday the "tireless" work of medics in India and urged them to stay strong, in a message of support for the coronavirus-plagued country.

COVID-INDUCED "BLACK FUNGUS" REPORTED IN DELHI HOSPITAL

Doctors at a leading private facility in Delhi infection caused a high mortality with many are witnessing a rise in the number of Covidtriggered mucormycisis cases, according to a statement from the hospital.

Mucormycisis is a fungal infection triggered by COVID-19. Black fungus or mucormycosis has been a cause of disease and death of patients in transplants, ICUs and immunodeficient patients since long. Dr. Manish Munjal, senior ENT surgeon at the Sir Ganga Ram Hospital, said: "We are seeing a rise again in this dangerous fungal infection triggered by COVID-19. In the last two days, we have admitted six cases of mucormycisis. Last year, this deadly patients suffering from the loss of eyesight and the removal of the nose and the jaw bone.'

Dr. Ajay Swaroop, the chairman of the ENT department at the hospital, said the use of steroids in the treatment of COVID-19 coupled with the fact that many coronavirus patients have diabetes could be one of the reasons for this rise in the number of black fungus cases



"If you don't test very much, you're most likely to miss COVID deaths," Christopher Murray, director of the Institute for Health Metcaused during the pandemic. In the United States, the analysis estimated COVID-19 related deaths of more than 905,000. Official figures from the U.S. Centers for Disease Control and Prevention on Wednesday estimated 575,491 deaths due to the novel coronavirus.

The report only includes deaths caused directly by the virus, not deaths caused by the pandemic's disruption to healthcare systems and communities.

"Many countries have devoted exceptional effort to measuring the pandemic's toll, but our analysis shows how difficult it is to accurately track a new and rapidly spreading infectious disease," Murray said.

WHO CHIEF HAILS U.S. SUPPORT FOR VACCINE PATENT WAIVER

SWITZERLAND: World Health Organization Chief Tedros Adhanom Ghebreyesus on Wednesday hailed the United States' support for a global waiver on patent protections for Covid-19 vaccines, describing it as a "historic decision". The WHO chief wrote on Twit-

ter that the move was a step towards vaccine equity, "prioritizing the well-being of all people everywhere at a critical time".

"Now let's all move together swiftly, in solidarity, building on the ingenuity and commitment of

scientists who produced life-saving Covid-19 vaccines," he added.

Tedros has for months pleaded for such a patent waiver - an idea backed by India and South Africa - arguing this would help to ramp up production and make Covid-19 vaccines much more accessible for poorer nations.

"If not now, when?" has become a frequent refrain from the WHO chief, who has lashed out repeatedly against perceived vaccinehoarding by richer nations.

Tedros clashed repeatedly with former US president Donald

Trump, who began withdrawing his country from the WHO before President Joe Biden immediately rescinded the move upon taking office in January.

A later tweet from the WHO chief on Tuesday appeared to confirm that things had got off to a better start with Biden.

"This is a monumental moment in the fight against #COVID19," he said of US support for the patent waiver, describing Biden's commitment as "a powerful example of leadership to address global health challenges". - NDTV

SWEDISH TWINS SEPARATED BY

 $\underline{\textbf{SWEDEN,NORWAY:}}$ They haven't been allowed to have each other over to their homes for a year now because of COVID. So come rain or shine, two 73-year-old Swedish twins have met every Saturday, each on their side of the border, on a bridge that links Norway and Sweden.

Every week, Ola and Pontus Berglund each keeps well behind a thin, yet impassable line on the ground, toting camping chairs, thermoses, sandwiches -- and plenty of

"We're not allowed to cross the border. I have to stay one metre (yard) away on my side and he has to stay back one metre on his side," Ola explains, the little Norwegian and Swedish flags they've attached to the bridge fluttering

"So basically there has to be two metres between us," he says, pushing his chair back, suddenly aware that he is too close. At his feet, painted on the road, is a simple white line, the words "Norge" and "Sverige" on either side. The pandemic has put a halt to the identical twins' weekly visits to each other's homes.

Ola lives in Halden, in southeastern Norway, where he moved almost 40 years ago for love, while Pontus lives a half-hour drive away in the southwestern Swedish town of Stromstad. Instead, they come together here, at a more or less respectful distance, on the old Svinesund bridge that straddles a fjord between the two countries.

They've celebrated their 72nd and 73rd birthdays this way on April 20.

"It's very strange but it's become a need, a pressing need, because we used to see each other every week and we wanted to continue that," says Pontus from the Swedish side. "The pandemic hasn't stopped us from seeing each other and for us, that's a victory."

While the local restrictions have changed over the months as the virus situation has evolved, the border has remained closed. - FRANCE 24

"third wave" on the continent. "The tragedy in India does not have to happen here in Africa, but we must all be on the highest possible alert," said regional WHO Director Matshidiso Moeti. "While we call for vaccine equi ty, Africa must also knuckle down

> and make the best of what we have. We must get all the doses we have into people's arms."

Some African countries had been exemplary in deploying vaccines, the WHO said, without naming them.

But it added that in spite of this, only just under "half of the 37 million doses received in Africa have been administered so far".

Africa now accounts for only one percent of vaccine doses administered globally, the WHO said -- down from two percent a few weeks ago, as other regions' rollouts are progressing much faster.

The first vaccines deliveries to 41 African countries under the Covax scheme began in March but nine countries have so far administered only a quarter of the doses received, while 15 countries have used less than half of their allocations.

The vaccination rate in Africa is the world's lowest. Globally an average of 150 vaccine doses per 1,000 people have been administered, but in sub-Saharan Africa it is hardly eight doses per 1,000, according to the WHO.

WTO CALLS FOR AGREEMENT FOR FAIR ACCESS TO **COVID JABS**



World Trade Organisation Director-General Ngozi Okonjo-Iweala

SWITZERLAND: The World Trade Organization chief called Wednesday for international agreement on how to ensure more equal access to Covid-19 vaccines, amid an ongoing standoff over a proposed patent waiver for the jabs.

The way the WTO handles this matter is critical," Ngozi Okonjo-Iweala told country representatives taking part a meeting of the WTO general council, the organisation's main decision-making body.

"We need to have a sense of urgency on how approach this issue of response to COVID-19 because the world is watching," she said, describing equitable access to the tools to fight the pandemic as the "moral and economic issue of our time".

The global trade body has for months been facing calls led by India and South Africa to temporarily remove the intellectual property protections on Covid-19 vaccines, in a move proponents say would help boost production in developing countries that so far have received far fewer jabs.

But that notion has until now met fierce opposition from pharmaceutical giants and their host countries, which insist the patents are not the main roadblocks to scaling up production, and warn the move could hamper innovation.

Okonjo-Iweala, who became the first woman and first African to take the helm of the WTO on March 1, has not taken a position on whether the waiver is the way forward, but has insisted that countries need to agree on a common path that will help resolve the issue of inequal access to the vaccines.

"Vaccine policy is economic policy because the global economic recovery cannot be sustained unless we find a way to get equitable access to vaccines, therapeutics, and diagnostics," she said.

While the positions on waiving patent rights remain divided, WTO spokesman Keith Rockwell told reporters that Wednesday's discussions on the proposal had been "very constructive".

"All parties have the same objective, which is to ramp up production and improve the efficiency and the equity of the distribution process," he said, adding that all of more than 40 country representatives who spoke during the meeting agreed "that not enough vaccines are getting to the developing world." - FRANCE 24

FORMER MALDIVES PRESIDENT RECOVERING AFTER 'ASSASSINATION ATTEMPT'

THE MALDIVES: Former Maldives President and current Parliamentary Speaker Mohamed Nasheed was recovering in hospital Friday after an assassination attempt left him with shrapnel wounds.

The Indian Ocean archipelago's first democratically elected leader was hurt when a device attached to a motorcycle was detonated as he got into a car late Thursday, an official said.

"Nasheed escaped an assassination attempt," a Maldivian government official told AFP. "He is injured, but his condition is stable."

Images on social media showed a destroyed motorbike at the scene of the attack.

Armed Police Units and security forces cordoned off the area in the capital Male where the attack took place, and the Maldivian parliament, which was in recess, called an emergency meeting following the attack. President Ibrahim Mohamed Solih, a close ally of Nasheed, said an investigation was under way as officials rushed to denounce the targeted attack on the country's second most powerful figure.

"Strongly condemn the attack on Speaker of Parliament, President Mohamed Nasheed this evening. Cowardly attacks like these have no place in our society," Foreign Minister Abdulla Shahid said in a tweet.

"My thoughts and prayers are with President Nasheed and others injured in this attack, as well as their families," he tweeted.

A family member said Nasheed had sustained several wounds.

'They have put him under anaesthesia. There is a deeper cut on one of his arms," the family member told AFP, speaking on condition of anonymity.

The relative said Nasheed was respon-

sive and spoke with doctors as he was admitted with shrapnel injuries. One of his bodyguards was also taken to hospital. Nasheed rose to become the Maldives' first democratically elected leader in 2008 in the country's first multi-party elections after 30 years of autocratic

But the pro-democracy pioneer is maybe best known internationally for holding a 2009 underwater cabinet meeting to highlight the threat of global warming, signing documents as officials wore scuba gear against a backdrop of coral reefs.

"What we are trying to make people realise is that the Maldives is a frontline state. This is not merely an issue for the Maldives but for the world," he said at the time.


He resigned three years later after protests against his rule and has failed to reclaim the presidency despite several attempts. Instead, he secured the position of parliamentary Speaker in 2019, retaining his influence in political life.


