BY virtue of the powers vested in me by section 36 of the Land Acquisition Act, No. 9 of 1950, as amended by Land Acquisition (Amendment) Act, No. 39 of 1954, I, Charles Percival de Silva, Minister of Lands and Land Development, do hereby direct the Government Agent, Assistant Government Agent or other officer authorized in that behalf by such Government Agent or Assistant Government Agent and referred to in column I of the Schedule hereto, to take possession of the land specified in the corresponding entry in column II of that Schedule.

11 allotments of land called Katugastota Estate, depicted as lots 126, 127, 128, 129, 130, 131, 132, 133, 134, 135 and a portion of lot 136 in P. P. A 1,248, totalling in extent approximately 9A. 2R. 22.8P., situated in Pallegammedde Village, Village Headman's Division of Kahalla, D. R. O's Division of Pata Dumbara, Kandy District; and bounded as follows:—

North by road, the land called Ambagahawela Kumbura claimed by B. P. Percy Perera and V. G. Rankirie and Pusella Oya;

East by Pusella Oya and the land called Edandakotuwa claimed by Rev. P. Pagnananda;

South by the land called Edandakotuwa claimed by Mrs. P. B. Wijesinghe, and the remaining portion of lot 136 in P. P. A 1,248 claimed by M. Arnolis Singho;

West by the lands called Sri Dalada Pirivena Viharewatta, Henagederawatta claimed by B. K. Mudiyanse and others, Otanapitiyewatta claimed by Mrs. P. B. Wijesinghe and others, and Pallepitiyehena claimed by Mrs. Ratnayake and others;

exclusive of the V. C. road running through the land.
