SUBSIDIARY FOODSTUFFS. DRY CHILLIES

THE CONTROL OF PRICES ACT, No. 29 OF 1950

Order

BY virtue of the powers vested in me by Section 4, read with Section 3 (2) of the Control of Prices Act, No. 29 of 1950, I, Wilfred Francis Ferdinando, Assistant Controller of Prices (Food), Kalutara District, do by this Order—

- (i) revoke with effect from this date my Food Price Order No. KL 51 dated November 3, 1958, published in the *Ceylon Government Gazette Extraordinary* No. 11,576 of November 5, 1958, in so far as it relates to the wholesale dealer's maximum wholesale price and the retail dealer's maximum retail price mentioned in columns 2 and 3 respectively, of the Schedule thereto of Dry Chillies mentioned in Column 1 of that Schedule ;
- (ii) fix with immediate effect the prices specified in Columns 2 and 3 of the Schedule hereto to be a wholesale dealer's maximum wholesale price per hundredweight gross, a retail dealer's maximum retail price per pound nett to a consumer, respectively, above which the articles specified in the corresponding entry in Column 1 of the Schedule shall not be sold within the limits of the Kalutara District ;
- (iii) direct that paragraphs (iii) to (viii) of the Food Price Order No. KL 47 of August 19, 1958, relating to the Subsidiary Foodstuffs published in *Ceylon Government Gazette Extraordinary* No. 11,480 of August 23, 1958, shall apply in the case of Dry Chillies mentioned in Column 1 of the Schedule hereto as though those paragraphs were incorporated in this Order.
