 - (d) The lessee shall, within one year from the date of the lease and in accordance with plan previously approved in writing by the Anuradhapura Preservation Board, erect and complete a building or buildings thereon to be used as motor repair garage;
 - (e) The lessee shall not sub-let, mortgage, donate or otherwise dispose of or deal with his interest in the lease without the prior written consent of the Chairman and General Manager on the lessor's behalf;
 - (f) The lessee shall pay all rent and taxes and other assessments in respect of the land and any buildings erected thereon;
 - (g) At the expiration or earlier termination of the lease the lessee shall yield up and surrender to the Chairman and General Manager or any officer duly authorised by him quiet possession of the land and building thereon in good condition (due allowance being made for fair wear and tarn): and tear);
 - (h) No compensation shall be payable by the Crown for any building on the land on any other account whatsoever.
