ABSTRACTS OF SEASON REPORTS FOR THE MONTH OF NOVEMBER, 1897.

NORTHERN PROVINCE.

MULLAITTIVU DISTRICT.

Weather: there was little rain during the month. The days were very hot, and heavy dew fell at night. The wind blew from the north-east.

Crops: the paddy plants are dying for want of water. Rain is very much needed throughout the district. Preparations for tobacco cultivation are going on.

General health: not satisfactory. Fever has been prevalent.

Murrain broke out among cattle at Panikkankulam, but soon died out.

Prices of articles of food: paddy, Re. 162½ per bushel; rice, Rs. 350 per bushel; kurakkan, Re. 125 per bushel; varaku, Re. 1 per bushel; ellu, Rs. 350 per bushel; kuluntu, Rs. 350 per bushel; payaru, Rs. 350 per bushel; manioc, 3 cents per lb.; palmirah roots, 25 cents per 100.
