#### The Award

This is an award made under section 17 of the Industrial Disputes Act, Chapter 131, of the Legislative Enactments, Ceylon, (Revised Edition) as amended by the Industrial Disputes (Amendment) Acts, Nos. 14 and 62 of 1957. It deals with an Industrial Dispute that had arisen between the Lanka Estate. Workers Union (hereinafter referred to as the "Union") and the Management of Pillagoda Valley Estate, Baddegama (hereinafter referred to as "the Management").

The Honourable Acting Minister of Labour and Nationalised Services by his order dated 2nd October, 1961, made under section 4 (1) of the aforesaid Act, has referred this dispute to me for settlement by arbitration.

- 2. According to the statement of the Acting Commissioner of Labour dated 21st September, 1961, and attached to the order of the Honourable Acting Minister, the matter in dispute between the aforesaid parties is whether the non-employment of U. L. Peiris Appu by the Superintendent of Pillagoda Valley Estate, Baddegama, is justified and to what relief he is entitled.
- 3. At the inquiry before me Mr. Neil de Alwis, Assistant Treasurer of the Union appeared for the Union and Mr. Advocate A. S. Wijewardena, instructed by Messrs. F. J. & G. de Saram appeared for the management. Hearings were held on the 27th and 28th November, 1961; January 15th, February 26th, 27th and 28th, 1962,

4. The case for the Union is that U. L. Peiris Appu was a rubber tapper on Pillagoda on daily wage and worked on the estate for a period of 38 years since 1912. On 20.5.60 at about 12.30 p.m. Peiris Appu brought latex and scrap to the factory. 12.80 p.m. Peiris Appu brought latex and scrap to the factory. He strained the latex and sorted the scrap rubber before the weighing. Hendrick Kangany, under whom he worked, found fault with his sorting of scrap rubber and complained to the Rubber Maker, Suppiah about the bad sorting by Peiris Appu. Suppiah thereupon came up to Peiris Appu and pulled the tapping knife from his waist and asked for the bucket. Peiris pointed out his bucket which was near the door way of the factory. Suppiah then told the kangany under whom Peiris Appu worked that no more work should be given to Peiris Appu from the next day. Peiris Appu then went home, brought the estate tapping knife and delivered it to Suppiah and asked Suppiah to return the knife which he took from his waist as it belonged to him. Suppiah returned his knife to him. Later that day, at about 4 p.m., he met the Assistant Superintendent of the estate and complained to him about the unhappy treatment he received about 4 p.m., he met the Assistant Superintendent of the estate and complained to him about the unhappy treatment he received from the Rubber Maker, Suppiah. The Assistant Superintendent without making inquiries into his complaint told him to find employment elsewhere as he could not give him work on this estate. Peiris Appu thereafter made his complaint to the Union. In its statement the Union avered that "U. L. Peiris Appu was discontinued from servise without any known adequate reason whatsoever or being called upon to show cause for any alleged offence on his part. . Peiris was dismissed from service without notice and the Assistant Commissioner of Labour, Galle, to whom this dispute was referred was not able to assist him in this matter because of the attitude adopted by the management. 'Peiris Appu's position is that he is now too old to work on the estate and that he be given a gratuity for his long period of service.

5. The case for the management is that the entire story of Peiris Appu is a fabrication. What really happened on 20.5.60 was that when Peiris Appu brought the latex and scrap rubber to the factory he was asked to sort out the scrap by Hendrick Kangany. Thereupon Peiris Appu flew into a temper and refused to do any sorting. He was extremely insolent, insubordinate and rude to the kangany in charge, field kangany and the rubber maker who were functioning in the factory at this time. Later when the Assistant Superintendent tried to inquire into this matter Peiris Appu was equally insolent to him and time. Later when the Assistant Superintendent tried to inquire into this matter Peiris Appu was equally insolent to him and behaved in an unseemly manner and refused to attend the inquiry. His attitude was to snap the fingers at the management, throw in his hands and walk away. The position of the management is that Peiris Appu voluntarily terminated his services; When the management offered work to him he deliberately refused it. Peiris did not work in the estate for 38 years. The estate records show that he did some work in 1942 and thereafter fairly regularly from 1949 to 1960. The management is still willing to give Peiris Appu work in the tea section of the estate as he could still work and that he is not as old as he tries to make out. The question of a gratuity therefore does not arise.

- 6. When the cases for the Union and the management were closed on February 28, 1962, the 6th day of hearing, I suggested to the parties that this is a case which should be settled in the interests of both employer and employee. The parties accepted my suggestion and arrived at/the following settlement:—
  - (i) U. L. Peiris Appu apologises to the Superintendent of Pillagoda Valley Estate for the incident of 20th May, 1960, and withdraws all the allegations made on his behalf by the Union in its statement. He thanks the Superintendent for his offer of work on the estate but owing to his present state of ill-health he is unable to accept the offer of work.
  - (ii) The Superintendent agrees to pay U. L. Peiris Appu an ex gratia payment of Rs. 300 on account of his past services on the estate. Payment shall be made through the Assistant Commissioner, Galle, within one month of the date of publication of this award.
- 7. I consider the above terms of settlement fair and reasonable and make award accordingly.

This is an award under section 17 of the Industrial Disputes Act, Chapter 181 of the Legislative Enactments, Ceylon (Revised Edition), as amended by the Industrial Disputes (Amendment) Acts, Nos. 14 and 62 of 1967, and it relates to in Industrial Dispute between The Ceylon Estate Staffs' Union, 'Estaff House', 13, Kande Vidiya, Kandy (hereinafter referred to as 'the Union'), and Tillyrie Estates Company, Limited, Lloyd's Building, Prince Street, Fort, Colombo 1 (hereinafter referred to as 'the management').

2. The Honourable the Minister of Labour and Nationalised Services has, by his Order dated 13th March, 1961, made under section 4 (1) of the aforesaid Act, referred the said dispute to me for settlement by arbitration.

According to the statement dated 31st January, 1961, made by the Deputy Commissioner of Labour and annexed to the Honourable Minister's Order referred to above the matter in dispute between the said parties is—

Whether the non-employment of J. E. Peter (clerk) is justified, and to what relief he is éntitled."

Mr. Advocate G. H. Gnanasekharam instructed by Mr. F. Rajapaksa, Proctor, and Mr. Advocate W. T. P. Goonetilleke instructed by Mr. D. F. J. Perera, Proctor, appeared for the Union and the Management respectively on all the dates of

After counsel for the parties had addressed me on their respective cases at the commencement of the enquiry, the possibility of a settlement was explored, but it resulted in a failure and the enquiry was proceeded with.

3. Glencorse and Penrith are two estates owned and managed by the Tillyrie Estates Co., Ltd. Glencorse is of an extent of 432 acres cultivated with rubber, and Penrith is 1580 acres in bearing rubber and 300 acres in tea.

Mr. H. S. Wijekulasuriya is the present Superintendent of both these estates. When he took charge of Glencorse in June 1957, there was a rubber maker-clerk who attended to the clerical work and the manufacture of rubber assisted by one Madasamy, who was the factory K. P.

In about the month of Cctober, 1958, the rubber maker-clerk, having left the clerical work of Glencorse, was transferred to Penrith to be done by Penrith staff, and Madasamy, the factory K. P. was placed in charge of the manufacture of rubber.

These measures which appear to have been carried out with a view to economy were a failure. The clerical work, especially the accounts, relating to Glencorse fell badly into arrears, and as was to be found at a later stage the quality of the rubber too deteriorated.

4. The Management thereupon decided to appoint a separate clerk at Glencorse, but allowed Madasamy to continue with the rubber-making. Applications were called for, and Mr. Peter was selected from among several candidates and appointed to the post on 15th May, 1959.

The appointment was on probation for a period of three months, but unfortunately no letter of appointment was given to him at the time setting out the terms of his employment. Mr. Peter had been out of employment then and perhaps owing to his anxiety to secure the post, he too had contributed to this lapse on the part of the management by accepting the offer without such a letter. If not for this omission, the occasion for these lengthy and protracted proceedings might, perhaps, not have arisen.

5. About three weeks after the probationary period of three months had expired, namely, on 7th September, 1959, Mr. Peter wrote to the Superintendent letter A 12 asking for the letter of appointment and also requesting him "to consider his class and grade for the job".

On 9th September, 1959, the Superintendent sent letter A. 13 confirming his appointment as from 1st September, 1959, on the class 4 grade, 12 salary of Rs. 80 per mensem as set out in Annexure A to the Collective Agreement No. 1 of 1958. He also reserved the right of the management to "dispense" with Mr. Peter's services at any time on giving him a month's notice or on payment of one month's salary in lieu of notice.

6. Mr. Peter appears to have promptly taken up the question of his salary with the Union for, on 11th September, 1959, the Union wrote to the Superintendent letter A. 2 pointing out that according to the Collective Agreement Mr. Peter should have been placed in class 4 grade 10, and not in class 4 grade 12 as has been done. The Superintendent replied by letter dated 15th September, 1959 (A. 3), that Mr. Peter was placed in class 4 grade 12 as that was the salary agreed upon at the time of his appointment, meaning thereby 15th May, 1959. Mr. Peter too, by his letter dated 18th September, 1959 (A. 14), acknowledged with thanks the letter of appointment A. 13 and stated that he "would be glad to receive the prescribed salary according to the Collective Agreement".

There is no reference in any of these letters written by Mr. Peter or the Union to the condition relating to the termination of Mr. Peter's services on one month's notice being given.

Thereafter the Union took the matter up with the Assistant Commissioner of Labour, Avissawella, who after having held an inquiry, informed the Union that he had requested the Superintendent to place Mr. Peter in class 4 grade 10 of the Collective Agreement, and pay him accordingly. The Superintendent was not satisfied with the Assistant Commissioner of Labourer's interpretation of the Collective Agreement, and refused to comply.

- 7. The correspondence on the subject between the Union and the Superintendent appears to have ceased by the 5th of January, 1960, although according to letter A. 11 written on 9th February, 1960, by the Assistant Commissioner of Labour to the Union an officer of the Labour Department appears to have discussed the matter with the Superintendent on 8th February, 1960. The final communication as between the Union and the Department of Labour is letter dated 11th February, 1960, (A. 16) by which the Union referred the dispute to the Commissioner of Labour for decision under section 10A of the Industrial Disputes Act. Although no action, however, could be taken by the Commissioner of Labour under this section as the management was not a party to the Collective Agreement, a reference of the dispute to an Industrial Court appears to have been under contemplation (A. 8). At this stage the Superintendent by letter dated 29th July, 1960, (A. 19) informed Mr. Peter that the management had, in view of the adverse reports of the Visiting Agent and the brokers on the quality of rubber manufactured at Glencourse decided to appoint a rubber maker-clerk and gave notice of the termination of his services as from 31st August, 1960. He also stated that Mr. Peter may apply for the post if he considered himself competent to perform the functions of a rubber maker-clerk efficiently. Mr. Peter applied for the post but failed to secure the appointment, as he was found by the management to have no knowledge of the "elementary principles of the manufacture of crepe rubber", and finally the management by letter dated 30th August, 1960, (A. 25) confirmed the notice given on 29th July, 1960.
- 8. Now, relying on these facts, the Union alleges that Mr. Peter has been victimised for, it says, the decision to appoint a rubber maker-clerk was a subtle method adopted by the management to get rid of Mr. Peter because he had raised a dispute regarding his salary.

If anything at all, the Union has succeeded in proving that Mr. Peter had been asked to leave whilst a dispute was pending. But to my mind the mere fact that a dispute was pending at the time is totally insufficient to establish that Mr. Peter's services have been terminated for that and no other reason.

The Management, on the other hand, contends that Mr. Peter's services were terminated in the exercise of a contractual right reserved in the contract of employment (A. 13) and that he had not been dismissed.

9. On a consideration of his conduct after he was confirmed in the post and the evidence given by him on the point I have come to the conclusion that Mr. Peter accepted the post subject to the conditions that his services were terminable on one month's notice and that the Management therefore had the right to terminate his services as it did.

Although he promtly protested against the salary scale in which he was placed Mr. Peter did not even make a passing reference in his letters to the condition relating to the termination of his services which was as important as, if not more important than, the question of his salary. His explanation that he did not do so as similar conditions are generally to be found in letters of appointment and because he could always have disputed it when the occasion arose is an explanation that does not bear examination.

The occasion did arise when he received the notice A. 19. Rather than disputing it he fell in line with the proposal to appoint a rubber maker-clerk and applied for the post knowing fully well that he had no experience in the manufacture of crepe rubber. Even after he had failed to get this appointment and received letter dated 30th August, 1960 (A. 25), Mr. Peter wrote letter dated 1st September, 1960, (R. 2) to the Superintendent requesting him to pay the balance salary for August with the "santosam" which had been promised, and offering to render any assistance to the new clerk, if required. This letter clearly shows that even at this stage the idea of victimisation had not occurred to him.

This certainly is not the conduct of a man who accepted the appointment in the belief that he had the right to dispute it if the Management relied on that condition and terminated his services.

The real reason why Mr. Peter was silent on this point appears to be nothing but a correct appreciation of the significance of the condition that had been imposed. On receiving the letter of appointment, two courses were open to him. He had either to accept it or reject it. He decided to accept it and fight for a higher salary in which he thought he was on safe ground.

Apart from other considerations, it would not be fair by the Management to allow Mr. Peter to say that he accepted the post subject to a mental reservation for, the Management might have made other arrangements if Mr. Peter refused to accept the post on this condition.

10. The Management goes further and says that even this right that it had reserved in the appointment was not exercised by it without good reasons. It says that the decision to appoint a rubber maker-clerk was taken on the advice of the Visiting Agent in view of the poor quality of Glencorse rubber.

The Visiting Agent's report (R. 8) and the broker's reports ("X") have been produced. In his report the Visiting Agent state that he does not think the rubber maker has any "great knowledge" of crepe manufacture, and suggests that a "rubber maker with good experience be employed even in a temporary capacity to look after Penrith and Glencorse, for even with a small crop like Glencorse's 1 cent difference in the average price makes a difference of Rs. 2,000."

Mr. Peter was given an opportunity for applying for the post, but from his own evidence it is clear that he had no knowledge of the manufacture of crepe rubber. It cannot be said that his application was rejected without good and sufficient reason.

I am unable to accept the suggestion that the decision to appoint a rubber maker-clerk was part of a scheme to get rid of Mr. Peter.

11. The Union also questioned why Madasamy, the K. P., who was responsible for the inferior rubber at Glencorse has not been removed. Madasamy is only a factory K. P. whose function normally is to work under the direction of a rubber maker, Madasamy's removal would not solve the problem for, even if he is removed, another K. P. would have to be appointed to take his place.

In the course of his address Mr. Gnanasekharam invited my attention to section 40 of the Industrial Disputes Act. He says that Mr. Peter's services have been terminated in violation of the provisions of this section, but he has not referred me to the sub-section or the paragraph of that section on which he relies. I am unable to find what the provision is that Mr. Gnanasekharam had in mind.

For these reasons I hold that Mr. Peter has not been victimised, but that his services have been terminated by the Management in the exercise of the contractual right reserved in his appointment and accepted by him.

The non-employment of Mr. Peter is therefore justified.

- 12. The dispute regarding Mr. Peter's salary is not a matter that has been referred to me for settlement by the Deputy Commissioner of Labour. No application was made to me by the Union in the course of these proceedings to include this question as a matter in dispute in terms of section 36 (5) of the Industrial Disputes Act. But in the course of his address Mr. Gnanasekharam referred me to section 23 of the above Act, and invited me to make an award with regard to Mr. Peter's salary as well.
- Mr. Goonetilleke objected to this application as the procedure laid down in section 36 (5) had not been complied with, but I find that in the statement filed under regulation 21 (1) the Union has "requested that the Arbitrator be pleased to order the aforesaid Tillyrie Estates Company, Limited, to reinstate Mr. J. F. E. Peter and pay the correct salary as per Collective Agreement, etc."

Section 16 of the Act (which is the relevant section) empowers an Arbitrator "to admit, consider and decide any other matter which is shown to his satisfaction to have been a matter in dispute between the parties prior to the date of the aforesaid Order, provided such matter arises out of, or is connected with a matter specified in the statement prepared by the Commissioner."

Mr. Peter's salary has been a matter in dispute between the parties prior to the date of the Honourable the Minister's Order, referred to above, and is a matter connected with the non-employment of Mr. Peter referred to in the statement prepared by the Deputy Commissioner of Labour.

The question of Mr. Peter's salary has been fully argued by the parties and no prejudice has been caused to the Management by reason of the fact that the matter had not been formally raised as an issue.

I therefore decide to consider the evidence and the submissions made by counsel and make an award on this dispute in the exercise of powers vested in me under section 16 of the said Act.

13. The Union complains that Mr. Peter has been placed in class 4 grade 12 of the salary scale set out in the said Collective Agreement, whereas he should have been placed in class 4 grade 13 and paid the salary appropriate to that class and grade. It is conceded that this Estate has been brought within the scope of the Collective Agreement, referred to above the Collective Agreement referred to above.

The Management contends that Mr. Peter had agreed to accept the salary paid to him when he was employed on 15th May, 1959, and that it was one of the reasons for selecting him in preference to any other candidate.

Apart from the letters written by the Superintendent himself, there is no independent evidence to support him that Mr. Peter agreed to accept the post on a class 4 grade 12 salary whilst Mr. Peter's conduct and the correspondence prior to and after the confirmation of his appointment stands out in strong contrast to the attitude he adopted with regard to the conditions relating to the termination of his services.

relating to the termination of his services.

It is true that he has accepted a salary of Rs. 80 plus allowances per mensem during the probationary period without protest. His explanation is that the Superintendent promised to place him in the correct class and grade later and pay him all arrears that may be due. In the very first letter he wrote to the Superintendent (A. 12), Mr. Peter has requested the Superintendent to consider "his class and grade for the job." I am inclined to believe Mr. Peter on the point, and I hold that Mr. Peter has not agreed to accept a salary in class 4 grade 12 for the post.

14. The Management further contends that it has satisfied the requirements of the Collective Agreement in placing Mr. Peter in class 4 and that grading is a matter within its discretion. There is no dispute with regard to the class in which Mr. Peter has been placed. The question for decision therefore is whether the Management has complied with the provisions of paragraph 3 (b) in the Schedule to the Collective Agreement. 14. The Management further contends that it has satisfied

Paragraph 3 (b) referred to above provides that-

- "Each employer shall allocate his employees to grades within their respective classes in accordance with the grouping set out in Annexure A. In making such allocations employers shall pay due regard to—
- (i) the acreage of the Estate and the yield per acre, and (ii) the nature and extent of the duties and responsibilities of the employees. "
- 15. The extent of Glencorse is 432 acres fully cultivated with rubber. The Management argued that only the tappable area has to be taken into account. The language of the relevant paragraph is clear. I am unable to agree with the Management on this point.

According to Mr. Ranasinghe, the Labour Officer, the yield per acre is 595 lbs. According to the Visiting Agent's report (R. 8) the yield per acre during the season prior to June, 1960, was 606 lbs. and the estimated yield for the following season was 702 lbs. per acre. The yield may not be very high, but it cannot be said that it is below the average.

The duties discharged by Mr. Peter have been of a rather onerous nature. In addition to the normal duties of his office such as keeping accounts, preparing Employees' Provident Fund Returns, Food Control Returns, Rubber Control Returns, typing, etc., he had cleared up all the arrears in the accounts that had accumulated during a period of one year (A. 34). Correspondence of a general nature had been attended to at Penrith; but if that had not been done an assistant clerk would have had to be employed had to be employed.

16. Mr. Gnanamuttu, Assistant Commissioner of Labour, and Mr. Ranasinghe, Labour Officer, who have investigated this matter, and the practice obtaining in comparable estates in the district are of opinion that Mr. Peter should be placed in class 4 grade 10.

Mr. Jayamanne, Secretary of the Ceylon Estate Employers Federation, who has given evidence, supports this view.

It appears that for practical purposes and with a view to attaining some degree of uniformity, the Ceylon Estate Employers' Federation and certain other employers have adopted a slab system, whereby 201 to 300 acres is allotted to grade 12; 301 to 400 acres to grade 11; 401 to 500 acres to grade 10, etc., in the salary scale.

Mr. Peter has been placed in the lowest grade in class 4. It is manifestly unjust that a clerk employed in a 400 to 500 acre estate should be paid the same salary as is paid to a clerk on a 200 to 300 acre estate.

17. I am satisfied that the Management has failed to allocate Mr. Peter to a grade as contemplated by the provisions of paragraph 3 (b) in the Schedule to the Collective Agreement, and hold that he should have been placed in class 4 grade 10 of the said salary scale and paid the salary due to him in that grade.

Mr. Peter is not a new entrant and he is entitled to be paid that salary as from the 15th of May, 1959.

I therefore order the Management to pay to Mr. Peter the difference between the salary that has already been paid to him and the salary he is entitled to in class 4 grade 10 of the salary scale referred to above as from 15th May, 1959, up to 31st August, 1960, such payment to be made through the Assistant Commissioner of Labour, Avissawella, within 14 days of the publication of this award in the Ceylon Government Gazette.
