Provided further that in the case of monthly contributions or instalments on account of loans or advances or interest thereon, payable by a member of the corporation who is absent on leave from Ceylon, such member shall be allowed to retain his membership during his absence on leave without payment of the same, for a period of not more than one year, if all arrears are paid within one month after his return."

2. Under section 7 of the same Ordinance, I proclaim that no movement of cattle or cart traffic from and to this area shall be allowed, until this proclamation is revoked.

The attention of all cattle owners and carters in the area, is drawn to the Contagious Diseases (Animals) Regulations, 1937, which lays down the actions which persons are by law required to take in an "INFECTED AREA". Details of these Regulations can be obtained from the Government Veterinary Surgeon, Ambalangoda, and the Divisional Revenue Officer, Bentota Walallawita West.
