NOTICE is hereby given that the Government Agent, of the Colombo District (hereinafter referred to as the Government Agent, which expression shall include any officer duly authorised by the said Government Agent for the purpose of this sale) will, on the 29th day of June, 1962, at 10.30 a.m., sell by public auction at the spot, the right to take the produce of about 1260 rubber trees standing on the Crown land known as Atherfield Estate, which was acquired for the construction of the New Hospital, Avissawella, and described in the Schedule hereto, for a term of one year commencing from the 1st day of July, 1962.

2. Prospective bidders may inspect the trees, if they so desire, between the 15th and the 29th June, 1962, after obtaining permission from the P. W. D. authorities who are in charge of the premises.

3. The bidding will be on the rental. The upset rent will be Rs. 1,000. The bid below the upset rent will not be accepted. No bid shall be final until it has been approved by the Government Agent himself, if an officer other than the Government Agent conducts the sale.

4. The Government Agent, may, before accepting any bid, satisfy himself to the bona fide of the person making it and his ability to comply with the conditions of the lease. If he is not so satisfied, the Government Agent, may refuse to accept such bid and continue the sale as if no such bid had been made.

5. Every bidder shall be present in person or by a duly accredited agent at the sale. Agents should produce their letters of authority to the Government Agent for scrutiny before the commencement of the sale.

6. The successful bidder shall pay 1/5th of his bid immediately after his bid has been accepted by the officer conducting the sale, and the balance 4/5th immediately after he has been informed that his bid has been approved by the Government Agent. In the event of the successful bidder failing to pay 1/5th of his bid immediately after the sale or the balance as required above, the Government Agent shall be entitled to cancel the sale and confiscate any monies paid by such bidder.

7. The successful bidder shall, if so required by the Government Agent, deposit by way of security, such sum as may be fixed by the Government Agent. Provided that sum at all not exceed 10 per cent. of the total amount of his bid. The Government Agent shall be entitled in his discretion to confiscate such sum or any part thereof in case of any violation of the conditions of the lease. Any portion of this sum which has not been confiscated will be returned to the successful bidder on the termination or expiry of the lease.

8. The successful bidder shall be entitled to be placed in possession of the land only on payment of the full amount of his bid. He will thereafter be issued a licence which will contain the following conditions amongst others :—

- (a) The licence shall be terminable at any time by the Government Agent on one calendar month's notice in writing being served on the licensee, personally or by post under registered cover addressed to him/her to his/her last known address or affixed in a conspicuous position on the land;
- (b) The licence shall be personal to the holder thereof;
- (c) The licensee shall not sublet, assign, mortgage, or otherwise dispose of or deal with his interest under the licence;
- (d) The licensee or his/her workmen shall not fell or in any way damage or cause to be felled or damaged any trees growing on the land except with the consent of the Government Agent previously obtained in writing;
- (e) The licensee shall keep the land free from scrub jungle and in good order to the satisfaction of the Government Agent;
- (f) Neither the licensee nor his/her workmen shall enter the land except with the permission of the P. W. D. authorities in charge of the land or otherwise than in accordance with the conditions on which such permission is granted;
- (g) Neither the licensee nor his/her workmen shall make any use of the soil of the land except with the written permission from the Government Agent;
- (h) The licensee shall not construct or allow to be constructed any shed or other building or structure on the land except with the prior written permission from the Government Agent;
- (i) The licensee shall not allow any cattle to be brought on or trespass on the land;
- (j) The licensee shall not slaughter-tap the rubber trees on the land;
- (k) The Government Agent or the P. W. D. authorities in charge of the land shall be entitled to fell any trees on the land or resume possession of the whole or any part of the land. In that event, the licensee shall be entitled to a rebate prorata and for a proportionate reduction of the rent. The decision of the Government Agent as to any rebate or proportionate reduction of the rent shall be final;
- (l) The Government Agent or any officer duly authorised by him shall be entitled to enter and inspect the land at any time;
- (m) The licensee shall pay all rates and taxes, assessment and other outgoings in respect of the land;
- (n) Any breach of any of the terms and conditions of the licence shall render the licence liable to cancellation on the orders of the Government Agent;
- (o) The licensee shall not have or make any claim for compensation for improvements effected or expenses incurred or for damages or compensation on any other account whatsoever;

- (p) On the expiry or earlier termination of the licence, the licensee shall deliver quiet possession of the land to the Government Agent or to any officer duly authorised by the Government Agent for that purpose;
