PART I: SECTION (I)—GENERAL

Government Notifications

THE CONTROL OF PRICES ACT, No. 29 OF 1950.

Order under Section 4

BY virtue of the powers vested in me by section 4 of the Control of Prices Act, No. 29 of 1950, I, Victor Lloyd Wirasinha, Controller of Prices (Miscellaneous Articles), do hereby order as follows :—

- (1) This Order may be cited as the Control of Prices (Imported Sarongs) Order, 1958.
- (2) This Order shall apply to the whole of Ceylon.
- (3) The price specified in each entry in column II of the Schedule hereto shall be the maximum retail price above which any imported sarong of the description set out in the corresponding entry in column I of that Schedule shall not be sold.
- (4) Every trader who has any imported sarongs in his possession or under his control at any place shall exhibit conspicuously at that place a notice in which there shall be set out the maximum retail price for such sarong fixed by this Order.
- (5) Every person who sells any imported sarong shall give the purchaser a receipt in which there shall be set out—
 - (a) the date of the sale ;
 - (b) the number of sarongs sold ; and
 - (c) the price paid for the number of sarongs sold.
- (6) Every person carrying on business as an importer of, or a wholesale or retail trader in imported sarongs shall furnish to me, not later than 12 noon on January 3, 1959, a return specifying—
 - (a) the stocks of sarongs in his possession or under his control at the time the return is made ; and
 - (b) each store or other place at which such stocks are kept.
- (7) For the purposes of this Order, a " double " sarong means a sarong having a minimum width of 29 inches and a minimum length of four yards, and a " single " sarong means a sarong having a minimum width of 50 inches and a minimum length of 2 yards.
- (8) In the preceding paragraphs of this Order " sarong " means a sarong of any description set out in the Schedule to this Order.
