- (k) Any breach of any of the terms and conditions of the licence shall render the licensee liable to cancellation of the order of the Government Agent;
- The licensee shall not have or make any claim for compensation for improvements effected or expenses incurred or for damages or compensation on any other account whatsoever;
- (m) On the expiry or earlier termination of the licence the licensee shall deliver quiet possession of the land to the Government Agent or to any officer duly authorised by the Government Agent for the purpose;
- (n) The licensee shall not have any claim to preferential sale of lease of the land by reason of this licence.
- 7. Any further information regarding the sale may be obtained from the Government Agent, Kegalla District, Kegalla.
