## THE LAND ACQUISITION ACT, (CHAPTER 460)

#### Declaration under Section 5

I, Charles Percival de Silva, Minister of Agriculture, Land, Irrigation and Power, hereby declare, under subsection (1) of section 5 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 39 of 1954, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act:
