# Increased compensation for victims of attacks by wild animals: Dr.Pathirana

The Wild Life and **Forest Conservation** Act of 1980, is to be amended to increase Compensation Payments for dying and completely or partially disabled persons, house and property damages due to attacks by Protected animals


The cabinet has decided to increase compensation paid to family members of those killed or severely maimed by wild animals and elephants, Cabinet spokesman, Plantation Minister Dr. Ramesh Pathirana said.

According to the cabinet memo submitted by Wild Life and Forest Conservation Minister and approved by the cabinet on Monday, the Wild Life and Forest Conservation Act

of 1980, would be amended to increase Compensation Payments for dying and completely or partially disabled persons, house and property damages due to attacks by Protected animals like Elephants, Leopards, Bears, Wild Buffalo and Crocodiles.

Under the newly introduced amendments, compensation payment of Rs.500,000 paid up to now for a loss of life to Rs.1 million despite the gender or age limit.

that in total 43 suspects had been arrested as of Monday (August 2) including the arrest of a 42-year-old building contractor from Kalutara and an owner of a mobile shop in Moratuwa.

The Police are continuing investigating the case following the arrest of a 35-year old man on June 7. The investigation was initiated based on the revelations made by the 15-year-old victim and her mother who is also one of the suspects, and the main suspect, police said.

Since June 7 this year, Police have arrested several suspects including the Deputy Chairman of the Mihintale Pradeshiya Sabha, former State Minister of Maldives, gem merchants, a cardiologist from the Sri Lanka Navy Hospital, a Police officer, hotel managers and a former manager of a bank.

They were produced before the Court from time to time over allegedly sexually abusing the victim. Also, several website owners were arrested on charges of aiding and abetting the crime, by advertising to sell the girl for sexual

SDIG Rohana said investigations into the case is still ongoing and investigation officers will take further action to arrest all those who are involved in the case following the outcome of the investigations.

Police said that the investigation has been expanded to analyze all the phone records, websites, bank records, CCTV and other information that have been uncovered.

Police said that the case is still being heard in courts and on several occasions, the Attorney General had appointed several State Counsels, including an Additional Solicitor General to advise on the need to expedite investigations and to file evidence properly.

# **FEATURE** ONE OF MANY LEGAL FRAMEWORKS EXPLAINED

The digital world plays an important role in our lives today. Intellectual Property law is one of many legal frameworks that help us navigate this world by securing our rights.

Law is Light is a series of trilingual legal discussions to shed light on the law. The Latin maxim "ignorantia legis neminem excusat" translates to ignorance of the law is not an excuse. The Pro Bono Committee of the Law Students' Association of Sri Lanka strives to educate the general public by simplifying the laws in our country. In the third discussion, the programme focused on 'Intellectual Property' to provide an understanding of the rights available for property created by the intellect.

The discussion featured Attorneysat-Law practicing in the field of Intellectual PropertyLaw: Mr. Thishya Weragoda is an independent legal counsel at Neelakandan & Neelakandan, a visiting lecturer at the Institute for the Development of Commercial Law and Practice and Ms. Aparajitha Ariyadasa is a visiting lecturer in Cyber Law at the University of Plymouth and at IJTS. She is also a senior consultant at Ceylon Chamber of Commerce and senior counsel, Chairperson of Lanka Intellectual Property Organisation.

#### What is intellectual property?

The concept of property concerns ownership and possession. Property can be tangible – what we can see, touch and feel and the intangible - value created by assets which cannot be seen. The name Coca Cola is a well-known product in the world. The value is not in the bottle but the brand loyalty. The brand name is an intangible asset. Photographs are intellectual creations and any monetization made out of it belongs to the photographer. The law recognises five different classes of intellectual property:

- CopyrightTrademark
- Patents
- Industrial designs
- Confidential information and trade secrets

Intellectual Property law protects literary, artistic and scientific work. People can benefit from what they create. Intellectual property splits into two categories; one is associated with trade such as industrial plans, scientific plans, patents, brand names and brand logos (industrial property). The other is intellectual properties with the right to publication such as literary works, artistic and scientific works, folklores, computer programmes, architectural plans, and maps. There are also related rights; these entail rights of actors, rights of broadcasters, rights of sound engineers.

#### What is the importance of Intellectual Property law?

This law helps protect new creations by providing economic rights to the inventors and the consumers by ensuring genuine products are bought.

#### Can you elaborate on the 5 different classes of Intellectual Property?

**Copyright** – The creations of the mind which are literal creations, artistic creations or scientific creations will be copyrightable creations. S.5 and S.6 of the Intellectual



Property Act recognizes the copyrightable works. The S.9 of the Act states the creator of the works hold on to economic rights. These economic rights can be sold to another individual. Copyrights will end after lifetime plus a 70 year period and the matter falls into public domain.

**Trademarks** – Logos can be registered as a trademark if it has value. Whether a mark is registered or unregistered, there are rights attached to it. As long as you pay on for the registration of the mark to the registrar's office, the trademark will be recognised. When a registration expires, it does not mean there are no rights associated. Unregistered marks will also have protection. That particular mark cannot be used without authorization. There is a trade mark registry at the National Intellectual Property office where vou can look for any conflicting or similar mark

**Patents** – this concerns new inventions. There needs to be novelty and be able to solve problems. Once a patent is registered, they get a 20 year period and after such period expires, it falls into public domain

Industrial design — the rights and

requirements are slightly less than for a patent **Geographic indicators** — like the basmati rice or the Champagne comes from a particular region. Someone who makes tea from Kenya can't say it's Sri Lankan tea. A person who makes sparkling wine in Australia cannot say

this is Champagne.

Confidential information and Trade secrets - The recipe for Coca Cola is unknown and a well-kept trade secret. The people involved in the manufacturing are bound to protect that secret.

#### If a person wants to register his own creation or invention, what is the procedure?

There are 2 methods of protection. The less stringent is the 'industrial design' scheme and the other is the most strenuous 'patent' scheme. They are two different regimes and the requirements are different. The Intellectual Property Act Chapter 3 covers Industrial designs. It is required to establish some form of novelty and a use in it. The registration is done at the National Intellectual Property office. There are 2 types of applications, one for industrial design and one for patents, decide which one applies to you. For patents, state your claim and give a full disclosure

#### Does a person require the assistance of an Attorney or can he do it on his own?

Services of a patent drafter is necessary for the application of a patent. In Sri Lanka, they are Attorneys- at- law but if you look at countries like Singapore, US and UK, they are patent drafters.

#### Is plagiarism when in written work, covered by IP law?

This is considered as an ethical right. Where there is a substantial amount of information copied and amounts to unfair competition, it may amount to an infringement of IP laws. It may amount to a theft when the original writer is not mentioned.

When it comes to music, we see different versions of an old song. How can upcoming musicians create their own version of the song, in doing so will they be infringing another's rights?

Reproducing a song will fall within the restrictions of economic rights of S.9 in the IP Act. The permission

#### When it comes to designer items, could you explain the A-grade category and how it affects IP rights?

The A- grade or B- grade bags are not always replicas, they can be originals which were rejected by the original owner. These end up in the market. An original product can come to the market through unrecognised channels, this is called grey market imports. This cannot be stopped due to it being an original product, unless there is an exclusive territorial agreement with

> A counterfeit product might look identical but it is not an original. Counterfeits are illegal.

On instagram we see people selling replicas of branded items in Sri Lanka. Can replicas be sold at the price of the original item? Does a consumer who buys a replica at the original price have

If there is a local agent, it can be reported.

#### **Does infringing Intellectual Property** law amount to criminal liability?

A violation of IP can lead to a civil and criminal liability. Example – if someone copies the song X created and makes money out of selling it, X can go to the Magistrate's Court for an Order to destroy these CDs and obtain an injunction order.

#### What are the remedies available for an infringement of IP law?

First check whether rights have been infringed. Next file a criminal and civil action. The person who infringed your rights can be arrested. An injunction order be obtained or seek damages.

If someone uses a copyrighted picture without attributing rights to the owner, what legal action can be

According to Copyright law, by virtue of creation, irrespective of artistic merit, it is protected. The moment a photograph is taken, it is protected.

#### If a self-portrait is used without that person's permission, can that individual take any action under IP law?

If the photograph was taken on behalf of the individual by the photographer, the individual would be the owner of the copyrights. The element of privacy ensures your profile picture cannot be taken for an advertisement. The permission of the individual in the picture is required.

#### Can an individual repaint an ancient piece of art work, say the portrait of Mona Lisa, and profit out of it?

Mona Lisa is Da Vinci's creation. The copyright protection lifespan has expired due to the demise of the painter 500 years ago. The painting is part of the public domain, therefore considering

drawing it will not be a problem.

Copyrights will be active for new paintings.

## Does IP protection have a time limit?

#### **EVICTION OF PALESTINIANS** -ETHNIC CLEANSING BY OTHER MEANS

he UN-created problem in Palestine -the arbitrary setting up of the state of Israel- on Palestinian land continues to fester to this day, with continued evictions of Palestinians and seizure of their homes and lands.

Approximately 750,000 Palestinians were displaced and became refugees as a result of the 1948 war, in the lead up to the founding of Israel. None of these displaced persons were ever allowed to return to the homes or communities from which they were displaced. The Palestinian refugee population has continued to grow ever since.

Today there are more than seven million Palestinian refugees -being, those Palestinians who fled, were expelled, or forced from their homes in the area of historic Palestine or who have been refused re-entry to their homes and now live scattered around the world. More than 5.6 million of these people are registered with UNRWA as refugees since 2019.

The continued Israeli expulsion of Palestinians based on their ethnicity and/or religion brings to mind 'Polenaktion' (Polish Action) carried out by Hitler and his fellow Nazis against Polish Jews and refers to the arrest and expulsion of about 17,000 Polish Jews living in Nazi Ĝermany in October 1938. These deportations, displaced thousands of Polish Jews along the German-Polish border.

It raises the question as to how a people who went through the horrors inflicted on their forefathers under Hitler's genocidal campaigns, can today coldbloodedly perpetrate those self-same strategies against another set of human beings based on differences of religion and ethnicity.

Even today Palestinians continue being expelled from their homes by Israeli occupation forces, and the Palestinian refugee issue is at the heart of the Palestinian-Israeli conflict.

On August 2, Israel's Supreme Court adjourned an appeal of four Palestinian families against their forced expulsion from the Sheikh Jarrah - a Palestinian neighbourhood in Israeli-occupied East Jerusalem, close to the Old City and its holy sites. The case involves Palestinians who face losing their homes in a part of Jerusalem they have lived in for decades.

Israel considers Jerusalem its capital, while to Palestinians East Jerusalem is the capital of the Palestinian state. The Israeli claim is not recognised by the UN nor is it part of the UN partition plan through which the State of Israel was founded.

After the 1948-49 Arab-Israeli war, Jerusalem, where Arabs and Jewish people had lived side by side, was divided between the state of Israel and the Kingdom of Jordan.

Jewish people were displaced from eastern Jerusalem and Palestinians from the western half of the city. In the aftermath of the war, the UN helped resettle displaced Palestinians in Sheikh Jarrah

War broke out again in June 1967 and, Israel occupied East Jerusalem and applied its own laws. In 1970, it introduced a law to process the competing ownership claims in places such as Sheikh Jarrah. Palestinians, however, have no power to recover property they lost in West Jerusalem, or elsewhere in Israel


In Sheikh Jarrah Israel is attempting to evict Palestinians and hand the lands to Israeli settlers. In the conflict which arose in May this year over Israel's attempt to evict Palestinians from their homes, 138 Palestinians died. Over 1,800 housing units were demolished in Israel's airstrikes, while over 16,800 or more housing units were partially damaged. More than 120,000 Palestinians were displaced from their homes, while 66 schools were also damaged in Israeli bombardments.

The question that arises, is what makes the one-time victims of genocide, change into a nation hell-bent on ethnically cleansing and perpetrating actions described as 'crimes of war' against a long-suffering population, who had had been living in the region prior to the establishment of the newer state?

For too long the world watched the illegal actions of the State of Israel against the Palestinians. Faced with Israel's continued transgressions and in the aftermath of the recent actions -fighting in Gaza- of which Sheikh Jarrah is part of, the United Nations' top human rights body voted on May 27 to appoint a Commission of Inquiry with unusually broad latitude to investigate possible war crimes and other abuses committed in Israel and the occupied Palestinian territories.

The Commission is not limited to looking just at hostilities in Gaza and the West Bank, but instead has been charged with examining "all underlying root causes of recurrent tensions, instability and protraction of conflict, including systematic discrimination and repression based on national, ethnic, racial or religious identity."

Perhaps this latest action of the world body may help bring an end to the ethnic cleansing of the people of Palestine in their own lands by the people who suffered genocidal campaigns under Hitler's Nazi campaigns.

# ADDRESSING THE CORE ISSUE OF "TRUST DEFICIT" IN INDO-LANKA RELATIONS

High Commissioner-designate Milinda Moragoda presents concept paper to the President

Sri Lankan High Commissioner-designate to India, Milinda Moragoda, has communicated to President Moragoda argues. Gotabaya Rajapaksa, that frequent, multifarious and systematized interactions with India from the top-most

India-Sri Lanka relationship of "distrust", which has plagued it for decades. Moragoda, who is to take up his assignment in New Delhi later this month, said in his concept paper entitled: "Integrated Country Strategy: For Sri Lanka Diplomatic Missions in India," that lack of trust has made the relationship "transactional" (meaning a relationship based on bargaining, and therefore, lacking in warmth and a natural flow). Disturbingly, the transactional character has grown in

recent times due to certain geo-political

changes (presumably the growing China-

factor in Sri Lanka). However, this need not be so, says Moragoda. Given the millennia of multifarious and unbroken interactions between Sri Lanka and India, the relationship ought to be a "special one" marked by "inter-dependence, mutual respect and affection." But such a makeover can only comewith increased, all round, frequent and structured interactions from the top-most level to the bottom,

he submits. Though there has been an improvement in the matter of top-level visits from India since Narendra Modi became Prime Minister in 2014 and declared his "Neighborhood First" policy, Sri Lankans have for long been bemoaning the lack of interest in the top Indian leadership in visiting Sri Lanka. To address this, Moragoda suggests annual visits by the Head of State/Head of Government. There should also be frequent visits by the Foreign Ministers. Line ministers too should make visits, if not physically, virtually. The India-Lanka Parliamentary Friendship Group should be re-activated with mutual visits encouraged.

Sri Lankan missions should engage Indian State governments which are of particular importance to Sri Lanka. Lankan Provincial Councils and local bodies should also be encouraged to interact with their equivalents in India while adhering to protocols. Chief Ministers of Indian States should be invited to visit Sri Lanka. People-to-people interaction should be encouraged by improving connectivity. Ferry services between Colombo and Tuticorin; Thalaimannar and Rameshwaram; and KKS and Karaikal should be launched/ re-launched.

#### **RELIGIOUS BASE**

India-Lanka relations rest on a sound foundation of the shared legacy of Buddhism "India's most precious gift to Sri Lanka." And

Buddhism was brought to Sri Lanka by the son and daughter of the Buddhist King Dharmashoka. "Against this backdrop, any setbacks to our relationship, however intractable they may appear to be at any given point of time, can only be temporary,"

Sri Lankan Missions should facilitate Indian scholars' study of Buddhism in Sri Lanka and Sri Lankans should be able to study Pali and Buddhism in India. Sri Lanka should be able to provide Ordination for Indian Buddhist monks and allocate places for them in its Pirivenas.

With the help of Ambassador Dr.V. K. Valsan, the document has identified areas of cooperation in Hinduism too. The promotion of the Ramayana Trail, the Murugan Trail and the Siva Sakthi Trail will increase religious tourism between the Hindus of Sri Lanka and India. Sri Lanka has officially sent a sacred stone from the Sita temple here to the Rama Temple in Ayodhya. The document urges the government to provide opportunities for Indian Hindu religious leaders and scholars to interact with their counterparts in Sri Lanka. And Sri Lankan diplomatic missions should actively participate in major Hindu religious ceremonies in India. The Lankan government should also facilitate Catholic devotees and scholars to visit the Velankanni church in Tamil Nadu, the document said.

#### INVESTMENTS

To attract Indian investments to Sri Lanka, Moragoda has set up an Inter-Agency Committee on Trade, Investment and Tourism. The Lankan missions in India should draw up a list of high net-worth investors, hold meetings with them and organize seminars and field trips to Sri Lanka.

The Board of Investment has set out targets for an Indian investment of US\$ 300 million in 2021, and the Lankan Mission in India has set a goal of US\$ 256 million. Indian investments could be in auto parts, electric and electronic goods, the hospitality industry, IT services, infrastructure, manufacturing, pharmaceutical, textiles and renewable energy. The documents have urged follow-up action in existing Indian projects.

Sri Lanka's access to Indian markets is hampered by protectionism and also 'challenging and changing regulatory mechanisms." Lankan Missions should interact with Indian governments to secure easier access to Lankan products. On its part, Sri Lanka should increase items in its export basket. The Export Development Board has set atarget of US\$ 621.9million for 2021 and the Lankan missions in India have proposed a target of US\$ 674.17 million for 2022. The products Sri Lanka could sell in India are: pepper, cloves, cinnamon, nutmeg, vegan and vegetarian food, processed meat and fish, confectionary and beverages, paper desiccated coconut and related products, tiles and kitchenware, electrical conductors, switch boards and panels, various kinds of tea, men's trousers, shirt and skirts. Sri Lanka should seek help from India in the field of technology innovation, capacity building and product development. Lankan trade associations and trade associations should participate in Indian trade fairs and invite Indian businessmen to Sri Lanka.

#### **TOURISM**

There is immense potential in the Indian tourism sector. The Lankan Tourism Board has set a target of 63, 733 Indian arrivals in 2021 and 169, 955 in 2022. The areas which show potential are: MICE, weddings, film shooting, and the Ramayana, Murugan and Siva Sakthi Trails. Sri Lanka needs to be present in tourism fairs in India. Fully vaccinated Indian tourists should be encouraged to visit Sri Lanka.

The document also propagates the facilitation of grid connectivity between the two countries for Sri Lanka to get power from India in times of drought and Lanka to sell power to India in case it has a surplus.

#### **DEFENCE COOPERATION**

The document points out that Sri Lanka has not used the Indian Special Line of Credit of US\$ 50 million for countering terrorism. Ways of using it should be explored, especially since more Lines of Credit in the defence sector are in the pipeline. The document points out the importance of having "political level strategic cooperation in the field of defence and security." This could be built on the model of the war-time Indo-Lankan "Troika" of top functionaries from both Sri Lanka and India, which was very useful.

There should be India-Lanka and multilateral military exercises every year. Facilities in Sri Lanka should be created for training Indian military personnel. There should be closer and regular interaction between the police forces of the two countries with places in Indian paramilitary and police institutions for Sri Lankan personnel. The office of the Defence Advisor in the Sri Lanka High Commission ought to be strengthened.

#### **FISHING ISSUE**

The Sri Lankan governmentis working out a proposal on the touchy fishing issue in the Palk Strait. The Moragoda document advocates a "humane approach" to the "genuine problems faced by fishermen on both sides of the maritime boundary."It also calls for joint research in fisheries and marine resources and cooperation to set up a mechanism for disaster management.


Stressing the need to bring back Sri Lankan displaced persons from Tamil Nadu (they have been denied Indian citizenship), the document suggests that Colombo announce a comprehensive package for their return, including customs duty waivers, settling-in expenses, housing, and economic rehabilitation.

Vitaly Shishov, 26, headed the Belarusian House in Ukraine, an NGO helping his compatriots flee repression in Belarus.

Belarus strongman Alexander Lukashenko has been cracking down on any form of dissent since mass protests erupted after last year's elections, deemed unfair by the West.

Many Belarusians have fled, often to neighbouring Ukraine, Poland and Lithuania.

"Belarusian citizen Vitaly Shishov, who had gone missing in Kiev yesterday, was today found hanged in one of the Kiev parks, not far from where he

lived," police said in a statement.

Police said they had opened a murder probe and would pursue all leads including a possible "murder disguised as a suicide".

The Belarusian House in Ukraine accused the Lukashenko regime of being behind the murder of Shishov.

The activist went jogging in Kiev

on Monday morning but did not return and could not be reached on his mobile phone.

Shishov moved to pro-Western Ukraine in the autumn of 2020, and helped establish the Belarusian House in Ükraine.




#### Blinken vows 'collective response' to tanker attack

US, (RT.COM), 2 AUGUST - US Secretary of State Antony Blinken has promised there will be a "collective response" to the attack on the Israeli-operated tanker off Oman, which Washington blames on Tehran, as Iran vowed a response of its own to any threat.



## POINT OF VIEW



A non-communicable disease (NCD) is a disease that is not transmissible directly from one person to another. These are the result of a combination of genetic, physiological, environmental and behavioral factors.

NCDs are also known as chronic diseases with long duration and said to kill 41 million people each year, equivalent to 71% of all deaths globally. 85% of these "premature" deaths occur in low- and middleincome countries. NCDs include Diabetes mellitus (DM), Hypertension (HT), Parkinson's disease, Strokes, Heart diseases, Cancers, Chronic Kidney Diseases (CKD) and others. Treatment modalities take a long time to cure these diseases and some of them are not curable.


Therefore an important way to control NCDs is to focus on reducing the risk factors associated with these diseases. Other than the medicines, mental status, behavioral and food patterns are also important in controlling and preventing from Non-Communicable Diseases.

Diabetes mellitus is one of the main NCDs which gives major long-term implications for individuals suffering from the disease as well as the healthcare system as a whole. This disease is characterized by elevated blood glucose levels higher than the normal reference ranges. Diabetes mellitus has 2 types as Type 1 and Type 2 Diabetes. Type 1 or the Insulin dependent Diabetes/Juvenile Diabetes is a genetic disease and Type 2 Diabetes is mainly caused due to sedentary life style and bad food patterns. Diabetic neuropathy, Diabetic nephropathy, Diabetic retinopathy are few major complications of this chronic noncommunicable disease. Resistance to Insulin hormone which helps in balancing the blood glucose level is the main cause for this disease. Signs and symptoms are increased urination, increased thirst, increased hunger, weight loss, blurred vision, excessive sleepiness. This chronic disease is diagnosed by analyzing signs, symptoms, clinical examination of the patient along with FBS, PPBS, RBS, HbA1C to check blood sugar level.

Ayurveda is one of the oldest holistic healing systems in world. Ayurveda means the "knowledge" or "the science of life". Ayurveda connects physical, spiritual and mental processes to promote a healthy relationship between the mind, body, and soul. The primary goal of Ayurveda is to maintain healthiness by being free from diseases and providing treatment modalities for the diseased. Each living being has a tendency toward disequilibrium of certain doshas structurally or physiologically and such imbalances may lead to disease.

According to Ayurveda disease that causes excessive urination is known as Pramēha ["mēhathi mūthrayathi ithyārtha:"]. There are 20 Pramēha rōgās mentioned in Ayurveda. Pramēha roga that is present for a long time without treatment can transform in to the disease stage called Madhumeha. Disease where the sweetness is present in urine and body fluids like sweat, mucus is known as Madhumeha and this can be correlated with Diabetes mellitus. Madhumeha is caused by intake of kapha vitiating food like curd, jaggery, river fish, excessive intake of cow's milk and inappropriate behaviors like physical inactivity, excessive sleep. According to Ayurveda this is one of the diseases that cannot be completely cured.

Unwholesome food in inappropriate

to diseases or can aggravate already present disease conditions. Food which is essential for the sustenance of life can become a cause for some diseases if used in an improper way such as excess usage, mal usage and reduced usage. Ayurveda has given supreme importance to food we take and food is known as the best medicine (Mahaa bhesaja) among all the other medications. A balanced diet mentioned in Ayurveda has 10 components such as Šhashtika, Shāli, Amla, Saindhva.

For the control and prevention of Madhumeha (Type - 2 Diabetes) healthy food patterns are important. According to modern medicine, they have mentioned about the importance of consuming food articles with low glycemic index for the control of Type Diabetes Intake of starchy for is bad for the patients with Diabetes. As Sri Lankans Rice is the main food we take for most of our main meals. Raktha shāli (Red/Brown rice) is the best type of rice that is mentioned in Shūka category (corns with bristles) of 12 food types mentioned in Ayurveda. Traditional rice varieties like Suwadal, Kalu hēnati, Rathu hēnati, Kuruluthuda also have low glycemic index and helps in reducing blood glucose levels. According to Ayurveda, pulses are collectively known as Shami dhānya. Whole grains like green gram (Phaseolus radiata), Kavupi (Vigna unguiculate), Black gram (Vigna mungo) [Undu / Māsha] and lentils like Dhal/Parippu (Lens culinaris) are also effective in supplying energy to body with reduced glycemic index.

Fruits and vegetables are low in fat, salt, sugar and they are a good source of dietary fibers. These contain many vitamins like vitamin A (beta-carotene), C, E, minerals such as Mg, Zn, P and folic acid which are good for health. Intake of fruits and vegetables can reduce the risk of Type 2 Diabetes mellitus and other NCDs like Hypertension, Heart disease, Cancers

Karavila / Bitter gourd (Mormodica charantia) is a cuisine commonly used in South-East Asian countries and consumed by cooking in the green or early yellowing stage.

Thembu (Costus speciosus) is a rhizomatous herb and leaves are properties by stimulating  $\beta$ -cells in the pancreatic islets to release insulin, increasing the quantity of insulin receptors and fighting against free radicals by behaving as antioxidants and thereby, decreasing cell damage. Kowakka (Coccinia grandis) is a perennial climber with single tendrils and glabrous leaves. This is claimed

is said to be having anti-diabetic

to be helpful in regulating blood sugar levels. Some researches support that compounds in this plant inhibit glucose-6-phosphatase, which is one of the key liver enzymes involved in regulating sugar metabolism. Green beans/Bonchi (Phaseolus vulgaris) is a vegetable with many dietary fibers with low calories and contain no saturated fat. Dambala /Winged bean (Psophocarpus tetragonolobus) is rich not only with protein, but in tocopherols (antioxidants that facilitate vitamin A utilization in the body). Pathōla/Snake gourd (Trichosanthes cucumerina) is mentioned in Ayurveda as a vegetable with laghu guna (lightness) that helps in giving strength and energy. This is a vegetable with low carbohydrates similar to Wetakolu/Ridged gourd (Luffa acutangular). Both these vegetables help in increasing Insulin level and helps in maintaining blood glucose level in balanced state.

Amla/ Nelli (Phyllanthus emblica) is a fruit with many nutritional ingredients mentioned in Triphala in Ayurveda. Triphala is included in many drug recipes. Star fruit/ Kaamarankaa (Averrhoa carambola) contains various essential nutrients including fiber, potassium, vitamin C, vitamin B5, folate and a small amount of protein. This fruit is also low in calories which supports weight loss. Lime (Citrus aurentifolia) is an acidic fruit with Vitamin C. This is rich with antioxidants such as flavonoids as well. Limes have a low glycemic index and help to regulate the way your body absorbs sugar into the bloodstream and helps in controlling blood sugar levels. Yellow vine/ Wenivelgata (Coscinium fenestratum) is a herbal drug which is used by Sri Lankans for curing body aches and pains very frequently. This is with bitter, astringent taste and light

(laghu), rough (ruksha) properties. Turmeric/ Kaha (Curcuma longa) which is used in cooking is said to be having many medicinal benefits including immune enhancing properties and strengthening the overall energy of the body. This culinary spice has digestive properties and used as a coloring agent as well. Turmeric which is known as Haridrā or Nishā is one of the commonly used medicinal drugs used in Ayurveda drug recipes prescribed for treating Madhumeha.

Ayurveda Dina charyā (daily routine) has highlighted the importance of proper exercises such as yōga to maintain healthy life. Vyāyāma (Exercises/ activities that need physical effort) like walking, running, swimming (against the water flow) has been specially mentioned for Madhumeha patients in Ayurveda. Other than these awakening in morning (Brahma muhurtha), adequate sleep at night, avoiding day sleep, sufficient intake of water, avoid alcohol usage, meditation, spiritual and mental relaxing activities are also advisable to maintain a healthy life style. By following healthy behavioral patterns and adding these important food varieties with health benefits will be helpful in preventing and controlling from this dangerous noncommunicable disease.

OVID-19 has changed our lives introducing "new norms" at least for the next decade. During good old days, when we went to school and mingled with friends has now become a dream for our children. They are confined to their studies and to a computer or phone screen.

Even with such a demand, the drawbacks for manufacturing vaccines are common to the countries with the presence of political instability, poor infrastructure, dubious regulatory frameworks thus prevent new investments in the ir

However, around the globe, several production plants have been manufacturing vaccines for decades. Most of these production plants still use immunological strategies that were developed decades ago. During the nineteenth century, scientists from United States, Great Britain, France, and Germany developed strategies for inactivating a whole bacterium and developed inactivated whole-cell vaccines against plague, typhoid, and cholera. Therefore, it is helpful to contemplate the past for having a great deal of forwarding gazing with new potential vaccine production strategies. For instance, the first influenza vaccine using attenuated virus was developed in 1936, while mRNA and viral-vectorbased vaccine have been developed in more modern plants faster than ever before, as is the case of the latest COVID-19 vaccines.

Given the global scenario that the production of vaccines in smaller countries are limited. Some of the central / South American and Caribbean countries have extremely small markets, hence the production of biological medicines is not worth.

The United States of America, Canada, Brazil and Mexico are considered the top vaccine manufacturers and have the infrastructure for biological manufacturing.

Some Latin American countries are among the Top 20 ranked vaccine manufacturers with self-sufficiency up to about 72% in vaccine production.

#### RAPID GROWTH

Nevertheless, over the past few decades, the world has experienced rapid growth in developing new vaccines, including recent novel coronavirus (COVID-19) vaccine. It has added more than 200 new

Pharmaceutical packing is also a unique part of the pharma industry which involves lots of expertise and technology and large investments. Specialised equipments are needed to process the filling while sensitive testing methodologies are adopted to maintain stability and quality of the end product.

Hence, it's much more scientific and complex than what it's seems to be.





# India revive memories of past glories by reaching semis

Hockey's profile in India could they will contest the gold medal reach new heights after both the men's and women's teams ended decades in the doldrums by advancing into the semi-finals of the Tokyo Olympics.

Indian men once ruled the Olympic hockey tournament, winning six successive golds from 1928 to 1956. When they claimed the top prize for an eighth time at the 1980 Moscow Games, no one could have guessed that they would have been left in Olympic wilderness for the next four decades.

But with India's men taking on Belgium in yesterday's semi-final, while their female counterparts take on Argentina in the last four a day later, the sport appears to be enjoying resurgence in a country where every sport has to compete with cricket to get any eyeballs.

With the country on the verge of ending the long drought, men's captain Manpreet Singh, 29, said: "I wasn't even born when India were reaching the semi-finals.

"I think that we're creating history right now but still there are two more games to go." Since 1980, India's men's team have not placed higher than fifth at an Olympics and reached their nadir when they failed to qualify for the 2008 Beijing Games.

If the women's team beat Argentina, it will be the first time in his players. (Reuters)

match, with their previous best showing being a fourth-place finish in 1980. In fact, their appearance in Tokyo is only the third time they have made it into the Olympic field.

While hockey still enjoys a considerable fan base in India, its popularity has faded since the country has produced worldbeating teams in other sports, especially cricket.

However, the strong showing of both the men's and women's hockey teams have spiked interest in the world's second most populous nation, especially since success in other sports in Tokyo has largely failed to materialise -- with India winning just a silver and bronze so far at these Games.

'Yesterday the men's hockey team, today the women's hockey team... Absolutely loving it,' cricket great Sachin Tendulkar tweeted after the women produced a stunning 1-0 win over Australia in Monday's quarter-final. "Well done to the women's team for making it to the Olympics semi-finals for the first time ever! The whole nation is behind you!" Dutchman Sjoerd Marijne, the head coach of India's women's team, said he has tried to instil big dreams

Simone Biles stared down the debilitating "twisties" to bravely win Olympic bronze on Tuesday as Norway's Karsten Warholm lit up the Tokyo athletics competition with a stunning hurdles world record.

# Stokes will be given as long as he needs, says England captain Root

England captain Joe Root said Ben Stokes has the full support of his England team mates and should take all the time he wants after the all-rounder took an indefinite break from cricket last week to focus on his mental health.

Stokes, 29, withdrew from England's Test squad and will miss the five-match series against India, which begins today. "Ben has always put other people first, and now is an opportunity for him to put himself first... Cricket should be a secondary thought right now," Root told reporters on Monday.

"He has my full support...He should take as much time as he wants. For me, it's hard to see a friend like that. I'm just desperate for him to be okay, and I'll be there for him as much as I can be." Root added that while Stokes was a player like no other in world cricket and the heartbeat of this English side, his absence provides an opportunity for others to step up.

"In the past, the likes of Sam Curran and Chris Woakes have managed to come in Both had a great series against India (at home) last time. We have managed without Ben before and, hopefully, we can do that again." India were already without Shubman Gill, Washington Sundar and Avesh Khan for the series after the trio returned home with injuries before opener Mayank Agarwal was ruled out of the first test after being hit on the helmet during practice on Monday. For Sri Lanka's Mathilda Karlsson it was fine margins of the biggest stage that led to her elimination from the Equestrian Jumping Individual competition at the Equestrian Park in Tokyo yesterday.

In the flood-lit park, Karlsson and her horse Chopin VA had to navigate 14 obstacles on the event's course – 13 fences and a water jump, each obstacle depicting a piece of Japanese culture or bearing reference to the Olympic Games – with penalties for added time taken and the failure or refusal to clear jumps.

For Karlsson, it was the latter that ended her campaign early, even before she could complete her run, with her Stallion twice refusing to jump over obstacles which, in this sport, incurs automatic elimination for both rider and horse.

The Stallion cleared the first five obstacles, if not unconvincingly at least cleanly, but pulled out on approaching the sixth obstacle, depicting Goldfish, or Kingyo in Japanese, with the significance being that they are said to have been rare and strange pets to the aristocracy in the 16th century.

Despite having got the horse around to make the jump on the second attempt, and leading the horse over the seventh obstacle, the equine's refusal to leap over the eighth obstacle, a water jump with pictograms of the sports in the Olympic Games, meant that her run was over. Karlsson said that she was at blame for the mistakes that led to the horse's refusals, adding that she had expected more out of her debut at the Olympics. "For sure, we are very disappointed at this time. I just came out of the ring, and I was expecting much more. For me, I have one of the best horses in this competition. In this kind of big event, you're not allowed to make any mistakes, and it was definitely my mistake to put too much leg into the triple bar, before the [first refusal]. Because he went so high and he lost his balance, and I know that happens when you put too much leg. You get a little in the moment and you want to do the best you can," she said after her event. That mistake effectively compromised her run, she said

"Âfter that there was five strides, I should have done six, but it's a millisecond where you can decide what to do and I went with the five, because that is what it should be. I was too far away and after something like that happens, it's just impossible to get going again," Karlsson added.


However, she said, that the experience in Tokyo 2020, would hold her in good stead moving forward. "The experience that we got, I know now so many things that I would have done differently, if I could have had another chance. But I definitely know now that I counted on the right horse, because jumping a track like this, you definitely need a horse like I have. It was just really unlucky, and I would say, maybe a little bit of a lack of experience as well which now we will have for the future. I would definitely do something different," Karlsson opined. For Karlsson, the journey to Tokyo has been wrought with challenges, from having to make a madcap effort to qualify for the Olympics, only to have her points invalidated making her ineligible to participate.

"Our road was a little different, because I was in the Olympics and then the points were taken back, and mentally that is kind of hard to cope with when you don't know if you're going to go or not. My horse never doubted it would go to the Olympics. It's a good thing he never knew. It's fantastic to be in the Olympics, this is something I will remember for the rest of my life," she added.













# Govt. does U-turn; to allow import of chemical fertiliser under licence regime

- Finance Minister issues new gazette with effect from July 31 allowing such imports
- Controller General of Imports and Exports instructs banks to facilitate such imports under ICL regime
- Customs has also been instructed to release imports of agrochemical items after ensuring importers are in possession of valid ICLs

urther relaxing the import restrictions initially imposed on agrochemicals, the Finance Ministry has allowed the importation of several previously banned chemical fertilisers under an import control licence (ICL) regime for plant nutrients, with effect from July 31, 2021, with the issuance of a fresh gazette notification.

"This department has brought chelated minerals and micro nutrients under the control of import licences for plant nutrients by Gazette Extraordinary No. 2238/45 dated July 31, 2021," Controller

General of Imports and Exports T.V.D. Damayanthi S. Karunarathne announced issuing a special notice.

According to the relevant gazette notification signed by Finance Minister Basil Rajapaksa on July 30, several nitrogenous, phosphatic, potassic mineral or chemical fertilisers as well as mineral or chemical fertilisers containing two or three of the fertilising elements are brought under the ICL regime, with effect from July 31.

Accordingly, Karunarathne issued instructions to the importers to obtain licences and banks to facilitate imports of chemical

fertilisers under the ICL regime.

The importers are required to submit applications of their requirements along the recommendation of the Director of the National Fertiliser Secretariat.

The Finance Ministry in an earlier gazette notification issued on May 6 allowed several chemical fertiliser elements and other agro-chemicals, including several insecticides, rodenticides, fungicides and herbicides, under the same ICL regime after imposing a blanket ban on agrochemicals previously.

## July food prices up 0.70%, indicates Advocata's 'Bath Curry Index' prices. The latest analysis

country continued to increase in July, according to Advocata's Bath Curry Indicator (BCI), which expanded by 0.70 percent from the previous month.

The BCI, established by Colombo-based policy think tank, tracks the monthly changes in food

indicates that the month of July witnessed an increase in the food prices compared to June. However, the change was below one percent.

For the month of July 2021, the prices of pumpkin showed the largest increase of 66.4 percent, whereas

minor increases were observed in the prices of Samba rice, beans, dhal and fish (balaya).

The changes witnessed in July 2021 is a year-onyear (YoY) increase of 45 percent when compared with the corresponding month of the previous year.

#### IMF US \$ 650bn reserves distribution clears last hurdle, takes effect on Aug. 23

International Monetary Fund (IMF) said on Monday its board of governors approved a US \$ 650 billion allocation of IMF Special Drawing Rights and said its largestever distribution of monetary reserves would become effective August 23.

The IMF member countries will receive SDRs -- the fund's unit of exchange backed by dollars, euros, yen, sterling and yuan -- in proportion with their existing quota shareholdings in the fund. Monday's approval by all 190 IMF member states was long expected.

'The SDR allocation will benefit all members, address the long-term global need for reserves, build confidence and foster the resilience and stability of the global economy," IMF Managing Director Kristalina Georgieva said in a statement.

"It will particularly help our most vulnerable countries struggling to cope with the impact of the COVID-19 crisis," she said, adding that about US \$ 275 billion of the allocation will go to emerging market and lowincome countries.



Georgieva said the IMF will continue to actively engage with members to identify viable options for rich countries that receive SDRs to channel them to poorer countries that need them more. A key option is for wealthier countries to contribute SDRs to the IMF's existin Poverty Reduction and Growth Trust for low-income countries. she said.

She added that the IMF was still considering a new trust for SDRs to facilitate sustainable growth in the medium term, indicating little change from discussions in July.





A. Baur & Co. (Pvt.) Ltd Managing Director/CEO Rolf Blaser in his welcome speech said, "We are proud to take a proactive stand on the organic fertiliser challenge. We established dialogue and started this initiative four months ago no sooner the country's announcement to ban chemical fertilisers and pesticides."

Together we will be visiting many sites and facilities in the coming days, including key officials, academics and professionals, to have an in-depth understanding of the system."

According to the International Federation of Organic Agriculture Movements (IFOAM), Sri Lanka currently has a 2.5 percent share of organic agriculture.

Prof. Dr. Christoph Studer, Professor of Natural Resources Management at HAFL, walked the audience through his presentation on the importance of having an agroecological approach. Prof. Studer highlighted the importance of soil fertility management, expressing that the objective is not only providing nutrients to crops but also nurture the soil to make it fit for its diverse tasks such as production and ecosystem services. He also stressed on organic matters, soil life, sustainable use of resources, diverse cropping patterns, nutrients, biofertilisers, among others.

Dr. Jacques G. Fuchs, Senior Scientist in Plant Pathology and Soil Quality at FiBL, shared insights on the basics of recycling organic residues, citing that everyone in Switzerland is individually involved with collecting and separating organic waste at home and that there is a wide range of waste categories. Dr. Fuchs also touched on improving soil fertility, numerous ways of composting practiced in Switzerland from farmers through to industrial plants, including systems for treating bio-waste, various waste that can be composted or treated by anaerobic fermentation, anaerobic degradation process, decomposition and maturation, entire cycle.

Dr. Fuchs shared the entire cycle of the process management from collection of green waste to utilisation of the final product, to include concept of organic waste collection, composting, anaerobic fermentation systems, mixture of raw materials, process management and storage of end products.

The event had an interactive Q&A session with all four members of the expert team, including Dr. Gurbir S. Bhullar, Senior Scientist in Tropical Agroecosystems at HAFL, Paul van den Berge, Senior Consultant at FiBL, followed by a vote thanks by A. Baur & Co. (Pvt.) Ltd Deputy Managing Director/Director Agriculture Janaka Gunasekera.

# Agri and livestock sector innovations virtual exhibition on Aug. 10

Thirteen universities, namely University of Ruhuna, Rajarata University, Wayamba University of Sri Lanka, Uva Wellassa, University of Peradeniya, Eastern University of Sri Lanka, South Eastern University, University of Colombo, Sabaragamuwa University, University of Moratuwa, Open University, Sri Jayewardenepura University and CINEC will present a wide range of innovative products to private sector companies through the virtual exhibition in August 2021.

Those who are interested in joining the virtual exhibition could visit https://chamber. Ik to register online. Participation is free of cost. The AHEAD is an operation under the Education Ministry, financed by the World Bank, where the objective is to develop the higher education sector in the country. One area of improvement was recognised as the research, development, innovation and commercialisation. Lack of connection between universities and private sector was identified as a major gap in the Sri Lankan higher education system in this regard. Intellectual property generated in universities should be of benefit to society and university research should fit to the requirements of the industries in order to reap benefits from research conducted at universities

As an initiative to address this gap, under Results area 3 of the AHEAD operation, University Business Linkage cells (UBLs) were established in all 15 state universities. These UBLs act as technology transfer offices and connect universities with outside parties to disseminates and commercialises research outcomes. The AHEAD also works with six non-state higher education institutions (HEIs) and contributed to establish Society Linkage cells (HEI-SL cells), which function similar to the UBLs.

These UBLs/HEI-SL cells now function as the central place, which links academics with the private sector. UBLS/HEI-SL Cells help university researchers to find suitable industry partners to commercialise the products/processes developed. Industries can also approach UBLs to get academic expertise to develop new products and processes. The final outcomes of all these commercialisation activities should bring win-win situations to both the university and the private party involved. The university can reinvest the revenue generated through commercialisation to further strengthen the research culture. Industries can save significant amounts of time, effort and money invested on R&D and to produce quality products to the local and international markets. These long-lasting and trustworthy connections eventually lead to the development of entire university system, the industries and ultimately the society.

The CCC joined hands with the AHEAD to support commercialisation of university research outcomes. The CCC was invited to the UBL/UGC standing committee meeting, which gathers every other month to address issues UBL/HEI-SL cells encounter and to make decisions required for the development of the UBL/HEI-SL cells.

## Pelwatte Dairy records 148% increase in profits before tax surmounting COVID challenges

Pelwatte Dairy, one of the leading dairy brands in Sri Lanka that locally produces a range of dairy products and saves foreign exchange for the country, has made a significant financial turnaround in 2020/21 recording a huge profits before tax (PBT) that year-on-year (YoY) surged by 148 percent.

The product line with the highest sale in 2020/21 was Pelwatte Full Cream Milk Powder, with a YoY growth of 76 percent. The product line with the second highest sale was butter, which showed a 42 percent YoY growth while the product line with the third highest sale was yoghurt,

Pelwatte Dairy, one of the indicating a 49 percent YoY eading dairy brands in Sri growth.

Other product lines too indicated a YoY growth rate exceeding 100 percent. Ghee oil, though was at the sixth place among the largest product lines of sale, showed the highest growth among all products in 2020/21, growing by tenfold (a 1070 percent YoY increase).

Seen from an operational point of view, the company strengthened its automation by introducing SAP, the Enterprise Resource Planning (ERP) solution, which boosted its operational efficiencies thus strengthening its bottom line in 2020/21.

Having set up in 2006, Pelwatte Dairy, which specialises in milk processing, animal feed and dairy products, is one of the Sri Lankan brands that successfully saves the outflow of foreign exchange for dairy product imports from abroad. # From battlefield to paddy field — A green revolution with ex-veterans



The Presidential Task Force for a Green Economy along with the Ranaviru Seva Authority that operates under the purview of the Defence Ministry has launched 'Ranabimen Govibimata – Sarupase Peraliya', a programme to empower the military community to produce organic fertilisers and related products.

Beneficiary communities of the Ranaviru Sena Authority, retired military personnel and their close relatives, have been encouraged to get involved in this programme to ensure a fertiliser-free national economy, as envisioned by the President's 'Vistas of

The process involves the contribution of ex-veterans, who served their motherland to further strengthen a fertiliser-free economic revolution. Following a message given by the President to the Agriculture Ministry, the Ranaviru Seva Authority made arrangements to extend its services to

the production of organic fertilisers and related products.

The project also aims to uplift the income status of ex-veterans, who have served their motherland by transforming them into small-scale entrepreneurs. Funds and facilities for the project will be provided by the National Enterprise Development Authority to empower beneficiary communities of the Ranaviru Seva Authority and engage in micro, small

and medium-scale enterprises.

Loan schemes are being provided by Bank of Ceylon and preparations have been made to execute the programme targeting the military community at district level, with the collaboration of the Agriculture Ministry, NEDA and Small Enterprise Development Unit. The pilot project of this programme was initiated at a farm producing organic fertilisers and related products operated by a disabled soldier in Hakmana, Matara

on July 20, 2021. The military community in Matara participated in this programme.

The second programme was held at the government farm in Labuduwa, Galle, targeting retired military personnel on July 27, 2021. Around 50 differently-abled ex-veterans also participated in this programme and the Ranaviru Seva Authority aims to empower them as entrepreneurs.

The programme also aims to engage retired military personnel and close relatives of ex-veterans, who have sacrificed their lives in the battlefield, as means of strengthening the capacity of the Ranaviru Seva Authority officials at provincial and district level to make this project a success.

Future programmes will be held in the Gampaha, Kegalle, Anuradhapura, Polonnaruwa and Kandy districts during the next two weeks.

"Has Finance Minister Basil Rajapaksa reversed President Gotabaya Rajapaksa's decision on banning import of chemical fertiliser? I questioned this morning on order dated yesterday but no reply yet. Below docs clearly show import ban that was 'B' has been replaced with licence 'L'," he stated.

The increase shows that an average family of four that spent Rs.899.85 on this basket of goods for a week in July 2020, paid Rs.1308.10 for the same amount of goods in a week in July 2021.

The BCI tracks the weekly retail prices in the Colombo market of the most commonly consumed food ingredients that might be used in a typical 'bath' curry meal. The prices are collected from the 'Weekly Indicators' published by the Central Bank of Sri Lanka (CBSL). The CBSL data showed that the Colombo Consumer Price Index (CCPI) increased to 5.7 percent in June 2021, from 12 months ago. The increase was attributed to the monthly increase of prices of items in the non-food categories.

Meanwhile, non-food inflation decreased to 11 percent in July, from 11.3 percent in June

oday on the Buzz I speak to a very strong individual. Natalie's talents are limitless from Photography to Writing to Designer, Natalie has done it all and continues to do so. Natalie also took the time to come on my show Date with Danu and speak about the journey of fighting cancer and it was a very powerful interview. Many request came my way for a print interview on this fighter so here is me sitting with Natalie for a quick chat on the Buzz.

#### I would say that at every part of this

harrowing process, the lessons have been different. For example, right now the lesson is learning to let go. As morbid as it sounds, I have been asking myself if I am ready to die. When you're this terminal, you can't help but ask yourself questions like this.

A friend asked me recently if I am not worried about the afterlife and coming to some sense of inner peace with myself before I have to go. But the afterlife isn't on my mind. Every religion has tried to give us some sense or interpretation of the up and down and I feel little need to worry about the unknown. My concern was more about how I would leave this life. Would I die in excruciating pain? Would the morphine stop working? I don't fear death, I fear pain. And I fear an incomplete life; leaving before my purpose is fulfilled, as a mother, activist, partner and friend.

#### WHERE ARE THE CRACKS IN THE SYSTEM?

The cracks are everywhere, but I think it begins with a lack of allocation of adequate state funding for public healthcare overall. This in turn leads to insufficient staffing and resources – and room for far too much negligence. When negligence exists in a space where you're meant to save lives – the opposite happens.

I walked into the Maharagama Hospital as a breast cancer patient in May 2020 and by the time I had had it with the hospital and walked out in February this year, I had multiple metastases spread throughout my body and organs which went undetected due to negligence.



So what was at first considered curable, has now become lethal. They may not know that I am no longer a patient there, but someone has to care enough in there to make sure patients come in for treatment with adequate follow up. You put your cancer and your life in what are the best hands for the job. You're not supposed to do the work - your job is to find the willpower to go on.

There is also a massive amount of information missing that should be essential knowledge for patients. So much is left unsaid by many medical practitioners in the system because they know they can get away with it. So long as we continue to revere doctors to an almost godlike status and accept their diagnoses and prognoses without question, then the system will continue to kill people unnecessarily.

Another big concern is how deeply embedded our social ideologies are within the healthcare system. In a space of healing, patients have to often battle social norms just as hard as their illnesses. It is why we expect women cancer patients to wear wigs, ski caps, uncomfortable padded bras so as to preserve a sense of gender that the world expects from you. It is why surgeons opt to offer complimentary breast reconstruction surgeries to younger women to help preserve their marriageability while it is assumed that older women have passed their "sell by date."

I am also deeply concerned about how many patients a doctor can keep track of. Most consultant doctors work the first half of the day in government institutions where they will encounter more cases and in turn a larger number of rare cases they could attach their names to. Then the second half of the day is spent in two or even three private hospitals where they see some 20 to 30 patients at each establishment. Patients pay an average of Rs. 3000 for a channeling session which often lasts a maximum of 5 to 7 minutes. Some, less than 3. To be able to fill their personal quota of patients, doctors rush through the process because there are only so many hours in a day and so many patients to see. Do you think the specialist has sufficient time to asses a complex illness like cancer in under 3 minutes? Things slip through the cracks this way. And I am proof

As a starting point, I ask that the Ministry of Health look into imposing a quota on the number of patients a doctor is able to channel privately. My current oncologist, who was in fact the woman who first diagnosed me with cancer has a self-imposed quota. She allows only 8 - 10 patients to channel her a day and spends a minimum of 30 minutes with them. She has the time to do this without another 22 patients



waiting in line to see her for 3 minutes. Shouldn't this be the way that all consultations go? WHAT HAS BEEN YOUR BIGGEST WORRY WHEN YOU


My son. As a single parent who has raised my kid for almost 9 years by myself, his wellbeing was foremost on my mind. But it has also given me the strength to fight. I want to continue raising the son I brought into this world – I want to see him grow up. To bear witness to his life, I have to keep fighting for

#### TELL ME ABOUT YOUR MASTECTOMY SURGERY? Firstly, I wouldn't call it a surgery. Butchery is a more

appropriate term.

Since the hospital and surgical team were not very communicative, I opted to do my own research on mastectomies. I discovered there were multiple types of surgical cuts and procedures - some that could save your nipples and breast skin which would in turn leave you with less scarring and make breast/ chest reconstruction easier. I sat in my hospital bed and waited for days before surgery to have a pre-op conversation with my surgical team, but this was not to happen.

Not getting to have anyone from your surgical team talk to you before surgery is not on. A few days later, I found out that not only was the senior surgeon who was to perform the surgery not in the theatre where I was being operated on, he wasn't even in the hospital that day, opting to perform a more lucrative surgery at a private hospital instead. The result was that a bunch of residents and a SR collectively scarred me badly, without supervision in the OR.



#### STAY POSITIVE?

I remind myself that I am more than the bad things that have happened to me. I remind myself of how full my

life is - I have a partner that loves me beyond words. a son like my twin, 2 beautiful canines and a wealth of the most amazing friends I could have asked for. I also find deep meaning in my work, confronting the things we would rather ignore: our complex relationship with ourselves and one another in the context of gender, race and religion in post-Colonial and postwar Sri Lanka. I know I am a fighter, I just needed to learn how to fight for myself this time.

WHAT ARE YOUR FUTURE PLANS?

To continue to be a fighter against all the things that drag the human race to its knees. To make more photographs and to celebrate the life I have been blessed with – bad things and all.

#### ARE YOU HOPING TO STOP TREATMENTS, AND WHY? It's a daily battle. There are days I feel this battle is

too hard and I long to get back to the life I used to have before Cancer and Corona struck together. Cancer medications take as much of a toll on you as the cancer itself. Having watched my father disintegrate into a shadow of himself during his own battle with when I look in the mirror now has been difficult to say the least. On days like that, I want to give up.

But then there are other days that remind me of what I have to live for: the work I am so proud of, the love I have to live for and my rage against the machines of power. These things make me want to apply that bravery to my own life. It is a reminder that I am still here.
