Order under Section 61

ORDER made by the Public Service Commission under section 61 of the Ceylon (Constitution) Order in Council, 1946.

ORDER No. 147

1. The powers specified in Column I of the Schedule hereto are hereby delegated to the officer or officers of the Department of Health specified in the corresponding entry in Column II of that Schedule, subject to the following conditions :—

- (1) those powers shall be exercised according to such instructions as may be issued from time to time by the Public Service Commission ;
- (2) any person dissatisfied with the decision made by an officer under any power delegated to such officer under this Order may—
 - (a) appeal to the Director of Health Services if that decision is made by any Deputy Director, Chief Administrative Officer or Chief Accountant ;
 - (b) appeal to the appropriate Deputy Director if that decision is made by any Medical Officer of the Senior Administrative Grade, any Superintendent in charge of any Special Campaign, the Chief Public Health Engineer, the Medical Superintendent of the Mental Hospital, the Superintendent of the Civil Medical Stores, the Judicial Medical Officer, Colombo, any Medical Officer of the Deputy Administrative Grade, any Administrative Officer, the Chief Nursing Officer (Medical), the Chief Nursing Officer (Public Health), the Chief Clerk of the Office of the Director of Health Services ; and
 - (c) appeal to the appropriate Medical Officer of the Senior Administrative Grade if that decision is made by any Medical Officer, any Medical Officer of Health, any Judicial Medical Officer (other than the Judicial Medical Officer, Colombo), the Secretary of any Hospital, the Secretary to any Superintendent of Health Services, the Secretary to the Superintendent Colombo Group of Hospitals, the Secretary to the Superintendent of the Tuberculosis Campaign, the Secretary to the Superintendent of the Anti-Malaria Campaign, the Secretary of the Medical Research Institute, the Secretary of the Public Health Engineering Division ; and
- (3) in any case where the Public Service Commission decides that any power of punishment delegated to any officer under this Order shall be exercised by the Public Service Commission, such officer shall not exercise that power in that case.

2. Nothing in this Order shall be deemed or construed to derogate from, or to affect in any other way, the right of appeal to the Public Service Commission conferred by section 61 of the Ceylon (Constitution) Order in Council, 1946.

3. This Order shall have effect notwithstanding anything in the Order No. 83 made under section 61 of the Ceylon (Constitution) Order in Council, 1946, and published in *Gazette* No. 10,847 of October 7, 1955.

4. The Order No. 89 dated September 17, 1956, as subsequently amended, is hereby revoked.

RULE made by the Public Service Mutual Provident Association and confirmed by the Minister of Finance, under section 16 of the Public Service Mutual Provident Association Ordinance (Chapter 283).

Rule

The rules published in *Gazette* No. 5,147 of June 17, 1962, as amended from time to time, are hereby further amended as follows:—

(1) in Chapter I,—

(a) in rule 6A—

(i) in paragraph (i), by the substitution, for the expression "60 years", of the expression "55 years"; and

(ii) by the substitution, for paragraph (iii), of the following paragraph:—

"(iii) The full contributed amount shall be paid by the Association within twelve months of the receipt of the application from the member for the refund of that amount.";

(b) in rule 13, by the substitution, for paragraph (vi), of the following paragraph:—

"(vi) (a) Every loan granted under this rule shall, subject to the provisions of rule 17 (A), be repayable in not more than 36 consecutive monthly instalments, the first of such instalments being payable on the last day of the calendar month immediately following that in which the loan was taken:

Provided, however, that where a member retires from service, he may elect to repay such part of the loan as is outstanding on the date of retirement, in not more than 60 consecutive monthly instalments.

(b) Any member who does not pay a monthly instalment on the date on which it becomes due, shall be deemed to be in default of that instalment.";

(c) in rule 15, in paragraph (1) thereof—

(i) by the substitution, for the expression "of the loan under Rule 12", of the expression "of the loan granted under rule 12 or rule 13";

(ii) by the substitution, for the expression "any further loans under Rule 12", of the expression, "any further loan under rule 12 or rule 13"; and

(iii) by the substitution, for the expression "to obtain further loans under Rule 12", of the expression "to obtain further loans under rule 12 or rule 13"; and

(d) in rule 17—

(i) by the renumbering of that rule as paragraph (i) of that rule; and

(ii) by the insertion, immediately after paragraph (i) of that rule, of the following new paragraph:—

(ii) A sum equal to half per centum of the interest recovered during each financial year of the Association upon loans granted under rules 12 and 13, shall be set apart as a reserve to meet any bad debts arising out of loans granted under rule 13"; and

(2) in Chapter 2, by the substitution, for rule 5, of the following rule:—

"5 (1) The rate of interest that shall be charged on loans, shall be 7½ per centum per annum:

Provided that where the interest is paid regularly on or before the tenth of the month succeeding the month in respect of which the interest is due, the rate of interest that shall be charged shall be 6 per centum per annum.

(2) Where the interest payable under paragraph (1) is recovered from the salary or pension of a member, the interest shall be deemed to have been paid to the Association by that member on the date of such recovery".

The Award

This is an award under section 17 sub-section 1 of the Industrial Disputes Act (Chapter 131), as amended by Act No. 62 of 1957. It relates to an industrial dispute between the Sri Lanka Nidahas Wathu Kamkaru Samithiya on the one part and A. S. Sithambarampillai, Proprietor, Castle Milk Estate, Gampola, on the other part.

2. By his Order dated 11th June, 1962, the Hon'ble Minister of Labour and Nationalised Services acting under section 4 (1) of the Industrial Disputes Act, referred the dispute to this Tribunal for settlement by arbitration. The matter in dispute between

the aforesaid parties as set out in the statement of the Commissioner of Labour is:—whether the non-employment of A. Sinniah and B. Araie is justified and to what relief they are entitled.

3. At the hearing the Union was represented by Mr. Advocate G. H. Gnanasekaram instructed by Mr. A. H. M. Jameel while the respondent was represented by Mr. E. D. Taylor. According to the statement filed by the union the worker Sinniah as well as his wife Araie had been in employment on Castle Milk Estate, Gampola, as labourers since 1st March, 1957, under the new proprietor. The union alleged that the management had without sufficient cause terminated the services of Sinniah and Araie on 14th June, 1961. At the time their employment ceased Sinniah's monthly earnings had been about Rs. 60 while the earnings of Araie had been about Rs. 40. The proprietor had offered Araie one month's wages as a payment in lieu of notice but which she had not accepted. It was contended that these two workers were entitled to reinstatement with back wages.

4. The management admitted the period of employment and the wages as set out by the representative of the union. It was submitted that Sinniah had reached the age of retirement sometime in June, 1961, as he was of 59 years old. It was contended that the management was justified in terminating the services of Sinniah and in consequence his wife because when he was ordered to vacate a particular line room he had turned abusive and threatened the Superintendent. Sinniah's family was said to consist of three children apart from himself and his wife.

5. On the very first date of the hearing the parties arrived at the following settlement:—

1. The management will treat Sinniah to have retired from employment as from 14th June, 1961, by reason of the fact that he has reached the age of 59.
2. The management will pay Sinniah a sum of Rs. 75 as an ex-gratia payment.
3. Sinniah will be entitled to occupy one of the two line rooms now occupied by him along with his wife and children.
4. The management will also pay Sinniah a pension of Rs. 10 per month as from 1st October, 1962.
5. In regard to Araie it is agreed that the management will reinstate this worker in her employment as from 20th October, 1962.
6. The management will pay Araie a sum of Rs. 275 as an ex-gratia payment in lieu of the claim for back wages.
7. The period of non-employment of Araie shall not be treated as an interruption in her service.
8. She will not be entitled to any other payments other than the sum of Rs. 275 as agreed upon for the period of non-employment.

In my view the above settlement, the terms of which were explained to the two workers concerned, is just and equitable and I make my award accordingly. It is further ordered that the proprietor shall pay the two sums as set out above through the Assistant Commissioner of Labour, Kandy, on or before 31st October, 1961, but the payment shall be released to the workers concerned upon production of a letter of authority from the Superintendent.

BY virtue of powers delegated to him by Excise Notification No. 1 published in *Gazette* No. 6,536 of December 13, 1912, the Excise Commissioner hereby directs under section 25 of the Excise Ordinance (Chapter 52), that, Excise Notification No. 351, published in *Gazette* No. 8,560 of December 15, 1939, as last amended by Excise Notification No. 429 published in *Gazette* No. 10,564 of August 14, 1953, be further amended as follows:—

(1) by the insertion, under the heading "Forms of", immediately after item III, of the following item:—

"IV. Special Licence for drawing of toddy for the purpose of bottling and sale of toddy.";

(2) by the insertion, immediately after paragraph (1) thereof of the following new paragraph:—

"(1A) Every licence issued for the drawing of toddy to supply any premises licensed for bottling and sale of toddy shall be in form Excise T 2A (vide Excise Notification 291)"; and

(3) in Part II of the First Schedule thereto—

(a) by the substitution in Condition 6 thereof, for the words and figure "one-sixth of an imperial gallon to any place other than the approved place of sale mentioned in case 4 of the application" of the words and figure "one-third of an imperial gallon to any place other than the approved place of sale mentioned in case 4 of the application or to a place licensed to bottle and sell toddy";

(b) by the substitution, in Condition 7 thereof, for the words "toddy tavern" of the words "toddy tavern or to any person who holds a licence to bottle and sell toddy";

(c) by the insertion at the end of Condition 16 (f), of the following:—

"Provided that where a licence has been issued for the purpose of bottling and sale of toddy, a separate licence may be issued on form Excise T. 2A for such number of trees as the Excise Commissioner may direct for the bottling and sale of toddy only, and for no other purpose. The fee for the grant of such licence shall be computed on the same basis as the tree-tax recovered under the tree-tax system in the area."; and

(d) by the substitution, in Condition 17 thereof, for the words "toddy booths" the words "toddy booths or the premises licensed to bottle and sell toddy".
