IMPORT CONTROL NOTICE No. 8/61 Imports

FURTHER to Import Control Notice No. 2/61, published in Gazette Extraordinary No. 12,274 of January 25, 1961, importers are hereby requested to forward to this Control separate statements of imports of the following goods in 1958, 1959 and 1960 supported by Customs stamped entries and invoices giving (1) entry number and date, (2) country of origin, (3) quantity and (4) c. i. f. value in Rupees:—

- (1) Biscuits;
- (2) Cocoa (prepared);
- (3) Coffee, Roasted ground;
- (4) Coffee, Roasted and not ground;
- (5) Coffee, not roasted and ground;
- (6) Confectionery (including chocolates);
- (7) Tamarind;
- (8) Fruits, fresh: Apples and grapes;
- (9) Currants;
- (10) Raisins;
- (11) Jams, jellies and marmalades;
- (12) Fruits preserved in sugar, syrup or spirits;
- (13) Vegetables, preserved or tinned;
- (14) Sauces:
- (15) Fruit cordials;
- (16) Pearls (natural and culture) unset;
- (17) Precious and semi-precious stones (cut and uncut);
- (18) Chinaware, porcelainware and stoneware other than sanitary fittings and satsumaware;
- (19) Domestic and fancy glassware;
- (20) Platinum;
- (21) Photographic instruments, appliances and apparatus (including paper, plates and films);

- (22) Wireless goods and apparatus;
- (23) Electrothermic apparatus (including domestic appliances);
- (24) Electric fans (complete);
- (25) Refrigerators and refrigerating machinery;
- (26) Sewing machines (household);
- (27) Footwear;
- (28) Account books;
- (29) Exercise books in paper covers;
- (30) Albums:
- (31) Motor cars (including motor station wagons);
- (32) Motor cycles and motor scooters;
- (33) Motor lorries;
- (34) Chassis, with or without engines mounted, for motor buses, motor trucks and motor lorries;
- (35) Imitation jewellery and haberdashery not included in class III, Group N (apparel);
- (36) Jewellery including silver, gold, silverplated and gold plated wire and thread;
- (37) Musical instruments and parts and accessories;
- (38) Gramophones and phonographs, including parts and accessories, and records;
- (39) Powder, face and bath, and eau-de-colongne;
- (40) Tooth paste and dentrifices;
- (41) Fountain pens;
- (42) Toys and parlour games;
- (43) Travel goods and hand bags;
- (44) Rubberised clothing, and
- (45) Manufactures of plastic, vinyl, polythene or any other similar material.

IMPORT CONTROL NOTICE No. 9/61

Imports of Textiles

THIS notice sets out the present policy relating to the importation of textitles. The previous notices are, in so far as they are inconsistent with this notice, of no effect, hereafter.

- 2. Individual import licences must be obtained from this Control for the importation from any source of the following items of textiles:—
 - (1) Cotton yarn and twist,
 - (2) Handkerchiefs of cotton,
 - (3) Banian cloth of any material,
 - (4) Towels and towelling of any material,
 - (5) Sarongs and sarong cloth of any material,
 - (6) Cotton camboys, handloom,
 - (7) Sarees of any material where the c. i. f. value per saree is more than Rs. 12,
 - (8) Hair-cord (other than 100% cotton), satin and crepe (this includes georgette, oriental, sheer, flat, pearl, beauty, crepe-de-chine but excludes voile and palace crepe) piecegoods in which the width of each piecegoods does not exceed 36 inches,
 - (9) Piecegoods (other than piecegoods of any description specified in any of the items (3) to (8) above of any material where the c. i. f. value per yard is more than Rs. 2,
 - (10) Apparel (including hosiery, haberdashery, millinery, hats and artificial flowers) of any material.

- 3. Registered Ceylonese Traders holding General Import (Textiles) Licences and General Import Licences permitting textiles may import, without an individual import licence, textiles of any description other than those set out in para. 2 above, manufactured in any country. Before clearance is effected from the Customs however, of any such imports from the Ceylonised area, the dollar area, Belgium, Denmark, France, Greece, Iceland, Italy, Luxemburg, Netherlands, Norway, Portugal, Sweden, Switzerland or Turkey, the relevant requirements relating to General Import Licences must be complied with.
- 4. Every holder of a General Import (Textiles) Licence who is not a registered Ceylonese Trader is authorised to import without an individual licence, textiles of any description other than textiles of the descriptions set out in para. 2 above, manufactured in any territory other than the Ceylonised area, the dollar area, Belgium, Denmark, France, Greece, Iceland, Italy, Luxemburg, Netherlands, Norway, Portugal, Sweden, Switzerland or Turkey. Established importers other than Registered Ceylonese Traders who wish to import textiles of any description other than textiles of the descriptions set out in para. 2 above manufactured in the dollar area should apply to this Control for individual import licence before an order is placed. Licences will be issued at the discretion of the Controller on the basis of past trade. Such licences will not be issued for the importation of textiles manufactured in the Ceylonised area, Belgium, Denmark, France, Greece, Iceland, Italy, Luxemburg, Netherlands, Norway, Portugal, Sweden, Switzerland or Turkey.
