##### THE VILLAGE COMMUNITIES ORDINANCE

BY virtue of the powers vested in me by section 11 of the Village Communities Ordinance (Chapter 198), as modified by the Proclamation published in *Gazette Extraordinary* No. 9,773 of September 24, 1947, I, Mahanama Samaraweera, Minister of Local Government and Housing, do hereby—

- (1) sub-divide the Village Headmen's Divisions situated in the Hiripitiya village area in the Kurunegala District and specified in column I of the Schedule hereto into the wards with the limits specified in column II of that Schedule, and
- (2) declare that the provisions of paragraph (1) shall—
  - (a) in so far as those provisions relate to any matter connected with the general election of members of the Village Committee of the aforesaid village area to be held in the year 1961, come into effect on the date on which the Order made in relation to the aforesaid village area under section 82 of the Local Authorities Elections Ordinance, No. 53 of 1946, is published in the *Gazette*; and
  - (b) in so far as those provisions relate to any other matter, come into force on the day immediately following the date of the expiration of the term of office of the members of the aforesaid Village Committee who are in office at the date hereof.

**Order**

The provisions of paragraph (1) of the notification relating to the Hiripitiya village area in the Kurunegala District made under section 11 of the Village Communities Ordinance (Chapter 198), and published in this *Gazette* shall—

- (1) in so far as those provisions relate to any matter connected with the general election of members of the Village Committee of the aforesaid village area to be held in the year 1961, come into effect on the date on which this Order is published in the *Gazette*; and
