### PART I: SECTION (I)—GENERAL

#### Government Notifications

##### THE QUARANTINE AND PREVENTION OF DISEASES ORDINANCE

###### Notification

BY virtue of the powers vested in me by regulation 1 of the regulations made under sections 2 and 3 of the Quarantine and Prevention of Diseases Ordinance (Chapter 173), and published in the *Supplement to Gazette* No. 7,481 of August 28, 1925, as modified by the Proclamation published in *Gazette Extraordinary* No. 9,773 of September 24, 1947, I, Alexander Perera Jayasuriya, Minister of Health, do by this Notification revoke with effect from November 8, 1961, the notifications published in *Gazettes* No. 12,726 of October 20, 1961, and *Gazette Extraordinary* No. 12,730 of October 24, 1961, confirming the declaration of the "diseased locality" made by the Superintendent of Health Services, Kurunegala, on October 16, 1961 and October 17, 1961.

#### Price Orders

Price Order No. FC/V—S.F. 1 (38)

##### THE CONTROL OF PRICES ACT, NO. 29 OF 1950

##### SUBSIDIARY FOODSTUFFS

###### Order

BY virtue of powers vested in me by section 4 of the Control of Prices Act, No. 29 of 1950, read with section 3 (2) of the Act, I, Arthur Cuthbert Bartholomeusz, Assistant Controller of Prices (Food), for Colombo District, do by this Order—

- (i) revoke with effect from this date my Food Price Order No. FC/V—S. F. 1 (37) dated June 12, 1961, published in the *Ceylon Government Gazette Extraordinary* No. 12,493 dated June 20, 1961;
- (ii) fix with immediate effect the price which for the time being has been fixed under the Control of Prices Act, No. 29 of 1950 as the wholesale dealer's maximum wholesale price for Colombo Municipality, increased by amounts specified in Column 2 to 11 of the Schedule hereto, to be the maximum wholesale prices per hundredweight gross above which the articles specified in the corresponding entry in Column 1 of the Schedule shall not be sold within the areas specified in Columns 2, 3, 4, 5, 6, 7, 8, 9, 10 and 11 respectively;
- (iii) fix with immediate effect the price which for the time being has been fixed under the Control of Prices Act, No. 29 of 1950, as the retail dealer's maximum retail price for the Colombo Municipality increased by the amounts specified in Column 12 of the Schedule hereto, to be the maximum retail prices per pound nett above which the articles specified in the corresponding entry in Column 1 of the Schedule shall not be sold within the Administrative District of Colombo (excluding the Colombo Municipal area);
- (iv) direct that for the purpose of this Order—
  - (a) any sale of any quantity of an article specified in Column 1 of the Schedule for the purpose of re-sale or any sale of article specified in Column 1 of the Schedule in a quantity of one hundredweight gross or more at a time shall be a sale by wholesale;
  - (b) any sale of any quantity of an article specified in Column 1 of the Schedule less than one hundredweight gross for the purpose of consumption or use shall be deemed to be a sale by retail;
- (v) direct that in every area where maximum prices are fixed by this Order, no person shall sell any article specified in Column 1 of the Schedule which is adulterated with any other article;
- (vi) direct that in every area where maximum prices are fixed by this Order, every trader who has any article specified in Column 1 of the Schedule in his possession or under his control at any place or in any vehicle, shall exhibit conspicuously at that place or on that vehicle a quantity of such articles in a suitable container with the maximum prices for such article fixed by this Order displayed in figures not less than one inch in height on price tags or boards attached to such containers in such a manner that the article and maximum prices could be clearly seen by any customer;
- (vii) direct that for the purpose of this Order "pound" or "lb" shall be deemed to be the standard pound avoirdupois weight;

(viii) direct that in every area where maximum prices are fixed by this Order, every person who sells any article specified in Column 1 of the Schedule by wholesale shall, and every person who sells any article specified in Column 1 of the Schedule by retail shall, on demand, give the purchaser thereof a receipt in which there shall be set out—

- (a) the date of the sale ;
- (b) the quantity of such article sold (by weight) ;
- (c) the price paid for the quantity sold ; and
- (d) the nature of the transaction, that is to say, whether the sale was by wholesale or retail ;

(ix) direct that when any article specified in Column 1 of the Schedule is sold, the maximum prices referred to in Column 2 to 12 of that Schedule shall include the price of wrapper or container, if any, in which such article is sold.
